### **Focus on Fire Safety: Communities United Against Arson**

Arson can devastate a community, resulting in the decline of the neighborhood through increased insurance premiums, loss of business revenue, and a decline in property values. Arson is difficult to prosecute, but the effects are felt throughout the community: workers lose jobs, towns and cities lose tax dollars, burned buildings create blighted areas, and innocent people are injured or killed. Uncontrolled arson, along with other serious crime, creates rampant fear among residents, business

customers, and potential visitors. If the community's streets seem out of control, people will be afraid to come into that area to visit or do business. These conditions can quickly lead to a second stage where residents who can afford to move out begin selling homes, even at a loss, to escape before the bottom drops out. Property tax collections plummet, giving the community less and less resources to fight back.

### **Six Fire Officials Selected for Harvard University's Senior Executives in State and Local Government Program**

Emmitsburg, MD – The U.S. Department of Homeland Security's U.S. Fire Administration (USFA), along with the Fire Protection Publications (FFP)/International Fire Service Training Association (IFSTA), the International Association of Fire Chiefs (IAFC), and the National Fire Protection Association (NFPA) announced today that six senior fire officials will receive fellowships to attend **Harvard University's Senior Executives in State and Local Government Program** (<http://ksgexecprogram.harvard.edu/Programs/sl/overview.aspx>) this summer at the John F. Kennedy School of Government. The 19-day program, which includes State and local government leaders from across the United States and other countries, focuses on exploring the interrelationships between citizens and government, analyzing policy options, and examining the ethical and professional responsibilities of leadership.

In congratulating the fellowship recipients, Deputy U.S. Fire Administrator Glenn Gaines said, "USFA and our partner organizations feel very strongly that this experience at the Kennedy School of Government enables fire and emergency services officials to have important conversations between elected officials, careerists, and appointed executives. Now more than ever we need to collectively examine and discuss the critical challenges facing state and local governments."

Gaines went on to say, "These senior fire executives will have an experience that will support their ability to exercise leadership. Our cities and communities are confronted with significant challenges and the Harvard program is a very valuable and unique experience that assists the fellows selected in exercising leadership to overcome them. The partnering organizations are delighted to award these fellowships."

The fellowship program for senior fire service executives is a joint effort between the USFA and FFP/IFSTA, IAFC, NFPA, and Harvard. The final element of the competitive selection process was held on April 26 at the USFA's National Fire Academy in Emmitsburg, Maryland.

The fellowships were awarded by the John F. Kennedy School of Government's Admission Committee based upon recommendations of a nominating panel that included representatives from each partner organization and former program participants. Those selected are:

How to become a PARAMEDIC

Peoples' lives often depend on the quick reaction and competent care of Paramedics. Incidents as varied as automobile accidents, heart attacks, drownings, childbirth, and gunshot wounds all require immediate medical attention. Paramedics provide the vital attention as they care for and transport the sick and injured to a medical facility. In an emergency, Paramedics are typically dispatched to the scene by a 911 operator and often work with police and fire department personnel. Once they arrive, they determine the nature and extent of a patient's condition while trying to ascertain whether the patient has preexisting medical problems. Following strict rules and guidelines, they give appropriate emergency care and, when necessary, transport the patients. Some paramedics are trained to treat patients with minor injuries on the scene of an accident or at their home without transporting to a medical facility. Emergency treatment for more complicated problems is carried out under the direction of medical doctors by radio, preceding or during transport.

Paramedics provide the most extensive pre-hospital care. In addition to carrying out the procedures described above, paramedics may administer drugs orally or intravenously, interpret electro cardiograms (EKGs), perform endotracheal intubations, and use monitors and other complex equipment.

**Working conditions:** Paramedics work both indoors and outdoors in all types of weather. They are required to do considerable kneeling, bending, and heavy lifting. Many people find the work of an EMT exciting and challenging and enjoy the opportunity to help others. Paramedics employed by fire departments work 40-50 hours per week; those employed by hospitals frequently work between 40-60 hours per week; and those employed by private ambulance services work between 45-50 hours per week. Paramedics held about 265,000 jobs in 2004. Most career Paramedics work in metropolitan areas; there are many more EMTs and Paramedics especially in smaller cities, towns, and rural areas.

**Training and other qualifications and advancement:** At the Paramedic level, the caregiver gives additional training in body function and learns more advanced skills than an EMT. Education for a Paramedic requires the individual to graduate from a school and take the National Registry EMT Examination to become a certified EMT/Paramedic. Extensive related coursework and clinical and field experience is required. Due to the longer training requirement, almost EMT/Paramedics are in paid positions rather than being volunteers. Refresher courses and continuing education are available for Paramedics at all levels.

**Job Opportunities:** Employment for Paramedics is expected to grow faster than the average of all other occupations through 2012. Population growth and urbanization will increase the demand for full-time paid Paramedics, rather than for volunteers. In addition, a large segment of the population – the aging baby boomers – will further spur the demand for Paramedic services as they become more likely to have medical emergencies.

**Where can you find training to become a Paramedic?** Almost all community colleges and some state colleges and hospitals offer training and certification to become a Paramedic. This training usually consists of between 750-1,500 hours of classroom and field instruction. Reaching this level will require a lot of sacrifice and studying on your part, but becoming a Paramedic will increase your chances of becoming a firefighter. Approximately 10-20% of all fire departments across the country now require their fire applicants to become Paramedics even before they take the examination. Remember – you must first become an EMT before you can go on to become a Paramedic.

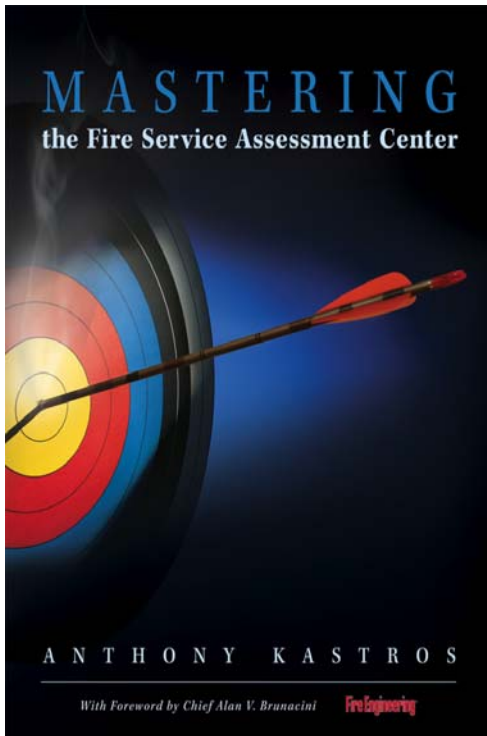

## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas. To see the

- NOTE: Do not wait until the last minute to attempt to complete the CPAT as it is common for people to fail their first attempt and have to go back on another day for a retest. More and more departments are asking for a CPAT card within six months or one year of the date of their testing process and I've seen many candidates fail the CPAT (and even retests) and not be able to continue through a department's testing process because of their failure to plan ahead. Don't let this be you!

**It appears that Texas Firefighter Greg Simmons died in the Line of Duty yesterday after being hit by a vehicle after he tried to escape his fire apparatus that was trapped in the wildfire. We have photos of that apparatus on our home page.** Eastland Volunteer Firefighter Greg Simmons was killed by blunt force trauma according to a preliminary autopsy report by a medical examiner in Fort Worth. FF Simmons was found on a roadside, but investigators don't yet know if he was hit by a

fire truck or car Friday in an area where a 3,000-acre fire caused thick smoke with nearly no visibility. Details now are that FF Simmons was traveling in was attempting to exit a pasture where he and others were fighting the wildfire, but the gate to the field was blocked by other fire apparatus. FF Simmons then reportedly exited the vehicle and went toward County Road 323. It appears that FF Simmons ran onto or near the roadway, which was obscured by heavy smoke, and was struck by the unknown vehicle. Reports initially were that FF Simmons jumped from the fire apparatus, apparently was overcome by smoke and fell in a ditch before fire reached him.

The funeral service for FF Simmons will be held Wednesday at 1300 HOURS at the Leon River Cowboy Church in Eastland. The family requests that in lieu of flowers, donations be made to the Eastland ISD Scholarship Fund (P.O. Box 31, Eastland, TX 76448) or the Eastland Volunteer Fire Department (414 S. Seaman, Eastland, TX 76448).

#### **FIREFIGHTER MAYDAY IN CT (AUDIO)**

A FF was trapped on the second floor of the house during a fire in Norwich on Friday, but escaped quickly after the RIT team responded and removed him. Companies arrived about eight minutes after the call to find fire showing from one corner of the house. Mutual aid from the Yantic Fire Company as well as the rapid intervention team from the Mohegan Sun Tribal department responded. The Firefighter issued a mayday after his foot plunged through the floor up to his knee. Two other firefighters held him up so he wouldn't fall through, while several others rushed over to help. A half-dozen firefighters worked to untangle wires that had dropped from the sagging ceiling and to extricate the firefighter from the damaged floor; the two who were holding him up also started to break through the floor. #### **FATAL EMS CRASH IN SOUTH CAROLINA:**

There was a crash this morning in Orangeburg County involving a Dodge four-door and an ambulance that had resulted in one fatality. It was reported around 0730 just north of Orangeburg. The driver of the Dodge four-door was 22-year-old Zachary Thomas and Thomas' passenger was the person killed in the crash. The driver of the ambulance was identified as Franklin Boardin of Orangeburg. There was a passenger inside the ambulance at the time of the crash.

#### **ANOTHER SPRINKLER ATTEMPTED GETS DOUSED:**

The Kansas FF's did their best of the last 2 years, but the Realtors and Homebuilders finally beat them. Governor Sam Brownback signed into law on April 8th the prohibition of any municipality or city to adopt residential sprinkler codes. **That's right.** Even if EVERYONE in any municipality within Kansas WANTED to vote in codes requiring residential sprinklers, they can't. We regret to advise you that a Firefighter collapsed on the scene of a fire call while standing by the hydrant late last night. Initial reports are that he collapsed, had CPR initiated by other Firefighters, was treated and transported to the hospital by a Windsor EMS ALS unit but was pronounced dead in the Line of Duty at St. Francis Hospital. The Firefighter's name has not been released pending notification of his family. The call was a report of smoke in the building at the Windsor Rehabilitation Center and came in around 2000 hours. As always, our most sincere condolences. More to follow.

**TEXAS FIREFIGHTER BURNED DURING RESCUE**

Firefighter Matt Clark has only been a Volunteer Firefighter for six months, his full-time job is as a prison guard in Abilene. When one of many Texas working brush fires broke out near his home in Gorman on Friday, he answered the call with his Fire Chief and, almost instantly, they were surrounded by the fire. "At this point, we are at a dead sprint, trying to outrun the fire," Clark said. A blast of flames scarred his face with first degree burns. He suffered third degree burns to his hands. The fire truck they were on was destroyed. "It was very scary," Clark said from bed at the Parkland Memorial Hospital burn unit in Dallas. "I'm not going to lie to you; I honestly did not think I would make it home." And that's when he saw one of his fellow firefighters collapse. "Actually, the burns weren't even hurting that much at that time. My thought was, 'I got to get out of here, and I got to take whoever I can with me,'" Clark said. Matt will be hospitalized for at least another week. He has skin

**MICHIGAN POLICE OFFICER / FIREFIGHTER/EMT (Public Safety Officer) KILLED IN THE LINE OF DUTY**

We regret to advise you that Kalamazoo Public Safety Officer (Police Officer/Firefighter/EMT) Eric Zapata lost his life last night in the line of duty. Kalamazoo Public Safety is one of the largest combined police/fire departments in the nation. Officer Eric Zapata was shot and killed after responding to reports of a shots fired call. Another officer had also responded to the call and approached a man on a porch. As the officer asked the man if he had heard any shots, the man suddenly pulled out a gun and exchanged shots with the officer. The subject then ran in between two houses where he confronted Officer Zapata. More shots were exchanged and Officer Zapata was struck in the head and chest. The man then committed suicide. Officer Zapata had served with the Kalamazoo Department of Public Safety as a Police Officer/Firefighter/EMT for 10 years. As always, our most sincere condolences.

**FATAL APPARATUS RELATED CRASH IN CANADA**

A man was killed in a highway crash after he drove past a road block and slammed into a parked fire truck at a crash scene northeast of Edmonton. The fatal collision happened just before 1330 hours last Friday on Highway 45 near the town of Hairy Hill. Royal Canadian Mounted Police (RCMP), Paramedics and County of Two Hills Firefighters were assessing a tractor trailer that had hit the south

ditch and rolled. The truck was carrying two full propane tanks, but there were no leaks, and the driver wasn't seriously hurt. Firefighters and RCMP had closed the highway in both directions, but a passenger van sped past the road block toward the collision scene, hitting an unoccupied fire truck - with flashing warning lights, positioned to block and/or divert traffic.

#### **CRASH VICTIM PULLS KNIFE ON FIREFIGHTERS**

In another attack on Firefighters responding to assist at a crash (Bellmore, Long Island Firefighter Justin Angell was shot in March and thankfully survived, cops killed the shooter), Miami (Florida) Firefighters say a woman who was involved in a fiery single-car crash on I-95 yesterday afternoon became a suspect when she pulled a knife on the men trying to help her. It happened after the woman crashed her van into a wall near the 112 Expressway around 1330 hours. Like any other FD, City of Miami Firefighters responded to rescue anyone who might be trapped after the van burst into fire, but no one was inside. Instead, Firefighter Robert Webster saw a woman 200 yards away walking in the emergency lane, appearing distressed, so he approached her. "She held a knife out towards me and she was saying things, I couldn't make out what she was saying," Webster said. FF Webster said the woman was so violent and combative, they called police for backup. It took two male and two female officers to restrain the woman, who was then hog-tied, placed in the back seat, and taken in for a psychiatric evaluation. Use caution, "ya neva know"

#### **CT LODD UPDATE:**

Windsor is mourning the loss of Volunteer Firefighter Robert Watts, 50, who died in the Line of Duty while operating at a fire call at the Windsor Rehabilitation and Healthcare Center last night. FF Watts was on the first engine to arrive on the scene, and was connecting a line to a hydrant when he collapsed. FF Watts joined the Windsor Volunteer Fire Department in 2003 and completed his training in 2006. He served in the Marine Corps from 1980-86 and is a graduate of Manchester High School. Watts' fire service began early when he joined the Manchester Fire Department 8th Utilities District in 1977 as a junior member. He tragically leaves behind 2 children. RIP.

One Philadelphia Firefighter is in critical condition w/burns and 2 other Firefighters were hurt following a flashover and mayday in Philly late last night. The fire also left a civilian dead. When PFD Firefighters got to the home (photos on our home page showing the conditions), they had reports of people trapped. Arriving in 3 minutes, they had heavy smoke and fire blowing from the windows of the home. One person was rescued from a second floor window by Firefighters. Fire Commissioner Lloyd Ayers described what happened: "While they were attacking the fire they had a flash over. Several of the firefighters were injured. We actually called a mayday on that to make sure we could get our firefighters out." As of this writing, one Firefighter was in critical condition at Temple while the other two were reported to be in stable condition. There were no signs of any smoke detectors in the home. **TRIAL UPDATE: FDNY RADIO AUDIO OF MAYDAY AT DEUTSCHE BANK FIRE**

Jurors in the manslaughter trial of 3 construction supervisors listened this past Monday to radio dispatches from FDNY Firefighters operating at the fatal fire at the former Deutsche Bank building. In the recordings, amongst the transmissions, the men asked for saws to cut through plywood that blocked stairwells. They are also heard transmitting MAYDAY's after they were unable to get water. The recordings back up the prosecution's claims that a disconnected standpipe hampered firefighting

efforts. Defense attorneys say it was not the cut standpipe, but other factors in the building that led to the deaths of two Firefighters. They argue failures by government agencies are to blame. **Firefighters Robert Beddia and Joseph Graffagnino were killed in the Line of Duty at this August 2007 fire.**

**OHIO FIRE APPARATUS STRUCK ON INTERSTATE**

A ladder truck from the North Ridgeville FD was attempting to make a U-turn on I-80 when it was struck on the driver's side door by a semi truck early this morning. The Firefighter driving the apparatus was transported to a local hospital with unspecified injuries. Shortly after midnight on Wednesday morning, the fire apparatus was traveling westbound on the turnpike between exits 152 (Route 57) and 145 (Route 10) when Firefighters received a call about a vehicle fire in the eastbound lanes. The fire apparatus attempted a U-turn from a lane other than the left-most lane. As the fire apparatus approached the median turnaround, it was struck by a semi truck that was traveling in the same direction. The driver of the semi truck was not injured. **TEXAS FIREFIGHTER DIES IN THE LINE OF DUTY-WILDLAND FIRE BURNS**

We regret to advise you that the Cactus (Texas) Firefighter who suffered 3rd degree burns a week ago last Saturday at a huge grassfire has died in the Line of Duty. FF Elias Jaquez suffered burns to 60% of his body in that fire. FF Jaquez, 49, a husband and father of four daughters, has been a Volunteer Firefighter at the fire for slightly less than two years. As you will recall, FF Jaquez, and 3 other Firefighters were injured after a Dumas and Cactus fire apparatus became stuck in the rough terrain. The Cactus crew was going on to de-flank the fire, the Dumas truck got stuck in the sand and the Cactus fire crew came up beside them grab the other FF's, and then they got stuck. The heroic attempts took FF Jaquez's life. As always, our most sincere condolences to all those affected, especially the family of FF Elias Jaquez.

**TEXAS CONTINUES TO BURN:**

**Firefighters in Texas continued to operate at fires that have scorched a million acres and have been burning for more than a week.** "We're actually seeing Texas burn from border to border. We've got it in West Texas, in East Texas, in North Texas, in South Texas -- it's all over the state," Texas Forest Service spokeswoman April Saginor told CNN Radio. "We've got one in the Dallas area that's four fires that have actually merged together." Saginor said firefighters from 34 states are now in Texas battling blazes that, over the past two weeks, have destroyed 170 homes and burned 1 million acres. "Some (fires) are over 100,000 acres and they've been burning for over a week, so that's our priority right now," Saginor said, "to put out the big ones." Much of Texas, however, is expected to get a break today from the dry weather and high winds blamed for the spreading wildfires, according to the National Weather Service. However, the fire danger is likely to return Thursday for various parts of the state.

A Mississauga (Ontario, Canada) Firefighter has been charged after a fatal responding wreck involving his fire apparatus. Citizen Kimberley Schulz, 42 (whose Brother and Father are Firefighters) was killed on March 6 when the fire apparatus, which was responding to a call, struck her car at an intersection. Police had been investigating whether the sensor system that is meant to change traffic lights had not switched the light. When an emergency vehicle approaches a traffic light, the vehicle supposed to have a green light, while all three other directions are supposed to have a red light. It is now clear that the fire apparatus did have a red light, according to the cops. Firefighter Jarrett Johns, 35, of Toronto, who was driving the apparatus, has been charged with failing to stop at the red light. FF Johns is scheduled to appear in court on June 16. The fire apparatus had its sirens on and was traveling to another crash when it went through the red light and hit her vehicle. Kimberley Schulz, 42, comes from a of Firefighters as her Brother, Steve Bayley, is a Toronto firefighter and her Father, Warren Bayley, is a retired Toronto Firefighter. None of the 3 Firefighters on the truck was injured.

The battle continues in California as at least one city is looking at trading in their FD to a for-profit FD who claims they can do it better and cheaper-and will guarantee it. As we shared a few weeks ago, this is a big deal as more and more local governments look to save money-and in many cases, ignoring what is best for public safety, not the public's purses. The city of San Carlos has utilized the services of Tri-Data consultants. You will recall Tri-Data as the company who, working for the National League of Cities, issued a report on CANCER & FIREFIGHTING. **Now, back to the private-for-profit issue-**

San Carlos FF's went on a door-to-door campaign today, hoping to save their jobs. Currently San Carlos shares its FD with the city of Belmont. But last year, San Carlos politicians said that they wanted to end that agreement to save money. The city has 3 options: it can create its own stand-alone FD, consolidate with the Redwood City FD, or it could shut down the FD completely and contract with the private for profit security company: Wackenhut Corporation.

**TRI DATA REPORT:**

According to Tri-Data, the city of San Carlos would be better off ending its joint FD with Belmont and outsource the service completely to private provider Wackenhut Services, Inc. or create a hybrid model to share management with Redwood City. The findings of TriData were released yesterday, a week after the City Council heard formal presentations on its fire alternatives. According to TriData, two of them should get more consideration - Wackenhut, or the hybrid model. "They offer the full range of fire and EMS services and in some cases innovation and they are the least costly today while offering potential for cost control in the future," the report concluded. But while Tri-Data was impressed by Florida-based Wackenhut, some residents most definitely are not. Some voiced their reservations at last Monday's meeting and others, on behalf of Firefighters Union Local 2400, visited residences with anti-Wackenhut literature asking the like-minded to attend the upcoming City Council meeting at which a decision is expected. (More below)

**CALIFORNIA APPLES, CALIFORNIA ORANGES & FIREFIGHTER SALARIES:**

And in southern California this week, San Diego Council members claim that San Diego Firefighters earn as much as 325 percent more than their private sector colleagues. San Diego Council members Carl DeMaio and Lorie Zapf issued a report using figures from the city's Independent Budget Analyst to show that San Diego FD employees who are classified as Firefighter II/EMT make nearly 3 times as much in salary as EMTs at Rural/Metro, a private for profit ambulance service that works under a city contract. The same SDFD employees each make nine times the benefits of the Rural/Metro worker for a total pay difference of 325 percent, according to their report. Large disparities exist in other classifications, as well, according to the IBA figures. **"Any time the city gives out salaries and benefits that are higher than the local labor market, we are wasting the taxpayers' money,"** said DeMaio. He and Zapf asked the IBA to provide more data for the city to have on hand when negotiations open on a new contract with the

**firefighters union.** Fire Chief Javier Mainar and union President Frank De Clercq both said the comparisons amount to mixing apples and oranges. (See link below)

### **CALIFORNIA CITY SAYS NO TO FOR-PROFIT FIRE SERVICE:**

The San Carlos city council unanimously voted to partner with Redwood City last night on a "shared services/collaborative" hybrid FD, with more than 150 vocally passionate attendees, many of whom held anti-Wackenhut signs in opposition of the private for-profit company who wanted the contract. The hybrid proposal will save the city \$1.8 million. As a back-up plan, the city also voted to 3-2 to re invite the private firm Wackenhut Services to re bid should negotiations with Redwood City fail.

The details of the hybrid option are as follow:

- Redwood City will provide four firefighters staffing "Truck 9" out of Fire Station 9.
- Supervision and scene management will be provided by Redwood City
- Administrative staff will be provided by Redwood City including Fire Chief, Deputy Fire Chief, an administrative assistant, a secretary, and another secretary working out of the 755 Marshall Street office.
- A fire inspector will be assigned to San Carlos.
- Training services will be provided by Redwood City's battalion Chief.
- San Carlos would maintain an EMS battalion chief.

Wackenhut, the for profit business that had a sent in a bid to the city just before the April 1 deadline - offers businesses and governments an array of services, including EMS and fire. Not surprisingly, the company had presented some "not completely accurate" details in their presentation.

### **PA GOV SAYS NO TO RESIDENTIAL FIRE SPRINKLERS**

Yesterday Gov. Tom Corbett signed House Bill 377, which **repeals** the mandate to require fire sprinkler systems in new homes. Gov. Corbett stated that this legislation is a "common sense" measure and will save Pennsylvania's working families thousands of dollars. He commented "whether or not new homes are equipped with fire sprinklers should be a decision left to individual consumers and not the government." The saddest part of the story is that the PA Fire Service did everything right. They encouraged the new codes, they went to the builder's meetings, they won the votes, they pitched it to the people, and then they got cut off at the knees by money and politics.

Two veteran Valentine (Nebraska) Volunteer Firefighters were burned while operating at a wild fire near Thedford. FF's JD Osburn and Warren Rockwell were on the back of a Valentine rural fire fighting rig when the truck was trapped by the 50 mph wind blown flames. Both men were wearing

their complete wildland fire gear which helped to protect them. They were checked out by EMS on the scene and transported back to the Valentine Firehall on the apparatus. After arriving in Valentine, both men were taken to the Cherry County Hospital for assessment. Warren Rockwell was transferred to the Saint Elizabeth Burn Unit in Lincoln for further assessment. JD Osburn was held for observation at the Cherry County Hospital. Several hundred fire fighters from across central Nebraska were called to that large grass fire west of Thedford. Over 25 departments were involved including an aircraft that helped bring the fire under control about 1800 Friday evening. The fire is believed to have started on the Mike Finney place about 9 miles west of Thedford. Fueled by wind gusts of 50 mph, the blaze raced for about 7.5 miles before it was finally contained about 1.5 miles west of Thedford. An estimated 11,000 acres were burned. The cause of the fire is not know at this time and this occurred last Friday. We wish them a rapid recovery.

Hey,

While there are numerous horrific stories of how this week's weather has devastated the south, including it impacting numerous Firefighters and departments, **this story is absolutely amazing.** While responding on a run before a tornado approached his community, the Fire Chief of the Shoal Creek (Alabama) VFD, was actually picked up by the tornado, flipped around several times and dropped upside down in the Coosa River! While the apparatus was upside down in the river, Fire Chief Vernon White amazingly managed to unbuckle his seat belt, get out of the truck through a broken window and swim to safety.

According to the Chief: "When I got to the end of the road, I saw the tornado coming--- I turned left and tried to outrun it. I got a quarter-of-a-mile down the road and the tornado hit me. It picked my truck up, turned it around and around. "I don't know how many times I rolled and rolled and rolled on the ground. I ended up in the river." Chief White said the tornado picked the truck up he knows at least one time and they made a complete circle one time before being dropped in the river. Chief White estimates the tornado took him and the vehicle 100 to 150 yards before it landed in the water. "When the tornado first hit the truck, I grabbed hold of the steering wheel and laid down in the seat," White said. "The force of the wind blew all of the windows out of the truck. I remember being upside down in the water. I had to hold my breath maybe 30 to 45 seconds as I unbuckled my seatbelt and went out the driver's side window to get out of and swim to safety." The only injury White sustained was a black eye and he did say he was real sore after all the tumbling. "I am thankful to God I survived," he said.

The patient's father said his son had also climbed onto the rooftops of neighbors that morning and that's why his wife called police. That'll do it every time. APD cops finally gained control of the patient. However, both Albuquerque PD and Albuquerque FD crews still recommended that Albuquerque Ambulance Service staff restrain the patient before taking him to the hospital **BUT the Albuquerque Ambulance crew decided not to.** "At the time of transport he was cooperative so the restraints were not used," an EMS spokesperson said. "We would rather not restrain people if they're being calm and cooperative." **TIP OF THE DAY:** If a patient is acting irrational, is found climbing amongst the neighborhood rooftops and the cops have to take him to get him to calm down, consider having the cops restrain the patient and if EMS must transport the patient, do it **WITH** a cop in the back. #### **FIREFIGHTER CLOSE CALL: Firefighters Exposed To Mercury**

A small fire at a Perkasio (PA) area manufacturing plant yesterday turned into a hazmat incident after firefighters were exposed to an unknown amount of mercury in the building. The Bucks County's Hazmat Team responded to the incident at PSG Controls and set up decontamination showers for the firefighters. 8 fire departments, EMS and about 125 firefighters responded to the scene and most had entered the building. 45 firefighters, who were the closest to the mercury, were taken to area hospitals to have blood drawn and to be evaluated. Perkasio Fire Chief Dave Worthington directed the precautionary move.

**TIP:** Metallic mercury is the liquid substance used in thermostats, thermometers and some batteries and electrical switches. At room temperature, metallic mercury will evaporate and form odorless mercury vapors, according to the Agency for Toxic Substances & Disease Registry, part of the U.S. Department of Health and Human Services. When the temperature rises, more vapors are released from liquid metallic mercury. Breathing these vapors can leave a metallic taste in your mouth. According to the ATSDR, exposure to very high levels of metallic mercury vapors can cause brain, kidney, and lung damage, as well as coughing, chest pains, nausea, and skin and eye irritation. Prolonged exposure to lower levels of metallic mercury vapors can cause irritability, tremors, changes in vision, memory problems, and other issues.

Los Angeles City is looking at closing **18 fire companies and 4 ambulances.** Other cities are doing similar things. In some of those cities, the citizens are fighting back. I don't care where you are, 18 fire companies and 4 ambulances being cut WILL impact those who dial 9-1-1. Currently, the LA City FD temporarily closes 22 fire companies and 6 ambulances in order to save money. LA City FD determines which companies should go with the help of a computer program that measures which companies were most in demand. A volunteer Firefighter died at his home in central France as a result of carbon monoxide poisoning. The construction worker (an immigrant from Ireland), who also volunteered with the local fire company, was found lifeless in his living room by his own colleagues. They believe 21-year-old Jamie Henry started cooking on Tuesday night when he came home but changed his mind and went to bed without turning off the gas stove. They think that he put oil into a pan to fry some chips and that it evaporated when he forgot to switch the cooker off. The pan then "carbonized" and started releasing carbon monoxide that killed the young man and his dog Daisy. His colleagues were so distraught that a second fire brigade from a different town took over the incident. Our condolences.

The fire was reported at 1655 hours yesterday and Kendall Park FF's arrived with unit filled with smoke. Firefighters made entry into the residence and found a fire in the bathroom area of the home and it was knocked in about 10 minutes. After the fire, South Brunswick Fire Marshals began to investigate the cause of the fire and they reported having a burning sensation in their eyes and were feeling lightheaded. In addition to the two marshals, 5 firefighters from the Kendall Park Fire Department and one firefighter from the Kingston Fire Company complained of similar problems. All were treated and transported and an investigation is underway to determine what caused their illness. While the cause has **NOT** yet been determined, this is a REMINDER for FF's and Investigators of the importance of air monitoring, SCBA or related protection-during and after an incident....for both short term, and long term protection, on any related run. We wish the members a rapid recovery.

#### **APPARATUS STRUCK ON I-70 IN MISSOURI-CIVILIAN CRITICAL**

A civilian had surgery this morning after he drove into the back of an engine company that was parked in the right lane of Interstate 70, on a run. The 42 year old motorist suffered two broken legs and other serious injuries. He was trapped in his car for about 20 minutes until FF's could cut the car apart. Firefighters were delayed in freeing him because the tools they needed to pry his car apart were in the back of the apparatus that was smashed in, but also used a saw to get to the tools. The crash happened at about 0430 hours this morning on westbound Interstate 70. The engine and an ambulance from the St. Charles FD had parked there to help an asthma patient. The asthma patient had forgotten his inhaler and was driving home to get it when he pulled over on I-70 and called for help. There was no shoulder in that section of the roadway. so the engine and ambulance ended up parking in the right traffic lane with their warning lights on.

The members had loaded the asthma patient and were caring for him. The driver of apparatus said he got out and walked up to the ambulance, he had a "bad feeling" and said they should probably hurry and leave, SCFD Captain Dan Casey said. "We're very nervous on the highway." Within about 10 seconds, Casey said, the car slammed into the back of the engine. "There were no skid marks," Casey said. "I'm sure he was going full speed, highway speed." The front part of the car went underneath the bumper of the fire truck. The driver of the car was trapped underneath the dash. Both of his legs were broken, and he suffered other injuries as well. None of the 3 Firefighters on the truck, nor the two EMT's on the ambulance, were hurt. Because of the damage sustained in the crash, the fire truck will be out of service for a while.

#### **NEW MEXICO FIRE CHIEF ARRESTED FOR DUI**

A Doña Ana County Fire Chief charged with aggravated drunken driving allegedly had a nearly empty bottle of whiskey in the government truck he was driving last week. Garfield Fire Chief Henry E. Duran, 52, pleaded not guilty to the drunken driving charge, as well as charges of failing to maintain his lane and having an open container in the vehicle. Garfield has a volunteer FD of about 20 members, who use county vehicles to serve their area. The white Ford Super Duty truck, with a New Mexico government license plate, was spotted speeding and then Chief Duran allegedly nearly struck the curb, then crossed the center line and white side line of U.S. 70 before nearly colliding with a concrete barrier at the intersection of Mescalero Trail and U.S. 70. An "overwhelming odor of alcohol" was reported when Chavez stopped Duran in front of the Holiday Inn Express, according to the criminal complaint. Inside the vehicle, Chavez reported finding a nearly empty bottle of booze. His blood-alcohol level was subsequently revealed to be .19 and .18, more than twice the legal limit of .08.

#### **2 FIRE CAPATINS KILLED:**

We take time to remember the 2 St. Louis (MO) Fire Captains who were killed in the Line of Duty on this date in 2002 at the Gravois Refrigeration Company. Captain Derek Martin and Captain Rob Morrison entered the structure looking for a fellow firefighter who had reportedly become disoriented. The firefighter, who was missing, was later found alive. When the two were finally found, neither had a heartbeat. Both were transported where they were later pronounced dead. Captains Martin and Morrison were 11 year veterans of the department and members of Rescue Squad 1. Both were married. Martin was a father of three and Morrison a father of two. RIP

In what turned out to be a controversial fire service death causing many FD's to revisit their "Junior Firefighter" programs and procedures, Christopher Kangas, a 14 year old Junior Firefighter with Brookhaven Volunteer Fire Company was struck and killed on this date in 2002. He was struck by a car while bicycling to the fire station in response to a fire call. In the period following his death, the Commonwealth of Pennsylvania recognized Jr FF Kangas as a Firefighter, and also recognized that his death occurred while in the Line of Duty. Although recognized by the State, the Federal government ruled that Jr FF Kangas did not meet the criteria to be recognized as a firefighter. RIP

**Budget Related Items:**

The Reno (NV) City Council on Friday reviewed a "hunky-dory" version of its next budget that assumes employee unions agree to cut their wages by 7.5 percent and no new layoffs will be required -- but city departments will remain stretched, and four firefighters whose jobs were temporarily saved by concessions will be lost. But on Monday, council members will be presented with a second, grimmer budget that assumes unions do not make concessions, resulting in layoffs and even more services being affected, including the closure of a fire station, to reduce expenses by \$7.4 million to balance the budget. Fire Chief Michael Hernandez offered the only clue Friday as to what more cutbacks would bring: He said another fire station would be closed, making the sixth fire or ladder truck company eliminated since the recession began three years ago. Fire employees total 257, down from 386 two year ago and down from 340 in July 2000 when Reno Fire took over operations for the Truckee Meadows fire district. Nevada Legislators approved a bill that would reduce local governments' obligation to cover heart and lung medical bills for future police and firefighter retirees, squeezing the measure in ahead of a legislative deadline for bills to clear committee. Senate Bill 135 cleared the Senate Committee on Commerce, Labor and Energy by unanimous vote Friday afternoon after a last minute rush to put together an amendment that enabled a firefighter union official and the leader of a taxpayer watchdog group to warily endorse it:

For years now, four out of every five 911 calls to the Los Angeles Fire Department have been for medical assistance, not burning houses. Yet, the department's staffing and deployment model still reflected the old emphasis on fire suppression. No more. With the aid of computer modeling software, Fire Chief Millage Peaks' team analyzed three years of 911 calls and came up with a plan that reflects the reality of L.A. today. His redeployment beefs up medical response, trims fire resources and cuts staff to save \$54 million this coming year. It won't be an easy sell. Nobody wants to hear that the city is cutting fire engines or shrinking the size of the fire force. But, Peaks said, the alternative is just as bad. Since 2008, the department's budget has shrunk by about \$100 million and the LAFD hasn't hired a single firefighter. Peaks' redeployment plan will permanently and selectively close fire companies based on the computer modeling data. He'll reduce the number of staffed fire engines in areas where demand is low, and increase medical response in areas where demand is high. Omaha's (NE) Fire Chief is sounding off on the battle between the department's union and the city regarding safety versus cost. In a 30-minute interview Wednesday with KETV NewsWatch 7's Ryan Luby, Chief Mike McDonnell discussed firefighter response times, how budget cuts have affected his department, and what else could or should be cut. "It's a balancing act," said McDonnell. "We have some city councilmen, we have some people from the business community, some people from the chamber that have very unrealistic ideas on how much it costs to run a fire department." "I don't think that is an accurate statement the Chief made," responded Councilwoman Jean Stothert. Stothert said she wholeheartedly supports public safety, but said the fire department staff needs to find a balanced budget:

How do you avoid rolling closures of neighborhood fire stations and laying off 171 police officers to balance San Francisco's (CA) budget? Mayor Ed Lee has a straightforward answer: pension reform. "A third of that \$306 million deficit is due to our pension overruns," Lee said Thursday. "If we can solve that, I don't think we'd even be mentioning ... police layoffs or brownouts" at fire stations. When you call 911 in San Diego (CA), a city fire truck is likely to arrive. It will come with several EMT's and at least one paramedic. About 80 percent of calls the fire department responds to are medical. Councilman Carl DeMaio said that makes the work of the firefighters comparable to EMT's and paramedics with private ambulance companies. "When you look at it from that lens, we are seeing very clearly that there is a significantly higher salary and benefit package in the city of San Diego for the same work that's done in the private sector," he said. An analysis requested by DeMaio and Councilwoman Lorie Zapf from the Independent Budget Analyst shows in some cases city firefighters are paid 325 percent more than private employees when you consider their benefits package. After two hours of at times emotional debate, the San Carlos City Council late Monday unanimously voted to seek a partnership with Redwood City for its fire protection and rejected a plan to outsource the service. Officials said they would attempt to reach an agreement with nearby Redwood City to form a joint fire department. However, they added that if those efforts failed, outsourcing would once again be on the table. San Carlos city leaders say the cost of fire services is up 30% over the last five years. Now the city is facing a \$3.5 million budget deficit on Monday night, the city council discussed the controversial idea of hiring a private company -- Florida based Wackenhut Corporation -- as its new fire department: <http://www.ktvu.com/news/27669922/detail.html>

Saying they don't anticipate revenues going up much, if at all, Los Angeles (CA) city officials plan on cutting \$300 million out of next year's budget. And the fire department is one of those agencies facing cuts. The union is fighting a plan that would close 18 fire companies and four ambulance teams. The move would save the city nearly \$200 million over three years. Currently the LAFD temporarily closes 22 fire companies and six ambulance teams each day on a rotating basis. Fire Chief Millage Peaks has called that system "disruptive" and is now seeking a more permanent solution that would eliminate the "rolling" service reductions. Come October, fire service in the city of Belmont (CA) will be provided by its own stand-alone department as talks to save the Belmont-San Carlos Fire Department have officially failed. Monday night, the San Carlos City Council voted to pursue a partnership with Redwood City on a hybrid fire department and last night, Belmont's legal counsel said it was no longer a possibility to mend the two city's fractured relationship. The critical next step for Belmont is developing a design for the new organization, said City Manager Greg Scoles. Previous estimates on establishing a stand-alone fire department, though, have indicated Belmont does not quite generate enough money through an annual assessment to support a new department. City staff will be working over the next month to try to bring costs closer to available revenue and will present the council with a more detailed analysis on command structure, work schedules, shared services and labor cost in May:

San Carlos (CA) City Council members unanimously voted to negotiate a contract for fire services with Redwood City, but they left open the option of going with a private company if the deal falls through. Councilors, facing an "anxious and apprehensive" crowd opposing a contract with the private company Wackenhut Services, decided in favor of the Redwood City deal by a 5-0 vote at Monday's meeting, city officials said. Under the proposed contract, Redwood City would provide administrative duties, fire prevention, and battalion-chief coverage and supervision to San Carlos, Redwood City fire Chief Jim Skinner said. Later, San Carlos would hire its own working staff to fill vacant positions at its two fire stations. The move, which in recent months evolved from a proposed merger to more of a hybrid model, could save Redwood City about \$1 million to \$1.5 million annually and San Carlos about \$1.7 million, officials said.:

Wildwood (NJ) City commissioners voted unanimously to approve the city's \$23.5 million budget and accompanying \$1.089 tax rate, despite hundreds of people filling the Wildwood High School auditorium Wednesday night to oppose the plan, which includes layoffs among the police, fire, support staff and public works employees. The fallout from San Jose's (CA) \$115.2 million budget hole came into sharper focus Monday when City Manager Debra Figone proposed a 2011-12 budget that slashes staff to its lowest level in 25 years. Figone's budget would slash police and firefighter services, library and community center hours, extend or add new park fees and significantly cut back on park rangers and employees who enforce city codes. City leaders promise it will only get worse if all 11 employee unions don't agree to 10 percent ongoing compensation cuts. Two of the unions also must agree to give up raises they received last year. Even if all the unions agree to the concessions, the numbers are grim. Of the 588 positions that could be cut, 370 employees could be subject to actual layoffs. Benicia (CA) is considering a plan to layoff its fire chief to help close a \$1.7 million deficit. Eliminating the fire chief position would save the city more than \$284,000. The elimination would be part of a larger plan to merge both the police and fire departments into one public safety department. If Benicia doesn't merge the two departments the city may be forced to make other cuts, which could include the elimination of two firefighter positions, a police night lieutenant position or a police investigations sergeant:

Battle lines sharpened Thursday over California's public pensions with the release of a new report that concludes pay and benefit packages for public workers are better than those for their counterparts in the private sector. Commissioned by pension overhaul advocates poised to seek changes, the report drew immediate fire from public employee unions, which have muscled up to fight the emerging pension wars. The two-part study, released by the California Foundation for Fiscal Responsibility, also cautions that public pension obligations threaten to crowd out money for public services. The foundation, headed by longtime pension change advocate Marcia Fritz, has proposed several pension cost-cutting ideas, including a cap on pension payouts, higher employee contributions and higher retiree health premiums. "The effect is on public safety for the entire city," Caynon said. "My members feel like they've been vilified by this administration." Caynon said the cuts could mean about 10 fire stations would close. Months ago, Mayor Annise Parker ordered the fire department to come up with \$17 million in cuts. The union says that's unreasonable. It's the number everyone dials in case of an emergency. But new internal documents obtained by the WDSU I-Team show that thousands of 911 calls are not being answered each month in New Orleans (LA). All day and throughout the night, the workers inside a building on City Park Avenue are busy. They're 911 call takers, the men and women responsible for dispatching police officers, firefighters and medical responders to emergencies in New Orleans. The report shows that last October, more than 38,000 people dialed 911 in New Orleans, but more than 5,000 of those calls were not answered. In December of last year, the report indicates more than 38,000 people called 911 for help. Almost 7,000 of those calls were not answered. That means almost 20 percent of all people who called 911 didn't get an answer. And one month later -- in January of this year -- more than 35,000 911 calls came in, and almost 5,500 went unanswered. That's more than 15 percent of all calls. The reason for the disconnect is staffing. Despite the fact that some calls are sent to the New Orleans Fire Department and EMS, all original 911 calls that come into the call center building are answered by the New Orleans Police Department. Kapler says in the lawsuit that he was allowed to use the city pumps to fuel his personal vehicle through a verbal agreement with former City Manager Debra Kurita, who hired him in October 2007. He says he had an "exemplary" work history for more than 40 years and that he stepped down as chief to preserve his reputation when he learned that city officials were planning to fire him. He is seeking compensation for lost wages, emotional distress and other damages. Kapler says in the lawsuit that Councilmember Lena Tam conspired with the firefighters union and that his termination was "politically motivated."

Here's a surprising number: two out of every three firefighters in San Jose (CA) retire on disability. Now a just released city audit says that high number should be questioned. The tax laws favor disability benefits versus retirement benefits, but the city auditors said that really doesn't explain what's going on in San Jose. San Jose firefighters don't dispute that a significant number of them leave the job on permanent disability. "Firefighting is a dangerous, strenuous job and over a career of service, it definitely takes its toll on your body," said Jeff Welch from the San Jose Firefighters Union. A 34-page report by the city auditor though said the numbers don't add up. That report was presented on Thursday to San Jose's Public Safety, Finance & Strategic Support Committee. "We can't ignore the numbers that we have people who are retiring out at a disability rate far greater than any of our peer cities," said Pete Constant, the Public Safety Committee chair. The audit said 67 percent of San Jose firefighters retire with a service related disability; 41 percent of San Jose police officers retire on disability. That compares to an average of 37 percent of sworn employees in Oakland and a 40 percent figure statewide. San Jose City Auditor Sharon Erickson said the number of workers' compensation claims also raises some questions:

San Bernardino County's (CA) firefighters will accept pension cuts and smaller raises in an effort to help preserve public services and balance the county's budget. San Bernardino County Professional Firefighters, Local 935, which consists of the county's 344 firefighters, fire captains and fire engineers, voted 98 percent in favor of accepting a reduction in benefits when their contract goes into effect July 2 – something that would save the county approximately \$2.14 million annually. "County firefighters are hyper-aware of the economic climate out there," Bret Henry, president of the San Bernardino County Professional Firefighters, Local 935, said in a San Bernardino County Sun article. "We're living through the hard times as well. We're interested in a balanced budget as much as everybody else." The concessions would involve a 7 percent salary reduction through a reduced retirement pickup, a 50 percent reduction in salary step increases from 5 percent to 2.5 percent and a capped medical subsidy that would no longer apply toward retirement calculations:

In a county where health-care coverage is unaffordable for more than 200,000 residents, Alameda County (CA) health officials are undertaking a project that could bring basic health care services as close as your local fire station. In an effort to get primary and preventive care to those who most need it and to cut down on expensive emergency room visits, the Alameda County Health Care Services is attempting to launch a unique pilot program in which fire stations serve as a type of health clinic. "When people get primary care, things go great. We know that," said Alex Briscoe, director of the county's health care services. "The problem is, there is a huge supply and demand disconnect on preventive and primary care in our community." The idea got a boost last week when the county's board of supervisors allocated \$750,000 for the proposed project — which in its basic outline would staff fire stations with three people — including a paramedic and medical or drug practitioner — to help residents who do not have health care deal with simple health issues like vaccinations, prescriptions or sinus infections. Briscoe said, in theory, such a program could save millions of dollars in unnecessary emergency room visits and paramedic response services. Sharing Tubbs on a 50-50 basis -- including his \$266,000 salary and benefits package -- saves the two cities the cost of a full-time chief. For at least the next year, which is the length of the pilot program, Tubbs will maintain a calendar in Piedmont, one in Albany and one at home in Danville. What's more, the calendars are on paper, which can make synchronizing them even more difficult. But Tubbs is taking his divided duties in stride, attending community gatherings in both cities to put a new face on the fire service while also getting a lay of the land. Tubbs works in Albany

on Mondays and Thursdays, in Piedmont on Wednesdays and Fridays and splits his time between the two cities on Tuesdays. Besides multiple calendars, he also has two email accounts and two phone numbers with voice mail to monitor:

Saying Reno (NV) and Washoe County officials are on the eve of deciding whether to merge fire services, their elected officials voted Monday not to adopt regional fire response standards contained in a new study. The fire study sets response-time goals for the urban, suburban and rural areas of the county that would require building five new fire stations and relocating two others stations. It also said two minutes could be cut from response times by changing dispatch procedures and improving the time it takes for firefighters to get out of the station and on the road. But the long-term plan comes at a time when Reno has idled equipment at five its 13 fire stations and the surrounding Sierra and Truckee Meadows fire districts overseen by the county also are looking at cutbacks because of declining property taxes. "We can't afford to have a fire department," Reno Mayor Bob Cashell. He proposed the city contract for fire service with Sparks, where he said the fire chief has more control of the department. Its chief has cut its fire crew size to three members to deal with the recession:

Cresskill (NJ) Police Officer Brad Levitzki used a switchblade knife to remove Dumont Fire Department emblems from a shirt worn by a Cresskill firefighter and essentially assaulted him, according to arguments made by a prosecutor. Levitzki's attorney said that the officer was horsing around with firefighter Bryan Hakim and that witnesses laughed because they considered it a joke. A nine-year veteran of the force, Levitzki faces six charges related to violating borough policies and Police Department rules and regulations tied to three incidents in which he was on duty, according to William R. Lundsten, the attorney prosecuting the case. The patrolman has been suspended without pay since October:
