Location: Alameda County, California

A properly completed Supplemental Questionnaire must be submitted with each application. Applications and Supplemental Questionnaires must be in the possession of the Human Resource Services Department by 4:30 p.m. on the Last Day for Filing. Postmarks and faxes are not accepted. Failure to submit the Supplemental Questionnaire will result in disqualification.

**Applicants must also submit a copy of the CPAT certificate to the Human Resource Services Department by the last day of filing. Failure to submit this information will result in disqualification.**

The Alameda County Fire Department is actively recruiting for the position of Firefighter/EMT and Firefighter/Paramedic. The Department serves the unincorporated areas of Alameda County, the City of San Leandro, the City of Dublin and the Lawrence Berkeley National Laboratory. The area comprises approximately 500 square miles and serves a population of 234,500. The Fire Department has a budget in excess of \$60 million with a staff of 265 firefighting personnel and 19 fire stations.

#### **Minimum Qualifications:**

The following are entrance requirements for admission to the examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. A candidate's performance in the examination will be judged in comparison with the performance of other candidates.

EDUCATION: Graduation from high school or possession of an acceptable equivalency certificate, such as the General Educational Development Certificate (State of California), AND

Applicants must meet at least one of the following requirements:

- Must be a paid Firefighter/EMT or Firefighter/Paramedic in a Fire Department (Seasonal employment is eligible); OR
- Current member of the Alameda County Fire Department Reserve program; OR
- A current member of a Reserve Program that is supported by a professional City or County Fire Department or Fire District.
- Must be a nationally registered paramedic.

LICENSE: Possession of a valid California Motor Vehicle Operator's license, possession of a Candidate Physical Ability Test (CPAT) certificate issued within the last twelve months from the last day of filing, and possession of a current and valid California Emergency Medical Technician-1 (EMT-1) certificate or Certified by the National Registry of Emergency Medical Technicians, Emergency Medical Technician – Basic.

SPECIAL REQUIREMENTS: Applicants must have visual acuity correctable to 20/30 in either eye. Job offer will be contingent upon passing a physical ability and medical examination, a thorough background investigation and a psychological evaluation.

AGE: Applicants must be a minimum of 18 years of age.

#### **Examination Components:**

THIS IS A NEW OPEN ASSEMBLED EXAMINATION. The eligible list resulting from this selection process will last approximately one year but may be extended as needed. **This eligible list may also be used by other fire departments within Alameda County. This examination may be reopened as necessary and the names of additional candidates merged onto the existing list according to examination score.**

THE EXAMINATION WILL CONSIST OF the following components: A review of candidates' applications to verify possession of minimum requirements. Those candidates who possess the minimum requirements for the class will move on to the next step in the examination process, a screening of applications and/or supplemental questionnaires to select for the best qualified candidates. Those selected will move onto the final step in the examination process, an oral interview, which will be weighted as 100% of the candidate's final exam score. The oral interview may contain situational exercises.

## ***THE COMMUNITY***

The City of Redding, a dynamic community, is located at the north end of the Sacramento Valley, 150 miles north of Sacramento. Redding has a superb climate with moderate springs and falls, sunny summers with low humidity and mild winters. Warm weather signals the start of after-work and weekend trips to the local lakes, Shasta and Whiskeytown, as well as the Sacramento River. Snow decorates nearby Mt. Shasta and Mt. Lassen year-round. Snow skiing, sledding and other winter sports are abundant within a short drive. A thirteen-mile trail along the Sacramento River, the Sundial Bridge, numerous community parks, a world-class museum and arboretum complex, and continuous community events provide for a healthy environment in which to live and work. Redding is truly a fabulous location for those interested in an active outdoor lifestyle.

The community offers an impressive complement of housing in all areas and housing types: riverfront, mountain view, country acreage, and traditional subdivision, with median home price still below the statewide average. Redding is an excellent place to live, work, and raise children. Educational opportunities abound in the highly regarded public schools and through the many schools of higher learning, such as, Shasta Community College, Simpson University and National University. Also, Chico State University is located just 70 miles south of Redding and offers extension courses in Redding. In addition, a wide variety of cultural and community activities support a great quality.

## ***THE ORGANIZATION***

The Redding Fire Department is a progressive organization committed to serving the citizens of Redding. The Department does so through the use of state of the art equipment, constant training, public education, and community involvement.

Redding Fire Department protects 70 square miles with a population of nearly 100,000 residents. Under the direction of Fire Chief Duane Fry, the Redding Fire Department responds, from eight fire stations strategically located throughout the City, to approximately 12,000 calls for service each year. Of the 91 uniformed personnel, 25 are assigned to each of the three alternating shifts. The three platoon shift is comprised of a 4-4-4-6 schedule rotation. The Department's Operations Division responds to hostile fires in structures, vehicles, and wildland; provides emergency medical services; participates in Shasta Cascade Hazardous Materials Response Team; has its own 30-person water rescue team; and is responsible for natural or manmade disaster mitigation.

## ***ABOUT THE POSITION***

The City of Redding is establishing an eligibility list for future Firefighter vacancies and is seeking highly motivated persons who will demonstrate their commitment to the community by continuing the Department's emphasis on excellent customer service and a "can do" attitude. The ideal candidate will be a positive person who values teamwork and cooperation within the organization while continuously looking for opportunities to enhance and improve the Department.

## ***DUTIES PERFORMED***

Incumbents of the Firefighter classification perform all types of fire suppression, prevention, and emergency medical rescue work and promote fire prevention and code enforcement. The

Firefighter is expected to perform the full range of fire suppression, safety and prevention duties assigned to the class and to learn journey-level skills in all areas of work assigned.

Including these listed:

- Respond to reported emergencies with a company on a fire apparatus.
- Rescue persons endangered by fire and other hazards.
- Operate hose streams; perform ventilation, salvage and overhaul to extinguish fires and minimize damage.
- Perform first aid, resuscitation, and defibrillation.
- Operate firefighting equipment and medical rescue equipment.
- Inspect housing, industrial and commercial occupancies, write notices of hazards and make re-inspections; conduct home safety checks.
- Present fire and life safety education programs; conduct tours of the fire station.
- Participate in firefighting tactics and physical training.
- Keep records and prepares reports.
- Participate in pre-fire planning with the company.
- Maintain fire station.
- Perform daily, weekly and monthly apparatus and equipment checks.
- Perform related duties as assigned.

### **QUALIFICATIONS**

Knowledge of: Modern fire prevention and suppression principles, methods and equipment; principles of hydraulics as applied to firefighting equipment; construction and operation of private and public water supplies, standpipes, fire pumps, aerial ladders, elevating platforms; all City and outlying streets and the location of fire hydrants and fire department connections in the district; Federal, State and local vehicle safety regulations.

Ability to: Interact effectively with the public and employees; remain composed during emergency conditions; pass the medical examination, including vision and hearing examinations, and perform the required physical fitness tests for the position; maintain effective working relationships with fellow employees and the public.

Education & Experience: Any combination of training and experience that provides the required knowledge, skills, and abilities is qualifying; typical education would include a high school diploma, equivalent of A.A. Degree in Fire Technology, or 60 semester units from an accredited college or equivalent. No prior experience required.

Special Requirements: Satisfactory completion of California State Certified Firefighter I and either Emergency Medical Technician I or First Responder. **Copies of Firefighter I as issued by California State Fire Marshal, EMT and/or First Responder certificates and college diploma or transcripts must be submitted with application.** Possession of a California Class B drivers license, or the ability to acquire one by the end of the probationary period if hired.

To obtain this credit, veterans must provide a copy of the DD214, indicating honorable discharge with each employment application before the closing date.

Final Filing Date: 4 p.m., November 1, 2007.

Interested individuals must submit a City of Redding employment application and required attachments, as outlined under "Special Requirements" above, to the Personnel Department by 4:00 p.m. on the closing date in order to be considered. Postmarks may not be accepted. Applications received after the closing date may be rejected. NOTE: Incomplete applications may not be processed. Meeting the announced requirements does not guarantee selection into the examination process. Candidates considered well-qualified based on information provided will be invited to participate in an interview process to further assess qualifications.

### **TEST REQUIREMENTS**

The examination process will consist of a written examination to be held November 17, 2007 and an Assessment Center to be held November 29 & 30, 2007 (dates may be subject to change). Candidates must pass the City of Redding Fire Department physical agility test before they are eligible for hire. CPAT certification may be accepted in lieu of the City's physical agility test. If a background investigation is conducted, the CPAT certificate will be required at that time and must not be more than one (1) year old at the time of submittal.

Comprehensive background investigations are conducted on finalists. Final selection from the list of qualified candidates will be made by the Fire Chief.

## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

**T**he Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter. Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas.

### ***Basic Information For The CPAT Test***

#### **QUALIFICATIONS:**

Applicants must be 18 years of age and must show government issued photo identification (i.e. drivers license, school or military ID; or a passport or visa). Candidates without a photo ID will not be allowed to take the CPAT.

#### **APPLY EARLY**

Applications are accepted in the order they are received. Applications are not accepted until the fee has been paid.

#### **PAYMENT:**

The fee to take your first test at their site is \$150.00. Your fee must be paid for your application to be accepted. This fee is non-refundable. Payment can be made with check, money order, Visa, or MasterCard. If you are paying by check, the check must clear your bank before you can take the CPAT. Make payments to "CFFJAC." Your fee includes participation in an orientation session, related printed materials and test.

### **ORIENTATION SESSION:**

Working with experienced CPAT proctors, you will be given the opportunity to try each of the 8 events and determine where you may need to strengthen yourself. You will be given a set of exercises to physically prepare yourself for the CPAT. If you elect not to participate in the orientation, you will be required to sign a waiver acknowledging that the orientation was offered. There are no discounts if you elect not to participate in an orientation. The CPAT dress code is enforced for all candidates who attend an orientation.

### **TEST:**

The registration form has a place for you to choose a preferred and second orientation day as well as a preferred and second test day. ### **The IAFC and the USFA Develop Report on Effects of Sleep Deprivation on Firefighters and EMS Responders**

**Fairfax, Va., Sept. 24, 2007...** The International Association of Fire Chiefs (IAFC) and the U.S. Fire Administration (USFA) announce the release of *The Effects of Sleep Deprivation on Fire Fighters and EMS Responders*. This new report is based on a comprehensive literature review of fatigue and sleep deprivation in other industries (primarily the transportation and medical fields) and features applications to the fire and emergency services as appropriate, along with useful mitigation strategies. A resource section is included.

“This is an in-depth culmination of available sleep-deprivation research that, if taken seriously, should keep the fire chief awake at night,” said IAFC President Chief Steven P. Westermann. “The research can apply to any busy station, volunteer or career, with any of the traditional schedules, not just the newer 48/96 schedule. The report ends by providing several recommendations, not the least of which is how to spot sleep deprivation.”

This program is a result of a partnership between the IAFC and USFA, with assistance from the faculty of Oregon Health & Science University. In addition to the report, a self-guided, computer-based training program has been developed.

“We were pleased to work closely with the IAFC on this initiative,” said Chief Gregory B. Cade, U.S. Fire Administrator. “We have long known the stresses long-term operations place on all firefighters. The impact of sleep deprivation is an important issue to the health and safety impacts on members of the fire service and the residents they protect.”

Incident Description: A tractor trailer rig took a wrong turn and had to turn around because a bridge was closed for construction. When turning around, the rig struck a utility pole causing a live wire to fall and spark a grass fire near houses. While battling the wind-whipped grass fire, Lieutenant Johnson came in contact with the live wire and was severely shocked. Lieutenant Johnson was taken by air ambulance in critical condition to Via Christi Regional Medical Center-St Francis Campus where he passed away within an hour.

Today the FDNY relieved and reassigned 3 Fire Officers and ordered inspections of buildings under demolition after last weeks double LODD fire. They also state that a preliminary investigation indicated that careless smoking by construction workers started the fire that lead to the deaths of 2 FF's. Officials said smoking was rampant in the structure. Someone on site should have thought that was a problem.

The FDNY Commissioner has now ordered all Deputy Chiefs to inspect every building in their divisions that are under construction or demolition & review all plans for fire operations at every building in their area. The Commissioner also reassigned a Deputy Chief, a Battalion Chief and a Captain to headquarters after being relieved of their commands. Word is that the reassigned Deputy Chief had received a memo more than two years earlier that included recommendations for how to fight a fire in that contaminated hi-rise. It recommended that if they had a fire, an officer and two firefighters should go into the building to investigate and evaluate the situation. That's not what was done last weekend and Firefighters Robert Beddia, 53, and Joseph Graffagnino, 33, both died in the line of duty. What the media is not talking about-or at least we haven't read or heard it, is that there were radio reports of workers on the scaffolding upon arrival at the working fire....and that's a factor in light of all the others facts. (For more on this fire's IC-see below).

The Deutsche building has been empty since it was destroyed due to the collapse of the WTC on 9-11-01....essentially it was a hi-rise dumpster awaiting politicians and hi-dollar suits to decide what to do with it. And this wasn't the first time the building gave FDNY trouble. And then there was a fire-two FF's were killed-and now it becomes a high priority issue. Sadly, it takes a fire in a high visibility building killing 2 FF's to get the attention it should have had weeks, months and year! s ago by the suits, the politicians and the contractors-who all own a major part of this loss as well. And then there are the rest of us...how are our 1st due buildings? What's the plan? What if it was our fire? Hear the train?

Hey...  
Here is an update on last night's fire that tragically killed 2 Boston Firefighters and injuring others. Initially, there were reports of 2 other Firefighters on life support, but all surviving injured members are now reported to be non life threatening.

The Firefighters who gave their lives in the Line of Duty last night are Paul Cahill (55) and Warren Payne (53),

who were assigned at Engine 30 and Ladder 25. Numerous other Firefighters were transported with non-life-threatening injuries. Boston Fire Chief Kevin MacCurtain said several firefighters from the first due crew that arrived on scene entered the building to attack the fire. Civilians were all out of the building but the heavy smoke and fire conditions in the initial stages of operations caused the members to become disoriented. "When they arrived they had heavy fire in the Thai restaurant with heavy smoke conditions on the block," MacCurtain said. "They advanced their lines into the store, and they became trapped and they were disoriented and they couldn't find their way out." Chief MacCurtain also said that a 3-ton air conditioning unit partially crashed through the roof of the restaurant but that it was unclear what role this played in the firefighter deaths and injuries. He said the first crews of firefighters quickly became trapped and disoriented. Other crews found the trapped firefighters and pulled them out.

FF Payne was the father of two and FF Cahill was the married father of two. Both had 25 years on the job. Five Boston firefighters have died during or after fires since 1994. They include David Milton, who died earlier this year when he got home from a shift at a firehouse; David Packard, who died of a heart attack after a fire in 1999, Dick Murphy, died of a heart attack after a fire, also in 1999; James Ellis, who died from injuries after he fell down a fire pole when responding to a fire call in 1996 and Steve Minehan, who was killed in a warehouse fire in Charlestown (Boston) in 1994. Steve was killed following a search for other missing Firefighters in that fire.

We are closely monitoring the conditions of the 2 Firefighters who are in critically condition and will update as applicable here and on our home page. Our deepest sympathies go out to all effected but especially the Payne and Cahill families and the members of the BFD E-30/L-25.

5 of the 7 surviving Firefighters have life threatening injuries with very severe burns covering 85-90 percent of their bodies. Croatia has battled a huge number wildland fires this summer. There was also another LODD recorded this week-where a Firefighter there died Wednesday following fire operations on another island.

**UPDATE: The Deutsche Bank DOUBLE FDNY LODD Fire.** In today's NY Times, veteran Firefighter Dennis Smith provides commentary on the Deutsche Bank fire. He writes about how the horrible loss of 2 FDNY Firefighters won't be alleviated by an arbitrary transfer and public humiliation of three Fire Officers. If Deputy Chief Richard Fuerch, Battalion Chief John McDonald and Captain Peter Bosco did something wrong, Dennis pushes the issue that they should be tried in a court of law and given the same rights as anyone else in the United States.

The Line of Duty deaths of FF's Joseph Graffagnino and Robert Beddia, yet to be explained, were followed 6 days later by serious injuries to FF's William Carbettis and Neil Nally when a power tool fell 23 stories and collapsed a shed on top of them. Dennis reminds us that this building, effected by the greatest tragedy in the history of the United States continues to linger and cause death and destruction almost 6 years later!

2 FDNY Firefighters were killed but who ultimately is responsible? Dennis pushes the question of "who owns this horrible loss and who is really responsible? Please take a few moments to read Dennis's piece as he digs deeper into the real RESPONSIBILITY of that deadly fire.

A civilian who was helping a crash victim right near his home was killed yesterday when he was hit by a responding Firefighter in Wilmot Township. Ont, Canada near Waterloo.

Around 0800 hours, a 19-year-old teenager lost control of his car, swerved and hit a tree. The 53-year-old resident heard the crash as well as the Wilmot Township fire apparatus arriving at the scene, and he went out to help. According to the cops, speed was a factor in both crashes.

**FF STAFFING, CUTS & BROKEN AXLES**.....Recently, the Elyria (Ohio) FD (protecting 56,000+ citizens) staffing dropped from 17 firefighters to 14, (staffing 2 Engines and a Truck) resulting in one of the city's four firehouses being closed most of the time. The Mayor, Bill Grace said the reduction is necessary because of budget problems. The city made the same move for about 10 months a few years ago, from November 2004 until October 2005, Grace said. This time, however, Mayor Grace said, it could be permanent. At the very least, the staffing will be reduced for the remainder of this year and all of next year. The FD leadership and the members of IAFF Local 474 have busted their tails to do whatever it takes to turn this failure of funding around. Disturbingly, Mayor Grace said the city has had to make reductions in every department over the past several years and the fire department is no different.

**And THAT IS THE PROBLEM.** Cut parks-who suffers? Cut recreation-who suffers? ...But the Fire Department: **EVERYONE SUFFERS.**

And then, this morning, while RESPONDING TO A WORKING FIRE, it appears that an AXLE SPLIT (photos on our home page) on one of their fire apparatus. How is the fire apparatus maintenance budget? Who is impacted? Firefighters? Civilians? TRAPPED civilians? Are we being over dramatic? Depends on if it is YOUR house that is on fire or if you are riding that apparatus. When your City staffs 1 Ladder and 2 Engine Companies protecting nearly 60,000 people.....and THE ladder has this happen....are the end results predictable? DO THE MATH. Photos of the apparatus are posted on our home page.

If you recall, a while back, Bill Dedman's MSNBC did an in-depth report on the issues of FF LODD investigations as well as equipment failures. Since then, the Inspector General of the CDC (NIOSH) did an internal investigation to find out the facts. Bill's report made a significant difference in helping the fire service and NIOSH take the investigation of FF LODD's to the next level.

Additionally, during the same time period, the IAFC President and Board directed that a FIRE SERVICE report be done to determine what would be the best response to Firefighter Line of Duty Death investigations. The participants in the task force who developed the IAFC report (link below) represent the IAFF, the Volunteer Fire Service, the NFFF and some highly qualified fire service veterans who have 1st hand expertise in FF line of duty death issues and investigations. As Sen. John Kerry stated: "I thank the inspector general for conducting a thorough investigation...the IG found not a lack of willpower (by the folks at NIOSH), but a lack of resources. It's obvious that Congress needs to provide more funding to investigate firefighter deaths and clearly define what it expects from the CDC (NIOSH Fire Fighter Fatality Investigation and Prevention Program:

<http://www.cdc.gov/niosh/fire/> )This is very good news and support that must and will be followed up on by the Fire Service.

Interestingly but not surprisingly, BOTH reports lead to almost all of the same recommendations which is also EXCELLENT news for the American Fire Service.

FD FATAL VEHICLE CRASH: In Maryland yesterday, a civilian was tragically killed in a vehicle crash involving an SUV from the Hebron VFD who was responding to another accident. Firefighters from the Hebron VFD initially responded to a two-car accident with multiple people injured at the intersection of Route 50 and Route 670 around 1400. While responding to that crash, FF Steve Brown, driving a FD SUV struck another car, driven by a woman, who was killed. Investigators said they have not determined who was at fault and would not say how fast the HVFD's Explorer was traveling and whether it had its emergency lights and siren activated.  
FF FALLS OUT OF APPARATUS WHILE RESPONDING: At approximately 1500 hours yesterday, a volunteer firefighter was seriously injured while responding to a call in Kingston, Ontario, Canada. The firefighter was seated in the front passenger seat of a pumper and fell out while the apparatus was rounding a turn while responding to the incident. We regret to inform you that a Burlington, North Carolina Firefighter was killed Monday night. Anderson Township VFD Captain Michael Dean Stanfield had been on the scene of a motor vehicle accident call and was returning to the station when the motorcycle he was riding left the roadway, and crashed. He died while being transported to the hospital.

## UPDATE: FIREFIGHTER INJURED ON LONG ISLAND:

That Malverne FD Lieutenant was exiting the apparatus and had his back to the vehicle. The front, passenger side wheel grazed his right foot as it backed up. His foot was not fully run over, but it did cause a lot of pain, causing the Lt. to fall to the ground. Members in the area did not witness the actual accident, but saw the Lt. fall in extreme pain. Members assumed the Lt. was run over (rightfully so) and immediately ordered ALS and a medivac helicopter. After the initial assessment, it was discovered his injuries were not as serious and the medivac was canceled. He was transported, is in good condition but may need surgery for a broken toe. The driver of the apparatus is also in good condition, although obviously very shaken up. The MFD advised that internal reviews will be done and necessary changes to SOGs will be recommended.

## THE TRUTH HURTS

The Randolph (MASS) Board of Selectmen suspended their Fire Chief Monday evening for telling the truth...following comments he made at a fire in May that trapped and killed two boys.

Randolph Fire Chief Charles Foley truthfully said his staffing was short-handed, which didn't help their ability to effectively do search and rescue that night. He said if they had not been understaffed due to budget cuts, in part, they would have had more firefighters and the tragic outcome may have been prevented. "I can't promise you that there would have been a different outcome," Foley honestly said. "All I can tell you is the operation would have been enhanced by additional staffing."

The Board's "investigation" determined Chief Foley's comments were inappropriate, misleading and unprofessional. "These remarks were intentional and motivated to bring his staffing and budgetary issues to the public forefront through the media," said a selectman. We would bet the outcome and fate of Chief Foley was decided before the investigation was started...but that's just our opinion.

In March, residents rejected additional funding for the RFD. The executive secretary of the town's board of selectmen defended the current FD staffing, saying it is adequate. And of course, that depends.

As readers of The Secret List know, many communities have rejected tax increases designed to support the FD and increase staffing. Fire Chiefs who say their services will be affected, and that public safety could be compromised, are being honest and have an obligation to provide the facts.

It might be something like: with this much staffing we can do this, with that much staffing we can do that. Simple, plain and understandable language (and numbers) so everyone knows the truth. Forget the drama of what they see on TV...fire operations require specific numbers of firefighters for predictable success. Not always-but almost always. Our hats go off to Chief Foley for letting the public know the true fact. Like it or not-adequate and well trained STAFFING arriving quickly with qualified bosses CAN and HAS proven to make a big difference to those who call 9-1-1....and directly impacts Firefighters ability to survive.

When a community does NOT support the funding needed, then the FD simply cannot provide that unsupported but usually-still anticipated high levels of service. But yet when so many FD's do suffer staffing cuts...the FD goes on acting as if they CAN do the same job with less Firefighters....which isn't the case. When we act as if "we can still do it all, even! though they cut us" ...we are fooling the public and we are fooling ourselves. Eventually the numbers catchup when we aren't truthful.

For example: If you have a 1 story, w/f, SF dwelling fire that requires the proven and measurable services of 20 Firefighters...it CANNOT be done with less. Something has to suffer...either a little...or a lot....be it:

Water Supply.  
Pump Operations.  
Line Stretching.  
Command and Control.  
Venting.  
Forcible Entry.  
Search.  
Rescue.  
Patient Care.  
Safety.

These basic "house fire tasks" CANNOT be done as quick, as safely or as effectively when we do not have enough Firefighters responding to match the required tasks. Forget the emotions...this is all about numbers and these numbers are easily measured, proven and demonstrated.

But just like when FD's and Chiefs, such as Chief Foley, are told by budget cutting non-supporters and city hall dwellers that "it's just a matter of numbers" when those folks are talking to us about cutting budgets and funding....the same exact response applies back to them from those charged with trying to rescue kids out of a house: It's just a matter of true numbers. Numbers of Firefighters.

WE DO understand that not everything can be funded the way we would like. That's understandable. And sometimes there are other solutions such as true "mutual" aid, automatic aid and other supplements to staffing. Sometimes that will work-but sometimes it will not. So then, when budgets and funding are cut that directly and honestly relate to staffing and the FD's ability to deliver fire and life saving services, SOMEONE has to stand up. Someone must let the elected officials and those who elected them know what the FD CAN do...and what the FD simply CANNOT do, based upon the type of emergency reported. Someone must tell the truth.

Firefighters cannot "do it all" when the ! community and elected officials are not willing to support Firefighters "doing it all"....without the needed support and funding. And sometimes that truth hurts.

It appears that Fire Chief Leonard Bailey, 56, had a heart attack. The suspicious fire was reported at 0119 hours this morning and Bailey was stricken and died as he responded to the call. Authorities say Bailey's father had previously owned the bar decades ago. The current owner of the vacant building was not immediately identified. Our deepest sympathies go out to all effected.

UPDATE: Several of you have written in asking how you can send letters of support to the Randolph (MA) Fire Chief who is in a jam over a staffing and budget issue...and speaking up about it. One very significant factor in the situation is that one of the selectmen is the former Fire Chief in

Randolph....who is clearly no help to the current Fire Chief related to the staffing issue. But he was the current Fire Chiefs former immediate supervisor....so there is some personal history.

Some of the best...and some of the worst help to Fire Chiefs are those who stop being Fire Chiefs and become local politicians....with short-or long term memory.

It should be noted that Fire Chiefs from throughout Massachusetts responded to support Chief Foley during his disciplinary hearings, in part because they were shook that he might be punished for complaining about budget cuts after the fire in which two young half brothers were killed. The chiefs were further surprised this week to now learn that Foley has been suspended for 15 days without pay for suggesting, following a deadly fire in May, that the two could have been saved if the department was fully staffed.

As Chiefs and Firefighters should...they sympathized with him because it was something they could have done, knowing the emotions firefighters face when someone (especially 2 kids) dies under their command and the frustrations we all face with budget issues. More to follow.

NOTE: We also posted another story on the home page this morning about a FF in New Mexico who questioned some safety issues...and was threatened by his supervisor.

UPDATE: UPDATE: A Kingston (Ontario, CN) firefighter remains in serious condition in hospital after tumbling out of the fire apparatus while responding to a fire call on the weekend. Tracy Killoran, 33, a volunteer with Kingston Fire & Rescue, was injured after hitting the pavement when a door opened while the truck turned while responding to a call. The Ontario Ministry of Labour and Kingston Police are investigating the accident. The use or lack of use of her seat belt has not been released as of yet.

The call came in at about 2:45 p.m. Sept. 9. Killoran, who has two young children, suffered head injuries. She was not wearing a helmet, which fire officials say is standard procedure while riding in the truck. While only three months with Kingston F/R, Killoran was an experienced firefighter who came to the city from the South Frontenac Fire Department.

UPDATE: AMISH SCHOOL SHOOTINGS (This message is from Chief Curt Woerth of the Bart Township Fire Company)

Almost a year ago, on October 2, 2006, the tragic disaster of the shooting at the Nickel Mines Amish School struck our community. Five girls were hospitalized, five girls were laid to rest, and families' lives were shattered. Our whole community was shocked and is grieving since that fateful day.

In this year our department and our community have been tested and tried. Together we were able to work our way through these difficult times. Our fire company was able to meet our responsibilities to the community during this tragic event and in the months that followed due to the support we received from our neighboring Fire companies, Emergency Medical Services, Law Enforcement forces, and the South Central Pennsylvania Regional Counter-Terrorism Task Force.

The Bart Township Fire Company supplied the facility and leadership for the response to this event. As the world watched Fire, EMS, and Law Enforcement worked hand in hand with the Amish Community. In fact, many volunteer members of our fire company are Amish. However without the support of our community, this tragic event may have been worse.

Counseling sessions were held at the fire station for months following the incident. Separate sessions were offered for the families, Fire/EMS, and the community. The Nickel Mines Accountability Committee that was established to receive and disburse funds contributed in response to this tragedy holds its meetings in the fire station.

Hundreds of packages and thousands of letters flowed through the fire station. All packages and letters were sorted and checked before being distributed to the families. Volunteers from the community helped our fire company sort and distribute as many as 900 letters a day during those first weeks.

The Special Division (Ladies Auxiliary) of the Bart Township Fire Company, with help from community and local businesses, provided three meals a day to all Fire, EMS, Law Enforcement, and the Amish families of those involved during that first week. They served more than 800 meals a day during the time of the funerals.

We as a fire company have learned that life will never return to what it was before October 2, 2006. We have also learned through this tragic event that we live in a community where people care about one another and put the needs of others first. With this support we will work through the future that lies ahead.

The Bart Township Fire Company has no memorial remembrance planned for October 2nd. But each day we carry a living memorial in our hearts and minds of this tragic event and of the community's generous response. We ask that you keep the children and their families in your prayers. (End of message)

The above is relevant and worth sharing because-like many calls-this could happen to any of us. Any of us could be called to respond to a call-involving people, or kids we know-or family members...often a Firefighters worst nightmare. And if we don't have a pre-existing response, incident management and command plan to

manage it...in spite of the emotions-it only gets worse.

Some of the IAFC staff and I had a chance to spend time with Curt, his officers, his members and the community immediately after the shootings. We also had a chance to observe the Command operations at their firehouse following the shootings. The members of the Bart Township Fire Company knew every victim involved...yet the members of Bart Twp FC and the neighboring Fire Companies, EMS and Lancaster County EMA, LC Communications and related support personnel did a phenomenal, text book job in managing this nightmare.

Hey....

As we recently reached U.S. FIREFIGHTER LINE OF DUTY DEATH No. 93 for this year....South Carolina's Occupational Safety and Health Administration has now cited the Charleston FD for a willful violation involving Firefighter safety and 3 other serious violations related to their Firefighters on the scene not wearing protective gear and SCBA. The city was fined a total of \$9,325 for the violations. The fine \$\$ amount isn't really the issue at this point-the fact that they were found in violation and those violations directly contributed to the Line of Duty Deaths of 9 CFD Firefighters is the issue.

One of the more serious violations involved the CFD's failure to have procedures on operating at a fire in a structure with a steel truss roof design. The CFD also lacked an incident command system to coordinate, track, lead, manage, account for and take care of their Firefighters.

A "serious violation" is one where the employer should have known that by violating the law, their actions (or failure to take action) could cause death or physical harm to their Firefighters.

As you know, Charleston Firefighters James Drayton, Melvin Champaign and Brandon Thompson; Captains William Hutchinson and Louis Mulkey; Engineers Mark Kelsey and Bradford Baity and Assistant Engineer Michael French gave their lives on June 18 at that warehouse fire.

Hey...  
If you recall, there was a very tragic Firefighter Line of Duty Death in August when Lt. Paul D. Baker, 39, of the Turtle Creek FD in Arkansas lost his footing while involved in an extrication of a patient from a single-vehicle crash on the I-30 bridge over the Saline River. Lt. Baker fell about 40 feet, landing on the river bank and was killed instantly.

This tragic loss serves as a strong reminder for Firefighters and other first responders when working incidents along highway bridges and overpasses. We have been advised that most if not all of the sidewalls that border bridges and overpasses are only 27 to 32 inches high where there is not a pedestrian walkway or bike path (they are 10" to 15" higher).

When Firefighters and EMS personnel are working incidents along these sidewalls there is naturally an increased chance of falling over the wall with very little chance of survival...depending. Firefighters are reminded to conduct patient care, rescue extrications and all other duties as far away from the sidewalls as they can possibly get...or be secured using extreme caution being aware of the working conditions-and taking appropriate precautions based upon your FD SOP.

While lighting is helpful, scene and emergency lighting at night can create a glare that may interfere with depth perception and this too may contribute to mis-judging our distance from a sidewall. Safety officers and other Officers and Firefighters should insure that members know where the side wall is and how far members are from it. Our thanks to the Firefighters in Arkansas who reminded us of this horrible LODD-and some suggestions to use caution.

**CALIF FF LOSES BATTLE TO CANCER:** As we have said, we cannot send each and every non-trauma LODD out, but when logistics allow, we do feel compelled to share as much as possible. Chris Johnson, a firefighter with the Fresno County Fire Protection District-Cal Fire, has died after three years of battling cancer. Johnson, 32, of Sanger died Thursday at a cancer facility in Southern California where he was being treated for leukemia, and where he had been awaiting a bone marrow transplant, which he never received. FF Johnson's death is covered under California's cancer presumption laws. A fire apparatus engineer, Johnson was an 11-year-veteran of the department. Johnson's survivors include his wife, Rebecca, and a 3-year-old son, C.J. A Chris Johnson Memorial Fund has been set up to help pay for funeral expenses and other costs for his family during his illness, contact: Fresno County Fire Protection District headquarters at 210 S. Academy Ave., Sanger, CA 93657.

A Sedgwick County (Kansas) Firefighter died in the line of duty this afternoon after suffering a severe shock while operating at a grass fire ignited by a downed power line. A tractor trailer struck a pole which caused the downed a power lines, which ignited a grass fire. The 37 year old Firefighter somehow came into contact with the line after arriving at the scene of the fire.

A resident who lives in the area, said truck drivers have been ignoring the "No Through Traffic" signs and driving on through to a closed bridge. Realizing they can't get through, he said, they turn around -- and more than one has hit a power pole in the process and this time, a Firefighter lost his life.

The initial call to dispatchers was that a car had hit a power pole, downing electrical lines. Those lines also sparked the grass fire. Several hundred homes were without power in that area.

The tractor-trailer that hit the pole left the scene - cops worked the case as a hit and run and the driver was arrested in Oklahoma - where he admitted to officers there that he made the u-turn when he hit the pole. Details to follow.

1 Firefighter remains in very critical condition but others have improved. Updates will follow on the news/updates section on our home page.

ELECTROCUTION UPDATE: The power line that killed Kansas Firefighter Bryon Johnson was thinner than a pencil. Dangling next to a utility pole, it was difficult to see. Strong south winds fed the grass fire ignited by the power line, which was knocked loose when a semi truck pushed over a pole. Lt. Johnson may not have seen the dangling power line as he hit the fire. Lt. Johnson, 32, was shocked about 1400 hours and died in The Line of Duty less than an hour later at the hospital. Firefighters knew there were down power lines but because strong winds were pushing the fire toward houses, they attacked the fire from a different angle. They worked their way to the west edge of the fire and began moving south. The SCFD still isn't sure if Lt. Johnson saw the power line or how he came into contact with it. The Engineer of the apparatus lost contact with him and, following SOP's, went to check on him...and found him...the driver risked his own life by removing Lt. Johnson out of the area by his suspenders. Other FF's came in close contact with the live line as well.

2 IRISH FIREFIGHTERS LODD UPDATE: Either a wall or roof collapse was the cause of the LODD's of County Wicklow Firefighters Brian Murray (46) and Mark O'Shaugnessy, 26, who lost their lives when the roof of the building collapsed. Another member of their crew who was with them at the time is listed as critical in hospital. A 19 year old Sharon Hill Firefighter remains in very critical condition with burns and related traumatic injuries after being struck and trapped by the exterior collapse of a garage at a fire call last night. Initially the cops arrived confirming a working fire in a detached 3 car garage. Companies arrived and went with an exterior attack using 1-3/4" hand lines. While they were operating, there was a outward collapse of a wall. The Chief estimated that they were about 8 feet outside of the building when the front of the structure collapsed.

1 FF (who was hit by a steel crossbeam when the structure collapsed) was transported in cardiac arrest (he is the one who is critical at this time) and another Firefighter was transported with a serious leg injury. A total of 4 Firefighters and 2 Police Officers were injured either from the collapse or the effort to rescue the Firefighters who were trapped. The cops were transported for burns to the hands from their helping with the Firefighter rescue effort. All trapped and injured members were removed within 6 minutes. The fire began in the garage at the 900 block of Coates Street, where a man had lit a candle while working on a motorcycle

Important Update: The 19-year-old Sharon Hill Firefighter who was very critically injured in the line of duty was actually put on life support yesterday late afternoon. The hospital had incorrectly reported yesterday that FF Michael Reagan had actually died. A hospital spokesperson apologized for the erroneous report, blaming it on an internal miscommunication. Please continue reading.

We have been advised by local Fire personnel that it is the intent to harvest his organs so that others may benefit. As you know Firefighter Reagan of Ridley Township was rushed to the hospital for burns and very serious trauma Wednesday evening after a wall of a garage on fire collapsed on him. Firefighters had to extricate FF Reagan and 2 other Firefighters from the burning collapse.

FF Reagan's LODD was initially and well intentionally advised from the hospital, but a heroic decision by his family to harvest his organs will allow this tragic situation to benefit others..in FF Reagan's honor. The fire began around 2300 hours on Wednesday as a civilian was working on his motorcycle....the gas line broke when he removed the tank, spraying fuel on bug-repellent candles he had lit. He tried to fight the fire with a garden hose before calling the Fire Department.

The other two Firefighters who were injured are Joe Tesauro and Chris Miller. FF Tesauro, 23, suffered leg and back burns and FF Miller, 21, had non-life-threatening injuries to his shoulder and buttock.

Due to tightening budgets and limited ability to increase our budgets, most fire departments are being forced to do more with less. Here is a story about a few Central California fire departments who are looking at a form of consolidation, where they are going to share resources, including administrative staff members and reserve firefighter personnel. Most cities are competing for the same pool of reserve/volunteer firefighters, full-time firefighters, and even chief officers, so why not just have one pool to help the regional area and that way, we're not fighting with each other to get the best employees!

**Budgets are probably not going to get better, and it will require us to be very creative to ensure we keep the same level of service we have been providing, and also continuously look at ways to increase those levels of service, while still working within our budgets.**

Dear Friend of the LAFD,

With weather conditions having a seasonal impact on energy supplies, many people are turning to portable electric generators as a source of temporary electricity for their homes.

If improperly installed or operated, a portable electric generator can become deadly due to electrical shock and carbon monoxide fumes.

Using a generator indoors CAN KILL YOU IN MINUTES!

Firefighters encourage you to contact a licensed electrician to install your generator to make sure it meets all local codes. Never connect a generator directly to household wiring without an appropriate transfer switch installed and be sure to notify your utility, which may be required by State Law.

Power from generators connected directly to household wiring can backfeed along power lines and electrocute anyone coming in contact with them, including lineworkers making repairs.

The Los Angeles Fire Department reminds you:

- \* Generators can produce high levels of carbon monoxide (CO) very quickly, which can be deadly. At least 64 people in our nation died in 2005 from generator-related CO poisoning!
- \* Never operate the generator in an enclosed or partially enclosed space such as a patio or garage, and place it far, far away from any structure housing people or pets. Most of the serious carbon monoxide poisonings handled by Los Angeles Firefighters have been from generator exhaust fumes drifting into doors, windows and crawl spaces.
- \* Use carbon monoxide detectors in nearby enclosed areas whenever you operate a portable power generator.
- \* Read the owner's manual thoroughly and make sure your generator is properly grounded and maintained.
- \* Store fuel for your generator safely. Turn the motor off and let it cool before refueling.
- \* Keep the generator dry, and make sure extension cords are rated for the load, free of cuts and worn insulation and have three-pronged plugs.
- \* Do not overload the generator. A portable generator should be used only when necessary and only to power essential equipment or appliances

- \* Use a ground fault circuit interrupter (GFCI) to help prevent electrocutions and electrical shock injuries
- \* Turn off all appliances powered by the generator before shutting down the generator
- \* Keep children away from portable generators at all times!

Remember: Electricity is a powerful tool and odorless carbon monoxide fumes can quickly lull you to a deep and deadly sleep!

#### USFA RELEASES SCHOOL FIRES REPORT

WASHINGTON D.C. - The U.S. Fire Administration (USFA) has issued a special report that explores the causes and characteristics of school fires. The report, School Fires, developed by the National Fire Data Center under the Federal Emergency Management Agency's USFA, is part of the Topical Fire Research Series and is based on 2003-2005 National Fire Incident Reporting System (NFIRS) data. The report looks at all school fires, including those occurring outdoors on school property and compares such characteristics with those of school structure fires.

"This week marks the return of many students to schools across this nation as well as the start of National Preparedness Month," according to U.S. Fire Administrator Greg Cade. "Fires in buildings as special as our nation's schools are unacceptable. I ask all first responders to encourage students, families, and school faculty members to take the time to know exactly what they will do in the event of any type of school emergency, including fire."

Between the years 2003 and 2005, an estimated, annual average of 14,700 fires occurred on school properties. These fires were responsible for \$85 million in annual property loss and an estimated 100 civilian injuries. No fatalities on school properties were reported to NFIRS during this period. Forty percent of school-related fires occurred outdoors on school property. Forty-three percent of fires on school properties were structure fires, and an additional 6% were vehicle fires.

The leading cause of school structure fires is incendiary or suspicious activity (32%), followed by cooking (29%), and heating (9%). Fires in preschool and day cares are predominantly due to cooking, whereas incendiary or suspicious activity is the leading cause of middle and high school structure fires. The three leading areas of fire origin in school structure fires include restrooms, kitchens, and general assembly areas.

INCIDENT MANAGEMENT TEAM ALL-HAZARD POSITION TASK BOOKS AVAILABLE FROM USFA

Emmitsburg, MD. - The U.S. Fire Administration (USFA), in cooperation with the Incident Management System Division/National Incident Management System (NIMS) Integration Center and the National Wildfire Coordinating Group (NWCG), announces the availability of position task books for All-Hazard Incident Management Team (IMT) members and others who may serve in those roles. Similar in concept and design to existing position task books used by NWCG, the task books are based on Incident Command System position competencies identified by NWCG and USFA for the NIMS Integration Center.

The position task books are intended for use by the authority having jurisdiction to certify that the person to whom the task book belongs has demonstrated the required competencies and behaviors required by the Incident Management System Division/NIMS Integration Center. Each position task book lists the competencies and behaviors for the specific position in a format that allows a trainee to be evaluated against those competencies and behaviors.

Successful performance of all tasks, as observed and recorded by an evaluator, results in a recommendation that the trainee be certified in that position. Evaluation and confirmation of the individual's performance of all the demonstrated competencies can occur on incidents, in classroom simulation, and in other

work situations. These task books are utilized by established All-Hazard IMTs trained through the USFA's All Hazards IMT Technical Assistance Program.

**Fire personnel in Vail, Colorado are having a tough time finding affordable housing; nothing new there to most of us who live in California. That's not the part of the article that scares me - the part that scares me is the statement that chiefs who are responding from 30 minutes away are having to give orders over their cell phones. I'm**

sorry, but if you can't trust your personnel on scene to make decisions, then they shouldn't be working for you.

Also, I'm not an ICS purist per se, but if someone is not on scene, they should not be the Incident Commander. The Incident Commander on scene should be making the decisions, and anyone responding from regardless of how far away should focus on driving safely and not interfering with on-scene activities unless for some strange reason, things sound like they're going south in a hurry. As tempting as it is for me at times to want to give orders or ask questions when I'm responding - at times up to 25 minutes code 3, I've learned to just shut up, soak in everything going on and trust my officers on scene to do the job we pay them to do - manage the incident.

If I can't make it better (which I most likely can't since I'm not on scene), then I need to just shut up and drive, and listen to the activity and try to think big picture, long-term, and focus on overall needs that I can discuss with the officer when I arrive to take over as the Incident Commander. Heck, in 30 minutes, by the time they arrive, most working incidents are not "working" anymore, and into the cleanup or winding down phase where you can just let the initial officers maintain their assignment and support them as needed for experience.
