Application Period to Open: Fiscal Year 2007 Fire Prevention and Safety Grants

The Department of Homeland Security recently posted the FY07 Fire Prevention and Safety (FP&S) Grants Program Guidance on the Assistance to Firefighters Grants (AFG) Program Website. The application period is scheduled to begin on October 22, 2007, at 8:00 a.m. Eastern Daylight Time (EDT). Applications for these grants must be received by November 30, 2007, at 5:00 p.m. (Eastern Time).

FP&S grants support projects that enhance the safety of the public and firefighters from fire and related hazards. The primary goal is to target high-risk populations, firefighter safety and mitigate high incidences of death and injury. Examples of the types of projects supported by FP&S include fire prevention and public safety education campaigns, juvenile fire setter interventions, media campaigns, and arson prevention and awareness programs.

The applicant tutorial is available through the www.firegrantsupport.com Website. The tutorial will provide you with valuable grant information and will walk you through the

preparation and submittal of competitive applications. In addition, the applicant tutorial will provide an overview of the funding priorities and evaluation criteria. Applicants who have questions regarding the Fire Prevention and Safety Grants opportunity should contact the help desk as soon as possible at 1-866-274-0960 or at firegrants@dhs.gov. During the application period, the help desk will operate Monday to Friday, from 8:00 a.m. to 4:30 p.m. (Eastern Time), but is prepared to revise hours of operation based on volume, demand, holidays and urgency to complete the FP&S Grants application period and processing for FY07.

The AFG Program is administered by the Department of Homeland Security (DHS) Federal Emergency Management Agency's (FEMA) Grants Program Directorate in coordination with the U.S. Fire Administration.

Tualatin Valley Fire & Rescue, a fire protection district in Oregon, is seeking information on successful open-continuous hiring practices for firefighters. Traditionally, we have recruited every two years, conducting testing to establish a ranked eligible list that is used for one or more selection processes over a period up to 24 months. We are exploring a process that would allow candidates to apply at any time, test periodically, and earn a spot on a ranked eligible list that evolves over time. Instead of the list expiring, candidates would come onto the list as they apply and test, and be removed from the list after a certain period of time from when they came onto the list. Rankings would change with each new merging of new candidates. The goals of this process is to allow candidates to apply, test and become eligible for hire much more frequently than they can currently on our two-year cycle, and to provide our operations management a "fresh" list whenever they wish to fill spots in a new recruit academy.

We would like input from various fire departments/districts who have experience with a process similar to what we envision or who have explored these ideas in the past.

If you fail to complete it or do not complete it adequately, you will not be accepted into the course.

THIS CANNOT BE ANSWERED WITH THREE OR FOUR WORDS. You MUST provide an adequate explanation for review.

TRADE's Virtual TRADEing Post is available online. This site allows you to see an index of each of the CD's, then access and download any specific lesson plan or program you see and use it as you need in your Department. When you find a file you wish to download, just open it and then "SAVE AS" to your computer. Then you can modify it as you wish. Remember, please do not take any program and use it in a copyrighted program. The intent of TRADE is to "share" information that will allow the Fire Service not to reinvent the wheel each and every time they need something. FIREFIGHTER SAFETY INFORMATION TO LEARN FROM:

If we do not learn from history, we are doomed to allow history to repeat itself. I encourage you to go to the Firefighter Fatality Investigation and Prevention website (hosted by NIOSH – the National Institute of Occupational Safety and Health – the organization that comes in to evaluate what went wrong after a firefighter line-of-duty-death). Go to <http://www.cdc.gov/Niosh/fire/>

A great way to incorporate these numerous reports into your busy schedule is to just pick one report a day, read it, and see what can be learned from it. Then, start seeing what the commonalities are between the numerous firefighter fatalities that have been researched and investigated. Very sad to say, but you will see some commonalities and lessons that were not learned by others since they allowed history to repeat itself.

It is sad, but a reality that certain issues such as lack of (or poor) command, poor communications, complacency, and lack of training continue to be major contributors in firefighter fatalities.

CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter. Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas.

Basic Information For The CPAT Test

QUALIFICATIONS:

Applicants must be 18 years of age and must show government issued photo identification (i.e. drivers license, school or military ID; or a passport or visa). Candidates without a photo ID will not be allowed to take the CPAT.

APPLY EARLY

Applications are accepted in the order they are received. Applications are not accepted until the fee has been paid.

PAYMENT:

The fee to take your first test at their site is \$150.00. Your fee must be paid for your application to be accepted. This fee is non-refundable. Payment can be made with check, money order, Visa, or MasterCard. If you are paying by check, the check must clear your bank before you can take the CPAT. Make payments to "CFFJAC." Your fee includes participation in an orientation session, related printed materials and test.

ORIENTATION SESSION:

Working with experienced CPAT proctors, you will be given the opportunity to try each of the 8 events and determine where you may need to strengthen yourself. You will be given a set of exercises to physically prepare yourself for the CPAT. If you elect not to participate in the orientation, you will be required to sign a waiver acknowledging that the orientation was offered. There are no discounts if you elect not to participate in an orientation. The CPAT dress code is enforced for all candidates who attend an orientation.

TEST:

The registration form has a place for you to choose a preferred and second orientation day as well as a preferred and second test day. You will be notified by mail of the confirmation of your orientation and test dates. A group of candidates are scheduled every half hour to report to the CPAT center. Please be on time, but not excessively early. Space for waiting is limited. If for some reason you cannot attend your scheduled test day, please notify us as soon as possible. Every effort will be made to reschedule you to a test day that will fit your schedule.

RETESTS:

If you have taken the CPAT at a CFFJAC monitored venue in the past and would like to retest, the fee is \$100.00.

PRACTICE SESSIONS:

For \$25.00, you can schedule a supervised practice on the CPAT course with a proctor. Your session is designed to meet your individual needs. A session may include: Training on the CPAT equipment, watching the instructional video, going through the course in its entirety. You also receive the benefit of mentoring: techniques, expert evaluation and conditioning advice from our CPAT proctors.

Refunds for cancelled or rescheduled practice days will not be given if requested after 10:00 am the day before your scheduled practice day.

WHAT TO WEAR:

The dress code is strictly enforced for safety. The CPAT dress code for the orientation, practice sessions and test is: Long Pants (no shorts), T-shirt or sweatshirt, footwear with no open heel or toe, and no loose or restrictive jewelry. Candidates must be in proper CPAT attire before being allowed to participate in the orientation, practice sessions and test.

PARKING:

When you arrive at the CPAT center, please park to the rear of the building and enter the front door.

There is limited space at the CPAT center. In order to accommodate a fair and standard testing process for all candidates, we will not be able to allow spectators on the CPAT course or in the facility.

Hey...

Attorneys for Monica Keane, the widow of Waterbury (Ct) Capt. John Keane, filed notice on Friday announcing their intention to file a wrongful death suit against the city and others involved in the fatal fire engine collision in May. The notice to the city cites a law that makes municipalities liable when an employee is injured by another worker who is negligent while driving a city vehicle.

The claim asserts that Firefighter/apparatus drivers Joseph Fischetti and William Mahoney were negligent "in the operation of their respective vehicles."

Around 1000 hours on May 19 while responding to a reported kitchen fire, Engine 12 and Truck 1 entered the same East Aurora Street intersection and collided, throwing John Keane and Fischetti from the engine and Keane succumbed to his injuries three days later.

A subsequent Waterbury Police investigation into the accident determined that no one in Engine 12, on which Keane was the ranking and supervising officer, was wearing a seatbelt.

ANOTHER REPORT: Here is an article related to the Line of Duty Death of a veteran Baltimore City Firefighter. A year after Firefighter Allan Roberts was killed, Baltimore fire officials released an investigative report that blamed the death on more than a dozen errors and safety violations - including miscommunication and possible equipment misuse.

According to one report, the tower ladder was equipped with Opticom and the lights and siren were operating. As they made a left turn off Laburnum Ave. onto Creighton Rd. they were hit by an oncoming vehicle who was passing another vehicle and may not have seen or heard the apparatus. Details to follow.

Hey....

By now you have probably read the media reports where some undisclosed sources say that autopsy results showed that a Boston Firefighter who died in the Line of Duty while operating at a restaurant fire in August had traces of cocaine in his system, while another Firefighter had a high blood-alcohol content.

Firefighters Warren Payne, 53, of Newton, Mass., and Paul Cahill, 55, of Scituate, Mass., were both tragically killed at that fire in August.

The media is reporting (from leaked documents) that one Firefighter was legally drunk and the other Firefighter had illegal drugs in his system. Meanwhile, the victims' families are grieving over the loss of their loved ones....with a new twist to further add to their life long grief. Five children lost their fathers. "I hope this isn't true. My husband really died a hero," Cahill's wife, Anne, is quoted in the papers in Boston.

Well, they clearly lived heroic lives and were heroic firefighters. One of the most well know and written about Chiefs of the FDNY was Chief Edward Croker, he served in the late 1800's and early 1900's. He had many great quotes but one I have always liked that says something to the effect of "When a man becomes a Fireman his greatest act of bravery has been accomplished....what he does after that

is all in the line of work...."

Sorry ladies, but people who rode fire apparatus (horses included) back then were called Firemen, that's history and that's the quote. Don't get off the subject.

The point is that Firefighters Payne and Cahill were brave and absolutely lead heroic lives as Firefighters. Their history and years of heroic, brave and dedicated service prove it and speak for themselves.

But, if what the reports are saying is true related to the alcohol and drugs, they have caused irreparable and life long pain and suffering to those they love the most-their family members. How? There are significant possibilities that local, state and Federal death benefits to the families may be challenged-if what is reported is true and factual. So it is possible that not only have the families of these fallen Firefighters suffered horrific losses-but may also end up without the fiscal death benefits that the families are entitled to-because of the actions of their lost loved ones.

What a nightmare.

Ever work with a Firefighter who is not "clean"..? It's a real treat. We could get into the discussion of how that can happen-but the fact of the matter is that it does happen. I would guess each of us have known a Firefighter at one time or another that had no business being on duty. And I would also guess that in almost every case, the issue was ignored. More back then, "back in the day"---a bit less these days. But ignoring the condition of another Firefighter is and has been a chosen option. It's not easy taking on issues like drinking on duty for most. And in some places, if you do it, your career is pretty well shot..like it or not. Ahhhh the Brotherhood. So for that and other reasons, many firefighters and fire officers choose to ignore it. They let someone else worry about it. Another tour/shift, another Officer or Chief, another Firefighter or whoever. But unfortunately, the "system" (official and unofficial) at many FD's creates an easier avenue to ignore the problem than to deal with it. That's the problem.

As you know, inappropriate drinking and illegal drug abuse is a societal problem-and the FD, any FD, is a part of society. So it shouldn't be a shock that a Firefighter may be drunk or high on duty or responding to calls. To me, the bigger shock is the in-depth cultural behaviors and attitudes that can allow it, hide it and sometimes even support it. After all "He's a great Firefighter and what a great guy"...."He has issues-what are you gonna do, rat the guy out"? "She is always like that-and functions better that way" .

A Department that provides open doors to help those with a problem is probably a better place than those that don't. But most FD's already do that. Having access to getting help is not generally the problem....it's getting the "problem" to get the help and the actions required to make that happen.

The problem is at the 1st line supervisor level, where the rubber meets the road-and so often is where FD's succeed or FD's fail, as the link. This is NOT an easy issue by any stretch of the imagination. It is sometimes much easier to make decisions on the fireground than it is to make tough decisions related to those you work with. And in many, many cases, these are people who you have gone thru a lot with-good times and bad. Whadayagonnado....turn the guy in!?

The solution is supervisory training and more related training for fire officers so they find a way and understand how to help "the Brother or Sister" who has a drinking or drug problem. And those may absolutely be the toughest decisions any fire officer has to make due to the way "we" act either as the victim or as the ones who don't want to see a "good" firefighter get "ratted out". "Let him sleep it off"...."she is going thru some tough times"...."who are you to talk???....I have smelled you when you have arrived at the firehouse-and now you want HIM to get help"

Not easy stuff but stuff that must be dealt with and confronted by officers working with other officers

and firefighters. It takes courage and bravery. Words we are familiar with. But the courage and bravery used at runs and the courage and bravery used in "attacking" a serious personal issue or disease are from two different worlds. Courage and bravery on the fireground is one we usually have no problem dealing with--after all, we are attempting to save a life. Courage and bravery in dealing with a member who has a drug and/or booze problem is a lot tougher in some respects. There are some in our business who do/don't see that as heroic. But you are still attempting to save a life--they just don't know it and often "the victim" doesn't want rescuing--because they don't know they need help. A bit different than a kid trapped in a 2nd floor bedroom. The kid is in a room filled with smoke and fire--the kid clearly wants out. The firefighter who has a drinking or drug problem thinks the "room" they are in is just fine and doesn't always want out. And if you enter that "room", THEIR room, the response could be and has been "who the hell do you think you are entering MY room to rescue ME"!?

Tough stuff.

Good fire officers are often the only way this problem can be dealt with along with appropriate drug testing that recognizes everyone's rights. Everyone's rights means the victim, the other firefighters who have to work with the victim, all the families and the public. Another option, that being the FF with the problem actually taking responsibility in getting help on their own before there is a crisis, cannot always be counted on for a variety of reasons. But good fire officers working with other good fire officers, firefighters, Union or Association officials and others working together with counseling pros to save a career and a life is a system that must be in place. But before that--a process is needed that helps determine who can and should be a boss and who shouldn't. Some FD's have that in place, some don't. A white hat and a gold badge can be pinned on anyone with a pulse. Ever seen that?

Leading the "Brothers" and the "Sisters" at and into a fire takes good fire officers. Officers with years and years of experience and training so that we have a good shot at succeeding at whatever the emergency is. And with being a good officer also comes the ability, training and qualifications to take on the internal cultures that hide and cover up these difficult dependency and personnel issues. It is far from easy. Many GOOD Fire Officers have tried and ended up on the cutting room floor. But that comes under the courage and brave stuff.

Real Brotherhood? I got your "real brother/sisterhood" right HERE if we are picking and choosing when to do our jobs as officers and firefighters when we decide to ignore the problems. We would never ignore the signs of flashover if they were right in front of our faces--and we would take immediate action to protect our members. We would never ignore the signs of structural collapse, and again, would take immediate action to protect our firefighters. But yet when it comes to booze and drugs in the firehouse, so often we intentionally decide to take no action and hope that it will take care of itself, or that "someone else" will take immediate action. And sometimes it flashes over, impacting numerous victims.

Many in our business were mad when the coroners report was leaked to the media regarding the conditions of those firefighters. Firefighters should have been more than mad. It is disgusting that the information was used the way it was without it first being officially released. The families--who had only started the grief process now had to deal with the way it was handled and what was published by the Boston media. Family members learned about the coroners report from the media?!?! WTF! The actions related to the leak were absolutely horrible, unfair, inappropriate and any other related words you can come up with. It was BS. But it did happen and the information got out. How it will end up, how the families will now suffer even more and what additional fiscal and benefit related losses they will encounter remains to be seen. I don't think families should have to suffer when we do some of the things we do. But they do. That's the way it works. We rarely think about how our actions will effect others--especially those we love. Sometimes we need to think more about those whose pictures are in our wallets and desks...than we actually do. Sometimes they are the ones who suffer the most due to our inappropriate actions. They get left holding the bag. Our families are the "them" when it comes to

the booze, the drugs and us.

Some in our business even got mad at the fire service media for relaying what the Boston media had printed. Look, it was FIRE related news and since it was out, the fire media reported it. While we may get angry at the Boston media for handling this the way they did (they had a choice-they made their decision), look past that at the real issue while praying real hard for the Payne and Cahill families. The real issue at this point is to think about what can be done to avoid that from happening again in any FD. I am not talking about some reckless and sick decision to leak a coroners report-which was reckless, sick and if criminal-someone should have their clock rung. But the fact of the matter is that the info got out and firefighters have no control over that now.

What I am talking about though is what was leaked in the coroners report and what the booze and the drugs can do to firefighters individually, as a group or company, our families and us personally. There is a lot that can be done to avoid that from happening again in any FD. We just have to want it.

Love our families? Brotherhood? Sometimes I think that's just another word.
Ignoring the booze and drug problem in our firehouses creates a 100% BMA situation.
Brotherhood my a**.

And look where it leaves kids and families.

For this weekends WTF, we stumble into New Ulm (Minn) where there is nothing like enjoying an icy cold beer in the firehouse after fighting a fire. As you may know by now, the City Council approved the measure Tuesday, giving their Firefighters the option of drinking at the firehouse after fire calls. "I feel these (firefighters) who put themselves at risk in fighting fires are responsible enough to know when they've had too much," said City Council President Dan Beranek.

Silly, silly President Dan.

A city attorney, however, said that letting "the boys" down a few, raises "serious concerns about liability." He said there are some legitimate causes for concern...concern? What concern? Ya mean like crawling down halls, using SCBA's, throwing ladders, driving apparatus and who is going to determine when a firefighter is too toasted to respond?

We also heard rumor that small and convenient appetizer sized portions of pot may also be offered soon, to help Firefighters "take the edge off" after a particularly difficult emergency call...but that measure is still under consideration. The concerns from council are that while they feel a firefighter would always know how drunk they might be and can then always stop drinking---like most drunks always do---being high after a call may cause significant memory loss and the firefighters may not remember exactly why they are expected to stop smoking the dope. Additionally, the grocery budget for the FD is limited this year and the expected rise in the cost of purchasing numerous 55 gallon drums of doritos, cheetos, tostitos, pringles, sun chips, ruffles and related munchies and salty favorites may simply be too much for the town budget to bear.

A Rabbi, a Priest, and a duck walked into the New Ulm firehouse. The bartender looked up and said, "What is this? A joke?"

And now, back to the real world.

Last night at approximately 2000 hours a Hualapai Valley (Kingman, Arizona) Firefighter was seriously injured while performing overhaul on a two story structure fire. Initial reports are stating that a wall collapsed trapping the firefighter momentarily. His injuries are a severely fracture leg and ankle. The fire building was described as a two story residential home with most of the top story completely destroyed by fire. More details to follow.

And while these two deaths are off duty members of the service (MOS) , they are related and worth our time.

Last night in Stafford County (VA) a Deputy Sheriff, Jason Mooney, who was also a Volunteer FF in the county, was responding to an accident with people trapped on I-95 when he lost control of his vehicle. Prior to the crash, he was having coffee with his fiancée, a FF/Medic on Engine 9, in Aquia Harbor. Engine 9 was actually behind him responding to the crash and witnessed it. When they got to him he was trapped and in trauma arrest. They cut him from his patrol car and transported him to Mary Washington where he was pronounced dead.

And in Illinois, Chicago FD Medic was struck by a car and killed Thursday in Schaumburg after stopping for a flat tire. PM Randy Orzada, 33, was hit at 3:30 a.m. and he later died at Northwest Community Hospital.

Orzada had been a Chicago Fire Department paramedic since April 1997. He was assigned to Ambulance 48. PM Orzada had parked his car after getting a flat. A 42-year-old Crystal Lake man passing by accidentally struck Orzada. The Crystal Lake man, believed to be on his way to work, got out of his car to help Orzada after the crash.

Our deepest and sincere sympathies go out to the members of the Stafford County and Chicago FD's...and especially the families of Jason Mooney and Randy Orzada.

Four firefighters were injured this afternoon when their engine company was engulfed by flames from the Harris Fire at around 1400 hours. The Firefighters were flown to the UCSD burn center in Hillcrest in unknown conditions according to CalFire. The incident may be related to a report by the California Highway Patrol that they had lost radio contact with one fire crew about an hour prior to that. The Harris Fire that began early Sunday morning about 70 miles east of San Diego and has burned more than 2,500 acres and injured at least these four firefighters, four civilians and has killed one civilian. There are unconfirmed reports of other civilian burn victims.

There are several fires burning out of control between L.A. County and the San Diego areas. The "Santa Ana" winds have become so bad that some fire aircraft were initially unable to fly but now, are flying.

All national news agencies are covering the fire. Updates as needed.

As we all watched shockingly at the horrible fire in NC that killed this 7 kids yesterday morning, the SMOKE DETECTOR issue raises its head again. The question "do all smoke detectors really detect all smoke" is one that's been out there for a while with limited response.

While this house in NC that killed the 7 kids is reported to have had smoke detectors, could this be another example of the issue involving "ion" detectors that have, in the past, failed to activate quick enough when a smoldering fire from (possibly candles, or smoking materials), permitted the fire to progress?

DCFD Sgt. Michael LaCore remains in critical condition after he and three other firefighters were injured in that row house fire Monday. Sgt. Michael LaCore, 37, underwent surgery yesterday morning and was scheduled to stay in the Burn Intensive Care Unit at Washington Hospital Center for an indefinite period of time. He suffered burns on 50 percent of his body and remains in a medically induced coma. Three other Firefighters: Charlie Shyab, 30, Kenneth Humphries, 23, and Douglas Donnelly, 27 are listed in good condition, and FF Humphries and FF Donnelly were released from the hospital yesterday. All four of the Firefighters were from Engine Co. 4.

DC Fire Officials said the blaze began about 1520 hours after rags soaked in linseed oil spontaneously combusted and caused a container of propane gas to explode. The fire spread to the home's rear porch and then jumped to porches behind houses on either side of it.

IL. LODD: We regret to announce the unexpected non-traumatic Line of Duty death of Mendota, IL Firefighter / Paramedic Scott A. Mumm on Monday, October 29, 2007 at approximately 21:45 hours. Scott was 34 years old and has been a member for 13 years. He leaves behind a wife and three children. For further information go to www.mendotafire.com . Lieutenant Mumm responded to a rail car full of coal that was on fire and assisted with tanker water supply operations. The train car burning was fully extinguished approximately two hours later and all firefighters were released at 2010hrs. Lieutenant Mumm returned home and went to bed for a nap prior to his other job at midnight. When Mumm's wife attempted to awaken him at 2130hrs, he was unresponsive. Hey...

Very sadly, hopes are fading for the missing Firefighters at that suspicious warehouse fire in Warwickshire, U.K. As we sent out last night, 1 FF died after being pulled from the fire at that vegetable packing plant located in Atherstone on Stour. 3 more Firefighters are still missing. The fire is now reported to have been extinguished but conditions are difficult for entry. Reports are that the roof had collapsed and the 3 Firefighters who were unaccounted for had not been seen since early in the evening.

Companies responded to the site of the fire, the Atherstone Industrial park shortly before 1800 GMT on Friday. Matt Wrack, General Secretary of the Fire Brigades Union (FBU...link below), says the potential loss of 4 Firefighters would make the incident the worst loss of life among its members since 1972. (See UK LODD history below)

A search of the building for the missing Firefighters is underway-but conditions, collapse etc make it tough.

From a U.K. LODD historic perspective, their last major FF LODD loss was in 1972, when 7 Firefighters died while operating at a warehouse fire in Glasgow. In that fire, one Firefighter was trapped inside the building and six other Firefighters died in the Line of Duty attempting to rescue him.

For those of you that viewed the video, I wanted to provide more factual details yesterday but time was tight.

The firefighters you see in the video ARE NOT the crew that was burned, Engine Co. 4 was the crew that was burned. The crew of Engine 4 was on the second floor of the Delta exposure, which is the building in which the first floor suddenly and quickly becomes heavily involved. You can see Engine 4's stream coming out the windows on the second floor from time to time. On background, one of the burned firefighters stated that they were making progress knocking down fire 2nd floor from front to rear of Exposure D, and he could see day light from the rear windows. Suddenly the daylight changed to a wall of fire. The fire then came up the stairs behind them. The mayday follows that on the video.

MEDICAL UPDATE: Sergeant Michael LaCore remains in critical but stable condition in the Burn Intensive Care Unit at MedStar. There have been no significant changes since yesterday. Many weeks of rehab and therapy are ahead for Sgt. LaCore. FF Charlie Shyab has been upgraded to good condition. His burns encompass an area described as 30 % of his body with about 10% being third degree burns. He, too, has many weeks of rehabilitation and therapy ahead.

The State of New Jersey has held 3 Fire Officers accountable for a fire training drill that was conducted against rules, laws and standards. The N.J. Division of Fire Safety has barred Emerson Fire Chief Thomas Carlos, Deputy Chief Mark Savino and Lt. Rich Solimando from commanding emergency calls or serving as officers for periods of time that go from 60 days to a year. All 3 volunteer Firefighters, are still allowed to go to calls as Firefighters during that period. Local Borough of Emerson elected officials decided not to issue any more punishment and are satisfied with the state's corrective actions.

In April 2006, the EFD conducted a training drill in a vacant commercial building. Other FD's were drilling with Emerson's firefighters to train in smoky conditions. The state said the EFD didn't have a permit for their live burn drill and that their actions violated N.J. Environmental Protection and Division of Fire Safety rules. The department burned hay, wood pellets and other combustible materials to create smoke. In Jersey, it is illegal to perform live burns in structures other than fire academies and training centers.

Something we tend to forget when we take the oath of office is that since we are public employees, our lives may be more public than we want them to. Many newspapers are starting to publish the salaries of firefighters and other governmental employees, and there is nothing we can really do about it – except.....continue to show the public that we are worth every cent we make!

If we continue to show the public that we are always offering value-added service every shift we come to work, we may weather this storm. Instead of getting emotionally charged in a negative (mad) way towards the newspapers for doing what they are doing, realize courts have ruled they can do so since our salaries are public information. So, instead of being on the defensive, get on the offensive and start proving to your customers that you’re worth every cent. Deliver “wow” service every

public contact you make, whether it is on a call, doing inspections, answering the fire station door, providing a public education drill, or just doing anything where you interact with the public (which is pretty much most of the day). And if you're not interacting with the public that often, I encourage you to start looking for positive ways to do so.

Many folks still think firefighters just fight fires, and that all we do is shop, eat, workout, and sleep. Don't get mad at me for saying that, I'm just quoting from numerous experiences I have had over the years. Instead of living up to their perception, take the time to positively educate them as to the numerous services we provide and that while fires only make up a small part of what most departments actually do, that we are making a positive difference in their community in so many ways.

Are you volunteering in the community you work for? Are you spending your money – off duty and on duty, in the community you work for? Are you spending time in the community you work for, on duty and off duty? Just some things to think about if someone ever questions your salary – which they will at some point. Instead of getting mad at them, prove to them through your actions that you care about the community, and that you are continuously giving back and worth every penny you are being paid by them – the taxpayer. You're a taxpayer – don't you want your tax dollars going to good use?

10/24/07 As you know CalFire engine 3387 was involved in a burn over on Sunday, Oct. 21st

on the Harris fire. At this time I am not able to go into great detail concerning each individual, but can provide some general information.

As a result of the burn over four of our firefighters received burn injuries. Two of our firefighters have suffered second degree burns, one on his face and hands the other on his back and the back of his legs. Both are doing well in the intermediate care ward of the burn center. At this time visitors are encouraged to call prior to coming in. This is due to the need for lots of rest and an overwhelming request for visits.

Our other two firefighters received second degree burns to their faces and respiratory systems. Their burns are not considered life threatening, but have required intubation and heavy sedation to allow for lung recovery. Both are surrounded by family members and are receiving excellent care. At this time only family members are being allowed to visit.

Status of our firefighters.

Our brother and sister in the ICU remain in critical condition due their respiratory injuries. They are being monitored closely by the hospital staff and continue to be surrounded by family and friends. Our firefighters in the Intermediate Care Unit are making progress. One had to have cadaver grafts on his hands and face on Friday and spent yesterday recovering. He is feeling much better today and even shows a little of his old self now and again. Our other brother in Intermediate Care is in good spirits despite the news that he will require surgery early this coming week. Overall, both are doing well.

Community Support.

For those of you have not heard the news, the San Diego Chargers are donating \$30,000 to our firefighters and their families. In addition to the generous donation, the Chargers provided an all expenses paid day at the game for the families. On the field for the opening ceremonies were the Governor, CALFIRE's Rick Henson, Alex Davenport and Joseph Lopes. I am told that Alex and Joseph were able to enter the stadium through the "tunnel" with the Charger players. I don't know that there is enough ice cream in the world to pay for that one.

Today Tim Ward delivered money raised at the Harris Incident base to the families. Our thanks go to all who donated. You have helped make the lives of the families working so hard to be ever present for their loved ones a little easier.
