FIRE SERVICE SAFETY & TRAINING **INFORMATION:**

The following information affects all fire service, law enforcement, and emergency services personnel, and goes into effect Monday November 24, 2008. All emergency service workers (Fire, law, EMS) working on a federally aided highway (which could probably be argued as every road in the nation, minus private roads) must wear a reflective vest to ensure they are being seen by vehicles passing by.

Why does the Federal government have to regulate how we do business? Because we continue to injure and kill first responders on the highways, that's why. Yes, it may take an extra few seconds to put on that stupid vest, but that stupid vest may just save your life. And if it takes a few extra seconds, so be it. Also, remember – we didn't cause the emergency.

We are here to mitigate the emergency and the last thing we want to do is become patients our peers will have to also be treating at the scene. While there will probably not be any penalties or fines for personnel not wearing the vests, how would you like to be the supervisor (Captain, Battalion Chief, etc.) getting grilled by an attorney as to why you did not require your personnel to comply with the law, and as a result of your failure to have them wear the vests, they were seriously injured or killed? The "vest police" will more than likely not be fining or scolding us if we don't wear them....but if something bad happens to our personnel, all fingers will be pointing at us, and can you blame them?

Here is some information from the United States Fire Administration to hopefully answer some of the burning questions still out there:

Safety Concerns Raised by the Firefighting Community Regarding High-Visibility Safety Apparel Result in Modification to Vest Rule

November 21, 2008 -- The Federal Highway Administration (FHWA) today issued an Interim Final Rule to address safety concerns raised by the firefighting community regarding high-visibility safety apparel (see **Worker Visibility Final Rule - 23 CFR Part 634**, below).

The Interim Final Rule:

- Revises the definition of "worker" to exclude firefighters when they are exposed to flame, fire, high heat or hazardous materials.
- Exempts firefighters from the requirement to use high-visibility safety apparel, as defined in this rule, when they are exposed to hazardous conditions where the use of such apparel may increase the risk of injury to firefighter personnel.

Worker Visibility Final Rule - 23 CFR Part 634

A new FHWA regulation ([Worker Visibility Final Rule - 23 CFR Part 634](#)) that goes into effect on November 24, 2008 requires firefighters and other first responders responding to or working at an incident on federally funded highways to wear a retro reflective safety vest that meets the Class II or III standards of the **American National Standards Institute/International Safety Equipment Association (ANSI/ISEA) 107-2004** publication. The **ANSI/ISEA 207-2006 Public Safety Vest** standard has also been interpreted as meeting this requirement. Benefits of taking this test include:

- You're only taking one test (as opposed to separate tests for each fire department)
- The hiring list will be in effect for one year
- There is a chance other fire departments will hire off of this list

You may be wondering, is any fire department going to be hiring? Of course! While the California budget crisis has impacted a number of their clients, and there are some agencies that do not have or do not anticipate any openings in the next year, there are always going to be some departments that will be hiring.

Why then would a department participate if they were not planning on hiring? Well, number one, things can and do change. Just because a department does not have any openings as of this moment, does not mean that situation cannot change over night. Firefighters retire,

firefighters get injured, firefighters quit (usually to go to other departments), many times without any advance notice to the department. Number two, many fire departments are required to keep a current, active hiring list because of their civil service rules or union contract. Even if they do not anticipate hiring, many departments still have to have a current list. Why is that so? Well, just like number one, things can and do change. Additionally, it allows them to get the most current “best-of-the-best” candidates out there. Even though fire departments are facing severe (or potentially severe) budget shortfalls, it does not mean they won’t ever hire again. Departments will have to hire at some time in the future to fill vacancies from retirements, permanent injuries, etc. The question is when, and **the bottom line is that if you are not actively testing and on the current hiring list, you do not stand a chance at getting a badge!**

The financial situation in the State is very dynamic and it is just a matter of time when it gets better (when exactly is anyone’s guess). If you decide not to test because of the budget problems, that is your choice. Many departments **ONLY** hire candidates from the [Firehire](http://www.firehire.com) testing process. So, if you don’t take the test, you don’t stand a chance.

U.S. Fire Administration Seeks a Safer “Home Fire Season” *Fatal Home Fires Jumped Nearly 68% during Cooler Months*

Release Date: November 13, 2008

WASHINGTON, D.C. – “Home fire season” starts now, and the U.S. Fire Administration (USFA) is working to make this year’s cold months safer than last years—when there was a dramatic increase in home fire deaths. According to the USFA, during the “home fire season” of October 2007 to March 2008, there was a 68% increase in the number of fatal home fires and a 67% increase in the number of people killed in home fires, compared to the warmer months.

Not including arson-related deaths, from April 2007 through September 2007 at least 589 people were killed in home fires. When it became cooler, from October 2007 through March 2008, at least 982 people were killed in home fires.

Through its **Smoking & Home Fires Campaign** - www.usfa.dhs.gov/campaigns/smoking/, the USFA wants to make this season safer, especially as it relates to the number one cause of preventable home fire deaths in the nation -- fires caused by smoking materials.

“Every year, about 1,000 people are killed in smoking-related home fires,” says U.S. Fire Administrator Gregory B. Cade. “Smokers tend to smoke inside their homes more often because it’s cooler outside, so what’s important to remember is that smoking home fires can easily be prevented.” He added, “It just takes a few seconds to light up – and a few seconds to make sure that cigarette is really out.”

During this time of the year, the use of holiday lighting, ornamental candles and space heaters also raises the risk of home fires.

Here’s what you can do to prevent a smoking home fire:

- If you feel you must smoke, it's better to smoke outside.
- Inside the home, use big ashtrays with a stable base.
- Really put the cigarette out, don't just tap it into the ashtray.
- It's not a good idea to smoke if you are drowsy, and never smoke in bed.
- If people smoke while at your home, check for cigarette butts near the furniture and under sofa cushions before you call it a night.
- Douse butts and ashes with water before you toss them into the trash.
- If you or someone in your family smokes, **Put It Out. All the Way. Every Time.**

The USFA has **materials for consumers, firefighters, and the media** – www.usfa.dhs.gov/campaigns/smoking/materials/index.shtm including a video demonstrating how fast a smoldering cigarette can ignite and consume a room.

Through its *Smoking & Home Fires Campaign*, the USFA is reminding smokers and those who live with smokers to make sure smoking materials are properly extinguished and that they “Put It Out. All the Way. Every Time.”

USFA data show that one-in-four people killed in home fires is not the smoker whose cigarette caused the fire. In fact, 34% were children of the smokers and 25% were neighbors or friends of the smokers. Most smoking-related home fires happen on beds, furniture, or in trash when smokers do not put cigarettes all the way out, toss hot ashes in the trash or fall asleep while smoking. Launched in January 2008, the USFA's *Smoking & Home Fires Campaign* is working in partnership with 16 national organizations to spread the message about fire safety including the:

FAQ – NFA Vacancy Lists

Q: Why are there vacancies at the National Fire Academy? Are enrollments down?

A: Enrollments in the National Fire Academy (NFA) are actually up. Last year, in cooperation with our State training partners, our on-line training at NFAOnline, and in our resident and off-campus delivery program, the NFA reached 108,000 fire service professionals. In 1995 we

trained just 15,000. Like every college, we plan our academic year based on last year's enrollments, the number of new courses on the schedule, waiting lists for current courses and the calendar and our best estimate of the demand for courses the following year. It's not an exact science.

Vacancies occur for any number of reasons – some classes have low demand because the number of fire department members doing that job is low (e.g. public educators, data analysts, training, plans review, budget), but these courses are in many ways critical to the success of fire and life safety and the administration of the fire department. Other times we may overestimate the demand. When that happens, we cancel a low-demand course, move the enrolled students into another delivery of that course and use the funds to run an additional high-demand course.

Q: It seems that I'm hearing more about vacancies than I ever have in the past. Why is that?

A: Well, you are. Before widespread communication using web sites and email, the NFA relied on last minute telephone calls to fill seats. We couldn't announce the vacancies in sufficient time to get the students here to campus. Now, with improved communications, the increased membership and support of the Alumni Association and the participation of many of the fire service organizations, we distribute vacancy announcements in a matter of minutes. It is working very well.

What you are seeing, though, is only the vacancies. We never send out the list of classes that are already filled and have a waiting list. The lists show only the few vacancies we have.

Q: I don't apply during the application period, I like to wait to see what classes have vacancies before I apply, is that a good idea?

A: NO! The first requirement for a student's eligibility to attend the NFA is their current job responsibility (Box #16). If you wait, it is likely that the courses you qualify for will be filled by others in the normal application process. When that happens, you lose the best chance you had to attend the NFA. Worse, if applications are low, the class you seek may be cancelled. The most useful and valuable course for you may never show up on a vacancy list. The better strategy is to apply during the normal application periods (May 1- June 30 and Nov 1 to Dec 30). Remember, if you qualify, you may apply for two different courses in the same semester (using a separate application for each); however, you will only receive a stipend for one trip per fiscal year (Oct 1 through Sept 30)

Q: Why are there waiting lists and vacancy lists at the same time?

A: Our courses are academically rigorous, and every class is considered mid- to upper-level college course work. It is important to ensure that each student is capable of success in the course before being admitted.

Students are accepted to the NFA based on the 'target audience' criteria listed in the catalog. We want to make sure that the course is a benefit to both the fire department and the students when they return; and is of sufficient complexity to advance the student's

knowledge to improve local service delivery. Students who do not meet the 'target' criteria would slow the class down, and expose the student to possible failure.

It is more important to fill a seat with a qualified student than it is to simply fill a vacancy. This ensures success for the department, the student and the rest of the class.

Q: What is the most frequent cause of application rejection?

1. Used the wrong application. For resident courses, applicants should submit the long form (75-5) application which requires the chief's signature
2. Didn't fill out the application completely
3. Didn't sign the application, or have the Fire Chief sign the application
4. Failure to describe your activities/responsibilities as they relate to the course for which you are applying and identify how you will use the information obtained from the course. (Box 16).

Q: Any suggestions to increase my chances of success?

A: On our website, there is a document that provides eight "tips" for completing a successful application. It only takes a minute – but will dramatically improve your chances for success:

FIREFIGHTER EMPLOYMENT OPPORTUNITY – CAL FIRE:

The **California Department of Forestry and Fire Protection (CDF)** – now known as **CAL FIRE**, is now accepting applications for **Firefighter I**. Applications will be accepted **until January 30, 2009** for the 2009 fire season, which generally starts in the end of May and generally goes through October. If you are interested in applying you must complete a Firefighter I application (CAL FIRE Form 215) and mail it or deliver it in person to the North Coast Region I and Cascade Region II units (see next page for locations). Applications will be accepted on a file in person basis only for the units in Southern California Region III and Central Sierra Region IV. Applications must be filed at each unit in which you wish to be considered for appointment.

There are 21 units through-out the state and they are divided between two regions, North Region, and South Region. In the Northern Region you can mail the completed application to each unit that you are interested in applying for. In the Southern Region they must be hand delivered. A list of the units can be found at the end of this announcement.

What you can expect working as a firefighter for CAL FIRE:

A firefighter 1 is a temporary position. You work a 72-hour workweek, four days on and three days off. You work the same four days in a week. Your responsibilities will include responding to vegetation fires, vehicle fires, structure fires, vehicle accidents, medical aides, public assist calls, or any other emergency. You are responsible for maintaining equipment and tools, following oral and written directions, cooking and cleaning around the station and other duties as assigned. At some stations you may get only one call per shift and others may get as many as four or five calls on a busy day.

Because CAL FIRE is a statewide fire department, you can get sent to any area within the state on a strike team assignment. You may only be gone one or two days or as many as fourteen days depending on the needs throughout the state. You may be assigned to an incident, usually a large fire, or may be assigned to cover behind other engines on an out-of-county assignment.

In addition to being assigned to working on an engine, a firefighter 1 may be assigned to work at an Air Attack Base refueling aircraft, and reloading tankers with retardant. Another opportunity that is available to firefighter I is to work as a helitack firefighter assigned to one of nine helicopters throughout the state.

There is the opportunity to work as a fire fighter assigned to a Schedule A Contract. This is where a city, county, or fire protection district makes a contract with CAL FIRE to provide fire protection for the community. For example in the Santa Clara Unit, the South County Fire Protection District has contracted with CAL FIRE to provide the personnel to operate their fire department. As a result CAL FIRE personnel operate very much like any other municipal department with firefighter, engineers, captains, and chiefs, operating type I engines, and providing advanced life support medical care.

The hiring process:

After submitting an application, it is reviewed and given a preliminary score based on your education, training and experience. The more boxes you can check the more points you can get. By mid March you should receive a letter indicating weather you passed the preliminary evaluation. If a passing score is given you may then be invited to an interview. The interview is 100 percent of you score. Because each unit must follow the same guidelines for hiring you can expect to hear the same, or close to the same questions at each interview. This can be a big help when trying to improve your interviewing skills. So the more units that you apply to the better chance you have to interview and improve.

Typically an interview panel is made up of an engineer and a captain. In some cases at the completion of your interview you are given your score, in other cases it is mailed to you. Your score is based from 0 to 100 points. Typically you need to get a score in the upper 90's to be considered for employment. By mid May you should have received a letter indicating weather or not you are being considered for employment. From here one of a number of things can happen, you could get a letter stating that you will not be considered for future employment, or you can be contacted and offered a job, or you could be contacted and offered a slot in an academy but not a job.

The presumption is that a position may open up in the future and you would already be trained to take it. Typically a new hire academy is scheduled for the first or second week in June and consists of learning basic skills needed to work as a fire fighter. The end result is that by attending the class you can obtain the CAL FIRE 67 hour Certification.

What generally happens around August or September is some firefighters quit and go back to school opening up position to hire more firefighters. So this provides some people second chance to get hired. If you stay in contact with the hiring coordinator in each unit and are willing to start later in the season you might get picked up as a late hire. After you get hired with CAL FIRE and work three months you have automatic rehire rights. Meaning you don't have to go through the same process to get hired the next season.

What CAL FIRE can offer you?

CAL FIRE is an all risk fire department. They respond to an average of 6,400 wildland fires annually and more than 275,000 non-wildfire emergencies each year. As a firefighter I you will gain experience in working on an engine as part of an engine company. You will get

experience working at emergencies under stressful situation. You will learn what station life is like and how to work with people of different backgrounds in that environment.

You will have the opportunity to earn additional certifications including Incident Command Systems, Confined Space Rescue Awareness, Haz Mat Operations, Swift Water Rescue, Auto Extrication, and many other classes. You will gain experience working with the ICS system as part of an engine company at small and large incidents.

Just like anything else you can get out of CAL FIRE what you put in. Because of the number of people retiring you have a very good opportunity to gain a permanent position if you put the effort into it. It is now up to you to make the first step.

 - a. If you have never heard what about a Thomas Guide Map, then you have missed out on a valuable resource. Thomas Guide Maps produce maps of specific counties throughout California and most of the United States. Thomas Guide Maps can be found at any major book store chain or on their web site at www.thomas.com – take a look to see for yourself. If you are a Costco member, they usually have them available for a very reasonable price.
 - b. Why are they so valuable?
 - **Number 1** – to become a firefighter, you are probably going to be doing a great deal of driving around the area if not the state and you'll need a map anyway.
 - **Number 2** – when you take a test for a fire department, you should be doing some basic research such as stopping by fire stations or determining what types of target hazards are found in a community, etc. Besides target hazards, Thomas Guide Maps list every governmental facility such as fire stations, police stations, city hall, etc. These maps can do a portion of your homework for you!
 - **Number 3** – they are in a book format, thus they won't be easily damaged like regular fold-out maps will.
 - **Number 4** – since many fire departments and ambulance companies use Thomas Guide Maps in their vehicles, you will be getting a leg up on learning. Reading maps is almost like a lost art in the fire service. Many of the new firefighters we are hiring cannot read a map to save their life. When

someone calls 911, we don't have every address memorized in our head – 99.9% of the time, we have to use a map to find the address. Start your training now!

- c. What types of maps do they sell? They usually produce a map of a county or multiple counties, such as:
- Alameda County.
 - Contra Costa County.
 - Los Angeles County
 - Sacramento County.
 - Multiple counties, such as Alameda County and Contra Costa County or Orange County and Los Angeles County (Best value – 2 counties in one book).
 - Bay Area Metropolitan Area – All bay area counties in one book (Excellent value).
 - State of California (an excellent book to supplement your other county books).

Additional items geared for your friends and family members to help ensure they remain safe and sound year round!

- Smoke alarms
- Fire extinguishers (car and home)
- Emergency escape ladders for the home
- Whistle and lanyard
- Carbon monoxide alarms
- Childproofing and safety latch, gate and lock items
- Earthquake and disaster supplies (food, water, self-help)
- Cordless telephone for the pool area
- New large reflective numerals for a home address
- Anti-scald and non-slip devices for the bath and shower
- First-aid kits
- CPR mini-mask (to provide a barrier instead of true mouth-to-mouth resuscitation)
- Registration for a free Community Emergency Response Team (CERT) class with the local fire department
- First aid and CPR training
- Sturdy work gloves, goggles, and face mask

- An automotive safety check by a certified mechanic

CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter. Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also

look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas.

Basic Information For The CPAT Test

QUALIFICATIONS:

Applicants must be 18 years of age and must show government issued photo identification (i.e. drivers license, school or military ID; or a passport or visa). Candidates without a photo ID will not be allowed to take the CPAT.

APPLY EARLY

Applications are accepted in the order they are received. Applications are not accepted until the fee has been paid.

PAYMENT:

The fee to take your first test at their site is \$150.00. Your fee must be paid for your application to be accepted. This fee is non-refundable. Payment can be made with check, money order, Visa, or MasterCard. If you are paying by check, the check must clear your bank before you can take the CPAT. Make payments to “CFFJAC.” Your fee includes participation in an orientation session, related printed materials and test.

ORIENTATION SESSION:

Working with experienced CPAT proctors, you will be given the opportunity to try each of the 8 events and determine where you may need to strengthen yourself. You will be given a set of exercises to physically prepare yourself for the CPAT. If you elect not to participate in the orientation, you will be required to sign a waiver acknowledging that the orientation was offered. There are no discounts if you elect not to participate in an orientation. The CPAT dress code is enforced for all candidates who attend an orientation.

TEST:

The registration form has a place for you to choose a preferred and second orientation day as well as a preferred and second test day. You will be notified by mail of the confirmation of your orientation and test dates. A group of candidates are scheduled every half hour to report to the CPAT center. Please be on time, but not excessively early. Space for waiting is limited. If for some reason you cannot attend your scheduled test day, please notify us as soon as possible. Every effort will be made to reschedule you to a test day that will fit your schedule.

RETESTS:

If you have taken the CPAT at a CFFJAC monitored venue in the past and would like to retest, the fee is \$100.00.

PRACTICE SESSIONS:

For \$25.00, you can schedule a supervised practice on the CPAT course with a proctor. Your session is designed to meet your individual needs. A session may include: Training on the CPAT equipment, watching the instructional video, going through the course in its entirety. You also receive the benefit of mentoring: techniques, expert evaluation and conditioning

advice from our CPAT proctors. Refunds for cancelled or rescheduled practice days will not be given if requested after 10:00 am the day before your scheduled practice day.

WHAT TO WEAR:

The dress code is strictly enforced for safety. The CPAT dress code for the orientation, practice sessions and test is: Long Pants (no shorts), T-shirt or sweatshirt, footwear with no open heel or toe, and no loose or restrictive jewelry. Candidates must be in proper CPAT attire before being allowed to participate in the orientation, practice sessions and test.

PARKING:

When you arrive at the CPAT center, please park to the rear of the building and enter the front door.

NO SPECTATORS PLEASE:

There is limited space at the CPAT center. In order to accommodate a fair and standard testing process for all candidates, we will not be able to allow spectators on the CPAT course or in the facility.

Water-Based Fire Protection System Plan Review (P136) Pilot Course Scheduled at NFA

The United States Fire Administration (USFA), Department of Homeland Security, is recruiting students and instructor candidates to attend an on-campus pilot class for its new six-day off-campus or State enfranchised course ***Water-Based Fire Protection System Plan Review***.

The course will enable students to perform a plan review to evaluate the suitability of the fire sprinkler, pump, and standpipe plans and calculations in accordance with nationally recognized standards for design and installation. Course content covers fire protection standards, plan reading, water supplies, building envelope features, fire protection hydraulics mathematics, fire pumps, sprinkler systems, and standpipe systems.

The pilot will be delivered at the National Emergency Training Center (NETC) in Emmitsburg, Maryland March 29 to April 3, 2009. Students will arrive Saturday March 28 and depart Saturday, April 4. Other than this pilot, there are no plans to offer this on campus at the National Fire Academy.

Pilots are highly participatory among the instructors, course developers, and students. Attendees are expected to contribute their ideas and expertise to improve course content and delivery.

Target Audience

The target audience for this course is the student who is responsible for the review and approval of plans for water-based fire protection systems in his/her jurisdiction.

Student Selection Criteria:

Individuals who have code enforcement responsibilities for the review and approval of plans for water-based fire protection systems in his/her jurisdiction.

Priority selection will be given to **those applicants who express interest in and meet minimum qualifications to become course instructors**. The suspect eventually crashed Riggins' vehicle and was attempting to carjack a third vehicle when police approached and, in an exchange of gunfire, killed him.

ALABAMA LINE OF DUTY DEATH UPDATE:

More preliminary information is coming out related to the tragic **LODD of Crossville (AL) Firefighter Adam Cody Renfroe** who is being laid to rest, today. This info, while preliminary, helps us all further understand what may have lead up to this loss and is of great value by discussing what is known and applying it to our own local scenarios.

Asbury Volunteer Fire Chief Albert Childress, who was at the scene Wednesday, said he understands that Firefighters Renfroe and Andy Brown were the first to arrive at the working house fire...neighbors already had helped the home's elderly owner escape the dwelling, unharmed. It is Chief Childress' understanding that FF Renfroe said, "Let's go check it out."

FF's Renfroe and Brown, wearing turnout gear, air packs and stretching a hose line, approached the house. With heavy smoke and fire showing, the two volunteer Firefighters, according to Chief Childress' information, approached the door when FF Renfroe asked Brown to return to the truck and get a light. When FF Brown returned, FF Renfroe was not there but the hose line was still there lying on the ground...causing concern about FF Renfroe's whereabouts. Fire conditions continued to worsen at the same time, making entry into the dwelling tough...and with no hose leading to Renfroe's possible location, information and help for the trapped Firefighter was delayed. Chief Childress said other area firefighters, waiting on standby at other fire stations were said to have heard over their radio FF Renfroe's pleas of "**Y'all come get me.**"

Based on statements of witnesses at the scene, because of the intense heat, it took about 45 minutes before Firefighters were able to reach FF Renfroe who had by that time, gave his life. In a tragic irony, Renfroe's dream of being a firefighter with a larger FD would have been realized Friday. He had applied and been accepted by the Irondale FD and was scheduled to begin his rookie training with them. May FF Renfore rest in Peace.

Unfortunately there have been 2 more **fatalities involving responding apparatus**. In what appears to be an unavoidable situation for the Firefighters in Bethlehem, PA, where a 60-year-old man whose car collided with BFD apparatus Oct. 24 died Saturday night in the hospital.

William Samer was pronounced dead at 9:48 p.m. and died of multiple traumatic injuries. Bethlehem police Capt. David Kravatz on the day of the accident said the ladder truck had its lights and sirens activated at the time of the crash. The car did not yield as the engine

headed north on Eighth Avenue in Bethlehem....Samer passed several cars that yielded the right of way to the fire apparatus, then swerved, spun and struck the fire apparatus just north of the Route 378 overpass. The apparatus, responding to an alarm call, was driving in the opposite travel lanes in order to bypass traffic in the northbound lanes, according to police. The apparatus driver, FF Frank Dashner, 50, of Bethlehem, was treated and released that same day.

And across the pond in England, **a civilian died after his car collided with a responding fire apparatus** last night. The driver was pronounced dead at the scene while a Firefighter injured in the crash was taken to the hospital. East Sussex Fire and Rescue Service confirmed the fire engine was on an emergency call when it was involved in the accident. Sussex Police Road Policing Unit is investigating.

RHODE ISLAND LODD: A Firefighter in Bristol (R.I.) died in the Line of Duty early Monday. Volunteer FF Wayne Brown called for EMS for himself while getting ready to respond to a call. FF Brown, 63, was found near his door with his gear on. The cause of his death was not immediately known. FF Brown was a longtime volunteer at the Hydraulion fire station as a member of the fire police. FF Brown was responding to a fire call for a car fire....a man's body was found in the car...the fire is under investigation. Our condolences to all affected.

HOUSTON FIREFIGHTERS INJURED, 1 CRITICAL, both burned.

Earlier this evening, while operating at a dwelling fire, a portion of a roof reportedly came down on 2 Houston (Texas) Firefighters. Reports are that at least 1 FF was in cardiac/trauma arrest, was rescued/revived but was critically injured with burns over his upper body and head. The 2nd Firefighter suffered burns to his hands. Both are being treated. The event and subsequent injuries may have been received during a flashover. Details will follow.

PA FIREFIGHTER CRITICAL:

A teenager (home on school suspension!) watching a working fire from her home porch, noticed a Firefighter down at a corner who had been pumping an engine. The 17-year-old jumped off the porch of her Middletown house across the street from the burning home and hustled toward the firefighters who were battling the blaze and had not noticed the pump operators collapse. Firefighters responded and started performing CPR and used an AED on Steve Weaver, a Lower Swatara Twp. Firefighter....saving his life. He is in critical but stable condition at Milton Hershey Hospital.

An off-duty **Firefighter** working his regular job as a **Police Officer** was killed in a crash on Interstate 70 in Western Pennsylvania yesterday afternoon...reminding us of the serious dangers when operating on roadways. **Nathaniel Burnfield, 27, a South Strabane Township police officer who was also a local Firefighter, was tragically killed in the Line of Duty.** Officer Burnfield was also a Firefighter for the Canton Township Fire Department. A civilian truck driver was also killed. A pickup truck apparently lost a tire...and it appears a UPS tandem tractor trailer hit that tire....Officer Burnfield pulled over to help, seeing the debris in the road...when a gravel truck lost control and hit the back of the UPS truck. P.O. Burnfield had been returning from training in a marked police car and stopped to help remove the tire from the road. Officer Burnfield activated the lights on the cruiser and was attempting to move the tire when he was hit. The truck had been traveling west on Interstate 70 and attempted to go around the right side of the police cruiser when his vehicle struck and killed Burnfield.

HOUSTON UPDATE: Captain Darin Unruh remains in serious but stable condition after he was injured while operating at a 2 alarm fire that destroyed a house Monday. Capt. Unruh suffered third-degree burns and smoke inhalation in the fire. Firefighter Dennis Valencia, who suffered 1st and 2nd degree burns, was released from the hospital. Reports now are that it appears a section of the roof collapsed, sending a wave of flames and superheated gases toward the less-damaged back portion of the home where Unruh and Valencia were. Unruh and Valencia went in through the back door after receiving reports that someone may have been trapped inside the dwelling.

FALLEN FIREFIGHTER HAD EXPRESSED CONCERNS:

An experienced Irish Firefighter, who was killed in the Line of Duty with his partner, had warned superiors weeks before they died, of his concerns related to the practices of the local fire service. FF Brian Murray, 46, died with FF Mark O'Shaughnessy, 26, in September 2007 after they became trapped inside a vacant factory fire in Bray, Wicklow County. The Firefighters families claim there was a delay in responding to the fire and believe this was a major factor in the two men's deaths. FF Murray had written to the county's Assistant Chief Fire Officer 3 weeks before he died after office workers were asked to check a fire themselves before Firefighters were dispatched-creating concerning delays. Authorities continue to investigate the deaths.

FIREFIGHTER INJURY REPORT:

The NFPA has released their 2007 Firefighter **INJURY** report. Over 80,000 Firefighters were injured last year but there has been a **measurable decrease**. The report points out loads of interesting and valuable facts such as 38,340 or 47.9 percent of all firefighter injuries occurred during fireground operations. An estimated 15,435 occurred at non-fire emergencies, while 13,665 occurred during other on-duty activities

In another example of a Firefighter attempting to do good, there was a fatal shooting in St Louis County (MO) involving an off-duty Fire Captain, 52 year old Leonard Riggins, of St. Louis Fire Department tonight. The Captain Riggins died at a local hospital, the suspect died at the scene. Cops believe there were as many as four car jackings over a 15-minute period. The first carjacking occurred in a person's driveway...the bad guy took off but eventually crashed the vehicle.

The Fire Captain came upon the crash scene and attempted to help the carjacker...the carjacker then shot the Fire Captain in the chest and took his car. The murderer then crashed again and attempted to carjack another person. He then got involved in a shootout with police and was shot dead in the middle of the street.

Tragically, Captain Riggins gave his life trying to help, in what he thought, was someone genuinely needing help...but thankfully, the murderer himself was gunned down by the police stopping him from any further action. Our condolences to Captain Riggins' Family and friends.

FIRE SERGEANT CRITICAL AFTER FALL FROM ROOF:

A Detroit Firefighter is in serious but stable condition tonight after he fell off the roof of a burning vacant home overnight. The Fire Sergeant, with at least 15 years' firefighting experience, suffered multiple broken bones when he fell at the fire on Detroit's southwest side.

MAYDAY RADIO TRAFFIC FROM NEW YORK:

Rochester Firefighters responded for a house fire early Wednesday morning. Engine 7 was on location with smoke from the rear of a large three story row house. Battalion 2 called for the second alarm...a Firefighter mayday was called for a Firefighter in trouble on the second floor rear. Operations confirmed the mayday and deployed the RIT team to assist the firefighter to safety. Upon hearing this mayday, command called a third alarm and the fire was under control in about 40 min. Monroe County Fire Wire has the radio traffic on this link and LISTEN to the SHARP dispatch and fire operations on this fire.

The five firefighters suffered minor injuries in the crash, and a 55-year-old woman and a 6-year-old girl in the car were also injured. All seven were transported but none of the injuries appeared life-threatening.

The reason The Secret List exists is to pass along details and facts of interest to you as a Firefighter or EMS member, usually specific to Firefighter Close Calls, Near Misses and Line of Duty Deaths. While the information is of varied levels of interest, the true intent of the 11+ year old Secret List is to "pass along" details ..so we can all learn. We all respond to and see alotta bad stuff, and in some cases, the most horrific situations and outcomes. Sometimes the incident is "by accident" ...but other times it is totally avoidable-for us or for

those who impact us. Sometimes what we write about to you is so avoidable that it infuriates all of us. We have also written about the impacts of drunks on the fire service-and within the fire service and the impact on us before...here we go again.

2 nights ago in Illinois, a young mother and her two little kids were killed in a t-bone crash Thursday night. The crash took the lives of Amanda Jahn, 27, and her children, Ryan Jahn, 3 years, 11 months old, and Kaitlyn Jahn, 11 1/2 months old....**the ENTIRE FAMILY of Dwight (IL) Firefighter Josh Jahn.**The driver of the car that struck the Jahn vehicle, Ann Marie Goetz, 43 was transported to the hospital, where she remains a patient....she has already been charged with blowing a stop sign and felony driving while drunk.

"Firefighters Wife" Amanda Jahn was heading home with her kids. Imagine your family doing that. It's easy-every family does that. Where were they coming from? Amanda was a violinist...she was on her way back from teaching lessons and had stopped at her Mom & Dad's house to pick up the kids and go home. That's when **"Drunk Driver"** Goetz's car shot through the stop sign and struck the Jahn family on the driver's side door. Following the violent t-bone crash, the Jahns car rolled over multiple times....Amanda was trapped inside the vehicle...the 2 children, Ryan and Kaitlyn were **EJECTED IN AND FROM THEIR CAR SEATS...and Mom WAS WEARING HER SEATBELT...**but it couldn't save them from the drunk driver. The crash actually ripped the Jahn car apart into multiple pieces.

As we have also heard before, Veteran Drunk Driver Goetz has a lengthy criminal record, including prior DUIs dating back to 2000. Most of us are all very familiar with the impacts of a Firefighters death, in this case, this death will all but take the life of Firefighter Josh Jahn.

3 Quick Points:

1-If you are interested in expressing your condolences, the FD sent us FF Josh Jahns e-mail address, which will be checked and passed along to him....so if you wanna send a few words, here ya go - jjahn@dwrightfire.org

2-The holiday season is just about here. And while we are always at risk on this job, operate on or off the job extra defensively this time of year because of the drunk drivers.

3-Us. "Us" also are familiar with "us" drinking and driving ...mostly off the job, but sometimes even on the job in the firehouse. Don't ignore it. Don't allow it. Speak up. Stop it. Know a FF with a problem? Get'm help...do whatever it takes. You into the "Brotherhood" stuff? Cool. Prove it. We aren't saying don't have a drink when off duty-we are saying if "us" are ever drinking, we cannot ever drive. And "us" needs to look out for "us". The on-duty issue speaks for itself, hopefully.

The "drinking" issue-internally or externally has impacted Firefighters throughout our entire history...and again most recently, at the above "firefighters deaths" -the preventable deaths of FF Josh Jahns' Family.

Our sincere condolences to FF Josh Jahn. What a nightmare.

Two Philadelphia Firefighters fell through a thin fiberglass roof while operating at a 1 alarm fire last night. The fire was at an auto body shop and the run came in around 2111 hours...and was placed under control at 2137 hours. When Philly Firefighters went up on the roof, they may have miscalculated the thickness of the roof, which turned out to be made of fiberglass and only a couple inches thick. One firefighter broke thru and fell all the way through, about 15 feet and landing. He was transported and is listed in critical condition. Philly Fire officials said while his injuries are pretty severe, he is expected to survive. The other Firefighter fell partially through the roof and was also taken in with minor injuries. The cause of the fire is under investigation. We'll post more on our home page.

And in Newton (MA) last night, a Firefighter suffered minor burns and injured his shoulder after he fell through the floor of a million-dollar home fire. The Firefighter, who also had elevated carbon monoxide levels, was kept overnight at the hospital and is expected to recover. A second Firefighter twisted his ankle and was treated at the scene. The house had just been renovated and was unoccupied and appears to have begun in an electric meter and is not considered suspicious.

As posted on our home page yesterday, to be clear, the incident yesterday in Pennsylvania involved a piece of apparatus being delivered-NOT an in service rig. The man was struck and killed by a New Jersey FD's brand new aerial ladder truck in Monroe County, PA. The circumstances were pretty unusual-workers at a nearby vineyard saw the car go airborne then bounce down an embankment and slam into an iron gate and stone wall at the winery. The workers said a man staggered out of the car. They called 911 and told the man to stay put, but he refused their help and crawled back up the embankment...the man, now a "pedestrian" was then struck by the rig on the highway. The apparatus is brand new and has yet to be added to the fleet of the Passaic, NJ FD. A vendor was driving it from a Pierce Manufacturing plant to N.J., where it was going to have final work done before being delivered to the FD.

PHILLY FIREFIGHTER CRITICAL:

A Philadelphia FF remains in critical condition after surgery where doctors were treating him for soot inhalation, broken ribs and a broken arm, according to Fire Commissioner Lloyd Ayers. FF Raymond Rajchel, a 34-year veteran, and firefighter Robert Underwood, a 23-year veteran, fell through a roof late Wednesday while operating at a fire inside an automotive-repair shop.

FF Underwood was treated for bruising and released...he caught himself as he fell, and colleagues rescued him as he dangled 20 feet above the concrete floor where Rajchel lay injured. Both work at Ladder 28 and were venting the garage's roof when the incident occurred. Our prayers go out for his quick recovery.

As per Prince Georges County (Maryland) Fire/EMS PIO Mark Brady, about 11:30 hours this morning, Prince George's County Firefighters were alerted to a house fire in the Riverdale Heights area. Fire/EMS units arrived at 6318 57th Avenue and found a 1-story single family home with light smoke showing from the front of the house. The engine from Riverdale Heights (813) arrived first and advanced a hoseline to the front door and then paused, to don their PPE and SCBA. The house was vacant and a small fire could be seen in the front living room. The ladder truck from Riverdale (807) was the second to arrive, almost at the same time as Riverdale Heights. The crew from Truck 807 donned their PPE and SCBA and entered the dwelling to begin ventilation by removing windows. As the engine crew from November 22, 2008

Riverdale Heights prepared to enter the structure and extinguish the fire, their hoseline sustained damage from glass or debris and broke; rendering it useless. As additional arriving companies stretched another hoseline into position, a flashover occurred. The flashover occurred with the crew from Truck 807 inside. The crew quickly exited the structure, some requiring assistance from other firefighters. The fire was then out in about 10 minutes. 2 Firefighters sustained burn injuries and were transported to a Burn Unit.

Fire Fighter Anthony "Tony" Blazek, 27, and a 3-year volunteer member of the Riverdale Fire/EMS Station sustained 2nd and 3rd degree burns about his face, neck and back. He has been admitted to the Burn Unit at the Washington Hospital Center. His burn injuries are serious, however, not life-threatening.

A second firefighter, Cory Johnson, 23 years-of-age, 6-year volunteer member of the Riverdale Fire/EMS Station sustained minor burn injuries and was treated and released from the Burn Unit. Fire Investigators believe the fire started in a couch and was caused by vagrants improperly discarded cigarette. Fire loss is estimated at \$25,000.

We have posted several images on our home page (provided by PGFEMS PIO) taken by Probationary Volunteer Member Tony George of Riverdale Heights 813. He was on the first arriving engine and snapped the pictures in sequence. Additional details and links to follow. Our sincere wishes for FF Blazeks rapid recovery.

As of this afternoon, Riverdale (Prince Georges County, MD) Volunteer F/F Anthony Blazek has been moved out of ICU and to a regular room at the Burn Unit at Washington Hospital Center. FF Blazek will have to remain hospitalized for a period of time and will undergo skin graft surgery on Monday for burns on his face, neck and shoulders. There are no serious respiratory problems as he did have his mask on, according to Chief Ryan, of Riverdale. It is unknown when FF Blazek will be released from the hospital but he will have a lengthy recovery time. His family along with his Brother and Sister Firefighters have been by his side to support him.

FF Blazek is able to receive visitors from 1100 - 2100 daily, room number 3E-8, MedStar-Washington Hospital Center. The other injured member, FF Cory Johnson is resting at home after being released from the hospital ...but will be further evaluated later this week. Thanks on behalf of the Riverdale VFD and Prince Georges County FD to all who have offered support and well wishes.
