## **National Fire Academy Open Enrollment**

The student application period for National Fire Academy second semester classes (April 1 to September 30, 2012) is now open. The application period closes December 15, 2011.

**The National Fire Academy offers several new courses this year:**

- **Hot Topics Research in Emergency Medical Services (R139)**. Students in this six-day course will research emerging issues in EMS to identify, promote, and embrace system or service improvements. The course is structured around how to make persuasive justifications through effective data collection and presentation using a wide variety of research methods. Students will construct a program proposal or progress report for presentation.

### Chabot College Fire & EMS News

- **Electrical Aspects of Fire Investigation (R255)**. This six-day course helps investigators properly and effectively electrical systems and related component to determine their role in fires. Topics include a basic explanation of electricity, electrical circuits and distribution systems, electrical faults and failures, and how NFPA 70, National Electrical Code applies to fire investigations. Students will learn the skill of arc mapping to aid in determining fire causes.
- **Hot Topics Research in Fire Protection (R138)**. What's new in fire protection? This course is intended to identify new and emerging issues, products and trends that may apply to local jurisdictions. Students will learn how to conduct research, evaluate technological and human behavior topics, and present the material in a meaningful way to effect change to reduce fire losses or enhance understanding of new technologies.
- **Cultural Competence in Risk Reduction (P394)**. This six-day course seeks to improve cultural and linguistic determinants within the application of risk reduction strategies. The first pilot class is scheduled to be delivered Sunday, December 4 through Friday, December 9, 2011. The second pilot is scheduled to be delivered January 29 through February 3, 2012.

Decorating for the winter holidays is fun but can lead to tragedy if you don't practice fire safety. Following a few simple fire safety tips can keep electric lights, candles, and the ever popular Christmas tree from creating a tragedy.

- Don't place your live Christmas tree close to a heat source, including a fireplace or heat vent.
- Keep the tree stand filled with water at all times.
- Never put tree branches or needles in a fireplace or wood-burning stove.
- Inspect holiday lights for frayed wires, bare spots, gaps in the insulation, broken or cracked sockets, and excessive kinking or wear before putting them up.
- Use only nonflammable decorations.

**FEMA Administrator Fugate Lauds Senate Confirmation of Ernest Mitchell as U.S. Fire Administrator**

WASHINGTON - Federal Emergency Management Agency (FEMA) Administrator Craig Fugate today praised the Senate for confirming Ernest Mitchell Jr. as the Administrator of the U.S. Fire Administration (USFA). USFA, a component of FEMA and the Department of Homeland Security (DHS), is the lead federal entity responsible for providing support to America's fire departments and fire services organizations. "With decades of experience fighting fires and leading fire service organizations, Chief Mitchell will be a great addition to our team at FEMA and a tremendous asset to firefighters and first responders around the country," said Fugate. "As with our other senior leaders at FEMA, he comes from a state and local background, which means he understands the kind of support

our nation's fire departments and fire service organizations need. He will be a tireless advocate for firefighters and the communities they serve and I look forward to working with him."

Mitchell, a retired fire chief, has more than 33 years of experience working in the fire service at the federal, state and local levels. He is a past president of the International Association of Fire Chiefs (IAFC). Prior to retiring in 2004, he served as the Fire Chief and Assistant Director of Disaster Emergency Services for the City of Pasadena, California, Fire Department. He previously served as Fire Chief and Deputy City Manager of Monrovia, California, and also served as a Battalion Chief for the City of Compton in California. In addition to maintaining his active membership in the IAFC, Mitchell currently serves on the International Association of Firefighters Hazardous Materials Advisory Board and the International Fire Service Training Association Executive Board. Mitchell holds an A.S. in fire science from Long Beach City College, a B.P.A. from the University of San Francisco and an M.P.A. from California State University at Northridge.

## **USFA Releases 2010 Fire Estimate Summary Series**

EMMITSBURG, Maryland — The Federal Emergency Management Agency's (FEMA) U.S. Fire Administration (USFA) issued the 2010 **Fire Estimate Summary Series** today which presents basic information on the size and status of the fire problem in the United States as depicted through data collected in USFA's National Fire Incident Reporting System (NFIRS). The data summary series was developed by USFA's National Fire Data Center and is further evidence of FEMA's commitment to sharing information with the American public, fire departments, and first responders around the country to help them keep their communities safe.

"The fire estimate summaries serve as a great resource tool for members of the fire service and the public to obtain general information regarding fire issues impacting our nation's communities," said Glenn Gaines, Deputy U.S. Fire Administrator. "It is important to use this information to further reduce the risk of deaths, injuries, and property loss due to fire."

Individual summaries are issued as part of the **Fire Estimate Summary Series** and address the size of a specific fire or fire-related issue as well as highlight important data trends. As part of this series, 17 summaries have been issued presenting basic information on the leading causes of residential building and nonresidential building fires, deaths, injuries, and dollar losses for 2010 and highlighting overall trends in these leading causes for the 5-year period of 2006 to 2010. Additional new and updated fire estimate summaries will be periodically released under this series as future year data become available.

## **INFO FOR FIREFIGHTERS ATTENDING CA COMMUNITY COLLEGES:**

### **Important information for firefighters who attend community colleges in California**

The California Community College Chancellor's Office has implemented a number of changes impacting course repeatability that affect almost all seasonal students and many permanent employees. I will try and summarize, but it is going to be lengthy. What follows are my personal thoughts and comments, and do not reflect the official position of any college or state institution in California (legal disclaimer).

1. Firefighters frequently drop courses mid-semester based on an active fall fire season, or an early hiring rotation in the spring.
2. Prior to the current regulatory change a student could, in theory, enroll in any single community college course up to seven times (different sections of the education code allowed four transcript withdrawals, two fails and a final attempt to pass the course). After that, a student could still petition the college's Scholastic Standards Committee for a case-by-case review, and potentially retake the course one more time.
  - a. As a side note, prior to this change some colleges did not monitor course withdrawals ("W") and students could take and drop a course a dozen times with no negative academic impact.
3. With the current legal change, a student may only attempt/withdraw/complete a course three times (in any sequence) within any college district. Two withdrawals and fail, and you are done.
4. The few (very few) exemptions that existed in the old code language still exist such as forced military deployments or declared natural disasters. Keep in mind that the natural disaster exemption applies to where you live, not where you work. If your town is evacuated and the college is shut down, the exemption applies. If you are sent on a strike-team, the exemption does not apply.
5. Here is the real kicker- **this legal change is retro-active**. Students who already have three withdrawals (or two withdrawals and a fail) for any course will not be allowed to repeat that course within that same college district.
6. The law is in place, but the Chancellor's Office has given community colleges until summer secession 2012 for full implementation. For most California community colleges it will require a massive recoding and programming change to the enrollment management systems. Even if the college's enrollment management system is currently capable of enforcing this change, they will probably wait until next summer to implement the requirement (check with your local college).
7. One argument is "so what, I will just take my English 1A class on the other side of town" (for cities with multiple colleges). This title-5 regulatory change applies to courses within a college district. Most college districts in California have one college, but some of the larger districts have multiple colleges within that district. The three maximum transcribed attempts would

apply to all of the colleges within that district. The college on the “other side of town” may be within the same college district, and you will not be allowed to repeat the course.

8. The next argument is “so what, I will just take my English class in the next closest county which is outside of “my community college district.” Or, take it online on the other side of the state. Use caution, every college has limits related to the number of courses that can be transferred “into” your current college. There are lots of other issues related to transferring courses that go well beyond the scope of this update. Find out what “catalog rights” apply to you (typically that is the catalog that was in effect the year you started at that specific college). If you have not had a break of greater than two consecutive semesters your catalog rights are properly still in effect (varies between colleges). Specific course transfer limitations will be listed in that course catalog (not the course schedule). Check with a college counselor for specifics and recent changes.
9. What does it mean for firefighters in the California Community College system?
  - a. If you have already taken a course three times (in any manner) and those three attempts show up on your transcripts, **and** you have not yet passed the course, next semester is your last chance to take that class (within that same college district).
  - b. In the future, do not enroll in a course unless you are positive you can attend. The drop date for a course (without having a “W” show up on your transcript) is normally between the end of the second and third week of the semester (for a semester based college). Check with your college at the time of enrollment as the drop dates vary between colleges.
  - c. If you do enroll, and it is clear early on that you will not be able to complete the course, formally drop prior to the withdrawal date. Do not assume you will be dropped by the college or the instructor. Make sure you formally drop the course and get a hard copy that confirms that date.
  - d. If you were not able to drop a course prior to the “W” date, consider staying enrolled. Meet with the instructor and review your options. If you can complete most of the work within the semester, the instructor may be willing to assign an “incomplete” grade and you could finish the missed material in the following semester. Instructors are not obligated to assign incomplete grades, and in some courses, (hard sciences) incomplete grades are not a very conducive grading arrangement.
10. One final note, and it is confusing. Everything listed above applies to the number of attempts required to **pass** a course. It does not apply to a different type of repetition related to repeating a course that you have already passed. Some courses (music, arts, and athletics) can be approved at the college for multiple repetitions once a student passes that specific class. While the state is also reviewing that type of repetition, there are currently no changes to repeatability for those courses. What is described above only applies to the initial and repeat attempts to pass a course.

**FIREFIGHTER EMPLOYMENT OPPORTUNITY – CAL FIRE:**

**CAL FIRE**, (formerly known as **California Department of Forestry and Fire Protection or CDF**) is now accepting applications for **Firefighter I**. Applications will be accepted **until January 31, 2012** for the 2012 fire season, which generally starts in the end of May and generally goes through October. If you are interested in applying you must complete a Firefighter I application (CAL FIRE Form 215) and mail it or deliver it in person to the North Coast Region I and Cascade Region II units (see below for

locations). Applications will be accepted on a file in person basis only for the units in Southern California Region III and Central Sierra Region IV. Applications must be filed at each unit in which you wish to be considered for appointment.

There are 21 units through-out the state and they are divided between two regions, North Region, and South Region. In the Northern Region you can mail the completed application to each unit that you are interested in applying for. In the Southern Region they must be hand delivered. A list of the units can be found at the end of this announcement.

#### **What you can expect working as a firefighter for CAL FIRE:**

A firefighter 1 is a temporary position. You work a 72-hour workweek, four days on and three days off. You work the same four days in a week. Your responsibilities will include responding to vegetation fires, vehicle fires, structure fires, vehicle accidents, medical aides, public assist calls, or any other emergency. You are responsible for maintaining equipment and tools, following oral and written directions, cooking and cleaning around the station and other duties as assigned. At some stations you may get only one call per shift and others may get as many as four or five calls on a busy day.

Because CAL FIRE is a statewide fire department, you can get sent to any area within the state on a strike team assignment. You may only be gone one or two days or as many as fourteen days depending on the needs throughout the state. You may be assigned to an incident, usually a large fire, or may be assigned to cover behind other engines on an out-of-county assignment. In addition to being assigned to working on an engine, a firefighter 1 may be assigned to work at an Air Attack Base refueling aircraft, and reloading tankers with retardant. Another opportunity that is available to firefighter I is to work as a helitack firefighter assigned to one of nine helicopters throughout the state.

There is the opportunity to work as a fire fighter assigned to a Schedule A Contract. This is where a city, county, or fire protection district makes a contract with CAL FIRE to provide fire protection for the community. For example in the Santa Clara Unit, the South County Fire Protection District has contracted with CAL FIRE to provide the personnel to operate their fire department. As a result CAL FIRE personnel operate very much like any other municipal department with firefighter, engineers, captains, and chiefs, operating type I engines, and providing advanced life support medical care.

#### **The hiring process:**

After submitting an application, it is reviewed and given a preliminary score based on your education, training and experience. The more boxes you can check the more points you can get. By mid-March you should receive a letter indicating whether you passed the preliminary evaluation. If a passing score is given you may then be invited to an interview. The interview is 100 percent of you score. Because each unit must follow the same guidelines for hiring you can expect to hear the same, or close to the same questions at each interview. This can be a big help when trying to improve your interviewing skills. So the more units that you apply to the better chance you have to interview and improve.

Typically an interview panel is made up of an engineer and a captain. In some cases at the completion of your interview you are given your score, in other cases it is mailed to you. Your score is based from 0 to 100 points. Typically you need to get a score in the upper 90's to be considered for employment. By mid-May you should have received a letter indicating whether or not you are being considered for employment. From here one of a number of things can happen, you could get a letter

stating that you will not be considered for future employment, or you can be contacted and offered a job, or you could be contacted and offered a slot in an academy but not a job.

The presumption is that a position may open up in the future and you would already be trained to take it. Typically a new hire academy is scheduled for the first or second week in June and consists of learning basic skills needed to work as a fire fighter. The end result is that by attending the class you can obtain the CAL FIRE 67 hour Certification. What generally happens around August or September is some firefighters quit and go back to school opening up position to hire more firefighters. So this provides some people second chance to get hired. If you stay in contact with the hiring coordinator in each unit and are willing to start later in the season you might get picked up as a late hire. After you get hired with CAL FIRE and work three months you have automatic rehire rights. Meaning you don't have to go through the same process to get hired the next season.

### **What CAL FIRE can offer you?**

CAL FIRE is an all risk fire department. They respond to an average of 6,400 wildland fires annually and more than 275,000 non-wildfire emergencies each year. As a firefighter I you will gain experience in working on an engine as part of an engine company. You will get experience working at emergencies under stressful situation. You will learn what station life is like and how to work with people of different backgrounds in that environment. You will have the opportunity to earn additional certifications including Incident Command Systems, Confined Space Rescue Awareness, Haz Mat Operations, Swift Water Rescue, Auto Extrication, and many other classes. You will gain experience working with the ICS system as part of an engine company at small and large incidents. Just like anything else you can get out of CAL FIRE what you put in. Because of the number of people retiring you have a very good opportunity to gain a permanent position if you put the effort into it. It is now up to you to make the first step.

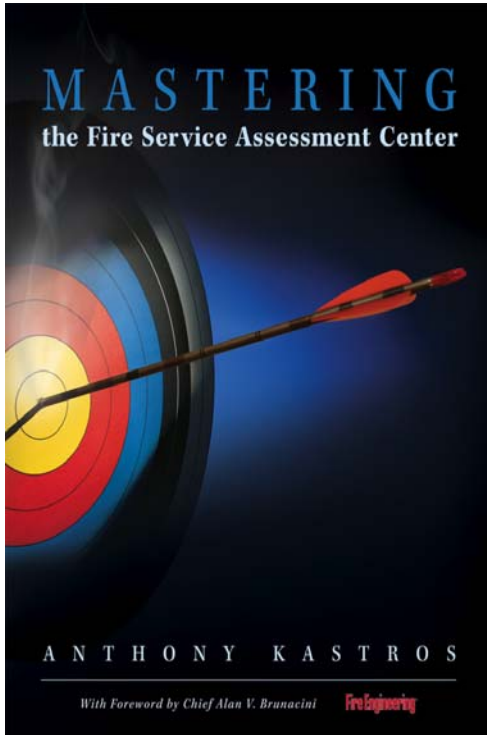

## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

**T**he Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

**S**uccessfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas. 3 Farmington Firefighters were injured, one very seriously, in a crash last night during a fire training exercise in Davis County, Utah. The Firefighters were training around 2100 hours on a mountain when the fire apparatus they were in, rolled over. Around 2200, other Firefighters extracted the 3 from the mountain near the Centerville/Farmington city border. One of the firefighters was flown by EMS helicopter to Intermountain Medical Center in Murray with very serious head injuries. The other 2 were transported by ground ambulance to other hospitals. They suffered serious injuries however, all 3 were conscious when transported and all were likely to survive. It isn't immediately known what went wrong or what the firefighters were attempting to do when the crash occurred, but initial reports indicate the 3 FF's were riding inside the truck's cab. The truck is primarily used for wildland firefighting and only the Farmington FD was participating in the training exercise. We'll post more on our homepage as it becomes available. We have also posted details on the Lumberton (NJ) apparatus rollover crash that occurred last evening (while returning to quarters) as well as the funeral details in regard to yesterday's Roselle Fire Officer LODD.

**FLORIDA FIRE INSTRUCTOR BURNED**

An instructor at the training center for Miami-Dade Firefighters was burned yesterday morning when a training demonstration he was setting up reportedly "flashed"....but what that actually was has yet to be determined. Lt. Kevin McCrea, 38, an 11-year veteran of the department, was taken to Ryder Trauma Center by air rescue Friday morning after the live fire demo he was setting up flashed, burning his body. Other people were nearby and put out the flames, then helped McCrea with his injuries. The Lt. was wearing a polo shirt and pants when he was burned. They still don't know why the demonstration did what it did, and will conduct their own investigation and they have also called in outside agencies to assist. The prop's been used many time and Lt. McCrea and the instructors have used it many times, so they are going to find out what went wrong. Lt. McCrea is married and has three children and he is doing well. It took place at Miami-Dade Fire Rescue Headquarters where the state-of-the-art training facility opened last year. The facility features a 2-story residential building, a liquid fuel storage facility prop, a commercial warehouse, a strip mall and a 6-story apartment building/tower with unique live fire training props. This incident reportedly took place at a vehicle fire. prop. **We'll post more on our homepage as they release more facts.**

A 52-year-old South King Fire & Rescue Firefighter was struck by a car and critically injured this morning. It happened while operating at a previous collision on Interstate 5 in Federal Way, south of Seattle, in Washington State; The Firefighter was unconscious when he was taken to Harborview Medical Center, where he is listed in critical but stable condition. He suffered severe head and face injuries, collapsed lung and fractures. The incident happened at 0530 hours on the Interstate, just south of South 272nd Street in Federal Way. It appears that slick roads, fog and speed were factors in the crash that injured the firefighter, and booze or drugs were not factors-though the investigation is ongoing. Just prior, at 0500 hours, a black pick-up traveling southbound on I-5 hit the left barrier and rolled over, coming to rest in the right shoulder. Turns out that the truck's two occupants were not injured and had left the scene. South King Fire & Rescue dispatched a company of 2 Firefighters and their Lieutenant to the scene. While they were sizing up the roll-over crash, a red Chevy in one of the

**OHIO FIRE CHIEF DIES IN THE LINE OF DUTY-MEDICAL AT STRUCTURE FIRE**

It is with deep regret that we advise you that Chief Greg Baker of the Lewisville Community VFD (Ohio) has died in the Line of Duty. The department turned out early Sunday morning for a structure fire and Chief Baker was working at the tanker fill site when he became ill. An EMT on the scene checked Chief Baker and called for the EMS who placed Chief Baker on a heart monitor and called for a medical helicopter. Chief Baker was air lifted to a Wheeling West Virginia hospital where he died several hours later with family present. Our sincere condolences to all affected.

**8 NEW JERSEY FIREFIGHTERS HURT IN GAS EXPLOSION**

Eight firefighters were injured following a natural gas explosion at a dwelling in Pennsauken around 0430 this morning. A family member heard the smoke alarms, after hearing a bang, smelled some- and left the house. The department was called and as Firefighters went in to investigate, it turns out that a second natural gas explosion occurred. When it exploded, a Battalion Chief was literally thrown over the railing of the front porch onto the front yard. All the other members suffered minor injuries from the explosion. In addition to the 8 Firefighters, one EMT was also injured and all but one were treated and released, and he remains in fair condition.

**WASHINGTON FIREFIGHTER STRUCK ON THE INTERSTATE-He Remains In Critical Condition**

The 52-year-old South King Fire Rescue Firefighter, injured yesterday morning when he was struck on Interstate 5, remains hospitalized today with no change to his medical condition-remaining critical. FF Wynn Loiland, who has been with South King Fire & Rescue more than 30 years was struck by a car on I-5 in Federal Way. Engineer Loiland and 2 other members were operating on the shoulder, initially responding to a call about an overturned pickup, which had actually been abandoned. Slick roads and fog were factors in the collision but the investigation is ongoing. Loiland was taken to Harborview Medical Center in Seattle with severe head and facial injuries, a collapsed lung and broken arm and as of this afternoon, Loiland has had no change in his medical condition. Hes had cat scans showing no change and is still in the 24-hour to 72-hour window to see what direction hell go in, hoping hell stabilize and improve from there. We wish him a rapid recovery.

Many of you knew Joey as a internationally recognized Technical Rescue Instructor, Firehouse Expo Instructor, FDIC Instructor, but all of you knew Joey from the infamous FDNY BLACK SUNDAY FIRE in the Bronx. As you recall, January 23, 2005 was "Black Sunday" in New York when FDNY Lt. Curtis W. Meyran (covering Ladder 27 that day) and FF John G. Bellew (Ladder 27) died in the Line of Duty at an apartment fire in the Bronx. Four other FF's were injured: Jeffrey Cool (Rescue 3) Joey (Rescue 3), Brendan Cawley (Ladder 27) and Eugene Stolowski (Ladder 27).

All 6 FF's were forced to jump from the 4th floor of an apartment building as they were trapped by that life altering fire-for all involved.

As you know, retired hero, FDNY Lieutenant, Joseph DiBernardo, Jr. -- who held a safety rope for a brother Firefighter, as they tried to escape that horrific Bronx fire in 2005, was found dead in his Long Island home early yesterday morning. Joey was widely known as one of four survivors of the "Black Sunday" fires on January 23, 2005, where two other Firefighters were killed in the Line of Duty in the Bronx ----and another Firefighter died in Brooklyn, later that same morning. Lt. DiBernardo , 40, was one of 6 Firefighters forced to jump from the top floor of the burning building on East 178th Street in the Bronx during a winter blizzard in January 2005. Illegal partitions installed in some of the apartments blocked access to the fire escapes, and the firefighters were overwhelmed by what the Lieutenant called a "freight train of fire."

With no way out but the windows, they jumped from the 4th floor onto concrete sidewalks in a back alley. Two of the firefighters, Lt Curtis Meyran and John Bellew, were killed. The 4 survivors--DiBernardo, Jeffery Cool, Eugene Stolowski, and Brendan Cawley--suffered horrific injuries and required many months of intensive rehabilitation. Lt. DiBernardo smashed both feet in the jump and suffered internal injuries. He was in a coma for more than two weeks at New York-Presbyterian Hospital after the incident, receiving the "last rites" two times, before leaving for rehab in the spring of 2005. Lt DiBernardo--the son of retired, FDNY Deputy Chief, Joseph DiBernardo, Sr--was walking tall during his promotion to Lieutenant in 2005--and later danced at his sister's wedding.

His injuries required him to retire on a medical disability from the FDNY--and DiBernardo struggled with alot in the years after he left the FDNY. But he remained active, recognized as an international expert in Technical Rescue operations, lecturing across the country and overseas. He adopted a dog that he named "Rescue"--after his beloved FDNY Rescue Co. 3 in the Bronx. His Brother Firefighter from Rescue 3, Jeff Cool, posted a tribute on his FB page yesterday, thanking Joey for saving his life on "Black Sunday". Joey once recalled that he wanted Cool, a father of two sons, to escape first--because he had children. DiBernardo remembered, "Fire was blowing out around Jeff like a jet

engine." So Joey held Cool's personal safety rope from a 4th floor window ledge, and Cool made it down a few feet, before the rope gave way. DiBernardo later tried to use the rope to rappel from a window guard, but the rope--once again--gave way. The managing agent of the Bronx building was convicted of criminally negligent homicide after a dramatic trial, but a judge later overturned the verdict. FDNY Lt. Joseph DiBernardo leaves behind his parents, Joseph, Sr. and Barbara, along with his sister, Carolyn, her husband, and baby daughter. Joey was also a member and former Captain of Hook & Ladder Company No. 1 of the Setauket Fire Department.

A Pinewood (Texas) Firefighter who was very seriously injured after being struck by an 18-wheeler this morning, is in critical condition. Pinewood Firefighter Kimberly Huckabee lost her left arm as a result of the crash and surgeons are trying to reconnect Huckabee's fingers on her right hand, as of our last report. FF Huckabee also suffered head injuries after being struck. Firefighter Huckabee was hit by that 18-wheeler while assisting at the scene of a tanker explosion this morning near Sour Lake. It is believed that the tanker crashed & caught fire, after the driver fell asleep sometime before 0530 hours. Firefighter Huckabee was struck by that 18-wheeler in one of several crashes that resulted from the initial crash on Texas Highway 105. The driver of the 18-wheeler, that was filled with 6700 gallons of crude oil, has suffered NLT injuries. The tanker ran off the road, hit two culverts and burst into flames. After the 18-wheeler crashed, several subsequent crashes also happened, including the one that critically injured Firefighter Huckabee. Firefighters from Sour Lake, Kountze, Lumberton, China, Nome and Bevil Oaks Volunteer Fire Departments responded to the scene. We will keep you advised on FF Huckabees condition and progress.

This message is for all of you and us-but especially for those younger, newer Firefighters...with less than 10 years on the job-volunteer or career. And I'll keep the wording short so you can focus on the 2 quick videos that you will never forget. Seriously.

**Please read this and watch the two very short videos below. Officers-PLEASE force feed this to "the kids" (Firefighters). Even the older kids. And also please forward this to anyone and everyone who is a Firefighter-or who wants to be. We did not want today and tomorrow to pass without ALL of you knowing a bit about Joey DiBernardo. \***

Joey is the FDNY Lieutenant who was found at home last week, he had passed away, at age 40. While Joey had a stellar career as a Volunteer Firefighter (and former Captain with the Hook & Ladder Company of the highly respected Setauket FD in Suffolk County, Long Island, New York) - he was also a very well known and popular FDNY Dispatcher, but the last chapter of his career was what he was so proud of-being a member of the FDNY and especially, Rescue Company 3.

There is the fact that he followed in his Dad's footsteps. Chief DiBernardo is a highly respected (now retired) FDNY Deputy Chief and Division Commander. He is the kind of Chief whose reputation was no non-sense-and who deeply respected "the potential" of the job....and who understood his deep responsibility for the members operating under his command. Those under his command knew he was strictly business. As it has to be. As he guided his Son. As his Dad told the media last week: "He (Joey) never fully recovered from 9/11 and since 'Black Sunday' - he has been in terrible pain and agony," said Chief DiBernardo, who served 35 years in the department. "After all these years, he has been in physical pain and the mental pain. His whole life had been the FDNY ."

Joey was one of 6 Firefighters who were forced to jump out of the windows as they were trapped by fire in The Bronx "chapter" of Black Sunday, January 23, 2005. Lt. Curtis Meyran, 46, covering Ladder 27 and Firefighter John Bellew, 37, of Ladder 27, died after jumping that day. When the fire caught them, they were faced with a horrifying choice. They jumped out a fourth-floor window, knowing that it was really bad. Firefighters Jeffrey Cool, Joseph DiBernardo, Eugene Stolowski, and Cawley were very, very badly hurt at that fire.

Now Joey is added to those who gave their lives that day, since for so many involved or affected by The Bronx fire that day, it is a fire that never went out. Last week we sent you numerous links to related reports, NIOSH reports and other details about The Bronx and the Brooklyn Fires, and that day, "Black Sunday" in NYC. That's not the goal\* of this issue of The Secret List.

All we are doing today is asking you to please watch these two short videos:

1-This video is a media story about Joey DiBernardo. It will show you who he was and what he was made of. It's worth you watching-it's a wonderful story (when you see him on video, you'll understand) involving a horrific event - leading to a tragic and deeply sad ending. It will also allow you to hear from his Father as well as his "Brother" FDNY FF, Jeff Cool, who was also trapped-who will tell you all you need to know about Joey.

#### **FIREFIGHTERS RETURN TO WORK AFTER EXTREME CLOSE CALL**

2 Firefighters who nearly died searching for trapped residents in a house fire are heading back to work. FF's Chris Paine and Kevin Jacovetta are Arvada (Colorado) Firefighters who on April 3, both were badly burned when they got caught in a house fire. The fire actually started at a house next door but the fire spread to the home they were checking for trapped residents. No one was inside except for the firefighters who almost didn't make it out.

"We were in the back bedrooms when the fire blew in on us and we had to go back out through the fire to get out," said Paine. "The sliding glass door on the back melted and it just fell in, and then all of a sudden the fire just came in on us." "It was just a solid wall of fire. It was like sitting in a blast furnace," said Jacovetta.

Both firefighters would sustain bad burns, but nearly didn't make it out of the house altogether.

We are exposed to highly variable environments including high temps and convective and radiant thermal flux, which can put a significant burden on our PPE-especially our SCBA facepiece. Thermally degraded and melted SCBA facepieces have been identified as a contributing factor in some FF LODD's and injuries in the USA. **The SCBA facepiece lens is often the weakest component of a fire fighter's ensemble in high heat conditions, but the level of thermal performance of the facepiece lens is not well understood.**

**WASHINGTON DC FEMS CHIEF WANTS TO ELIMINATE 24 SHIFTS---ALONG WITH CUTTING 400 FIRE & EMS POSITIONS**

As the world appears to continue to lose some of it's mind, we see that our own "Nation's Capital" is looking at reducing their ability to protect the citizens, visitors and their Firefighters...but what's the real motivation behind doing this? Time will tell. But in the meantime, read the below...and as you know, this is not the only FD seriously looking at changing shifts, cutting jobs, reducing staffing and "saving" money....and as long as the FD isn't needed, all will be fine. Uh. Err. Umm. Welcome to Fantasy Island.

**Penny wise? Pound foolish? Things that make you go hmmm.**

**DC FEMS** Chief Ellerbe wants to change the 24-hour shift system to 12-hour shifts he says will eliminate overtime and reduce the number of Firefighters who live hours away in Delaware, New Jersey, North Carolina and South Carolina. **He is also looking at cutting 400 positions within the department with his goal being to reduce the Firefighters from 2,200 to 1,600 total.** He is gearing up for a fight against the Firefighters union, which wants to hold on to the current system. The Firefighters contract has been expired since 2007, and negotiations on a replacement are beginning soon, Ellerbe said at the monthly breakfast attended by Mayor Vincent C. Gray (D) and the D.C. Council. Through attrition that will likely take 3-4 years, the department would save \$36 million annually under the 12-hour shift system, Ellerbe said. Currently, DCFD Firefighters work a 24/72 schedule. Under FEMS Chief Ellerbe's proposal, they would work two 12-hour day shifts on consecutive days, then two 12-hour night shifts, then a day off before restarting the cycle.

Ellerbe wants to go to a "3-3-3" system: three 12-hour days on and three days off. He said the system will increase the number of days worked from eight to 22 and add 60 to 80 firefighters per shift, eliminating the need for overtime. He also said it will allow the department to more quickly recall personnel during an emergency and will reduce the chances of accidents on the job. "During the second half of a 24-hour shift, mistakes can happen," he said. Finding time for training is also a dilemma, Ellerbe said. He also said there are "public safety" concerns, including tired firefighters likely to make mistakes in the second halves of their shifts and firefighters living hours away who are unable to mobilize for a major disaster. Ellerbe said 25 percent of firefighters live in the city while 41 percent live 30 to 100 miles away.

**SUPPORT FROM DC CITY COUNCIL:** Council member David Catania (I-At Large) hinted at support for the shorter shifts, saying "We ought not to be paying people to sleep." Marion Barry (D-Ward 8) said the department worked on 12-hour shifts between 1965 and 1987 and "service was excellent." Yvette Alexander (D-Ward 7) wondered whether 12-hour shifts were still too long, asking whether eight-hour shifts might be better. Ellerbe expects resistance from the firefighters' union. "They're going to be probably angry," he said. "All they know is the 24-hour shift. This does represent a dramatic change. ... But the truth is, most Americans don't work a 24-hour shift." **WTF!? **2 NEW ZEALAND FIREFIGHTERS DIE IN THE LINE OF DUTY-WILDLAND CRASH**

We regret to advise you that 2 Firefighters died this morning when a helicopter operating at a wildland fire that destroyed homes in New Zealand's North Island. The helicopter went missing late last night off the Karikari Peninsula, at the northern end of the North Island, and the wreckage was found early today. Rescue divers reached the wreckage and confirmed the two-man crew, a commercial helicopter pilot and a conservation department ranger, died in the crash. The helicopter was carrying out a reconnaissance flight over the fire when it crashed. The 2 Firefighters faced very heavy fire and smoke conditions. Pilot John de Ridder, along with Department of Conservation Ranger William Macrae, were sent to help evacuate trapped residents on the Karikari Peninsula. The Squirrel helicopter went down not far from the fire while making a reconnaissance flight over the fire which burned two homes in Matai Bay.

De Ridder, a seasoned pilot in these conditions, was a director for Salt Air, a charter company. Chief executive Grant Harnish said that de Ridder was one of the Far North's most experienced and respected helicopter pilots. They were fighting the fire when he was requested by command to divert to pick civilians up from the beach and get them away from approaching fire and out of harm's way. The pilot removed the monsoon bucket and then began the new task. William Macrae, 54, was in the passenger seat when the helicopter crashed and was a long serving and highly respected ranger who has worked the job for 16 years. Macrae's brother, also a DOC ranger, was busy operating at the fire when his brother crashed. His wife is the receptionist at the Kaitaia office. The fire, believed to have been deliberately set, started late Wednesday, forcing some residents in the remote area to wade into the ocean to escape the fire. Our sincere condolences to all affected.

Each December, there are some very significant dates for the fire service, worthy of note and well worth discussion with Firefighters-especially with the younger ones. Yesterday, as an example was the OUR LADY OF ANGELS fire anniversary in Chicago where 92 kids and 4 nuns lost their lives-a day in 1958 where the heroics of Chicago FF's were well documented. And in that same city, just last year, Chicago Firefighters Corey Ankum and Ed Stringer were killed in a collapse-on the 100th Anniversary of the Union Stock Yards fire that killed 21 Chicago Firefighters. Additionally, every Firefighter should well familiar with the multi LODD loss in Buffalo (NY) when 5 BFD Ladder 5 Firefighters (and 2 civilians) were killed in a propane explosion on December 27, 1983. And on December 20th in 1991, 4 Firefighters were killed when they were trapped in a partial floor collapse in Brackenridge, PA. Ever read that report?

In December of 1999, there were also 2 other very significant multiple Firefighter Line of Duty Death fires that we must remember.

The first is the Worcester Cold Storage fire that occurred on December 3, 1999. The second, discussed below, is the loss of 3 Firefighters in Keokuk, Iowa.

**===WORCESTER (MA) WAREHOUSE FIRE TAKES THE LIVES OF SIX FIREFIGHTERS**

We all remember wonderful but also (and sadly), tragic events that have occurred in our lives as well.

On December 3rd of 1999, I was attending a community Christmas celebration in our town when beepers started to beep providing initial details about missing Firefighters in Worcester (MA)-and then more details-and then even more info and the final incredible details came out. The Worcester Fire Department responded at 1813 hours that night to Box Alarm 1438 for a fire at 266 Franklin Street.(NOTE: 266 Franklin Street is now the the address and location of WFD's E-6, E-12, L-1, R-1 and Scuba-1 quarters) 2 members of Rescue 1, Firefighter Paul Brotherton and Firefighter Jerry Lucey, entered the building searching for occupants. Fire conditions worsened in the building at a rapid and unexpected rate. FF's Brotherton and Lucey, on the fifth floor, became disoriented in the smoke-filled building. Lost, and running low on air, they called for help. Several crews began searching for the lost Firefighters. Two crews reaching the fifth floor also found themselves disoriented in the smoke and trapped by the maze of interior walls: Lieutenant Tom Spencer and Firefighter Tim Jackson from Ladder 2, and Firefighter Jay Lyons and Firefighter Joe McGuirk from

Engine 3 were now trapped. **Though many more highly heroic Worcester Firefighters attempted to locate their missing brothers, their efforts proved futile.**

The Line of Duty Deaths of Worcester Firefighters Paul A. Brotherton, Timothy P. Jackson, Jeremiah M. Lucey, James F. "Jay" Lyons III, Joseph T. McGuirk, and Lt. Thomas E. Spencer devastated Worcester, the Fire service, the nation and the world. Their Line of Duty deaths marked the worst loss of Firefighters' lives in more than 20 years in a building fire in America, and the third worst fire in Massachusetts' history. R.I.P.

**===KEOKUK, IOWA-THE LOSS OF 3 FIREFIGHTERS-AND 3 CHILDREN IN A DUPLEX FIRE**

At 0824 Hours on Wednesday, December 22, 1999, a fire was reported in a multifamily dwelling in Keokuk, Iowa. Several neighbors phoned the Keokuk 911 center to report smoke coming from a residence, and that a woman was outside screaming that there were children trapped inside. Assistant Fire Chief Dave McNally, 48, Firefighter Jason Bitting, 29, and Firefighter Nate Tuck, 39 were killed while attempting the rescue of 3 trapped kids in that fire-who also perished. The 3 Firefighters left 8 kids of their own behind. The Firefighters died when a flashover occurred while the 3 were doing their search. The fire started in the kitchen of an old wooden two-story b/f home that had been converted into apartments. Staffing is a major issue in Keokuk, and that morning, 4 of the 5 total (+ the Chief) on duty firefighters arrived on scene with heavy smoke showing, and upon hearing the mother screaming that her children were trapped inside, they immediately and understandably went in after them. When "Mom" screams that her kids are inside-we go in.

The 3 were inside, (the Asst Chief and 2 FF/pump operators) a Lt. was on the hydrant-couldn't see the building and one Firefighter was on side "A"... starting to pack up, to back the interior members up. The Chief made the terribly difficult decision to leave the scene for 3 minutes to personally transport a non-breathing rescued child--there were no other resources available... none. The hospital was a minute away. When he returned, the flashover had already occurred with only the Lt. and the one Firefighter left outside. A/C Dave McNally, FF Jason Bitting, and FF Nate Tuck perished in that duplex. R.I.P.

To all of us, he made a statement that sums it up... **"Always remember that we as firefighters are there to help people with a problem, while also doing ALL that we can to never become PART of that problem"**

-and so we can honor the WFD and KFD members who gave their lives in the Line of Duty.

FF Gilbert went for an inspection to a balcony on the second floor where for an unknown reason he slipped and fell and landed on his chest = and was declared DOA at the scene. Cpl Gilbert Strijbos was Volunteer Firefighter for more than 20 years and a very active member. He leaves his wife and several children behind. Our sincere condolences.

**SAN FRANCISCO FIRE DEPARTMENT CITED BY THE STATE IN DOUBLE FIREFIGHTER DEATHS**

State investigators have cited the San Francisco Fire Department for "serious" worker safety violations in the Line of Duty deaths of two Firefighters killed while operating at a house fire in June. Firefighters lost track of Lt. Vincent Perez, 48, and Firefighter-Paramedic Anthony Valerio, 53, after they went into the four-level home at 133 Berkeley Way on June 2 and failed to respond quickly

to the men's last radio communication, investigators with the state Department of Industrial Relations' Division of Occupational Safety and Health said in a report issued Monday. In recommending that the SFFD be fined \$21,000, the state investigators also said the department had violated state rules requiring that two firefighters be designated outside to assist any 2 Firefighters who venture into a life-threatening environment. Only one firefighter from Perez and Valerio's engine company - the first on the scene - was available to come to their help during the fire.

The state also cited the SFFD for an incident - evidently before the flashover - in which a Battalion Chief went into the burning building alone, without keeping in contact with Lt. Perez and Valerio which they deemed a serious violation of safety rules. The state investigators identified several command, control, communication and accountability issues:

Fire Chief Joanne Hayes-White said the SFFD would appeal the findings. She said state officials have told her commanders that the violations fell short of finding the department's actions responsible for the two firefighters' deaths. "None of the citations involved a direct cause of the line-of-duty deaths," Hayes-White said. The state investigator confirmed that, saying the exact circumstances of the firefighters' deaths could not be determined. The Fire Department is still conducting its own investigation into the incident. "If it is recommended that we need to make a change, we owe it to Lt. Perez and firefighter Valerio" to implement it, Hayes-White said.

Valerio, Perez and a 3rd member of Engine Company 26 were the first Firefighters to arrive at the mid-morning fire, which started when a sparking electrical outlet set curtains on fire. The 3rd firefighter ran the pump while Valerio and Lt. Perez went inside to fight the fire, but the regulations require a 4th Firefighter to be available outside to assist. A fire commander, identified by Firefighters as Battalion Chief Thomas Abbott, ordered a crew from Engine Company 24 to back up Valerio and Perez inside the building. For several minutes, however, scene commanders tried to find the Engine 26 firefighters, without success. Finally, what appeared to be the last communication from the crew came over the radio. "This is 26, this is 26. ... Battalion 6, what's your location?" said a muffled voice. "Twenty-six, this is command, I need to know your ..." came a reply.

"This is Engine 26, we're on the third ..." At that point, the voice over the radio trailed off. There was an unspecified gap between that last communication and any effort by Firefighters to respond over the radio or track down the men. Chief Hayes-White said the SFFD's investigative report - still in draft form - concluded that the fire had melted one of the firefighters' microphone cords, cutting off communications. She said any delay in Firefighters' response would be addressed in the final report. Firefighters ultimately found Perez and Valerio in a landing area and carried the injured men outside. Perez was pronounced dead at San Francisco General Hospital, and Valerio died there two days later.

The state probe also faulted the actions of the unnamed battalion chief who went into the building "alone and also did not remain in contact with the firefighters who were inside." Chief Hayes-White said the battalion chief had gone inside only briefly, had seen Perez and Valerio alive and had never been out of other firefighters' view.

### **LOUISIANA FF DIES AFTER PERFORMING RESCUES**

A 45-year-old Volunteer Firefighter died in the Line of Duty after operating at a fire and rescuing people from a burning mobile home early yesterday morning in Livingston Parish. Firefighter Scott Osenenko was operating at the fire where the family had been awakened when they found their home on fire around 0400 hours. FF Osenenko was on the first arriving company to respond and he worked for nearly 20 minutes removing people from the home and fighting the fire. After exiting the building, FF Osenenko began to experience cardiac distress and was treated and taken to the hospital where he was pronounced dead as a result of the injuries he received at the scene. No one inside the home was reported to have suffered significant injuries. The cause of the fire is under investigation, and an electric space heater is being looked at as a possible cause. Firefighter Osenenko leaves behind 2 children. "Scott was a model firefighter," said his Fire Chief James Wascom. "He was scheduled this morning to take the hazmat operations certification test. All he was trying to do was save lives and serve our community this morning. Now, he is gone". We'll post more details on our home page. Our sincere condolences to all affected.

**WEST VIRGINIA FF LODD-FALL FROM A RAILROAD BRIDGE**

It is with deep regret that we advise you that early this morning, a Kanawha County Firefighter fell and died in the Line of Duty while trying to locate a fire involving railroad ties. Houses burning down and fire departments not putting fires out, as occurred in Obion County, Tenn., in September of 2010, are nothing new, they are just news once again. And again last week, ANOTHER house burned down in Obion County. It's ridiculous, but certainly not new. To be clear, any fire department on any scene should generally put the fire out. In this case, I think the fire department should have put it out again this time and then billed them for all the costs or just figure it all out later. However, there is a lot more to this situation. Keep in mind, with the economy and related politics (some places are using the economy as a political excuse to cut fire departments even though they can fund them, as are others that do have genuine fiscal problems), stuff is going to burn down. Even with great funding, stuff burns down. But, to have a fire company arrive and not put water on the fire, is, as some write, "shocking."

Can you imagine if you forgot to pay your insurance bill and then filed a claim? Would the insurance company insure you and handle it later? Ask the Gecko. See what he says. The point is that fire departments cost money, and the elected officials of Obion County do not want to fund a fire department and haven't for years, -according to area fire chiefs. They do not want a tax-funded fire department, and the taxpayers don't either, at least not as a whole, otherwise they would direct their elected officials to implement one.

The Fire Chiefs of Obion County have worked for many years to offer the county elected folks a proposal of a fire tax or have them just fund the eight municipal fire departments in the county for a reported \$360,000 total to provide all residents of the unincorporated areas of the county: a fire service. However, the elected members of the county commission refuse to force a tax on its citizens. And to be clear, the latest homeowner who lost his house in the Tennessee fire was very well aware of the fee. But they didn't pay so the fire department dropped his name off the list. They still should have put water on the fire.

Of course, little do most of us know that the fire department subscription was set up 20 years ago because someone else's house outside city limits burned, and the city wanted to provide service to those residences where there is no other fire service. However, city taxpayers understandably do not want to fund a free fire department for non-taxpaying residents outside their city. No one does. The bottom line is, if a fire department shows up at or near a fire, they should put it out. If they want to limit exposure to legal action or bad publicity, they should not respond outside their jurisdiction. An archaic system that determines who gets fire protection based upon billing is a whole lot different than residents of the rest of North America are used to. However, if the citizens and their elected officials do not want to fund a fire department, it's their choice. If the residents care, they need to speak up, vote, join up or never ever forget to subscribe. And keep in mind, the latest resident whose home burned down was again, very well aware of the fee. But, after all, they'll never have a fire. Err. Uh. Damn. Maybe the fire departments in Obion County should have a credit card system, where the residents get billed annually automatically, unless they choose to opt out. Just imagine the ad: "Your fire department: We're everywhere you want to be." Fire departments, paid or volunteer, cost money, and those in the community who want a fire department need to pay, one way or the other. Interestingly, the cost of a fire department - any FD - has never been so discussed as it is these days - in every city, town, village or district. And it's never been so justified as it is in Obion County, TN.

Washington D.C.'s fire chief wants to reduce the size of his department by more than 20 percent and make changes to the schedules firefighters now work. Chief Kenneth Ellerbe told Mayor Vincent Gray and the D.C. Council Wednesday he wants to reduce the number of full-time employees by 475, shrinking the department to about 1,625 employees. Ellerbe also wants to move from 24-hour shifts to 12-hour shifts, more than doubling the number of days

firefighters work each month. "It's an absurd idea," says Ed Smith, president of the D.C. firefighters union. Smith says he doesn't believe Ellerbe's assertion that the moves will save taxpayers \$36 million. Ellerbe says the shift change would encourage firefighters to live closer to the District. "Forty-one percent of our members live between 30 and 100 miles away," Ellerbe told elected officials at their monthly breakfast meeting. "That creates a homeland security challenge if we have to recall our entire workforce right away for an emergency." Ellerbe says some members of the department live as far away as Delaware, North Carolina and South Carolina. Gray agreed that's an issue of public safety. "It's very much of a concern," Gray said after the briefing. "If there is a catastrophic event people will be challenged to get back into the city." D.C. firefighters currently work a 24-hour shift, then have three days off. Under Ellerbe's proposal, firefighters would work three 12-hour day shifts, then have 12 hours off before returning to work three 12-hour night shifts. New pension cost projections unveiled Thursday were expected to slash San Jose's (CA) \$80 million deficit next year by more than half, easing fears of libraries and community centers closing and prompting Mayor Chuck Reed to call off Tuesday's scheduled vote on whether to declare a fiscal emergency. Reed was set to ask the City Council to proclaim the emergency to justify putting a pension measure on the March ballot aimed at trimming retirement benefits for city workers. The mayor said he now wants to push the election to June. While ostensibly good news, the relief for next year's budget gap was fraught with politics as it arrived just days before what was to be a key council vote on Reed's proposed pension reforms. City Manager Debra Figone said it would be weeks before the city has a better sense how the revisions will affect next year's projected deficit. But in a memorandum issued late Thursday, she said that Cheiron, which in July had projected police and fire pension costs would rise from \$127 million to \$160 million next year, now projected they would actually drop to \$105 million. That's a \$55 million difference in the city's expected cost, which Figone said would shrink next year's budget gap to a more manageable \$25 million. But, Figone added, "Unfortunately, current retirement costs are still unsustainable." The new numbers, Unland said, do "not for one second mean that we're not on board with pension reform." Police and firefighters late Thursday offered a revised pension concession that would offer new hires the same retirement benefit in effect in the mid-1990s before a series of enhancements. The clock is ticking, but volunteer first responders in Spotsylvania County (VA) don't seem to be in a rush to meet a looming training deadline. With little more than a year to meet minimum training standards, some 377 volunteer firefighters and rescue workers still need basic courses. And yet the county's free training classes still have empty seats. Four times since August, training officials have had to cancel courses because so few volunteers signed up. "We're offering quality training here, and for some reason people aren't signing up," said Division Chief Jeff Bailey, who oversees training for all Spotsylvania rescue workers. Last year, the Spotsylvania Board of Supervisors adopted minimum training standards, requiring every county firefighter and rescue worker to complete basic training courses by Jan. 1, 2013. Some volunteers initially balked at the training standards, saying the timeline was too strict. Others speculated that the new requirements were the county's way of getting rid of volunteers. "I'll stop short of saying that people are discouraging training," Bailey said. A 62-year-old blind man has filed a complaint with the U.S. Department of Justice claiming Baltimore (MD) Fire Department paramedics refused to allow his service dog to accompany him in an ambulance after he was struck by a car. Curtis Graham Jr., a Marine who served in Vietnam, was on his way to the city's Veterans Day parade on Nov. 11 when he was hit by a car near his West Baltimore home. Paramedics would not allow Indo, his 2-year-old golden Labrador retriever, into the ambulance, Graham said. "They refused to take a service animal who I need very much," said Graham, who suffered minor injuries. "He is my eyes." Baltimore City Fire Department spokesman Kevin Cartwright said the incident was under investigation. He confirmed that a blind man was struck by a car and taken to a hospital by ambulance, and said he believed the victim's guide dog had not been transported. Cartwright said that to his knowledge, the department did not have a policy on service animals. A spokesman for the National Federation for the Blind said first responders are "legally obligated to transport the service animal" under Maryland law. "You're basically taking the blind person's way of understanding his environment away from him," said federation spokesman Chris Danielsen. "I have no idea what sort of irrational thought process was behind not letting the dog in the ambulance, but that is an act of discrimination," he said:

It's a great deal of money, it's money that taxpayers shouldn't be paying. If someone calls in sick and they're not actually sick that is wrong." According to city records, overtime in the fire department went from \$4.8 million to \$10 million in 2008 and it was that year that the city says it discovered a substantial amount of overtime going to a small group of firefighters:

"The members had done some things wrong, obviously, but the charges should be dismissed based on a lack of deliberate misconduct." A judge has found there is enough evidence to hold a California volunteer firefighter for trial on eight arson counts, after hearing about an investigation that included placing a GPS device on his vehicle after he was identified as a suspect. During a preliminary hearing Monday, Butte County Superior Court Judge Michael Candela ruled that there was probable cause to set a trial for Jairo Perkins-Grubbs. Perkins-Grubbs was arrested Oct. 4 after a series of about 20 suspicious fires on the upper Paradise ridge starting in late July and ending Oct. 3. He was allegedly responsible for fires that consumed the DeSabra Market in August and the Lovelock Inn in September, as well as attempts to burn the Magalia Depot. The defendant is charged with two felony counts of arson of an inhabited structure and six felony counts of arson of a structure or forest. He also faces special allegations that the DeSabra Market fire involved multiple structures and that he used a petrochemical accelerant in five counts. If convicted of all charges and allegations, Perkins-Grubbs faces more than 47 years in state prison:

Cleveland (OH) Fire Chief Paul Stubbs answered questions about a recent audit exposing payroll abuses by city firefighters. "Obviously, there's things that should have been done differently," said Stubbs about the audit. Stubbs gave his first television interview about the scandal to NewsChannel5 Investigator Sarah Buduson Tuesday afternoon. "What I regret the very most is that we continued to use a somewhat antiquated and somewhat dysfunctional process for our payroll," said Stubbs. Stubbs said the fire department still uses some manual record keeping processes. He said the system made it difficult to detect some firefighters were getting paid for work they were not doing. "There are no crooks here. We were doing our best. We may have made mistakes," said Stubbs. Martin Flask, the Cleveland director of public safety, said the audit uncovered firefighters abusing a policy that allows them to trade shifts. For example, the audit found firefighter Calvin Robinson has worked approximately three months since January 2009, but was paid his full \$53,890 salary each year. Flask said firefighter Andrew Kovacic did not work for five months from November 2010 to March 2011, then worked 24 hour shifts for 18 days to make up the time. Flask said Kovacic's decision to work so many hours was "unsafe." Flask said firefighter Joe Coneglio did not work from January to April in 2011 and lists San Diego, California as his home address. He said Coneglio then crams in extra shifts when he is in Cleveland:

Four volunteer firefighters were arrested Tuesday on charges of allegedly setting fire to hundreds of hay bales at a Mesquite, N.M., dairy farm on Monday night. Doca Ana Sheriff's Office spokeswoman Kelly Jameson said Tuesday that four men allegedly set the fire at the Mountain View Dairy because "they were bored," according to a criminal complaint. This marks the second fire in more than two years at Mountain View Dairy, located near Stern Drive and New Mexico Highway 228 just south of Las Cruces. In January 2009, a similar hay fire took place. Luis Gutierrez, 20, Joshua Jaramillo, 19, Carlos Martinez, 20, and Primitivo "Junior" Perez, 18, all volunteer firefighters with the Mesquite Fire Department, were booked into the Doca Ana County Detention Center on charges of conspiracy and arson, Jameson said. Monday's fire was the latest late-night arson to strike Doca Ana County dairies, and not the first to allegedly be committed by a volunteer firefighter. Last year, Ruben Marquez of Vado, N.M., and Javier Ramos Mercado of Las Cruces allegedly torched a barn containing 500 tons of hay at the Del Monte Dairy in Mesquite, causing about \$140,000 in damage. In 2006, volunteer firefighter Jonathan Morales was charged with arson after allegedly setting three fires at the Bright Star, Dominguez and Gonzales dairies while drunk, causing an estimated \$112,000 in damage:

"The city is still operating under archaic conditions," said Joseph W. Diemert, a lawyer for the union. "To monitor -- clock in and clock out -- is something that the guys think is wonderful and a good thing to do. "There are mix-ups and there are slip-ups," Diemert added. "This is something that they could have done long before this and they don't need union approval to do it."

Three supervisors in the Cleveland (OH) Fire Department face disciplinary charges for letting a firefighter skip hundreds of hours he was scheduled to work over the last three years, the city announced Monday. Battalion Chief Robert Readinger, Capt. William Graham and Lt. Gregory Perrin are accused of failing to properly supervise firefighter Calvin Robinson, who worked only 12 round-the-clock shifts from January 2009 through June 30 of this year, but collected full pay. If found guilty by Public Safety Director Martin Flask, the supervisors could face penalties ranging from a reprimand to dismissal. More administrative charges are expected in the department's payroll scandal, uncovered last month by internal auditors. Criminal charges

are also possible. The internal audit, released Nov. 18, found that several firefighters collected full pay for hundreds of hours they did not work. Auditors said firefighters also violated a citywide bereavement policy and failed to properly deduct sick time, adding to what retirees can cash in when they leave the department:

The thin files on this fire and others raise questions about the department's investigations of suspicious fires, particularly during the early stages of what would become one of the worst arson sprees in the city's history: Did investigators do thorough investigations then? "It is humbling," Cummings told NBC4, about his first hours spent at the Downtown Women's Center, a shelter for homeless women. Cummings says he began volunteering in the kitchen there on October 15. This is the same shelter where actress Lindsay Lohan served part of her court-ordered community service for a shoplifting conviction. In September, NBC4 first reported that city trucks from two fire stations were allowed to be used as backdrops for lewd scenes in porn movies. As the scandal went viral worldwide, Cummings came forward with his own admission: that he too had allowed "inappropriate" photos to be taken of a semi-nude woman posing in front of an engine, years earlier when he was captain. Boise mayor David Bieter today joined representatives from Boise Firefighters Local 149 and Boise Police Local 486 at a press conference to announce the groundbreaking cost-saving measure. "During difficult times, we all need to make sacrifices," Bieter said. "It's clear with this agreement that Boise police officers and firefighters are willing to step up and work as partners to help address our budget shortfall for the greater good of our community. I thank them for their assistance. This agreement is a shining example of how city governments and public-safety unions can work together to solve difficult problems." The firefighters and police officers had contracts with the city which guaranteed cost-of-living increases for Fiscal Year 2013. The new agreement means that pay will be held back to current levels. "We were pleased to be able to help our community and civic government weather these tough economic times," Boise Firefighter Local 149 president Greg Womack said. "This agreement also means that our neighbors, the citizens of Boise, won't have to worry about having fewer firefighters and police officers on the street." The new agreement will save the city a total of \$1.275 million. The overall reduction in compensation to Boise public safety officers means the city will be able to guarantee that they will maintain staffing at current levels, with no need for layoffs:

The Renton (WA) Firefighters, through the Renton Firefighters Benevolent Association, are responding to an urgent need in their community. On Monday Renton firefighters delivered a fire truck full of food donations and a check for \$1,000 to the Renton Rotary Salvation Army Food Bank. Monday's check is in addition to a \$500 donations made earlier this year. The donation came after Salvation Army Captain Chris Aird requested the help of Renton Fire and Emergency Services at a recent union meeting, said Captain Rick Marshall. Aird's plea spurred the group to respond with a motion to increase its annual donation of \$500 to \$1,500 and asked all union members to collect food from their home pantries for the food bank. "We are trying to do a better job in being involved in our community," said Marshall:

The Hemet (CA) Firefighters Association agreed Wednesday morning to the terms of a new contract with the city in which the union will take cuts similar to other employee bargaining groups. Under the terms of the proposed two-year deal, the department will maintain the 5 percent pay cut it took last year, before getting that money back in the second year of the deal. Department members will also now have to pay all of their own pension contribution, with each member now paying 9 percent instead of 3 percent. A two-tier retirement system will be put into place for new hires and the city will no longer allow vacation sell-backs. Union President Steve Sandefer said more than 90 percent of the 49-member union agreed to the deal. "Under the circumstances, and considering the situation our city is in, we feel like it's a fair deal," Sandefer said. "Nobody really came out jumping for joy. The city would have liked more and the firefighters would have liked to give less, but it appears to be fair and reasonable."

**Training & Safety Related Items:**

An instructor at the training center for Miami-Dade (FL) firefighters was burned Friday morning when a training demonstration he was setting up flashed into flames. 38-year-old Lt. Kevin McCrea, an 11-year veteran of the department, was taken to Ryder Trauma Center by air rescue Friday morning after the live-fire demo he was setting up flashed, burning his body. Fire officials said other people were nearby and put out the flames, then helped McCrea with his injuries. Department officials told reporters Friday afternoon they still don't know why the demonstration flamed up, and as they conduct their own investigation they have also called in outside agencies to assist:

Why we need a culture of safe suppression by Billy Hayes - It's often said that the best offense is a good defense. Unfortunately, that's not a philosophy that we in the fire service have embraced. Quite the contrary, the American fire service in most places addresses strategy and tactics only from an offensive interior frame of mind. Before we go too far, I again want to remind readers that my columns are designed for your critical thinking. I'm not here to tell you what's right or wrong but rather I want to offer a different perspective for you to think about. Much of it is from observations I have made, and discussions I have overheard. So for this particular column, I'm really going to shake it up. If you take the time to read many of the NIOSH reports that are available resulting from a firefighter injury or fatality, you will find that situational awareness and tactical positioning are often a common theme as a root cause. In many cases, a 360 was not conducted initially and/or continuously during the event. The fatal act of freelancing often arises in the scenario, or simply the attack crews are incorrectly or dangerously positioned:

One-third of firefighter injuries caused by exercise. Firefighter injuries more likely to occur while exercising, which aims to prevent injuries, than while putting out fires, new research suggests. Firefighters are more likely to be injured exercising than putting out fires, new research suggests. A U.S. study found exercising caused a third of all injuries, followed by carrying patients (17%). Just over one in 10 (11%) injuries occurred during training drills. Exercising is designed to help firefighters stay fit to deal with the rigors of their job:

The San Francisco (CA) Fire Department has been cited by state investigators for "serious" worker safety violations in the deaths of two firefighters who died while battling a house fire. A report by the state Occupational Safety and Health said firefighters outside the house lost track of Lt. Vincent Perez and firefighter-paramedic Anthony Valerio. The two were fatally injured after being caught in a flash fire triggered by superhot gases during a June 2 blaze in the Diamond Heights neighborhood. The state issued four citations against the department,

three of them categorized as "serious." They included a battalion chief entering the house by himself without maintaining visual or voice contact and not ensuring that at least two firefighters were outside ready to perform rescue procedures. "These are serious in that they had protocols in place, but they weren't following them," said Erika Monterroza, a spokeswoman for the worker safety agency, told the San Francisco Chronicle on Friday. "There's no question that a lack of communications was a big issue here. The investigator found there was a breakdown there." **General Fire Service Related Items:**

It's widely known the City of San Diego (CA) needs more fire stations. Monday the City Council will consider adopting a plan to get them built, but there's no money to actually make it happen. The study by Citygate Associates was commissioned by the fire department last year. It made several recommendations, including building 10 new fire stations and assigning smaller, two-person crews to nine additional areas. Fire Chief Javier Mainar said there isn't money available to implement these recommendations. But he said the council will consider adopting the plan as a roadmap for the future. Mainar said it would cost just under \$100 million to build the additional stations and buy more trucks. It would cost about \$40 million a year to maintain the equipment and pay personnel: <http://www.kpbs.org/news/2011/nov/14/san-diego-council-consider-fire-station-study/>

They're trained to fight smoke and extinguish flames, but firefighters at Tampa (FL) Station No. 15 are having a hard time battling something else: Bedbugs. Since September, the station near Himes Avenue and Gandy Boulevard in South Tampa has had a bedbug infestation in its sleeping quarters. Multiple chemical and heat treatments failed to get rid of the bloodsucking pests, said Tampa Fire Rescue Capt. Lonnie Benniefield. The department has closed off the dormitory side of the station while a pest control company tries again. Part of the stepped-up remedy includes ripping up carpet and getting rid of linens. The three shifts of six firefighters who work from that station have been sleeping on sofas or in sleeping bags on the other side of the building, Benniefield said. Pest control workers have found only three bedbugs, he said, though more may lie in wait. "It doesn't mean there's not more there," he said. "They can hide in crevices, they can burrow." How did they end up there? Benniefield said that's hard to say, given that firefighters are in and out of homes and hospitals. Bonnie Bleskachek, who lost her job as Minneapolis (MN) fire chief in 2006 after a sex scandal and multiple lawsuits, once again wants to climb the department's career ladder. Mayor R.T. Rybak's administration told the city when it demoted Bleskachek to captain that she would never seek promotion, would stay out of fire stations and would not supervise anyone. Monday night's Atwater (CA) council meeting took an unexpected turn that could lead to the resurrection of Atwater's city-run fire department — a polarizing proposal that some think would harm public safety and cost the city more than it would save. After a standard verbal report by Battalion Chief Jeff Isaacs about Cal Fire's performance and service for the month, Mayor Pro Tem Joe Rivero led a discussion about how savings expected from the Cal Fire contract have not materialized. He later motioned to draft a letter of termination to separate from Cal Fire and get a better idea of the impact the proposal would have on city finances. An administrative law judge on Tuesday threw out a legal challenge of a ballot measure that strips Palo Alto (CA) police and firefighters of their right to take pay and benefit disputes to outside arbitrators. In September, the International Association of Fire Fighters, Local 1319 filed an unfair labor practice charge with the Public Employment Relations Board. It alleged the city council had failed to "consult in good faith" with the union before placing a repeal of binding interest arbitration on the Nov. 8 ballot. Measure D blazed to victory last week, winning more than two-thirds of the vote and giving elected officials the ability to impose terms on its public safety unions for the first time in 33 years. Chief Administrative Law Judge Shawn P. Cloughesy said in his 29-page ruling that the city, in fact, provided "reasonable written notice" to the union that changes were being considered to the labor policy, otherwise known as Article V in the city charter. He said it was union President Tony Spitaleri's responsibility to clearly communicate that a meeting was desired. The closest the firefighters union came to making such a request was on July 18, the same day the city council was scheduled to decide between asking voters to either modify binding interest arbitration or repeal it altogether. The Boston Fire Department has gone outside its ranks for the first time for a new chief, tapping former Dallas and Miami fire chief Steve Abaira to become the department's second in command and first Hispanic chief. "I chose Steve Abaira because he has an exceptional reputation," said Boston Fire Commissioner Roderick Fraser. "He leads by example. He's not afraid to stand up for what he believes in and he's not afraid to take a risk. Those are all good qualities in a leader." Fall River (MA) Mayor Will Flanagan, the son of a police officer, acknowledged a week after his controversial appointment that making a fire lieutenant the interim chief equated to appointing a sergeant as the head of the police department. But Flanagan held fast to his position that a public process would vet the best candidate and that his 90-day appointment of Lt. Michael Coogan was a job opportunity for a worthy candidate rather than the result of close political ties. Reaction from prominent people, including those with high level fire service training, has been nothing short of outrage. It seems clear that those speaking up see the next three months as an opportunity for Flanagan to change his course and correct an unprecedented selection. "Mr. Mayor, the FRFD chief position is not for everyone. It's for the best-qualified Fall River deputy chief or district chief. And that's the way it's been for generations," said fire Capt. Scott Flannery in a letter he wrote to Flanagan, with copies sent to the City Council and The Herald News. In placing a lieutenant at the helm, Flanagan passed over two deputy fire chiefs, nine district chiefs and 14 captains, although no one below a chief's ranking had ever vied for or been appointed for at least three or four decades and probably more than half a century, said other chiefs: <http://www.heraldnews.com/features/x473906681/Coogans-interim-fire-chief-appointment-prompts-mostly-outrage>

There were 2,400 applicants, but only 25 of were handed a badge by the Orange County (CA) Fire Authority to make them firefighters. The Wednesday night fire-academy graduation, at the agency's Irvine headquarters, was the first in more than two years. The graduates joined the department's 835 other firefighters. Fire Authority officials are considering looking at the possibility of beginning another fire academy in 2012. And after the 25 new firefighters are assigned to one of the agency's 61 stations, the agency will still have 46 vacancies:

The Norco (CA) City Council voted 3-1 Wednesday to approve a \$2.9million annual contract with Cal Fire/Riverside County Fire Department for fire and medical emergency services, a move that begins the process to dissolve the Norco Fire Department. The move is expected to save the city roughly \$1.4 million annually, excluding start-up costs. Norco had budgeted about \$3 million for services from its Fire Department this year, but that figure does not include overtime, workers' compensation and disability claims that could boost that figure to \$4.5 million, according to a staff report. Cal Fire officials say savings they provide comes from longer shifts and more available firefighters. The agreement transfers all 18 of the city's firefighter paramedics, captains and engineers to Cal Fire as state employees while the city plans to keep the full-time fire prevention specialist and two part-time clerical assistants. Some firefighters would continue to work in Norco, while others could be transferred to other county stations. The city also will keep ownership of its two fire stations and fire equipment but plans to transfer two fire engines to Cal Fire to avoid liabilities such as property insurance:

A sustainability task force that has been helping the University of Nevada, Reno Fire Science Academy agreed Tuesday to look at ways to rescue the academy from closure, but no one is holding their breath. "The key is this has to be a substantial plan with a strong framework," academy Executive Director Denise Baclawski said. Fire departments and districts in the Spokane (WA) Valley area were taking stock this week and trying to determine how to move forward after levy and bond requests on the November ballot failed. Newman Lake Fire District 13 tried to pass a \$2.2 million construction bond to build a new fire station. It received only 48 percent approval. The district's commissioners held a special meeting Tuesday to discuss the results. "They talked about whether to run it again," said Fire Chief Keith Yamane. The commissioners asked Yamane to take the issue back to the Building Committee, which was heavily involved in selecting the design of the proposed new station, for a recommendation on what to do next, Yamane said. "I think they want to get an idea relatively quick," he said. "They weren't opposed to running it again." Spokane County Fire District 8, which stretches across a large area south of Spokane and Spokane Valley, tried to pass its first Maintenance and Operations levy to replace dropping property tax revenue. It failed with 51 percent approval. The measure needed 60 percent approval to pass. The loss of a

fire levy was perhaps more painful in Rockford. The town's replacement fire levy got a 56.7 percent approval vote, just a few points shy of the 60 percent required. "We'll probably try again," said Rockford Mayor Micki Harnois. Four high-ranking Monarch (MO) Fire Protection District officials were fired for creating an atmosphere where discrimination was tolerated, the president of the district's board of directors said at a special meeting Tuesday. The board affirmed decisions to fire Assistant Chief Les Crews, Deputy Chief Cary Spiegel and battalion chiefs Fred Goodson and Mike Davis. A vote had been taken during a closed meeting Saturday. The move was in response to a decision denying an appeal the district made in a discrimination case that awarded \$200,000 plus interest and attorney fees each to two female employees. The women claimed they had been subjected to a hostile work environment:

A state agency that regulates paramedics has dismissed complaints that some members of the public filed over the Memorial Day death of Raymond Zack, who committed suicide off Crown Beach while emergency workers remained onshore, Alameda (CA) city officials announced Monday. The complaints alleged that paramedics could not resuscitate the 52-year-old Zack due to equipment failure, that a paramedic was working at the scene in violation of his probation, and that another paramedic who was not there covered for that individual by filing an incident report. Michael Smith, the chief enforcement officer for the Emergency Medical Services Authority, said he found no merit in any of the allegations in a Nov. 10 letter to Donna Mooney, acting city attorney for Alameda:

San Mateo and Foster City will explore further sharing of fire-administration duties over the next few years to reduce costs. "I think both cities are happy with the progress so far," San Mateo Mayor Jack Matthews said Wednesday. The two fire departments now have five battalion chiefs between them. Belville's plan is to get down to three battalion chiefs in coming years through retirements:

Buckeye (AZ) Fire Chief Bob Costello never thought he would be in the cemetery-management business, but that was before the town laid off 200 employees beginning in 2008. Now he and his fellow firefighters help set up graveside services at the Louis B. Hazelton Memorial Cemetery. They line up chairs, move awnings, help with excavation and burial closures and occasionally cut the grass, trim the trees and mount headstones. Administrative staff takes care of sales and record keeping. Costello understands it may not be the best role for the department, but the town is facing desperate times. "It's a service that absolutely has to be done," he said. "I can't think of a group of more compassionate, caring and reverent people than the firefighters. When it came down to looking at layoffs ... sometimes you have to do

things that wasn't in your job description and certainly wasn't something you signed up for." Buckeye is not the only municipality in metro Phoenix asking workers to add unfamiliar jobs to their regular duties. Cash-strapped cities already thinner from layoffs are combining departments and crafting unconventional ways to deliver necessary services:
