

FIREFIGHTER-TRAINEE RECRUITMENT

The District is seeking highly energetic and motivated candidates for the entry-level position of Firefighter-Trainee. Under supervision, the Firefighter-Trainee is expected to function as an integral part of the engine company. While this is a 12-month training program, the majority of our Firefighter-Trainees successfully obtain full-time career positions within our department or with other agencies. Incumbents are expected to exercise initiative and some independent decision making in assigned work details and carry out all instructions, directives and lawful orders, and participate in District training activities.

SELECTION PROCESS

Applicants shall submit a resume and application. Applications will be reviewed, in part, according to the criteria contained in this brochure. Applications will be accepted beginning November 8, 2018 at 9:00am and the application period will close on December 14, 2018 at 12:00pm. The selection process may include: application screening, oral and written examination, background investigation, medical and physical evaluations.

- **Examination Process TBD January 2019**
 - Applicants that most meet the District's needs will be invited to participate in the oral interview examination process
- **Fire Chief's Interviews TBD January 2019**
 - Top scoring candidates from the oral interview examination will be invited to a Fire Chief's interview
 - Selected candidate(s) will advance to a background investigation
 - Successful candidate(s) will be offered a position subject to a physical exam, drug screen and psychological evaluation
- **Start date Spring 2019: TBD**
 - It is anticipated that selected candidate(s) will be required to participate in a regional fire academy for approximately 11-12 weeks in Spring 2019.

Qualifications

Minimum Qualifications:

- 18 years of age
- High School Diploma (or equivalent) or higher
- Must possess a valid CA driver's license at time of application
- Must possess a valid CA EMT-B or EMT-Paramedic card at time of application
- Must possess a valid CPAT card successfully completed in 2018 at time of application (see "How to Apply" for further information)

- College Fire Science studies
- NWCG Firefighter Type 2

Knowledge, Skills and Abilities:

- Ability to learn firefighting tactics and EMS techniques
- Ability to learn the operation and maintenance of equipment
- Ability to act calmly and effectively in emergency situations
- Ability to understand and follow oral and written instructions
- Ability to communicate effectively
- Ability to maintain harmonious relationships with others in a group-living environment
- Ability to do strenuous physical activity for extended periods of time

The District:

The Tiburon Fire Protection District was formed in 1941 and is a combination department with 24 career and 12 volunteer firefighters under the direction of Chief Richard Pearce. The District has three shifts with a Battalion Chief, Captain, Lieutenant, Engineer, 3 Firefighters and 2 Firefighter-Trainees per shift working a 48/96 schedule; at least one member per shift is a licensed paramedic.

The District provides emergency response, fire prevention and public education to a 6 square mile area. Annually, the District responds to approximately 1700 emergency incidents utilizing a modern fleet of emergency response apparatus including 2 Type I engines, 1 Type III engine, a medium rescue, a Moose fireboat and an ambulance. The District belongs to the Southern Marin Emergency Paramedic System, a JPA that provides ALS treatment and transportation to the residents of the Southern Marin area.

The Community:

The Tiburon Fire Protection District is located in southern Marin County. We are bordered by the Richardson Bay, San Francisco Bay, and Angel Island State Park. We serve the communities of Tiburon, Belvedere, and parts of unincorporated Marin County. Our citizens enjoy spectacular views of the Mount Tamalpais and Angel Island State Parks, the Golden Gate National Recreation Area, and the Richmond-San Rafael, Golden Gate, and Bay Bridges.

Applications will be accepted at District headquarters: 1679 Tiburon Boulevard, Tiburon, CA 94920, beginning 9:00am November 8, 2018. For applications sent by USPS/FedEx/UPS to be considered, the application must be received prior to the application filing deadline on December 14, 2018 at 12:00pm.

Valid CPAT cards will have a successful completion date in 2018. If your CPAT card is dated prior to January 1, 2018, you MUST submit proof of registration for renewal, and successfully renew, prior to date of hire. No exceptions.
