National Cohesive Wildland Fire Management Strategy Update

March 14, 2013

The Regional Action Plans for each of the Cohesive Strategy Regions – Northeast, Southeast and West – were submitted to the Wildland Fire Executive Council (WFEC) March 5, 2013. The Action Plans were developed through a collaborative, intergovernmental and public process. In addition to a portfolio of actions and activities to be implemented within the next five years, the Action Plans also detail activity-tracking metrics including scope, timeframes, responsibilities and roles throughout the wildland fire community. The Action Plans, along with the Regional Risk Analysis Reports completed in December 2012, have been posted to the Cohesive Strategy website at <http://www.forestsandrangelands.gov>. The websites for all three regions are also available on this website. In response to requirements of the Federal Land Assistance, Management and Enhancement (FLAME) Act of 2009, the Wildland Fire Leadership Council (WFLC) - <http://www.forestsandrangelands.gov/leadership/index.shtml> directed the development of the National Cohesive Wildland Fire Management Strategy (Cohesive Strategy). The Cohesive Strategy is a collaborative process with active involvement of all levels of government and non-governmental organizations, as well as the public, to seek national, all-lands solutions to wildland fire management issues.

The Federal Emergency Management Agency's (FEMA) U.S. Fire Administration (USFA) announces the release of the ***Fire Estimate Summary Series (2007-2011)***. This series presents basic information on the size and status of the fire problem in the United States as depicted through data collected in USFA's National Fire Incident Reporting System (NFIRS). The data summary series was developed by USFA's National Fire Data Center to share information with the American public, fire departments and first responders around the country to help them keep their communities safe.

Individual summaries are issued as part of the ***Fire Estimate Summary Series*** and address the size of a specific fire or fire-related issue as well as highlight important data trends. As part of this series, 18 summaries have been issued presenting basic information on the leading causes of residential building and nonresidential building fires, deaths, injuries and dollar losses for 2011 and highlighting overall trends in these leading causes for the five-year period of 2007 to 2011. Additional new and updated fire estimate summaries will be periodically released under this series as future year data become available.

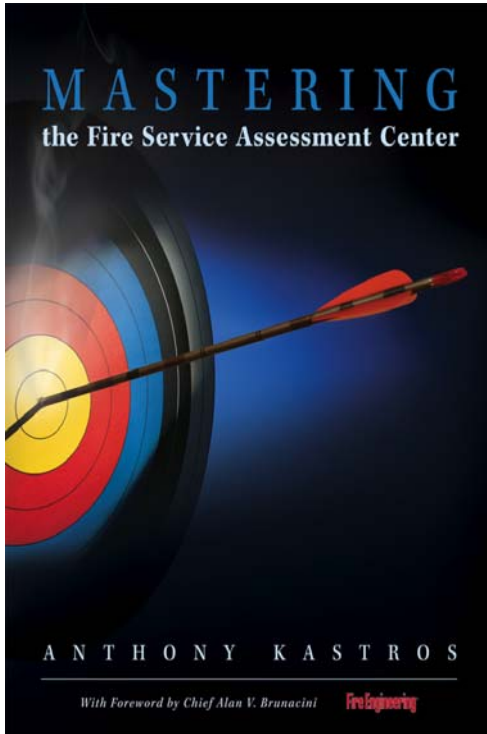

Full refunds will be provided if requested 14 calendar days in advance of each class at 1500 hours. If a class begins on Monday, then the refund deadline is 1500 hours two Mondays prior. If a refund is requested within 14 calendar days before the first day of the class, the student may be given credit for a future course, but not a full refund. No refunds will be provided if the student does not attend the class, or if they begin the class but do not complete the class.

FIREFIGHTER EMPLOYMENT OPPORTUNITIES:

If you want to become a firefighter, have you started taking fire department examinations yet? If not, what are you waiting for? If you say you're not ready, you'll probably never be ready. If you want to wait until you finish your degree, then you're going to have wasted about two (or more) valuable years that could have been spent learning how to master the fire service testing process. You should be taking every fire service exam you qualify for – what's the worst that can happen if you take a test? If nothing else, you will hopefully start to learn your strengths and weaknesses and what it takes to become a firefighter. Don't rely on us to provide you with every fire department that is accepting applications. We only send out a small fraction of the current open firefighter positions across the United States. If you truly want to become a firefighter, put your money where your mouth is and subscribe to a fire testing service that will notify you when fire departments across the United States are accepting applications.

Two of the best fire testing notification services I have seen are:

- www.firecareers.com

For less than \$100.00 per year (each), those companies (run by firefighters) will provide you with valuable testing information to help save you time and effort. Becoming a firefighter is not an easy task, and the badge will not drop from the sky into your lap. Don't wait for your friends to tell you about testing opportunities or expect to hear about them from us. That is not our job, to replace such companies.

CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas. To see the

- NOTE: Do not wait until the last minute to attempt to complete the CPAT as it is common for people to fail their first attempt and have to go back on another day for a retest. More and more departments are asking for a CPAT card within six months or one year of the date of their testing process and I've seen many candidates fail the CPAT (and even retests) and not be able to continue through a department's testing process because of their failure to plan ahead. Don't let this be you!

A New Castle County (DE) Paramedic operating at the scene of 2 serious crashes on 2 bridges, 1 each direction, was reportedly injured early this morning when he fell between the two roadways through a small gap. He fell 20 to 30 feet when additional ALS patients were determined on the opposite side from him and he attempted to cross over to assist. His injuries and status are currently unknown but was reported to be conscious at the hospital. The Paramedic was one of 5 patients, at least 2 of which were ALS, taken from what ended up being 3 incidents at the one location at the same time on Delaware Route 7 by the entrance to the Delaware Park Casino - just after midnight this morning. All patients were taken the Christiana Hospital Trauma Center, which is close to the scene.

The first crash was when a single vehicle crashed into a jersey barrier north bound on Route 7. That vehicle had 3 patients. The second was caused as a good samaritan, who had stopped his van in the south bound lanes, was struck by an SUV soon after stopping, trapping the driver of that SUV. The Paramedic fell just after arriving in the beginning of operations at the 2 MVCs. Fire companies from Mill Creek and Minquas of Newport, along with EMS from Mill Creek, Minquas, Elsmere, Cranston Heights, Aetna of Newark and Several New Castle County Paramedic units and Supervisors were operating on the scene.

REMINDERS:

This CLOSE CALL injury incident is grim reminder of the Line of Duty Death of Alexandria (VA) FD Paramedic Joshua A. Weissman. As you will recall, PM Weissman died on February 9, 2012 from injuries he sustained when he fell from a highway overpass on Interstate 395 while responding to a vehicle fire with a report of someone trapped on February 8, 2012. Furthermore, in related incidents, 2011 a West Virginia FF died in the Line of Duty when he fell from a bridge investigating a fire...and in 2007 an Arkansas FF died in the Line of Duty when he fell from a highway bridge while working a crash. **HERE is that report:** <http://www.cdc.gov/niosh/fire/reports/face200731.html>

TWO AUSTRALIAN FIREFIGHTERS KILLED IN THE LINE OF DUTY

We regret to advise you that two Australian Firefighters died earlier today while operating at a still out of control wildland fire. The two DSE Firefighters, operating on the western edge of the fire at Pheasants Creek Track, were killed when a tree fell on their 4WD apparatus. The Firefighters were a man in his 30s and a woman in her late teens. The fire is located 170km north-east of Melbourne.

The pair had been part of a major effort fighting the fire that has been burning in the Harrietville area for weeks, intermittently threatening various communities. The fire threat prevents emergency crews from getting their remains out of the area. They are the third and fourth Victorian Firefighters to die this season, where it is summer is Australia. In December, CFA volunteer Peter Harry collapsed died while battling a house fire in Gisborne. Last month, 61-year-old DSE firefighter Peter Cramer, from Gippsland, died fighting a fire in Tasmania. DETAIL UPDATE-THE LINE OF DUTY DEATH OF A 20 YEAR OLD FIREFIGHTER ANNE VESETH--- "DEATH WAS AVOIDABLE"

As you will recall, 20-year-old wildland firefighter Anne Veseth was killed in the line of Duty six months ago (August 12, 2012) in northwest Idaho. Now several investigations into the death of FF Anne Veseth are coming out. The first one finds Veseth died under hazardous conditions that could have been avoided. August 12, 2012 was a hot, dry day in when, during the fire, trees started crashing down...the trees that were falling hit a couple other trees that fell like dominos. Everyone ran for their lives. Once the forest came to a standstill again, fire crews made their way through the mess to find someone pinned under a tree. Forest Service radio traffic shows that Initially, the incident was called in as an injury but it quickly became clear on the ground that FF Anne Veseth, had been killed.

Safety protocols have significantly reduced the number of firefighter fatalities. But the federal Occupational Safety and Health Administration, or OSHA, says many of those protocols were not followed at the Steep Corner Fire. Inspectors found: poor communication; a lack of planning for escape routes; helicopter bucket drops without warnings to the ground crew; crews working amid numerous "hazard trees"; and a clear "potential for trees to domino." OSHA issued two citations for workplace safety violations to the Forest Service. OSHA didn't only find fault with the Forest Service though. The fire that FF Veseth was fighting was managed by a private entity. The Clearwater-Potlatch Timber Protective Association oversees a patchwork of state, federal, and private land, where the Potlatch timber company owns the largest share. OSHA issued three citations to the non-profit timber association and a \$14,000 fine.

WARNINGS: You may also remember that the day before FF Veseth died, a highly experienced and qualified hotshot firefighting crew **refused to work the fire** because it was too dangerous. One detail

the OSHA report did not pinpoint is which exact factors led to the death of Anne Veseth. The Forest Service is conducting its own set of investigations and expects to release those findings soon.

Lt. Eric Wallace was killed when a portion of the roof reportedly collapsed. 1 of the injured Firefighters is in surgery and reported to be very critical. The 3 Firefighters injured in the fire are Lt. Greg Pickard, 54; Firefighter Ricky Mantey Jr., 30; and Probationary Firefighter Mitch Moran, 21. 2nd MEDIC FROM INDIANAPOLIS EMS DIES FROM INJURIES IN YESTERDAYS CRASH

We regret to pass on to you that the second medic from Indianapolis EMS IAFF Local 416, EMT Cody Medley, who was reportedly the passenger of the ambulance, passed away in the Line of Duty at 0200 hours this morning. His EMS partner, Timothy McCormick a 24-year-old EMT died yesterday after suffering critical injuries in a car-ambulance crash in downtown Indy. The crash occurred around 0330 yesterday McCormick's fellow EMT, the lone passenger in the ambulance he was driving, was also taken to Wishard Hospital in critical condition; the name of that person has not been released yet. McCormick died at the hospital. The female driver of the car that struck his ambulance was also taken to Wishard for a legal blood draw. Police reports indicate that she ran a red light, with the ambulance moving through the intersection under a flashing-yellow right-of-way signal. She did admit to police of having a few drinks previously-but there have been no charges as of yet.

EMT McCormick is originally from Staten Island, NYC. Tim was the second oldest of four children - an honor student and had an intellectual curiosity for a career in public service. Tim had been working as an EMT for nearly three years while earning his bachelor's degree from IUPUI. He was also one of the first responders on scene during the south side house explosion last November.

DOUBLE LODD FIRE UPDATE FROM BRYAN, TEXAS

Here are some updates from Bryan and the horrible loss of two Fire Lieutenants yesterday at the social hall fire.

=Lt. Eric Wallace, 36, a 13-year veteran of the department, was transported to St. Joseph Hospital, where he died of injuries sustained at the scene.

=Lt. Greg Pickard, 54, who had been with department for 32 years, died later at a Galveston hospital, where he and two other injured firefighters had been flown. Firefighter Ricky D. Mantey Jr., 30, and probationary firefighter Mitchel Moran, 21, were reported to be in critical but stable condition late Saturday at the University of Texas Medical Branch Blocker Burn Unit in Galveston.

=FF Mantey has been with the department for five years; FF Moran for just 10 months. They are being treated for "serious" burns but are reported to be stable.

=Lt. Wallace is survived by his wife Brandie and five children ranging in age from 16 years to 11 months.

=Lt. Pickard is survived by his wife Susie, two adult children and three grandchildren. Pickard's wife is a teacher with Bryan ISD and his son is a firefighter in College Station.

The fire was reported by a passerby at about 2319 hours Friday. Companies from Bryan fire stations 1 and 5 originally responded to the fire as well as companies from the College Station with Brazos County volunteer firefighters and other Bryan companies later joining them. Lt. Wallace was one of 2 initial Firefighters who entered the structure. It was confirmed that Wallace and the other firefighter were searching the building to ensure no one was inside. They reported fire conditions above them from the interior (ceiling) and command officers confirmed fire conditions above them and thru part of the roof. While inside the hall, the Firefighters radioed that they were low on air and needed assistance and were unable to find their way out. They were ordered to evacuate the building, but for an unknown reason, Lt. Wallace was unable to. They then deployed a rapid intervention team, composed of Lt. Pickard, FF Mantey and FF Moran, to rescue Lt. Wallace. The team was able to locate Lt. Wallace and had gotten him close to a door. A second team was deployed to extract Wallace and assist the first team but **it's unclear at what point the roof collapsed.** The funeral for Lt. Wallace will be held Thursday at 10 a.m. at First Baptist Church of Bryan. The funeral procession will carry him to the Hillcrest Cemetery in Marlin. Arrangements for Lt. Pickard were not set as of this morning. More to follow. RIP.

FIREFIGHTERS DRAGGED IN WISCONSIN:

3 Milwaukee Firefighters were treated for injuries today after being dragged by a car in a confrontation with a medical patient. The firefighters arrived at E. Capitol Blvd EMS who was trying to control a driver who appeared to be in an "altered state." The man escaped from the medical responders and ran to his car. The Firefighters chased the man and tried to grab his keys but in the process, the driver took off with two FF's hanging on the side of the car" and one firefighter inside, trying to stop the vehicle. The man drove 20 to 30 feet before the Firefighters stopped him...the FF's have been treated and released from a hospital this afternoon. The driver also was hospitalized because of his condition.

LOW STAFFING RESULTS IN STATE INVESTIGATION FOLLOWING FATAL FIRE:

We have been writing about staffing here on The Secret List since we started in 1997, but this is the first time, that we are aware of, that a state investigation is being conducted directly related to the issue. The Georgia Bureau of Investigation (GBI) - investigation of the Columbus Fire & Emergency Medical Services records is resurrecting questions of **whether the first engine company at a 2010 home day care fire that killed one child and injured three otherswas understaffed.**

The questions aren't new. They were the subject of an internal fire department investigation sparked by firefighters' complaints that Engine 7 from Station 7 at 5343 Buena Vista Road should have had five firefighters instead of three. Engine Co. 7 was the first fire unit to reach the blaze at 5629 Mill Branch Road, off Amber Drive north of Buena Vista Road. The fire was reported at 1:37 p.m. Friday,

Feb. 26, 2010. First responders described a chaotic, congested scene, with neighbors gathering on the street and parents rushing to find children. The one-story house was the westernmost of a set of homes tucked away off a paved semicircle on the road's north side. The arrangement left little room for parking. Having originated in a carport where paint and gasoline were stored near a gas water heater, the blaze erupted with explosions and spread to two cars. When firefighters arrived, flames were racing through the attic.

According to the department's internal probe, Engine 7 was missing two firefighters because the lieutenant who would have been in command was out with an injury, and minutes before the alarm a battalion chief had picked up another crew member for a random drug test. The affidavit backing the search warrant GBI agents served Tuesday at fire department headquarters alleges Engine 7 was understaffed because both missing firefighters were out for drug testing. Records later were either removed or falsified to show only one was drug-tested, while the second was out sick, says the affidavit.

Dispatched

So Engine 7 left the station that afternoon with Sgt. Greg Adams as the ranking officer, backed by Firefighters Rodney Pitts and Connie Jones. FF Pitts was driving. When they reached the working day care fire 1.3 miles from the station, Adams heard witnesses shouting that children were inside. In his rush to get in, he neglected to radio that he was on the scene and kids were in the house, the investigative report said. The exact time Engine 7 reached the fire is unclear. Adams took a 1½-inch line off the truck as Pitts got the engine pumping. The line had kinks that Jones unraveled to maintain pressure. Adams raced through the unlocked front door and hosed the flames back toward the carport. He called for Jones to come in after him. His later complaint was that Jones never came. According to an internal report from Robert Futrell, the department's deputy chief for operations: "He stated that he called to Firefighter Jones numerous times for him to come in to assist with the attack but Firefighter Jones refused to enter the door." Futrell concluded Jones likely never heard Adams: "Due to the smoke-filled room, the use of breathing apparatus and the noise of the hose line, it is very unlikely that Firefighter Jones would have heard Sergeant Adams yelling for him to come inside." Also, Pitts confirmed that Adams' hose had kinks in it.....

**LANCASTER CITY FIREFIGHTERS BURNED ATTEMPTING TO FIND OCCUPANTS-
OCCUPANTS STILL MISSING AND PRESUMED LOST**

Two people are missing (an adult and a child) and feared dead and, as reported earlier, 2 Firefighters were hurt (1 seriously burned) during this mornings multi-rowhouse fire along Madison Street in Lancaster City. The fire heavily damaged the house and trapped two people inside their second floor bedroom. 2 Firefighters immediately went inside the home to try and rescue the trapped people, upon arrival. Lancaster City Fire Chief Tim Gregg says the first responding crews got to the scene within five minutes of the call and began an entry. Two of the Firefighters that made the first entry into the home to help were then trapped themselves. They had to be rescued. Both of the firefighters were taken to Lancaster General Hospital. One was released after a short treatment. The second firefighter was flown by medical helicopter to Crozer-Chester Medical Center outside of Philadelphia. **We'll keep you advised. Keep'm in your prayers.**

We have been provided with the following update regarding the Firefighters injured in this morning's double fatal dwelling fire. As you know, Lancaster City FF's were searching for a woman and a 6-year-old girl in that row house fire earlier today....a man and an 11-year-old boy managed to escape but the woman and the little girl perished ...in spite of the FF's heroic efforts.

Fire Fighter Craig Roberson suffered a fractured vertebra after bailing out a split door on the C side of the house.

Fire Fighter Thomas Bender suffered 1st and 2nd degree burns on his hands and a laceration on his shoulder after bailing out a second floor window on the A side. Both were treated and released from LGH.

Fire Lt Andre Kelly suffered 2nd and 3rd degree burns to about 20-25% of his body. Lt Kelly was flown to Crozer-Chester medical center where he is listed in critical but stable condition. Lt Kelly has undergone a bronchoscopy to determine the status of his airway. There was some swelling to the upper airway but the lower airway was clear which is good news. He will remain sedated for a few days at which time the test will be repeated. We will keep you advised as Lt. Kelly makes continued progress.

While this is an off duty incident, it is worthy of note. The Ashby (MA) community is mourning the tragic loss of a FF/EMT mother and her teenage son after they were killed in a two-car crash in Fitchburg Sunday morning....that was driven by another Ashby Firefighter.

Michelle Martens, 36, a volunteer FF/EMT in Ashby, came from a family of Firefighters. For reasons unknown, the car Martens was in crossed into oncoming traffic and hit a truck that was being driven by another Ashby FF, Wayne F. Patenaude. Martens and her son, Justin Fournier, were ejected from their vehicle after crashing head-on into the pickup truck. Martens was a third-generation firefighter at the Ashby FD. Martens father and grandfather were assistant chiefs. Martens' 16-year-old son was getting ready to follow in his family's footsteps.

FF Patenaude, 45, suffered a fractured femur in this crash and is listed in fair condition at UMass Memorial Medical Center in Worcester.

adults and kids. Radio recordings provide a unique opportunity to professionally and respectfully listen to one aspect of the incidents. One aspect, since radio traffic doesn't provide a full understanding and account of any incident-but it is of value for learning and training. This morning, Firefighters in Prince Georges County, MD arrived on the scene of a working dwelling fire with multiple kids trapped. Listen to their heroic efforts in attempting to save the little kids...the members arrived, initiated a search of the burning dwelling and removed 1 adult male and 3 children: 5, 8 and 10 year old females. All four were not breathing and had no pulse.

Firefighters have much higher levels and different patterns of these chemicals in their blood than the general population. There is no doubt that firefighting is a dangerous occupation. What we have shown here points to the possible link between firefighting and cancer."

FIREFIGHTER TAKES HIGHWAY LEAP OF FAITH:

This may sound familiar....you turnout for what appears and sounds like a "routine" one car off the road crash w/no injuries with no injuries? In this case it grew into a 5 vehicle pileup with a Firefighter close call. In Windsor (VT) a Firefighter who jumped off an Interstate 91 overpass to avoid an out-of-control tractor-trailer truck is recovering from injuries, yesterday. FF Molly Wood, a four-year member, came away from the 30' drop with a concussion, cuts and bruises and a likely broken ankle. She was fully geared up, including her helmet and the use of her gear contributed to minimising her injuries. Though FF Wood's was the only serious injury from the event that started above County Road early yesterday morning, it was only part of a wild few minutes that saw at least five vehicles - including three semi-trailer trucks - lose control on the icy interstate.

ILLINOIS FLOOR COLLAPSE-CLOSE CALL AT COMMERCIAL BUILDING FIRE.

FF Rick Flessner said yesterday he feels lucky to be alive after a floor collapsed underneath him during an early-morning fire at a bar in downtown Melvin (east central Illinois). "I'm just glad to be here," he said as he spent Friday recovering at home. "I've got a new outlook on life." Flessner, a 20-year veteran of the Roberts FD, was among an estimated 30 firefighters from 3 area departments that responded to the fire at Bubba's Bar and Grill, 103 W. Main St., about 0330 yesterday. Melvin Fire Chief Larry Boundy, who works as a snow-plow driver for the village of Melvin, said he was plowing snow in downtown Melvin when he noticed "flames coming out of the front windows" of the bar around 3:15 a.m. "The front part of (the building) was on fire," Boundy said. "It was just burning through the windows and stuff."

"....when we were pulling that ceiling down, the floor gave way, and when it did, I fell and caught myself on the pole I was using. I fell onto the pike pole across the floor space, and when the floor gave way the rest of the way, I went all the way down into the basement...."

On February 26, 1993, that group of terrorists detonated explosives in an underground parking garage below the North Tower, killing six innocent people. The World Trade Center bombing occurred on February 26, 1993, when a truck bomb was detonated below the North Tower of the World Trade Center in New York, NY. The 1,336 lb (606 kg) urea nitrate-hydrogen gas enhanced device was intended to knock the North Tower (Tower One) into the South Tower (Tower Two), bringing both towers down and killing thousands of people. The Fire Chief says one of his firefighters was returning to the station following a house fire when a tire blew out. The driver over-corrected and the tanker flipped on its side. **No one was hurt in the crash.** Another BELT IN Reminder.

TOUGH FIREFIGHTER TAKES ON CANCER-DIES ON HIS FAVORITE SCENE.

Three days, maybe a week. Three weeks ago, that's how much time doctors gave Mitch Zannette to live. **So last week, PA Firefighter Mitch Zannette checked himself out of hospice and headed to Florida to see the Daytona 500. He made it to the track. Went to the beach. Met Miss Sprint Cup. Drank some beers. And on Thursday, three days before the race, he died in the infield at Daytona International Speedway. He was 50.**

Mitch Zannette was a Firefighter, a mason, a pool player, a father and a friend. He lived in the tiny borough of Pen Argyl, Penn., population 3,600. His favorite foods were broiled seafood and cream cheese cupcakes. He loved hunting and drinking Budweiser, and both led him to tell some amazing stories. He was a NASCAR fan for most of his 50 years, and rarely missed a race at Pocono, his local track. In all this, he was not unlike so many other hundreds of thousands of NASCAR fans. But for the last 16 months, Mitch had been suffering from lymphoma and bone cancer. His body was withering, even if his mind and spirit weren't. He'd lost so much weight since the days he was the first one onto the fire truck. In October, he'd dislocated his shoulder dragging a buck, the spoils of a hunt, through the Pennsylvania woods.

And then, in early February, the final sentence. An examination prior to chemo revealed that he was dehydrated, and in the hospital he suffered an obstructed bowel. Surgery was deemed too dangerous, but left untreated, the obstruction would be fatal as well. He spent a couple of days

in the hospice, then decided enough was enough. His world had narrowed to a matter of hours. And he knew exactly how he wanted to spend them. He couldn't fly to Daytona, so he drove. Zannette left Pen Argyl at 6:00 in the evening of Valentine's Day, accompanied by his longtime companion Tammy Bloodworth, their son Mitchell Anthony, and Zannette's brother Joe. They drove their rented RV down Interstate 95 for 14 hours, arriving midmorning on Friday. "The hospice nurse gave us a week's worth of [pain] pills, so I asked her if we could do this," Joe said. "She said yeah. The next day, we called for reservations, a motor home, and tickets. We were off to the races. We were gone!" RIP Mitch. **READ THE REST OF THIS EXCELLENT STORY:**

FDNY'S AGGRESSIVE LUNATIC ATTACK: FIREFIGHTERS TAKE ON A MEAT CLEAVER PSYCHO:

A man attacked his young wife with a meat cleaver yesterday morning in Chinatown, but the bloody attack was broken up by nearby Firefighters who heard the woman's screams. It happened in front of Fong's Trading around 1030 hours when an argument between the suspect and his 23-year-old wife, ended with the man striking her multiple times with a meat cleaver. **Two Firefighters across the street at the Engine 9/Ladder 6 firehouse were preparing their rigs for the day when they heard the screams. and helped subdue the man. 18-year FDNY veteran Jose Ortiz describes the moment he stopped a vicious meat-cleaver attack by grabbing the suspect's arm to prevent him from hitting his wife.** "I saw a man dragging this woman, she's crying and screaming," said Jose Ortiz, an 18-year FDNY veteran. "As I get closer, the man pulls a cleaver out of his waistband and starts hacking at this woman. I'm trying to grab his arms (and) he's just swinging . . . six, eight, maybe 10 times he hits the woman in the head. So, we both [he and Firefighter James Trainor] bum rush him and get him against the fence." A fellow Firefighter flagged down a passing police car, and officers cuffed and arrested the subdued man. The woman ran down the block screaming hysterically before ducking into a noodle shop. She ran out of the restaurant and down the block, but Firefighters were finally able to stop her at 56 E. Broadway, where they treated and bandaged wounds to her abdomen, torso and head. Paramedics took his wife to Bellevue Hospital, where she is reportedly listed in critical but stable condition.

Indiana Prosecutors will not file criminal charges against the driver in the ambulance crash that killed two Indianapolis EMTs in the Line of Duty.

EMT Cody Medley, 22, and EMT Tim McCormick, 24, were fatally injured in the Feb. 16 crash at St. Clair Street and Senate Avenue involving their ambulance and another vehicle. The driver of the other vehicle, Jade Hammer, 21, survived the crash. Her speed was in the range of 35 to 40 mph and the ambulance's speed was in the range of 45 to 50 mph in a 30 mph zone. The traffic light at the intersection was flashing yellow for the ambulance and red for Hammer's car, and cops said Hammer did not fully stop. However, the Indiana Supreme Court in 2009 held that failure to stop at a red light due to error of judgment does not constitute recklessness as a matter of law. Ms. Hammer also told police said she had consumed one and a half drinks before the crash, but her blood-alcohol content was found to be 0.038, which is below the threshold legal limit of 0.08, police said. A separate toxicology screen found no evidence of other substances in Hammer's blood. "This was clearly a tragic accident, and we again extend our sympathies to the families and friends of Cody Medley and Tim McCormick," Curry said. "However, we do not believe that the circumstances of the accident rise to the level of a crime." Ms. Hammer will be ticketed for running the red light. RIP.

FATAL EMS CRASH IN FLORIDA: Unborn Child Dies-Witnesses Blame EMS Driver For Running Stop Sign

Fort Myers (FL) cops are conducting a traffic homicide investigation due to the death of an unborn baby. Just before 1700 yesterday, the police responded to a crash involving an ambulance and an SUV at the intersection of Veronica Shoemaker Boulevard and Canal Street. **Witnesses say the driver of the ambulance ran a stop sign at the intersection and the two collided.** 26-year-old Kristina Childs was driving the SUV. She had a 3-year-old, a 5-year-old and a 17-year-old in the car

with her. Two paramedics in the ambulance were transporting a patient to Gulf Coast Hospital, but witnesses say the emergency equipment was not activated. **All four people in the SUV were transported to Lee Memorial Hospital. INDIANA FIREFIGHTER DIES FOLLOWING SHIFT

We regret to advise you that the Zionsville Fire Department is mourning the loss of a Firefighter/Medic today. Fire-Medic Cody Richardson, 26, was found unresponsive Monday at a farm in northern Boone County-he had completed a shift with the department at 0700 hours Monday. According to the ZFD, he was taken to a local area hospital where he was pronounced dead. A cause of death has not been determined as of this morning. Richardson was hired as a part time firefighter/EMT in 2007. He was hired on full time in 2008. He later went through paramedic school and became a firefighter paramedic. Funeral arrangements were not finalized as of this morning. Our condolences to all affected-RIP.

=FLAME JETTING?!

The ATF crew wanted to share this information and below video segments for distribution on The Secret List. They have been trying to get the word out to firefighters, fire investigators and code officials. It's a not-so-well known flame jetting phenomenon that they came upon while evaluating a suspects statement. Since they've begun to get the word out, it turns out that there have been numerous flame jetting injuries that were once thought to be isolated "freak" incidents. The 17 year old victim in this particular case was the daughter of a Baltimore County Firefighter (and good friend of Fallen Firefighter, Mark Falkenhan).

Here's a quick overview of what the ATF crew thinks is going on:

Based on the testing series conducted at the ATF FRL, several observations were made regarding the flame jetting phenomenon. Flame jetting was only observed when the container was being tilted and the vapors were pouring from the mouth of the container. It is hypothesized that initially when the container is upright, the head space above the liquid is too fuel rich (above the Upper Flammability Limit) and combustion is not supported within the container. As the container is tilted and vapors

begin to pour from the container, air is entrained into the head space and the fuel rich mixture eventually falls within the flammable limits, allowing flame propagation within the container. The flame jetting phenomenon was only observed with "weathered" or evaporated gasoline (25% weathered gasoline was evaluated). No flame jetting was documented when "fresh" gasoline was poured from the container. It is hypothesized that "fresh" gasoline releases vapors more readily than "weathered" gasoline at the same temperature. Consequently, even when air is entrained into the container headspace while pouring, "fresh" gasoline releases flammable vapors readily enough that the headspace never drops below the upper flammable limit and therefore does not support flame propagation within the container.

In separate tests, flame jetting was documented with burner flames in direct contact with the mouth of the container (piloted ignition) as well as with burner flames that were several inches from the mouth of the container at the time of ignition (non-piloted ignition). The flame jet was observed extending as far as 4 m (13 ft) horizontally. The flame jet propelled ignited liquid out of the gasoline container. The propelled liquid ignited cotton clothing on a mannequin located 1.3 m (4.3 ft) away and sustained burning after the momentary flame jet self-extinguished. The entire jetting event lasted less than one second, with no observable warning signs prior to the phenomenon. When jetting did occur, there was no evidence of thermal or pressure damage to the container. The length of the flame jet was dependent on several variables, including the total quantity of liquid, the mixture ratio and the percentage that the gasoline was "weathered." Flame jets as small as 6 inches were observed in subsequent testing. If the nozzle is in place when the flame travels into the container, the container has been documented to rupture and often injures the person holding the container.

That firefighter is also expected to recover.

ARE YOU A FIREFIGHTER UNDER THE AGE OF 30?

DO YOU KNOW ABOUT THE POMPEY HILL FIRE?

Actually-everyone should be familiar with the date of March 7, 2002, (11 years today) where 2 Firefighters from the Manlius FD in NY were killed in the Line of Duty at a house fire-where so much went wrong...and the lawsuits followed...and continue.

John "Gino" Ginocchetti, 41, was President of Manlius IAFF Local 3316 and a veteran firefighter/paramedic of 12 years with the Manlius FD. He was survived by his wife Pam and his then 15-year-old son Timothy. Another tragedy struck the Ginocchetti's family a few years after the fire. His widow, Pamela, was stabbed to death in 2006 by her son. Timothy, who is now serving 15 years in state prison for manslaughter. Timothy J. "T.J." Lynch, 28, had been a career firefighter/paramedic with the Fayette Fire Department for a couple of years. He was also a volunteer with Manlius. He and his wife Donna had a 18-month-old son, Phillip. Pompey is about 12 miles southeast of Syracuse.

AMONGST THE FINDINGS:

- The IC was not clearly identified as the only individual responsible for the fire...the (then) County Coordinator added to the existing confusion of poor command, control and accountability.
- The Incident Commander did not convey strategic/tactical decisions to all FF's on the fireground and did not reevaluate the continuing fire conditions.
- Command did not conduct an initial size-up (including 360) of the fire before initiating and directing companies.
- There was no coordination between the ventilation crew and the attack crews.
- Fire fighters did not clearly report conditions and hazards encountered to their company officer or Incident Commander.
- Firefighters operated above the fire.

Remember Lionville. Today is the 15th anniversary of the PA Turnpike crash that killed a Lionville (PA) Firefighter and injured 9 others in the Line of Duty. As we saw this week in Illinois, when FF Chris Brown was struck and killed, being struck, injured and killed on the roadways continues to be a significant hazard and risk to this job. **(PLEASE CHECK OUT THE FREE TRAINING PROGRAM LINKS BELOW)**

WHAT HAPPENED IN LIONVILLE:

At approximately 1418 hours on 3/9/1998, Lionville Fire Company (Chester County, PA) and Uwchlan Ambulance were dispatched to a single vehicle automobile crash at milepost 310.9, just west of the Downingtown Interchange on the Pennsylvania Turnpike. A Heavy Rescue Truck, Engine Company, Assistant Chief and Ambulance responded. Upon arrival on the scene, the Ambulance, Rescue Truck, and Assistant Chief's vehicle parked on the shoulder of the road off the travel lanes of the highway. At the same time, two additional crashes were reported on the Turnpike. The second accident was reported at milepost 307 westbound (west of the first incident). The Engine responding to the first accident was directed to continue past the primary scene to respond to the second crash. A third accident was reported of a vehicle overturned at milepost 314 on the eastbound side of the highway (east of the original incident). Then Lionville Fire Chief William Minahan responded to that call with mutual aid units to investigate. At 1438 hours, as personnel were loading the accident victim into the Uwchlan Ambulance, a tractor trailer traveling westbound lost control and crashed into the Assistance Chief's vehicle, overturned, and slid into the back of the ambulance and the other responders in that area. The Assistant Chief and a Firefighter with him in his truck were trapped in the severely damaged vehicle and had to be extricated by mutual aid rescue personnel using the Jaws of Life. **Firefighter Dave Good of the Lionville Fire Company was killed in the line of duty. Nine other emergency responders were injured, three seriously.** The injured included Assistant Chief Steve Senn, Firefighters Chris Good, Mike Cox, Eric John, Pete Harmansky, James Rattrie, and Robert Doan, all firefighters with the Lionville Fire Company, and EMT Brent Kaplan and EMT John Wanczyk of Uwchlan Ambulance.

Firefighter David Good was 38 years old and had 5 years of service as a Firefighter with Lionville Fire Company. He was survived by his wife Maryanne and two sons, Johnathan and Jason Good. RIP.

That incident 15 years ago eventually led to the production of a video called the "10 Cones of Highway Safety" and a training program about Highway Safety both by VFIS. It also was one of two Firefighter struck-by-vehicle line of duty deaths in 1998 that led to the formation of the Emergency Responder Safety Institute (ERSI) (www.respondersafety.com) a committee of the Cumberland Valley Volunteer Fireman's Assoc. Since that time ERSI personnel have worked constantly to build awareness of the dangers responders face while working at roadway incidents, to develop training aids that are available for free from the website and to collaborate with government and fire service officials to develop standards, regulations and guidelines to protect emergency responders at roadway incidents. ERSI personnel continue to work on more new training programs and educational material related to this subject and to pass along this information at fire service trade shows and conferences. Their motivation started with the death of FF Good-and hasn't ended....**FIRE/EMS**

"WRONG WAY" RESPONDING CRASH LAWSUIT IN NEW JERSEY

Ever driven your fire apparatus, ambulance or related unit the "wrong way", against traffic?

Most have when trying to get to an emergency. HOWEVER-in this claim, a woman who was a Phillipsburg (NJ) High School senior, says she is lucky to have survived after an ambulance slammed into her car and two years later, she is suing the driver, the emergency squad and the town for a crash that she says still causes her pain. The March 7, 2011, crash left Taylor L. Gudzinis, 20, with an injured neck, back and knee. She also suffered facial scarring, and glass from the crash remains embedded in her face. Gudzinis is suing the ambulance driver, the Phillipsburg Emergency Squad and the town for the incident, according to a civil complaint filed in New Jersey Superior Court. The driver, Cody Kolb, 23, was responding to a call for an unconscious elderly man at 4:54 p.m. when he drove the wrong way down Chambers Street, a one-way street. He T-boned the passenger side of Gudzinis' car, sending the car into a store. The driver's side of Gudzinis' car had to be ripped open to free her from the car.

At the time, Kolb was issued a summons for driving the wrong way down a one-way street. Although the siren and lights were on, officials said the ambulance should not have been traveling the wrong way.

The Feb. 26 complaint holds Phillipsburg "vicariously liable" for the crash. The emergency squad runs independently of the town, said Mayor Harry Wyant Jr. He said the town had yet to receive a copy of the lawsuit and declined to comment on the complaint. After the crash, Wyant said the driver should have obeyed traffic laws. "You're still supposed to adhere to all traffic laws," Wyant said. "I don't know if the driver was confused as to whether the street was one way or not, but still, they were not supposed to be going the wrong way down a one-way street."

Hey,

The Fairfax County (Virginia) Fire and Rescue Department's communication section has produced an "unofficial" report that you may have seen*. The document essentially recommends that you wear your portable radio on a leather strap, under the coat, but with the radio extended (sticking out) below the bottom of the coat with the antenna tilted away from the body....as opposed to using PPE radio pockets. We have the document posted on our home page so you can check it out. **..But wait. Theres more. Lots More.** I wanted to look into the issue as well ... because when operating in IDLH areas, wearing it on a strap, under the coat had seemed to make the most sense to me-and pretty much what I have always done. Several firefighter injury and LODD investigations have shown that there are genuine and concerning issues with radios that are exposed to extreme fire conditions. Exposed radio mic cords (from the mic to the radio) have melted and been compromised under heavy fire conditions. It also makes sense to me that the newer system radios seem to work best when their antennas are not covered up. And I also know that when your radio is under the coat, you can't easily change channels on the radio itself. So now what!?! **..Well slow down....**

I did some digging and found out that the report has actually **not been** adopted by the Fairfax County Fire & Rescue **Department**. To be clear, this report was not been issued by the department as it may not provide all the answers to best benefit firefighter safety and survival. Hmmm. I spoke with some of the top brass at Fairfax County, who stated that the communication sections report findings are

being reviewed within the department, to determine if a change in policy will be instituted. I also spoke with IAFF Safety & Health Director Pat Morrison, who stated that, while not focusing on the Fairfax communications section report exclusively, **they do not necessarily agree that portable radios should be worn under our bunker coats.** Issues such as signal blocking, access to changes channels, openings in your PPE in IDLH areas, the mic poking out of an open top or the radio exposed out MAY not be the best way to use your radio. The IAFF is working diligently on the issue as an important safety priority and will be issuing recommendations soon. The IAFC Safety, Health and Survival Section is also well aware and have reached out to support and work collaboratively on the issue...So what is the answer?

For now, it makes the most sense to do what's worked best under the policies of your department. Actually, it makes more than just good sense, you should follow your departments policies - (*how 'bout that, free career advise*) ...and wait to see what all the researchers come up with. I know that sounds like a lame answer but it's my opinion that until the experts provide additional information on exactly what to do, we have to hang on just a bit and do whats worked best in our organizations...until a collaborative report or standard (NFPA is on top of this issue as well) for the wearing and using of our radios in IDLH environments is issued. I also have solid information that the radios themselves, and especially the cords, will be much more robust and better protected in the very near future-so that "weak" link may be minimized. Clearly, fire conditions and related fire behavior are major factors -and so is our fireground behavior. Nothing will survive the worst fire conditions... and some might even say "don't go in there" ...and that's nice--but not reality. We generally do "go in there." While water on the fire is the amongst the best solutions, there will be times, when all the best practices and behaviors are followed and we still get in a jam...and when in that jam, the hope is that the radio and system will allow us to call for help...wherever we are wearing it. Much more to follow. *We've posted the report on our home page so you can check it out-but keep in mind, this is a section report and has not been adopted as policy by the department.

FIRE APPARATUS SEVERED IN CALIFORNIA:

An Orange County Fire Authority truck slammed into a massive tree this evening in a crash that was apparently powerful enough to sever the emergency vehicle. Four fire fighters on board suffered injuries and were transported to the hospital with non-life threatening injuries. Ladders and fire-fighting gear were strewn across the roadway. Aerial footage showed the truck almost entirely on a roadway median, leaning against a gnarled tree. The right half of the truck's back portion appeared to have broken off from the rest of the apparatus (pictured below). It was not immediately known whether the truck's emergency lights or sirens were on at the time of the crash, or if the crew was responding to or returning from a call. **HERE IS A PHOTO:** <http://tinyurl.com/bwsqzlv>

UPDATE: APPARATUS STRIKES AND KILLS CIVILIAN

This is a horrible situation that appears couldn't be avoided. It seems that glare from a brightly lit Christmas tree in a downtown park might have been a factor in a Lexington Firefighter's running over and killing a pedestrian last Dec. 8. A report released Tuesday said ambient light reflected off rain-slicked pavement and the fire truck's wet windshield could have impaired Firefighter Chris Presley's vision as he turned the apparatus left from Main Street onto South Broadway. Lauren Woodall Roady, 27, was legally crossing South Broadway at the time. She was struck by the left side of the Lexington fire department's Engine 9 and run over by its back wheels, police have said. She died at the scene. Presley, 40, remains on paid, administrative leave. The police revealed numerous factors that could have caused FF Presley not to see Roady, and Roady not to see or hear the truck. The truck was not on an emergency run at the time of the accident, and its lights and sirens were not activated. Cops concluded that Roady had the right-of-way and Presley "had the obligation to observe and yield to Mrs. Roady." However, Presley told police he didn't see Roady before making the turn. "He felt like

he 'ran over a speed bump' with his back tires but saw nothing," the report said. "He looked in the mirror and saw something lying in the road' then immediately stopped Engine 9.

CLOSEST UNIT GOES? What's Best For The People Needing Help?

The Los Angeles City Fire Department is going to upgrade its dispatch center to mutually work with neighboring fire agencies to ensure the closest available units are sent during life-threatening emergencies-no matter what jurisdiction it's in. A media analysis of city and county records published in October found that in more than 70,000 emergency medical calls since 2007, the LACityFD sent its own rescuers to victims despite the fact that Los Angeles County firehouses were closer to the scene. More than 1,300 of those cases involved cardiac arrests. In two cases highlighted, cardiac arrest victims died after waiting for LACityFD units when county help was closer. LACityFire Chief Brian Cummings said he would like to see a seamless network that connects dispatch systems across municipal borders. Potential partners include the Los Angeles County Fire Department, the Long Beach Fire Department and the consolidated dispatch center that covers Burbank, Glendale, Pasadena and nine other cities, Chief Cummings said.

Budget Related Items:

A rash of late-summer wildfires and other unforeseen events made 2012 a lucrative year for a handful of public employees in Washington. Records show the top three overtime earners in Clark County's largest cities made nearly \$350,000 combined in overtime. Firefighters received the lion's share of the overtime pay in Vancouver, Camas and Washougal. In cities without fire departments, such as La Center, Battle Ground and Ridgefield, police officers were the top overtime earners. In some cases, the extra pay equaled a third of a six-figure, or near-six-figure, take-home salary. Although receiving overtime is nothing new for public employees, especially among on-call emergency responders such as police officers and firefighters, city officials say they vow to keep costs low; personnel expenses account for more than 80 percent of most cities' operating budgets:

The Daisy Mountain (AZ) Fire Department in the New River area will unveil a new program to sell ad space on its fire trucks. The fire district board will start taking bids February 15. You can't miss the big, red truck. "We're driving a billboard," said Daisy Mountain Fire spokesman Dave Wilson. The money would go toward community programs that were reduced by budget cuts. Daisy Mountain fire trucks don't just respond to emergency scenes. Firefighters take them to parades, community events, and, sometimes, they travel to other parts of Arizona.

With all of that exposure, the fire district decided there was a good opportunity to offset budget cuts, Wilson said. There are currently six trucks. The ads would be printed on two roll up doors on either side. "With the decrease in revenue, we've had to cut out programs such as CPR (and) public education," Wilson said. According to Wilson, property tax revenue dropped nearly 70 percent in the past five years due to the housing crash. That translates to roughly \$1.5 million out of the fire district's budget:

Two Davis (CA) fire stations could soon have fewer firefighters on staff, but officials say it'll save the city money, while also improving service to the community. That's because another station could gain a firefighter and more flexibility in how its rescue unit can be used. The Davis City Council on Tuesday night is scheduled to discuss the Fire Department staffing proposal, which could cut one firefighter from the "daily minimum staffing" model and save \$360,000 annually. Currently, all three fire stations in town have four people on staff; that's so they can follow a "two in, two out" model when responding to fires, according to a city staff report. But if each station drops to three firefighters on its engine company, and the Fifth Street Station 31 adds two people to a rescue unit, it would add flexibility and save money, city staff say. "Currently, Rescue 31 must respond in tandem with Engine 31 to all calls," the staff report states. "By making the Rescue a stand-alone unit, the rescue could respond to traffic accidents in Station 32 and 33's first-in area and leave Engine 31 in quarters to respond to additional calls." <http://davis.patch.com/articles/2-davis-fire-stations-could-have-fewer-firefighters>

A Polk County (FL) Fire battalion chief and two medical supervisors have been fired after an internal investigation found the three had ongoing and sexual affairs while on duty and on county property, according to reports. The initial investigation was first handled as a sexual harassment case. Battalion Chief Trampas Fletcher and medical supervisors Michael Tomlinson and Shellie Krauklis were notified of the investigation's findings Tuesday, according to letters from Assistant Fire Chief Rick Parnell. Accusations of bad behavior by firefighters working out of the downtown Toledo (OH) station have left two of them suspended for allegedly using a life squad as a party bus, two others under investigation for allegations of drunken driving, and a city attorney suspended for the way he handled one of the drunken-driving cases. The Toledo Fire Department suspended two firefighters in late February over accusations that they used the life squad on Jan. 19 to ferry three nurses to and from downtown's Station 5 and a Christmas party at the Blarney Irish Pub. The firefighters were on duty, and let the women pose for pictures in fire trucks. A nurse at one point slid down the station's fire pole, Fire Chief Luis Santiago said. Joseph Zuber, who is assigned to Station 5, was suspended for 16 hours for conduct unbecoming of a firefighter and for transporting a civilian in an emergency vehicle without permission. Brandon Walton, who is assigned to Station 9 but was filling in at Station 5 that night, was suspended for eight hours for the transportation charge. "Transporting civilians to and from a bar is unacceptable," a departmental document reads. The Spokane Valley (WA) Fire Department's Civil Service Commission denied a request by former Capt. Jon Sprague to get his job back after he was fired last year for sending religious emails from his department email account despite repeated orders to stop. The vote today was unanimous upholding the decisions of the fire commissioners and former Chief Mike Thompson to fire Sprague. Sprague runs the Spokane County Christian Firefighter Fellowship and routinely sent newsletters and other information to fellow firefighters that had agreed to receive the emails. He was ordered to stop and was disciplined several times, including two letters of reprimand and the suspension of two 24-hour shifts, before he was terminated. Sprague has argued that sending the emails is his First Amendment right and that other employees also send unofficial emails and have not been disciplined. Commissioner Diana Wilhite, a former Spokane Valley mayor, said she has experience with the proper use of a taxpayer-funded email system. The Arizona Department of Public Safety has closed its criminal investigation related to a female Phoenix firefighter's claim that she endured sexual harassment and discrimination from her colleagues. A recent memo from the Phoenix Police Department states that the DPS closed the investigation because the woman, firefighter Julie Simpson, said she did not want prosecution to be pursued and would not assist detectives. The DPS' inquiry specifically looked at an accusation that a male firefighter had stolen her cellphone. DPS investigators were looking into an allegation that a co-worker broke into her room at the fire station through the attic and took her cellphone to view its contents in February 2011, according to a memo. City Council members wanted the DPS to determine whether the actions were criminal. The theft allegation came to light last fall when the council voted to pay a \$70,000 settlement to Simpson over claims that she faced years of harassment and discrimination, with alleged incidents dating to 2003. Some council members felt the department did not appropriately discipline the male firefighter, who received a written reprimand:

The Orange County (CA) Fire Authority fire marshal was suspended from her post, just as officials completed an audit of an inspection program that charged hundreds of Orange County businesses for hazardous material inspections that were not done. The weeklong suspension is the first, and only, known disciplinary action taken since Orange County Fire Authority officials found that more than 1,400 businesses were charged for hazardous material inspections in 2011-12, even though the inspections were never completed. Fire Marshal Laura Blaul sent out an email to fire authority staff apologizing for the "embarrassment" caused to the department, after the Orange County Register reported on the errors in September, according to the email, which was obtained by the Register. "I am the Fire Marshal and I take full responsibility," the email reads. "This issue has caused embarrassment to our agency, pain to our members, confusion and ill will, and I apologize to all of you." The email was sent out to OCFA staff Feb. 14, the first day of the one-week suspension. Battalion Chief Kris Concepcion said he could not comment on specific disciplinary actions against department personnel. "Whenever something like this happens it is troubling and you never know if it is just idle talk or if someone really does mean to do that type of harm," Boston Police Commissioner Ed Davis says Mayor Tom Menino has been briefed on the situation. Hutchinson said Cal Fire won't begin an internal review of the crash until after the legal case concludes. A message left for McClelland seeking comment was not returned. San Bernardino County district attorney's office spokesman Christopher Lee said the court website that lists the charge as a felony is in error. McClelland was driving a white 2005 Cal Fire Chevrolet 1500 east on Highway 210 west of Del Rosa Avenue in Highland when it rear-ended a red 2001 Ford Focus, the CHP said. The Contra Costa County (CA) fire captain accused of threatening co-workers and stealing from his own department for years could face up to 5 years in prison if convicted on four felony charges filed today by the Contra Costa County District Attorney. Fire captain Jon Wilmot, 51, retired shortly after being arrested in December on second degree burglary and grand theft charges. "We're treating it like any other case. He is not going to get any special treatment and unfortunately he's violated the public trust," said DA Mark Peterson. Peterson filed the following felony charges: embezzlement, receiving stolen goods, possession of an assault weapon and commercial burglary of fire gear valued up to \$35,000. There are also new developments involving the workplace violence restraining order against Wilmot. Wilmot spent 27 years with the Contra Costa County Fire Protection District, but court documents show during several of those years, Wilmot allegedly harassed co-workers, stole from the department, and threatened citizens he was sworn to protect. In the workplace violence restraining order obtained exclusively by the NBC Bay Area Investigative Unit, the battalion chief said Wilmot wrote a co-worker's name on a bullet and gave it to him. He said Wilmot also stole another firefighter's uniform in retaliation when that firefighter reported Wilmot for having pornography on his computer at work. The chief also cites police reports showing Wilmot threatened a man with a hammer over a parking spot and threatened to rape and decapitate a woman after she called him by mistake. Police said they found 53 guns and thousands of rounds of ammo in Wilmot's three homes. Lewd behavior at a Tucson (AZ) fire station that a firefighter has called a sexual assault resulted in the demotion of a captain and could cost taxpayers \$500,000, records show. Paramedic firefighter Cody Jenkins filed a notice of claim against the city Feb. 19. It says Roger Sloan Tamietti, then a captain, "physically and sexually assaulted Jenkins multiple times" Nov. 9. In addition to demoting him to paramedic, the city of Tucson filed three misdemeanor charges against Tamietti. Two of them, an assault and a harassment charge, stem from the alleged incident in November. The other is an assault charge from an unknown incident that occurred in September. Tamietti is appealing his demotion, saying the punishment was excessive and the some of the testimony was a "lie or greatly exaggerated." At issue is what occurred Nov. 9 when Jenkins, who is a roaming paramedic, was assigned to Fire Station 7, on East Pima Street near North Swan Road. Jenkins had returned from a call about 10 a.m. Nov. 9 when Tamietti tackled him and knocked him over the back of a couch at the station, according to city records. Jenkins' face was pushed against the couch pillows and his legs were sticking up in the air. Tamietti then "straddled" Jenkins and "forcibly humped and ground" against him, the claim states. Tamietti admitted to investigators he threw Jenkins on the couch, but denied committing a lewd act. Tamietti said he was just "horseplaying" to make Jenkins feel more comfortable and treat him like he was one of the guys. Tamietti said he never intended to hurt or humiliate Jenkins. Three witnesses saw Tamietti tackle Jenkins on the couch, but none reflected the "severity of what Jenkins said he was subjected to" when interviewed by city investigators. A woman who was fired as an Orange Township (OH) firefighter after complaining of sexual harassment by a co-worker was awarded more than \$1.7 million in damages this week. Raechel Sterud, 32, sued the Delaware County township and her supervising lieutenant, Keith Myers, in 2010, saying she was the victim of gender discrimination. After a weeklong trial, a jury in Franklin County agreed, voting 7-1 on Monday that she was fired in 2007 because of her gender and that Myers acted "with actual malice" in recommending her termination. The head of the city of Montreal's fire department said his force is ridden with a culture of intimidation, which led one employee to commit suicide. "My organization is sick. He said the investigation into Stephane Archambault's suicide revealed that "there was a terrible environment in the fire prevention department. The people there were very, very unhappy." Archambault allegedly faced office harassment from at least three of his colleagues in the fire prevention office. The 48-year-old father of four killed himself last October. In an exclusive interview with QMI Agency, Tremblay said that nothing in his career prepared him for the death of a colleague. The past few years have been difficult for the force, he said. The firefighter's union was engaged in heated negotiations with the city over a collective agreement and his employees had to implement a new first responder service. Tremblay said the force "didn't manage the changes well. We neglected to look after our employees in the fire prevention department." He suspended one employee who was allegedly connected to Archambault's suicide:

The police and firefighters who remained on shore as Raymond Zack waded into San Francisco Bay on Memorial Day 2011 and succumbed to hypothermia were under no legal duty to help him, a judge ruled Monday. Officers and firefighters also did not worsen the 52-year-old Zack's condition by clearing Robert Crown Memorial State Beach or by preventing people from going to his aid, Judge George Hernandez said in a ruling that effectively tosses out a lawsuit that Zack's family filed against the city of Alameda (CA). He said he will also appeal if the judge refuses. Along with first responders, dozens of people were on the beach when the fully-clothed Zack waded into the water and stood at least 100 yards from shore. Police said they stayed on the beach because Zack was suicidal and possibly violent, while firefighters said they were not certified in land-water rescue and did not have a boat that could maneuver in the shallow water. Officers and firefighters did attempt to secure a rescue boat from the U.S. Coast Guard, however. Zack's family maintain onlookers should have been allowed to help. "It was a very tragic situation," said Gregory Fox, the city's attorney. The future administration of the city of Pinole's (CA) fire department remains in limbo as a newly formed City Council subcommittee studies service options and the best use of a two-year federal grant. Ideas under study include continuing the present arrangement of sharing a chief with the neighboring Rodeo-Hercules Fire District; reverting to a stand-alone municipal fire department with its own chief; or contracting for service with Rodeo-Hercules. The subcommittee, established Feb. 5 and made up of Mayor Debbie Long and Councilman Phil Green, will report back Feb. 19 to the full council, which could make its choice that day, or more likely March 5. The council is pressed for time because of a 90-day deadline to hire four firefighters under a \$1.24 million federal SAFER grant spread over two years that the firefighters union and many residents say should go to reopen Station 74 in the Pinole Valley, shuttered since July 2011. At 36, Tom Kras, a firefighter with St. Petersburg (FL) Fire & Rescue, has already had two knee surgeries. After the second surgery, he was on light duty for several months. Kras wondered what would happen to him if he could no longer carry people down ladders or cut a car open to pull out an injured passenger. That's when he decided to make himself more marketable and become a nurse. "I knew I never wanted to leave the fire department at this age to be a nurse," said Kras. "It was more of a backup plan." Kras is one of a small, but growing, number of firefighters who are juggling their already-bizarre schedules to become registered nurses. WRC-TV/NBC 4 reporter Mark Segraves is as least the third reporter this week who has had the accuracy of his reporting questioned in statements released by the Washington DC Fire & EMS Department Chief Kenneth Ellerbe. Segraves had reported late Friday afternoon that three firefighters, including a lieutenant who had done battle before with the chief, face possible disciplinary action for appearing in uniform at an event with President Barack Obama. A few hours later this statement from Chief Ellerbe was posted on the TV station's website: *Contrary to reports in local media, the DC Fire and EMS Department is not considering any disciplinary action against uniformed personnel for appearing alongside President Obama. At the request of the Deputy Mayor for Public Safety and Justice, DC FEMS is simply reviewing its internal protocols for such appearances to ensure that both the Department and its employees are fully informed. We fully support the efforts of President to highlight the essential and life saving work that our first-responders do every single day, and welcome his invitation for our members to participate. We're exceedingly proud of the men and women that wear the DC FEMS uniform, and thank the President for his support.* If this sounds familiar, it's probably because just 24 hours earlier Chief Ellerbe called into question the actions of reporters on two other stories. Delivering and further publicizing stories about firefighter bad behavior is probably the worst part of this job. I take no joy from nor feel any more superior when a fellow firefighter stumbles in life. They are human and they stumble — we all do at some time, in some way. So why would we report these failings? One can argue that by doing so only makes it more difficult for the rest of us to win or maintain public approval. One can argue that it gives ammunition to those who would strip fire departments of their resources or firefighters of their benefits. One can argue that in a profession that sees so much sorrow and loss, why pile on more bad news? As part of the fire-service media, we need to report it for the same reasons that we need to report firefighter near misses. Whether it is today's story about the fire chief **charged with embezzlement**, the on duty firefighter **arrested for heroin possession**, the assistant chief **charged with drug trafficking**, or the countless other stories, they all have lessons that are too important to ignore. Assessing our own behavior and attitudes is as much a part of being a firefighter as is assessing our skills and safety practices. When we read near miss reports, we learn about our own shortcomings and, hopefully, take steps to correct those. County supervisors are allowing the Contra Costa County (CA) Fire Protection District to continue exploring a joint fire station in Lafayette with the Moraga-Orinda Fire District despite growing concerns from some residents about equity, response times and the suitability of the proposed site. The Board of Supervisors voted 4-1 on Tuesday to allow Con Fire Chief Daryl Louder to continue "serious" negotiations with Moraga-Orinda chief Randy Bradley to jointly build, operate and staff a new fire station on the Orinda-Lafayette border. Supervisor Karen Mitchoff opposed the talks. The approval came a day after a majority of Moraga-Orinda directors voted to proceed with informal negotiations despite an outcry from residents living near the project site. Those negotiations have been underway since January when Con Fire approached the district about operating a joint facility following the closure of a station in west Lafayette due to budget cuts. Moraga-Orinda would close its station on Via Las Cruces as part of the consolidation -- a move some Orinda residents on Monday opposed. The district's board president Frank Sperling once again voted against the merger arguing that Moraga-Orinda was bailing out Con Fire. Director Steve Anderson, who supported the measure, argued the \$1 million annual savings was an opportunity to ensure Moraga-Orinda's longterm sustainability: http://www.contracostatimes.com/orinda-lafayette-moraga/ci_22776009/county-supervisors-agree-move-ahead-joint-lafayette-fire

Burbank (CA) Fire department recruits find academy tougher than they thought it would be. "This is probably the hardest thing I've ever done in my life," said former construction worker Richard Dunn, 33, who began preparing, training and testing to become a firefighter four years ago. He had almost given up on the dream and was pursuing a contracting license when the department called him last June with an offer. Fortunately, he'd maintained his workout regimen. "I thought I was in shape — then I got here," Dunn said. "There have been days where I thought I was going to pass out." During the 14 weeks, the academy covers everything from wildland firefighting and emergency services to how to handle hazardous materials. Recruits also work on their physical fitness — whether by throwing ladders or

dragging 165-pound dummies — and book smarts. Not all recruits pass muster with the department's rigorous academy curriculum. This class of nine started with 11. "If a recruit comes in and is not completely mentally and physically prepared, sometimes they can fall behind," Lenahan said. "There's a bar, there's a level they have to measure up to." Roughly 20% of recruits don't make it through the academy, which may be due to an inability to keep up physically or follow safety protocols during drills, Lenahan said:
