Hot Topics Research for Emergency Medical Services

NEW EMS Course at the National Fire Academy!

The United States Fire Administration (USFA), Department of Homeland Security, is conducting a pilot course at the National Emergency Training Center (NETC) in Emmitsburg, Maryland for the newly developed 6-day course *Hot Topics Research for Emergency Medical Services (P-139)*.

The National Fire Academy (NFA) will be delivering two pilot offerings.

- The first will be October 30 November 4, 2011, with students to arrive Saturday October 29 and depart Saturday November 5.
- The second pilot offering will be January 29 February 3, 2012 with students to arrive Saturday January 28 and depart Saturday February 4.

Course Description: This 6-day course provides the knowledge and skills to identify and research hot topics in Emergency Medical Services to ultimately identify, promote and embrace system or service improvements. This course is structured around how to make a persuasive justification through the effective collection and presentation of data with the use of a wide variety of research resources. Finally, students will construct a program proposal and/or progress report for presentation. This course includes research, writing, and presentation elements for successful completion.

Student Selection Criteria: Emergency Medical Services middle management personnel (including Shift Supervisor, Captain, Division/Battalion Chief, Crew Leader, Administrator, etc.) with at least 3 to 5 years experience.

Class Size: 24 Length: 6 days

Prerequisites: ICS 100 level and ICS 200 level training. Preferred courses are Q462 and Q463 available through NFA Online at www.nfaonline.dhs.gov. Chief's signature attests that the applicant has completed this required training.

Chief's Corner - Firefighter Safety in Extreme Heat

With this summer's extreme heat in most of the country, and many areas experiencing triple digit temperatures, it is essential that you - and all of the fire service working in it - take care. Hydration before dehydration is key: do not allow yourself or those responding with you to place yourself at risk for heat related illness. Also, keep a lookout for your fellow firefighters. Another critical function that needs to be established in this heat wave is emergency incident rehabilitation. Emergency incident rehabilitation is designed to ensure that the physical and mental well-being of firefighters and other emergency responders operating at the scene of an emergency does not deteriorate to the point where it affects their safety. It can prevent serious and life-threatening conditions such as heat stroke and heart attacks from occurring. Rehabilitation is not just for incidents, it is also a must for operational training. Fire departments should be in compliance with the National Fire Protection Association (NFPA) 1584 Standard on the Rehabilitation of Members Operating at Incident Scene Operations and Training Exercises.

USFA has resources to assist you and your department in establishing an effective emergency incident rehabilitation program, including a comprehensive guide on Emergency Incident Rehabilitation - <u>http://www.usfa.dhs.gov/downloads/pdf/publications/fa_314.pdf</u> (PDF, 5.6 Mb) which was developed through a partnership with the International Association of Fire Fighters (IAFF). FOCUS ON FIRE SAFETY Campus Fire Safety



Each year college and university students, on- and off-campus, experience hundreds of firerelated emergencies nationwide. There are several specific causes for fires on college campuses, including cooking, intentionally set fires, and open flame. Overall, most college-related fires are due to a general lack of knowledge about fire safety and prevention. According to information complied by Campus FireWatch, the great majority of student fire deaths occur in off-campus housing that lacks insufficient exits, missing or inoperative smoke alarms, and automatic fire sprinklers. Also, use of candles, careless smoking habits, and the misuse of alcohol—which impairs judgment and hampers evacuation efforts—contribute to off-campus housing fire deaths.

As the Fall semester approaches, colleges and universities are busy preparing for the arrival of new residents to their campus communities. Some will be first year students moving into the residence halls. Other arriving students will be moving off-campus and living on their own, some for the first time. For most of these students, the last fire safety training they received was in grade school; but with new independence comes new responsibilities. It is important that both off-campus and on-campus students understand fire risks and know the preventative measures that could save their lives.

USFA Releases Two Topical Reports on Residential Building Fires Involving Individuals with Disabilities

EMMITSBURG, MD – The Federal Emergency Management Agency's (FEMA) United States Fire Administration (USFA) announces the release of two special reports highlighting the characteristics of residential building fires involving individuals with mental and physical disabilities. The reports, **Residential Building Fires Involving Individuals with Mental** Disabilities -

http://www.usfa.dhs.gov/downloads/pdf/statistics/v12i6.pdf (PDF, 899 Kb), were developed by USFA's National Fire Data Center.

The analyses in these reports address residential building fires where a possible mental or physical disability, as reported to the National Fire Incident Reporting System (NFIRS), were the human factors contributing to the ignition of the fire. Annually, an estimated 1,700 residential building fires involving individuals with mental disabilities are reported to U.S. fire departments and cause an estimated 85 deaths, 250 injuries, and \$61 million in total loss. Additionally, there are an estimated 700 residential building fires involving individuals with physical disabilities that occur each year, resulting in 160 deaths, 200 injuries, and \$26 million in property loss.

According to the reports, the majority of the residential building fires involving individuals with mental (62 percent) and physical (63 percent) disabilities occur in one- and two-family dwellings. Cooking, at 22 percent, is the leading cause of residential fires where a physical disability is reported as a human factor contributing to the ignition of the fire. This differs from the leading cause of residential fires where a mental disability is reported as a human factor contributing to ignition. In these types of fires, intentional is the leading fire cause, at 40 percent. Fire incidence involving individuals with disabilities occur most often in January and December. In addition, these fires show a tendency to peak in the late afternoon to early evening hours.

The reports are part of the Topical Fire Report Series and are based on data from the National Fire Incident Reporting System (NFIRS) for 2007 to 2009. Topical reports explore facets of the U.S. fire problem as depicted through data collected in NFIRS. Each topical report briefly addresses the nature of the specific fire or fire-related topic, highlights important findings from the data, and may suggest other resources to consider for further information. 

Fallen Firefighters to Be Honored on October 16, 2011

The National Fallen Firefighters Foundation (NFFF) and the U.S. Fire Administration will honor 89 firefighters who died in the line of duty at the 2011 National Fallen Firefighters Memorial Weekend. These firefighters will be featured in the National Fallen Firefighters Tribute Widget on July 12, 2011. For more information on how you can include the tribute on your website, visit <u>http://weekend.firehero.org/widget/</u>

Emmitsburg, MD - The 30th Annual National Fallen Firefighters Memorial Weekend will be held at the National Fire Academy in Emmitsburg on October 15-16, 2011. The National Fallen Firefighters Foundation (NFFF) and the Department of Homeland Security's U.S. Fire Administration will honor 72 firefighters who died in the line of duty in 2010. A bronze plaque containing their names will be added to the National Fallen Firefighters Memorial, located here on the National Fire Academy campus. Seventeen firefighters who died in previous years will also be honored. The plaques surrounding the Memorial, which was established in 1981, will contain the names of more than 3,500 firefighters.

Twenty-seven states experienced line-of-duty deaths in 2010. Deaths resulted from vehicle accidents while en route to or returning from emergency calls, building collapses, natural disaster response, falling, drowning, heart attacks, and burns/smoke inhalation. Three multiple fatality incidents accounted for six deaths. One multiple fatality occurred during a flashover at a structural fire; one incident resulted from an apparatus accident, and one involved a building collapse at a commercial structure fire. Illinois had the nation's greatest number of firefighter line-of-duty deaths in 2010 with 8, followed by New York and Pennsylvania with 7; and Kansas had 6. "Firefighters are called upon to face danger on a daily basis," said Chairman of the NFFF Board of Directors, Chief Dennis Compton. "In October, a grateful Nation will honor their dedication and remember their sacrifice. The National Fallen Firefighters Memorial Weekend brings their loved ones and the fire service together to let their families, coworkers, and friends know that they will never be forgotten." f you want to become a firefighter, have you started taking fire department examinations yet? If not, what are you waiting for? If you say you're not ready, you'll probably never be ready. If you want to wait until you finish your degree, then you're going to have wasted about two (or more) valuable years that could have been spent learning how to master the fire service testing process. You should be taking every fire service exam you qualify for – what's the worst that can happen if you take a test? If nothing else, you will hopefully start to learn your strengths and weaknesses and what it takes to become a firefighter. Don't rely on us to provide you with every fire department that is accepting applications. We only send out a small fraction of the current open firefighter positions across the United States. If you truly want to become a firefighter, put your money where your mouth is and subscribe to a fire testing service that will notify you when fire departments across the United States are accepting applications.

Two of the best fire testing notification services I have seen are:

For less than \$100.00 per year (each), those companies (run by firefighters) will provide you with valuable testing information to help save you time and effort. Becoming a firefighter is not an easy task, and the badge will not drop from the sky into your lap. Don't wait for your friends to tell you about testing opportunities or expect to hear about them from us. That is not our job, to replace such companies.

<u>CANDIDATE PHYSICAL ABILITY TEST (CPAT)</u> INFORMATION:

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas. To see the <u>available dates</u> to take the CPAT at any of the below three locations, visit their website at <u>www.cpatonline.org</u>

 NOTE: Do not wait until the last minute to attempt to complete the CPAT as it is common for people to fail their first attempt and have to go back on another day for a retest. More and more departments are asking for a CPAT card within six months or one year of the date of their testing process and I've seen many candidates fail the CPAT (and even retests) and not be able to continue through a department's testing process because of their failure to plan ahead. Don't let this be you!

FIVE FIREFIGHTERS AMONGST THE DEAD IN CYPRUS EXPLOSION

A massive explosion ripped through a Cypriot naval base Monday after a brush fire detonated gunpowder stored in containers, killing 12 people including 5 Firefighters in the Line of Duty, wounding 62 and prompting the resignations of the country's defense minister and top military chief. Cyprus is a Eurasian island country in the Eastern Mediterranean, east of Greece, south of Turkey, west of Syria and north of Egypt. It is the third largest island in the Mediterranean Sea and one of its most popular tourist destinations. Bodies covered with white sheets lay scattered on a charred hillside near the Evangelos Florakis Naval Base on the Mediterranean island's southern coast, while ambulances ferried the injured to hospitals in Larnaca and the island's capital, Nicosia. The blast occurred in the early hours of the morning when a brush fire approached dozens of storage containers holding gunpowder that had been confiscated in 2009 from a ship which had been heading from Iran to Syria. Defense Minister Costas Papacostas and the country's top military official, National Guard chief Brig. Gen. Petros Tsalikides, resigned over the incident. Investigators had ruled out sabotage as a cause for the blast. Fifty of the 62 people injured had been treated and released from hospitals. Two of those still hospitalized had suffered serious injuries. As always, our sincere condolences.

On July 10, 2011 at 1830 hours, a CalFire Firefighter, while acting as a back-up person for an engine company, sustained a serious head injury when he became pinned between 2 CAL FIRE engine companies. The incident occurred following release from a companies cover assignment at Nevada-Yuba-Placer Unit. An Amador-El Dorado Unit (AEU) engine strike team stopped at a local restaurant

to eat. While attempting to back the AEU engine into a space immediately adjacent to another engine, the right rear tire rode up on the curb. When the fire apparatus operator moved the engine off of the curb, the engine shifted. The Firefighter who was acting as back-up person became pinned between the two engine companies. The Firefighter received a serious head injury and was transported by ground ambulance to a local trauma center for treatment. We wish the Firefighter a successful recovery.

Hey,

We have all responded to fires where, upon our arrival, well meaning police officers have attempted to assist us by searching and in some cases, rescuing victims. In many cases, they are successful, but in many other cases, they become victims themselves. Naturally, the goal would be to help people in trouble, without themselves (the PD) also getting in trouble, adding to the work we have already have to do. The most recent example of that is in New Jersey. were a short in an electrical wire in a hallway ceiling caused a fire in an apartment building in Red Bank yesterday. According to the RB Fire Marshal, the fire went undetected for about 45 minutes as the heat melted through a sprinkler pipe, which caused the roof ceiling of the bedroom to collapse, and the water from the pipe helped contain the fire.

Upon receipt of the fire call, 2 police officers went inside the apartment building looking for residents before the RB Firefighters arrived. Unfortunately but somewhat predictably, the police officers along with civilians became trapped by the heavy smoke conditions in the building. One police officer was able to get out of the building on his own, but a ceiling collapse trapped the second police officer in a second-floor apartment. Fortunately, Red Bank Firefighters arrived and raised a ladder to the second-floor window to get the other officer and civilians out of the building. Another reminder to share with the law enforcement folks in any area, as well intentioned as any may be. And while you are sharing, you may wanna remind them of our burning desire to gain access and use hydrants at fires as well as our interest in accessing the fire block/street-so please park outta the way. Just like the fire chief cars do. Just say'n.

TWO TRAGIC OFF DUTY EVENTS:

On Tuesday morning shortly before 0600,Columbia (SC) Firefighter Travis Kinley was hit by a car while cycling to work. It is reported that he was struck by two vehicles, the first of which did not stop. He is being treated for multiple injuries including head trauma resulting from the accident and is listed in serious condition. We wish him a rapid recovery. A veteran Fire Captain with the Greensboro (NC) FD died today in an off-duty incident. GFD Captain Jackie Spoon was changing blades under a 1,250 pound commercial lawnmower when the mower collapsed on him. He was pronounced dead at the scene. Speed, no seat belt use and driver distraction were the causes of a crash that killed FF David E. Remington, 58, in the Line of Duty on Jan. 3, 2011 in Maine. The crash was investigated by the York County Sheriff's office. Remington, a Shapleigh (Maine) Firefighter, was responding to a rescue call at about 2200 hours that night when he lost control of his personal vehicle, a 2005 Chevrolet 1500 pick-up truck about one mile from Route 109, in Shapleigh. The truck rolled, struck two trees and

came to rest on the passenger's side in a ditch. FF Remington was not wearing a seat belt at the time of the crash and at some point he was ejected from his vehicle-he was DOA at the scene.

There was no evidence or indication that Remington was impaired at the time of the accident, nor was there evidence of mechanical failure. The accident was reconstructed by law enforcement who concluded that FF Remington had become distracted for some unknown reason while rounding a gradual corner. The vehicle was traveling between 59 and 67 mph when it left the road, in an area posted for 45 mph. FF Remington was a retired career Firefighter for the City of Portland and had been an active Volunteer Firefighter for the Shapleigh Fire Department for four years at the time of the accident. Another tragic reminder about the critical and mandatory use of seat belts as well and controlling the vehicle-car, ambulance or apparatus when responding.

DC DUMB: FIREFIGHTERS TO FIGHT CRIME

Both D.C. firefighters and police officers are upset over a new program that forces the fire department to help fight crime. And should be. For the past three weeks, D.C. Fire and EMS personnel have been parking their apparatus at high crime neighborhoods. "It's to prevent things from bubbling up. The idea is that if you have a fire engine with adults there no one is going to commit a crime," said D.C. Deputy Mayor Paul Quander. City officials said they just want firefighters to call 911 if they see suspicious activity. The D.C. police union and firefighters union leaders say the plan is not safebecause it is not. "I think it is a disaster," said D.C. Police Union spokesman Kris Baumann. "You're putting untrained, unsupervised, unequipped firefighters in some of the most dangerous neighborhoods in town to perform a law enforcement function." Right now, the plan is to keep the policy in place at least through next spring.

Hmmmm. How about THIS AS AN ALTERNATIVE:

All salaried DC City Employees (from any and all depts and agencies) who have take home cars - at all levels - start doing this at night and on weekends as a part of a neighborhood crime patrol. And for those management folks who don't use take home cars due to public transportation, they can be grouped into teams of 2 walking the street corners, watching for heinous crime. Or, the big buck salary makers can use public works and related vehicles with yellow flashing lights on them-when those vehicles would just be sitting in the yard at night. And, the big buck makers don't make any OT-so talk about stretching taxpayer dollars. Wow, a home run. And-if they need uniforms or some sort of visible ID, there is a warehouse somewhere in DC that has LOADS of "no longer usable" DCFD shirts and jackets, since DCFD is no longer the preferred "label" when the switch was made to call them FEMS. Seriously.

While we support FD's doing everything within their realm of authority and training to help the public in so many ways, when not making runs, putting DCFD Firefighters and EMS personnel in the worst of the worst crime infested neighborhoods as "crime watchers" is a predictably dangerous move by the city hall dwellers. MORE re: FIREFIGHTER SUICIDE

A few weeks ago we wrote about the issue of Firefighter & EMT suicide in The Secret List, and, not surprisingly, received quite a lot of e-mail affirming the problem is a very significant one in our business. What is surprising is the training and education (or the lack thereof) related to mental health at the officer and peer level. We heard from folks who very recently lost family members (Firefighters) who were under treatment-but felt "not enough" was being done to prevent it. Some wrote whose loved ones were not under any treatment-and literally out of no where-took their own lives...with some telltale signs found after. Another issue that several who wrote in about, is the issue of the survivors, and family members of those who take their own lives and the care-or lack thereof-to those folks and other FF's left dealing with the loss. And we also heard from others who wrote that some departments mental health professionals are overwhelmed or may not even be qualified to deal with the challenge. The plate is full in many FD's, while others wrote in praising their FD's leadership in the mental health arena.

GOOD PROGRESS:

The NFFF hosted a special summit (with specific reps invited from major fire service organizations) on the subject last week. Subject matter experts in the field such as Doctors Richard Gist, Matthew Nock, Thomas Joiner and Lanny Berman presented to the group on topics ranging from Understanding Incidence and Epidemiology of Suicide to the Interpersonal Theory of Suicide Behavior and Current Best Practices in Suicide Intervention. The objectives were to help critically evaluate current empirical information on the incidence and epidemiology of suicide and apply to observed trends in the fire service;

-Critically examine current best practices in suicide prevention and intervention, with specific emphasis on empirical evidence of efficacy, effectiveness, and impact;

-Plan strategies and mechanisms to translate identified best practices and prevention/intervention options into programs that can be disseminated and applied in all segments of the fire service. There was excellent discussion held on not only the above areas but many related topics. There will be a final report in the future that will be shared fire service wide, and we will post it. Be on the lookout for that update and continue to check the NFFF website as well as your national associations for more information. http://www.firehero.org/

FAMILY OF FIREFIGHTER WHO COMMITTED SUICIDE SUES CITY

Related to the issue of suicide, the family of a firefighter who committed suicide after being asked to resign has sued the city of Salem (Oregon) and alleged the city should have been more responsive to his mental health problems. Representatives of former firefighter Craig Warren's estate are seeking \$4.15 million in damages. The city has not yet responded to the suit. Warren committed suicide on July 31, 2009, the effective date of his resignation. The lawsuit alleges that Warren changed psychiatrists in early 2009, and the switch led to a mix-up in his medication doses. UPDATE: ILLINOIS FF INJURED IN AERIAL LADDER INCIDENT AT FIRE SCENE

As we posted, an Illinois Firefighter was seriously injured while battling a 3-Alarm fire in Crystal Lake, Illinois 2 days ago. **Reports are that the Firefighter was on an aerial ladder and his foot/leg somehow was caught between the rungs as the ladder was being extended/retracted.** The Firefighter was airlifted from the scene and transported to Lutheran General Hospital, a Level I Trauma Center, in Park Ridge, IL by the Flight For Life Helicopter. Crystal Lake is located about 50 miles northwest of Chicago. Admittedly, we had about 30 seconds to put this Secret List together-but sort of had to get this out to you-so here it is. This is about airline pilots, SEVERAL airline pilots who, as they claim, looked out for their own safety/survival-as well as their passengers. They refused to fly the plane. Several pilots refused to fly the plane. Management doesn't agree with their claims.

Check this out:

The battle between US Airways (<u>LLC</u>) and its pilots over the airline's safety culture is continuing, this time focused on an incident in which a captain declined to fly a transatlantic flight.

On June 16, Captain Valerie Wells, a 30-year-pilot, was scheduled to fly an Airbus A330, which can carry nearly 300 passengers, on a flight from Philadelphia to Rome. But she declined to fly because of failures of both the auxiliary power unit, a backup source of electrical power, and the "hot battery bus," a primary source of electrical power. After the crew and passengers had returned to the gate Wells, in a particularly unusual event, was escorted out of the airport by security officials. Subsequently, a second crew of three pilots also declined to fly; the aircraft was repaired and underwent a rigorous inspection, and a third crew took off about six to seven hours late. In seeking to publicize the incident, the U.S. Airline Pilots Association took out a full-page advertisement in Friday's edition of USA Today. The ad proclaimed that US Airways put "revenues first, safety second. "The intimidation of flight crews is becoming commonplace at US Airways, which works to maximize their revenues by pushing their employees to move their airplanes regardless of the potential human cost," said the text. The ad referred readers to a website: www.USAirlinePilots.org/SafetyFirst

In a letter to employees on Friday, Robert Isom, chief operating officer, wrote that "USAPA has embarked upon a smear campaign that in reality is all about contract negotiations, not safety. "I can tell you unequivocally the union's claims are outlandish, false and a disservice to the 32,000 hard-working employees of US Airways," Isom wrote. "Safety has been and always will be the top priority at US Airways, as it is at any airline." Union spokesman James Ray said that initially, Wells

could not possibly fly the airplane because it lacked cockpit electrical power, but a chief pilot nonetheless encouraged her to fly. He said the incident symbolized US Airways' desire to enhance on-time performance and revenues.

"This is not just an isolated incident," he said. "It has been going on on a daily basis, and is the kind of practice we've been fighting for a number of years now." Airline spokesman John McDonald said the incident is under investigation. He said "the fact that Wellswas escorted off the property had nothing to do with safety," but declined to elaborate. Ray speculated the airline did not want Wells to tell the replacement crew of the problems she had with the aircraft. McDonald said that to be cautious, the airline "took the batteries off site and had them tested, and they were found to be in proper working order." He said the real issue in the incident was about the union "negotiating and trying to get leverage against the company, using safety as an issue, which it is not."

In a statement issued late Friday, the Federal Aviation Administration said the APU shutdown in the aircraft "is a failure that pilots are well aware can happen and that they are trained to recognize. The battery apparently was depleted by attempts to restart the APU." The agency said aircraft often fly with inoperative APUs, without a safety risk, but "the captain simply chose to exercise her pilot-in-command authority of not accepting an aircraft." It said US Airways maintained the aircraft in accordance with regulations. Ray noted that in addition to the APU failure, the hot battery bus also failed, causing an instrument failure that justified the Wells' decision. US Airways recently passed the International Air Transport Association's safety audit "with flying colors," Isom noted in his letter, while the FAA has cited US Airways as an industry model for its safety management system. Ray said the IATA inspection is "nothing more than a self-evaluation by a trade association." Ray also denied that the safety claims are a negotiating tactic. "How do you think pilots are going to gain at the negotiating table by pointing out we have a safety issue at the company?" he said. Friday marked the second time USAPA criticized US Airways safety practices in USA Today. A 2008 ad in the newspaper asserted that the airline was pressuring pilots to fly with less fuel than they might prefer. This article is from USA Today.

LODD - AZ HOTSHOT AT WILDLAND FIRE

Authorities are investigating the death of a firefighter who was reported missing from a blaze on the Fort Apache reservation in eastern Arizona. The U.S. Bureau of Indian Affairs says the efforts to reach the firefighter by handheld radio Saturday were unsuccessful. Search crews found the body early Sunday morning. The firefighter had responded to the lightning-caused Diamond Fire that broke out north of the Black River around noon Saturday. The terrain is steep and rocky with dense fuel. Crews hiked back to camp after building a line around the 35-acre fire, and that's when the incident commander discovered the firefighter missing. The name of the firefighter has not been released. Our sincere condolences to all involved.

Hey,

As you may have read, medical experts are claiming that there is not enough evidence YET to say whether the dust and smoke clouds produced by the terrorist attack on the World Trade Center caused cancer. We have trouble believing that there is "not enough" evidence as there certainly have been numerous funerals. Scientists say that some cancers takes 5 to 20 years to develop, so if there was a very strong effect from toxic substances released by the collapse of the twin towers, it might be expected to manifest itself by now, nearly 10 years after the attack. It has, please see above funeral note.

The report released by Dr. John Howard, the director of the National Institute for Occupational Safety and Health, claims that there was very little evidence to go on, as there have only been 18 published research studies on the attack that even mentioned cancer, and only five of those were peer-reviewed. The results of the peer-reviewed studies were mixed.

Even if it appeared that the events of 9/11 caused cancer in certain people, it would be hard to prove because cancer is widespread in the general population. In the United States, the probability that a person will develop cancer over a lifetime is one in two for men and one in three for women, the report said. "Drawing causal inferences about exposures resulting from the Sept. 11, 2001, terrorist attacks and the observation of cancer cases in responders and survivors is especially challenging since cancer is not a rare disease," the report said.

HOWEVER, and thankfully, this report is NOT the final word.

A second review of the cancer evidence will be conducted in early to mid-2012. Most doctors treating people exposed to the dust and smoke believe that cancer is a likely consequence. Dr. Philip J. Landrigan, head of a 9/11 treatment, monitoring and research program at Mount Sinai Medical Center, said yesterday that the possibility of cancer in the responders increases as time goes by. Mount Sinai, he said, is tracking the rates of 60 different cancers, and will be feeding that information to the federal government. Dr. Landrigan said his researchers were looking especially hard at multiple myeloma, because they had already found eight cases - an unusually high number - in responders younger than 45. Usually, he said, myeloma is found in people who are older. People at the World Trade Center on 9/11 were exposed to a large number of substances, Dr. Landrigan said, "and each different exposure has its own signature cancers, so there are a wide range of possibilities here."

We have deep trouble believing that the cancers that Firefighters, Police Officers and EMS Personnel are suffering from are NOT caused by the collapse, dusts and fires of 9/11.

Look, to us, it is simple: breathing smoke causes cancer-and the Federal Government agrees with that. For example, formaldehyde is a colorless, flammable, strong-smelling chemical that is used in building materials, materials that were in the WTC. Formaldehyde has been classified as a known human carcinogen (cancer-causing substance) by the International Agency for Research on Cancer and as a probable human carcinogen by the U.S.E.P.A. Research studies of workers exposed to formaldehyde have shown an association between formaldehyde exposure and several cancers, including nasopharyngeal cancer and leukemia.

Yeah yeah, we know, it's all about money-it always is. We aren't that naive, we get it. However, what happened on 9/11 has never happened before in modern day-with modern building materials being attacked causing modern fire, smoke, gas and dust. While we appreciate (to some extent) the need for science, there is also a need for some common sense by those people making the final decisions.

There was no hesitation by those who responded and worked at the WTC site from 9/11, until their final detailed day. It's our opinion that a little less hesitation and a little more common sense to insure every possible support be given to those responders suffering from cancer, should be a priority....as you would certainly want for yourself and your loved ones.

EXPLOSIONS HURT FIREFIGHTERS IN FDNY AND EDMONTON, CANADA

=2 EDMONTON FIREFIGHTERS were taken to the hospital yesterday to be checked over after they were thrown back by an explosion. A gas leak was reported Tuesday morning at a single family dwelling, and as firefighters were at the gas meter, something sparked and set off a blast. 4 firefighters working on the gas line when it blew. The explosion appears to have started in the basement and came out the side door near where Firefighters were shutting off the gas meter, and it knocked them over. 2 were taken to the hospital for minor burns and mostly a precautionary measure.

=FDNY FIRE OFFICER BURNED:

A Brooklyn Fire Officer was burned as he tried to help a motorist move his car away from a smoking manhole, just before a fireball suddenly engulfed the vehicle. Fire erupted within seconds after FDNY Lt. Richard Buckheit -- a decorated 16-year veteran who once helped rescue 3 little girls from a burning apartment -- got behind the wheel of the car to try to drive it to a safer spot in Flatbush late Sunday. Lt. Buckheit, 40, had been rushing to the aid of Pablo Mejia, 25, who called the FDNY shortly after midnight when he saw thick smoke billowing from a manhole directly beneath his girlfriend's car, parked near his home. "The firefighters got there, and I asked, 'Can I move my car?' But Lt Buckheit said, 'It's not safe. I'll do it,' " Mejia said. "He took my keys and got in, and right when he tried to back up, that manhole exploded with him in [the car]." Lt. Buckheit -- who suffered first-degree burns to his neck and face and second-degree burns to his left hand and ear -- is recovering at the burn unit at New York Hospital.

LIGHTS FOR LIFE AFTER THE PREVENTABLE DEATH OF 2 BELOVED FIREFIGHTERS IN VIRGINIA This week numerous people came out to remember Rocky Mount Fire Chief Posey Dillon and longtime Firefighter Danny Altice. Both were killed in the Line of Duty in a crash while responding to a call July 26, 2010 when the engine entered an intersection against a red light and was struck by a sport utility vehicle. Fire companies responded to the building fire at 445 Biltmore Avenue just after noon, today. Fire was showing from windows on the 5th floor of the building, which houses related medical practices and clinics. Around 1330 hours a "mayday" call went out over fire radio and there were MAYDAY reports of "firefighters down" in 2 different locations. A few minutes later, command ordered all members out of the building so they could do an accountability check/PAR. Maybe you can help. Maybe you'll see it on the Internet for sale or something like that-so we figured we would "Secret List" this because the family of a young firefighter killed 12 years ago in the line of duty is asking for help in finding clues to the defacement of his grave, including the prying off of a brass plaque on his headstone.

California FF Matt Black was just weeks short of his 21st birthday - and five days shy of his first year as a Volunteer Firefighter with Lakeport (California) Fire, when he was tragically electrocuted and killed in the Line of Duty by a downed 12,000 power line while fighting a fire on June 23, 1999. FF Black's mother, Jo Ann Gettman and her husband, Gerry, have regularly visited her son's grave at Hartley Cemetery outside of Lakeport, often going there on special occasions and his birthday. During a recent visit they discovered that his headstone had been defaced and several items removed that had been left at the grave by family and friends. When he died, FF Black's family had an 8-inch by 10-inch brass plaque engraved with "The Fireman's Prayer" added to his flat granite headstone, along with a picture of him under glass. They also placed there a brass spittoon that he had kept in his room since childhood, along with a small hula girl and other memorabilia, Mrs Gettman said, and they went out on July 4 for one of their regular visits, and everything was fine.

She said they noticed the brass plaque needed cleaning, and decided to come back and do that on July 18, what would have been Black's 33rd birthday. But when they got out to the site, the plaque was gone, she said. "We were just shocked," she said, explaining, "Somebody had to work to get it off." She and her husband spoke to the cemetery's groundskeeper, who hadn't noticed any issues with the grave or seen any suspicious activity. After the couple got home and began thinking about the site more, they realized the spittoon, the cowboy boots, hula girl, wooden rose, baseball cap and Cal Fire card all were gone as well. Jo Ann Gettman said they met at the

cemetery with sheriff's Deputy Carla Hockett to make a report on the thefts. Gettman said vandalizing a grave hurts all the people who love the person buried there, adding it's been devastating to her, her husband, her other son - a Santa Rose firefighter - and Black's friends. Following Thursdays fire that killed Asheville Captain Jeff Bowen in the Line of Duty, local media is already reporting their observations and opinions based upon recorded radio traffic. It should also be noted that the ATF has been requested to help investigate by the AFD as well as that all AFD Firefighters have been released from the hospitals, which is certainly good news. The Asheville Citizen Times reports that problems with pipes designed to carry water from a street hydrant to the fifth floor of a burning medical office building likely delayed firefighters as they battled the deadly blaze, according to the reporter who listened to radio transmissions. Nearly 25 minutes passed from the time the first trucks left their stations about 12:30 p.m. Thursday until a crew reported they were finally putting water on the blaze at 445 Biltmore Center from a ladder truck. Firefighters repeatedly made references to a lack of water, even as they reached the fourth floor and made their way toward flames one floor above.

"We got no water. No water," a firefighter on the fourth floor says about 13 minutes into the recording. The website radioreference.com, which tracks rescue communications nationwide, posted the 43minute recording of the transmissions on YouTube. Fire Department commanders would not comment on the recordings Friday, citing the ongoing investigation into the death of Capt. Jeff Bowen. The department also would not confirm the recording was from the fire, Assistant Fire Chief David McFee said. But it starts with Buncombe County emergency dispatch sending firefighters to 445 Biltmore Ave., the site of the medical office building, and there are no apparent gaps in the transmissions. Locked doors inside the building and trouble getting water into standpipes in the stairwells became

immediate obstacles as firefighters navigated through intense heat and heavy smoke. Standpipes carry water vertically in a multistory structure, enabling firefighters to fight flames internally. The fire scene commander, at about eight minutes into the incident, confirms from the water supply crew that water is flowing to the standpipe connection outside the building. "Just let me know when you get water on the fire, please," he says to a crew inside. Five minutes later, Rescue 301 - Bowen's crew - breaks in. The crew was on the fourth floor. "There is a lot of heat in here," a firefighter says. "We believe the fire is above us. We need to get some water in that standpipe so we can purge the lines." Budget Related Items:

Scottsdale (AZ) is expected to save more than \$6 million this fiscal year by merging many functions of the Police and Fire departments. In February, City Manager David Richert chose Scottsdale Police Chief Alan Rodbell to serve as both the police chief and public-safety chief. In that latter role, Rodbell has oversight of each agency, with a primary mission of identifying ways each can operate more efficiently. The Scottsdale Fire Department still is headed by Chief Garrett Olson, who is responsible for its day-to-day operations and long-range planning. Some open positions were eliminated, and some employees were laid off in June, including the Fire Department's public information officer. Scottsdale police officers now handle that duty for the Fire Department as well as for the police. Records reviewed by *The Republic* show that the Fire Department eliminated 11 positions, saving more than \$790,000. Those positions included a deputy fire chief, an assistant fire chief and two firefighters. The Police Department eliminated 14 positions, saving almost \$1.4 million, including nine officers and two crime-analysis technicians:

More than 1,000 United Kingdom firefighters' jobs have been axed under the Government's spending cuts, with the West Midlands being among the hardest hit areas, the service's main trade union has warned. And there are fresh losses in the pipeline, said the Fire Brigades Union. One in 10 jobs could be lost in the next three years, leading to several thousand fewer firemen and women across the UK, the FBU said. Research by the FBU, based on Freedom of Information Act questions, revealed that more than 1,000 jobs were lost in the first round of cuts to April, with the worst affected areas including Scotland, the South West, Yorkshire and the West Midlands:

Last week, Nevada state officials said they might have to take control of North Las Vegas' finances. City officials acknowledged that if things continue the way they are, the city won't be able to make payroll starting in October. Such a move would be a first for a Southern Nevada city, or any large Silver State city for that matter. Some have blamed firefighters and police unions for North Las Vegas' plight. The city was set to move forward with cost-saving layoffs before the police union sued. District Judge Nancy Allf halted the layoffs, agreeing with the officers' union that the city would violate the employment contract if it went ahead. That ruling is expected to bolster another lawsuit, by firefighters, trying to prevent 35 layoffs. The result: The city says it is spending \$165,000 a week (\$8.6 million annually) that it could have saved by cutting its police and fire workforce:

Huntington Beach (CA) Firefighters are offering to pay more into their pensions, but not without locking down a contract extension and minimum staffing levels. To some it's a good deal; others say it's a risky idea in an unpredictable economy. Union officials and city leaders have been negotiating for six months, but the City Council majority turned down the most recent proposal in May. Exploding pension costs have been a contentious topic as cities across California try to finagle a way to keep their promised contributions to their employees while battling the impacts of a suffering economy. Huntington Beach's unfunded pension liability, including the city's supplemental pension fund and using the most recent available market value, is about \$370.3 million, according to CalPERS valuation reports. Councilman Joe Shaw said he considers the union's offer a start on the path to combat looming pension issues. "Most of the City Council agrees that all of our employees have to pay more into their pensions," he said. "Our goal should be our non-safety employees pay 8 percent eventually and safety employees pay 9 percent." Councilman Don Hansen said the average firefighter has \$43,000 in pension costs and the average fire employee pays \$2,500. "Their contribution is pennies compared to what the taxpayers are supporting there," he said. There has been talk of a two-tier pension plan that would reduce benefits for any new hires, but Hansen said that would do nothing to help out with the current problem. Hansen said employees need to start paying more for retirement now and the city needs to have the flexibility to make cuts to the department, if needed, by denying the HBFA proposal. "They are like spoiled children that have never been told 'no,'" he said of the union. "They're used to having all these things just fall. ... We just can't afford it anymore."

But shrinking engine crews from four to three firefighters and the virtual grounding of the DC-10 supertanker shouldn't change the effectiveness of the California Department of Forestry and Fire Protection, agency officials said. "It was imperative to us to keep that aggressive initial attack capability, and we have," said Janet Upton, Cal Fire spokeswoman in Sacramento. Neither of the cuts stops an incident commander, or Cal Fire official, from managing how a fire is fought or ordering enough firefighters, engines and air support to snuff a wildfire, Upton said. Reducing the number of firefighters on each engine last January trimmed \$34 million from Cal Fire's budget, she said. Changing the contract for the DC-10, which used to be paid by the state to be ready to fly in 30 minutes, cleared another \$5 million from Cal Fire's budget this year:

Lombardi said falling real-estate values used to determine property taxes that fund the budget have pinched the 110-squaremile district's \$65 million budget. In the old days, when a fire erupted in rural Alhambra Valley (Contra Costa County, CA), volunteer firefighters and neighbors would rush to the scene to snuff the flames. But times have changed, and state regulations governing firefighters' training and certification have made volunteering more costly and time consuming. As a result, only two volunteer fire stations remain in the Contra Costa Fire District -- No. 19 in Briones and No. 18 in Clyde. About 10 on-call volunteers, also known as reserves, are assigned to Station No. 19, which houses an engine, a brush unit and a water tender. In 2008, the fire district told Alhambra Valley residents it would increase training and support for the station, but the recession derailed those plans, said Chief Darryl Louder. That doesn't sit well with some residents like Hetty Dutra, who runs a horse-boarding business on 360 acres in the valley. Battalion Chief Renee Dillingham, one of the firefighters named in February when Clark County administrators discovered e-mails appearing to show the county employees conspiring to abuse the sick-leave system, was let go, a county spokesman said Thursday afternoon. In released emails, Dillingham received an email from Battalion Chief Gina Geldbach-Hall that said: "I will be taking off June 10, 17, 19, 21, 23 and 25 (all sick days if I can work it out...). Again, thanks. It is so much nicer having a scheduler I can work with." In 2010, Dillingham earned \$274,309 in total wages and benefits. That included base pay of \$93,000, \$7,433 in sick-leave and about \$29,000 in call-back pay, which is earned when a firefighter is called in to work within 12 hours of their last shift. Call-back pay equals overtime pay of time-and-a-half plus a county contribution to the employee's retirement account. The average total wages and benefits for all firefighters in 2010 was more than \$180,000. Since instituting tighter oversight of firefighter sick-leave in February, the county has seen a 32 percent average decline in sick-leave use per pay period. Firefighter Donald Munn, based in Laughlin, was fired by the department in May for misuse of sick-leave, and more disciplinary actions are expected involving at least a dozen more firefighters:

Nine fire agencies from four Nevada counties and one in California have agreed to implement a standardized apparatus and station identification system. East Fork Fire and Paramedics Districts Chief Tod Carlini said participating agencies realized the value of having one system for numbering fire stations and apparatus, even though they are all dispatched from separate centers. Currently, each agency has its own numbering system creating conflicts with duplicated apparatus and personnel numbering on incidents where regional support and cooperation is essential, Carlini said. Carson City Fire Chief Stacey Giomi developed the system, which provides each agency with a master number as the primary agency identifier. Other numbers identify apparatus and personnel. The group also agreed on common apparatus terminology, whereby apparatus of the same type will be referred to with the same name. Regional agencies have three terms to identify an ambulance. Under the new system, an ambulance is now known as a "rescue" in all participating jurisdictions. "While this may seem like a simple step to take, it breaks with what we have been doing for at least the past 30-plus years I have been in the fire service," Carlini said. "With the current state of our economy, moving in a direction which attempts to maximize our efforts and funding on a regional basis makes sense," he said:

Tracking the number of emergency calls it receives is a top priority for Tualatin Valley Fire & Rescue, which serves 450,000 people in nine Oregon communities. But it wasn't until the release of its 2009 study on emergency calls that the department realized the extent of the problem it has with what it terms "low-risk, high-frequency" calls: of the more than 10,000 commercial automatic alarms the department responded to during a five-year period, 99 percent were what the report described as "false alarms" or "no-hazard incidents," which Tualatin defines as alarms triggered by burnt food, welding, dust exposure, and problems with heating, ventilation, and air conditioning systems. "We expected a pretty high number, but we were shocked when we saw the true magnitude of the problem," says Steve Forster, Tualatin's fire marshal. "We knew we had a huge number of fire alarms, but we really thought we would see more instances where automatic alarms alerted us to an emergency." The data prompted Tualatin Valley to rethink its alarm response. Last year, it amended its fire code to require all alarm monitoring companies to verify within 90 seconds if an actual incident is occurring before calling a 9-1-1 center. If the incident can't be verified, firefighters send a one-person response vehicle. Prior to the change, the department would send a four-person unit to check every alarm call:

While this level of pride is generally a great thing, and a characteristic many employers would love to see in their employees, it also raises a host of ethical issues that are particularly important given the current national debate about government, and government workers (career and volunteer, as most citizens neither know, nor care about, the difference). As many of you know firefighters from the Washington DC Fire & EMS Department have been ordered on crime prevention detail with orders to show up at some crime hot spots around town at all hours of the day. It has been a controversial program with IAFF Local 36 battling Chief Kenneth Ellerbe and top city officials over the wisdom and safety of such a program. Now comes the story from Scott McCabe at WashingtonExamniner.com of the firefighters themselves being crime victims. It happened while firefighters were battling a fire at 1720 Savannah Street, SE: Early Tuesday morning, Engine 33 firefighters returned from a call to their firehouse at 101 Atlantic St. SE to find it ransacked, with a BMW automobile, a firefighter's uniform and other valuables stolen. Thieves had forced their way into the station, trashed the watch desk, and stole a range of gear and personal property. Also missing were keys, wallets and a camera, according to the police report. The ripped-off BMW was the personal car of a firefighter:
