## **FIREFIGHTER 1 REFRESHER COURSE:**

We have just put together a new course called Fire Science 112 Refresher Firefighter One. It is a 40 hour course, and will be taught on the dates noted below at our Fire Academy program at our Airport campus, and Sunday, June 26 will be a live burn day at South San Francisco FD. We are addressing perishable skills such as SCBA, ladders, power tools, rope/tool/rescue ties, and so on. Each day will include a physical training component, a classroom component that will review each day topics such as ICS, Building Construction, Hazmat, Confined Space and an emphasis on safety (consistent with the new mandate to teach the new required Firefighter Safety course).

Hours are 8 a.m-5 pm. June 11, June 12, June 18, and June 25 will be at our Airport campus. June 26 will be all day at SSFFD. No class on Sunday June 19 as it is Father's Day. As you are all aware, the degradation of skills is a common complaint when new hires with a FF1 have been out of an academy for a while and have lost their skill base. We are trying to address that with this course. Students must have proof of a current medical, have their own fire hood, gloves, turnout boots, and we will supply turnout pants/coats and a Bullard fire helmet. The prereq is proof of a FF1 cert, either from the community college or State Fire Training.

The class title is Fire Science 112 Refresher Firefighter Academy. The CRN is 52174. Students may enroll online. If they are new students to CCSF, they need to stay in a menu that they are not taking any more than 9 units. If you can pass this on to your fire academy graduates or fire science students with a Ff1 Certificate, we would greatly appreciate it. Thank you.

## **CPSC Alert: Counterfeit Smoke Alarms Distributed in Atlanta**

WASHINGTON, D.C. - The U.S. Consumer Product Safety Commission (CPSC) is urging consumers in the Atlanta area to check their homes for counterfeit smoke alarms. About 18,500 counterfeit photoelectric smoke alarms were distributed for free in the Atlanta area between 2006 through May 2011 as part of the Atlanta Smoke Alarm Program. The smoke alarms can fail to alert consumers in the event of a fire. The Atlanta Fire Rescue Department, which distributed the free smoke alarms as part of a fire safety campaign, is recalling the smoke alarms and is working to provide free smoke alarm inspections and replacement units. Consumers who received these alarms should immediately contact the Atlanta Smoke Alarm Recall Hotline at (404) 546-2733. The counterfeit alarms can be identified by a silver Underwriters Laboratories' UL label on the back and three sets of vented slots on the front. The UL label is counterfeit. The alarms do not have a model number or brand name printed on them. "Important: Refer to Manual for Operating Instruction and Safety" and "Do Not Paint" are stamped into the plastic on the front of the alarm in both English and German. The package states, "This Smoke Alarm save [sic] life and property by early warning!" Claims that smoke alarms can "save property" are not typical claims for smoke alarms. The packaging states, "10 YEAR LIFE LITHIUM BATTERY," but the battery included with the smoke alarm is a carbon zinc, industrial, heavy duty battery, which will power the alarm for only one year.

CPSC's independent testing of the smoke alarms determined that the alarms pose a life safety hazard to the occupants in the event of a fire. The alarms perform poorly and inconsistently and do not meet voluntary standards requirements in Underwriters Laboratories' (UL) 217, Single and Multiple Station Smoke Alarms and the National Fire Protection Association (NFPA) 72, Fire Alarm and Signaling Code. The smoke alarms' sensitivity settings varied greatly between the alarms tested. Some alarms did not respond within an adequate time for life safety and other alarms did not respond at all. CPSC has worked with the voluntary standards organizations to improve smoke alarm performance and reliability. Counterfeit alarms can put lives at risk. Working smoke alarms that meet the voluntary standards are proven to save lives. CPSC urges consumers to install smoke alarms on every level of the home, outside sleeping areas and inside bedrooms. Replace batteries at least once every year and test the alarms once a month.

### **USFA Releases One- and Two-Family and Multifamily Residential Building Fires Topical Reports**

The Federal Emergency Management Agency's (FEMA) United States Fire Administration (USFA) announces the release of two special reports focusing on the causes and characteristics of fires in one- and two-family and multifamily residential buildings.

## **One- and Two-Family Residential Building Fires –**

...were developed by USFA's National Fire Data Center. One- and two-family residential buildings include detached dwellings, manufactured homes, mobile homes not in transit, and duplexes. Multifamily residential buildings consist of structures such as apartments, townhouses, rowhouses, condominiums, and other tenement properties.

An estimated 248,500 fires in one- and two-family residential buildings occur each year in the United States. Annually, these fires are responsible for 2,135 civilian fire deaths, 8,550 civilian fire injuries, and 5.9 billion dollars in property loss. Additionally, there are an estimated 103,000 fires that occur in multifamily buildings each year resulting in 390 deaths, 4,050 injuries, and 1.2 billion dollars in property loss. The reports are part of the Topical Fire Report Series and are based on data from the National Fire Incident Reporting System (NFIRS) for 2007 to 2009. According to the reports:

Cooking is the leading cause of both one- and two-family and multifamily residential buildings fires, followed by heating. Fire incidence in both types of residential properties peaks during winter months partially because of increases in heating and holiday-related fires. Fires peak over the evening dinner hours in one- and two-family and multifamily residences when cooking fires are prevalent.

Topical reports explore facets of the U.S. fire problem as depicted through data collected in NFIRS. Each topical report briefly addresses the nature of the specific fire or fire-related topic, highlights important findings from the data, and may suggest other resources to consider for further information. Also included are recent examples of fire incidents that demonstrate some of the issues addressed in the report or that put the report topic in context.

### **Bomb Arson Tracking System: Expanding the Fire Department Toolkit**

Fairfax, Va., May 13, 2011...

The Bomb Arson Tracking System (BATS - <http://www.atf.gov/applications/bats/>) is an invaluable tool to aid U.S. fire departments and fire marshals in their efforts to track arson incidents, manage investigation data, and apprehend arsonists. Recently, the IAFC partnered with the Bureau of Alcohol, Tobacco, Firearms and Explosives' (ATF - <http://www.atf.gov/>) U.S. Bomb Data Center (USBDC - <http://www.atf.gov/explosives/groups/usbdc/>) to create a new informational video - <http://www.iafc.org/displaycommon.cfm?an=1&subarticlenbr=154> to alert the fire and emergency service to its evolving capabilities and encourage them to participate in the multifaceted system. BATS is provided at no cost to participating agencies.

“Crimes that involve arson and explosives are among the most devastating incidents that confront our country,” said ATF Acting Director Kenneth Melson. “I encourage all fire service executives to incorporate BATS into their investigative policies and practices to help all of us maximize public safety surrounding these crimes.”

BATS, which has also been endorsed by the International Association of Arson Investigators (IAAI - <http://firearson.com/>), operates on many levels to support both local investigative needs and national collaboration and trend spotting. System benefits include:

- Secure, user-friendly, web-based computer application;
- Ability to track and manage investigations locally while simultaneously contributing findings to a national level database and national statistical reporting;
- Self-administered accounts that allow departments and agencies to control how their information is used and shared;
- Ability to rapidly research, track and compare multiple incidents—locally or across the nation—using real-time data and while maintaining operational security;
- Enhanced reporting using standardized terminology for consistency across stakeholders;
- Access to intelligence advisories and comprehensive resource library;
- Unique data sets associated with the tracing of explosive products from manufacture to the end-user;
- Ability to upload and store multi-media files relating to investigations;
- GIS mapping capabilities; and
- Versatile unit management tools provide a constant snapshot of activity, providing valuable data for administration management of personnel and budgets.

There are currently over 7,000 authorized BATS users from more than 1,500 local, state, tribal, and federal law enforcement and public safety agencies across the United States.

“This system has been utilized to assist with several major case investigations which were the result of serial arson fires,” reported Lt. Colonel Scott K. Hoglander of the Prince George’s County (MD) Fire/EMS Department, Special Operations Command. As one of the original pilot departments, Prince George’s County has been using BATS for seven years and praises the ease of the system, the value of the readily available information, and the continued evolution of service offerings. “The Prince George’s County Office of the Fire Marshall could not function in our current capacity without the BATS system,” said Hoglander. It is critical for fire department personnel to understand that BATS is not intended to replace the National Fire Incident Reporting System (NFIRS). While the primary mission of NFIRS is to collect fire incident information, BATS is dedicated to documenting and supporting the resulting post-incident investigation in cases involving fire or explosives.

“We are happy to lend our support to this effort with the Bomb Arson Tracking System,” said Glenn Gaines, Acting United States Fire Administrator. “The USFA and ATF are partners in promoting Arson Awareness, and BATS is currently included in the curriculum at the National Fire Academy’s Fire/Arson Origin-and-Cause Investigations course. In 2009, ten firefighters died as a result of arson-related fires. In addition, an estimated \$1.1 billion in direct property loss occurs annually. We all must continue every effort to protect our communities and be sure that when it comes to firefighter health and safety, everyone goes home.

### **Mastering Fireground Command – Calming The Chaos**



## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas. - NOTE: Do not wait until the last minute to attempt to complete the CPAT as it is common for people to fail their first attempt and have to go back on another day for a retest. More and more departments are asking for a CPAT card within six months or one year of the date of their testing process and I've seen many candidates fail the CPAT (and even retests) and not be able to continue through a department's testing process because of their failure to plan ahead. Don't let this be you!

**MISSOURI APPARATUS CRASH-FOLLOWUP FROM THIS MORNING**

2 of the 5 Firefighters who suffered serious injuries this morning when those two fire trucks crashed head-on in rural Platte County have been released from a hospital. The two firefighters were identified as Kevin Burge and Al Ryan. The 3 other Firefighters, Kent Pine, Carl Foreman and Fire Chief Larry Bigus, remained hospitalized. Their injuries are not believed to be life-threatening. 2 apparatus from the Central Platte FPD were responding from Platte City about 0400 to an electrical fire on the deck of a house. In the darkness, the first apparatus missed the house's driveway. The rig turned around and was headed back toward the house when it collided with the other apparatus and both trucks were severely damaged. We wish them a rapid recovery.

**CITIZEN STRUCK BY APPARATUS IN NEW YORK-ON PUBLIC SAFETY DAY IN NEW YORK**

An 87-year-old Brewster man was injured Saturday when he was struck by a Patterson fire apparatus. The accident happened about 0930 at the Government Campus at 110 Old Route 6, where people had gathered for Putnam County's Children's Expo and Public Safety Day. Norman Berenback walked in front of a slow-moving Patterson fire engine and was struck. He was rushed by TransCare Ambulance to Danbury (Conn.) Hospital after complaining of pain in his pelvis and abdomen and spent the night at the hospital and was released yesterday. The apparatus driver was not at fault as Mr Berenback walked out in front of the rig.

The triple fatal fire on in Utica (NY) yesterday caused a lot of emotion and finger pointing, as would be expected, especially when little kids are killed. Utica Fire Chief Russell Brooks is refuting any allegations stating the facts that his department arrived on the scene within 3 minutes of getting the call. The Chief said his crews initially went in immediately upon their arrival, but had to pull out because of the intensity of the fire. "It is not uncommon for people to point fingers when there is a tragedy," Chief Brooks said. "When we initially went into the building it was obvious anyone in there was dead."

**NOW, CHECK OUT THIS REPORTERS REPORT:**

One of the reporters at the scene was Utica WKTV's Photojournalist Tim Fisher - a 40 year veteran of the news business, who wanted to respond to an onlooker who was saying Firefighters didn't do enough to save the family. That would be the same onlooker who struck Tim when he saw him recording video at the scene. **HERE is Tim's side of the story, in his own words, as he stated:**

"I believe it is important, **especially at this moment in our country's history when public servants are being resented** for what they earn or bargain for to see them at work as they truly are. Folks just like all of us, doing a hard days work. In this case it was a very intense job in which they faced "a clear and present danger". Still, they did it and then went back to their firehouse to await the next call. We don't even know their names.

**ANOTHER "POWER LINE DOWN" REMINDER AT ANY FIRE SCENE, THIS TIME IN FLORIDA:**

A Firefighter was trapped inside his apparatus last night after a power line fell across the vehicle at a dwelling fire. The Orange County Firefighter was able to escape the truck after the power company secured the line. As members operated at the fire. the power line to the home burned through and fell on the fire apparatus and the Firefighter was unable to get out of the rig for about 10 minutes.

**A LOCAL LINE OF DUTY DEATH-POLICE OFFICER STRUCK DOWN BY CAR THIEF**

Not 15 minutes from where we live and work, this morning a Warren County (Ohio) Sheriff's Deputy was tragically struck and instantly killed in the Line of Duty while trying to stop a driver fleeing police in a stolen car. Sgt. Brian Dulle, 36, died after being hit while deploying "stop sticks," devices used to puncture the tires of fleeing vehicles. Dulle, a father of three children under the age of 10, including a daughter recovering from cancer, is the first Warren County deputy killed in the Line of Duty. A arrest was made earlier today. Sgt Dulle is survived by his wife and children Madelyn, 10; Emma, 7 and Jackson, 4, as well as by his parents Edward and Denise, brother Ryan and sister Brooke. RIP. While in past years, proposed cuts to fire/EMS related programs have been dealt with-and "fixed" - don't get too comfortable with this round-things are a lot different in Washington these days. **A lot different.**

**=WHY BE CONCERNED?**

**=WHY VISIT YOUR FEDERALLY ELECTED OFFICIALS WHEN THEY COME HOME NEXT WEEK?**

Today the House Appropriations Committee released a draft of the FY12 Homeland Security Appropriations bill. **The bill provides \$40.6 billion in funding for the Department of Homeland Security, a decrease of \$1.1 billion (2.6%) from the Fiscal Year 2011 level and \$3 billion below the Administration's request.** (The Committee's press release on the on the bill can be viewed at [www.CFSI.org](http://www.CFSI.org) )

**NOTE:** The draft bill makes **significant cuts to several programs of importance to the fire and emergency services.** The Assistance to Firefighters (FIRE) Grant Program and the Staffing for Adequate Fire and Emergency Response (SAFER) Grant Program would be funded at a total of \$350 million (\$200m for FIRE and \$150m for SAFER). The programs were funded at \$810 million (\$405 million for each) in Fiscal Year 2011. The United States Fire Administration (USFA) would be cut by more than \$3 million. The draft legislation provides only \$42.5 million for USFA, down from nearly \$45.6 million in Fiscal Year 2011.

**Additionally, the draft bill provides \$1 billion to be distributed at the "discretion of the Secretary" between several programs, including:**

- State Homeland Security Grant Program
- Urban Area Security Initiative (USAI)
- Metropolitan Medical Response System
- Citizen Corps
- Public Transportation Security Assistance and Railroad Security Assistance
- Over-the-Road Security Assistance
- Port Security Grants
- Driver's License Security Grant Program
- Interoperable Emergency Communications Grant Program

**This somewhat unusual provision represents a significant cut to these critical programs. In Fiscal Year 2011, the State Homeland Security Grant Program and UASI were funded at \$725 million each.** The Homeland Security Appropriations Subcommittee has scheduled a mark-up for Friday, May 12th at 11:00 a.m. in Room HC-5 of the Capitol Building.

"While very disappointing, it is important to note that this is just the first step in the lengthy appropriations process" said Bill Webb, Executive Director of CFSI. "We will continue to work with the House and Senate Appropriations Committees, as well as all of our allies on Capitol Hill, to ensure our nation's fire and emergency services have the resources they need to protect our homeland."

**=ARIZONA:** A fire apparatus rolled over in Casa Grande as it averted a collision with a vehicle that ran a stop sign, sending a firefighter to the hospital early today. Around 0100 hours 2 Firefighters

were inside the firetruck when it rolled over in an intersection-and were treated/transported for minor injuries. A white vehicle had been traveling west at a high rate of speed and ran a stop sign at the intersection and in order to avoid a collision, the firetruck took evasive action and ended up rolling over, The suspect vehicle was occupied by eight or nine undocumented immigrants, who were turned over to Casa Grande Police Department and the U.S. Border Patrol.

The incident occurred yesterday around noon when members were apparently doing a pump and hose drill. For a yet to be determined reason, the Firefighter was either thrown or fell due to an issue with a hose line and was injured. The Firefighter is reported to be in a medically induced coma at University Hospital ICU with serious head trauma. We wish the FF a rapid recovery.

#### **APPARATUS CRASHES IN KENTUCKY & ARIZONA**

Last evening on Kentucky 1394 in Laurel County fire apparatus was responding to a house fire. While enroute, the driver lost control on the wet roadway. The apparatus went about 100 feet down a ditch line and crashed over an embankment. Firefighters Kendall Osborne, and his passenger, FF Mike Sizemore, were taken to a local hospital for their undisclosed injuries.

**3 Phoenix (AZ) Firemedics** were injured yesterday when their ambulance was hit by a car while transporting an electrocution patient to the hospital. The victim electrocuted himself while working on a roof air conditioner. FF's used ground ladders to get him to the ground and continued to do perform ALS. The ambulance with a crew of 5 treated/transported but just as they turned left into the Baptist emergency room entrance, a Toyota Camry failed to yield. They were t-boned and hit by a car, which hit the back passenger side corner of the ambulance; that threw everybody in the back of the ambulance around because they were actively doing chest compressions, maintaining the airway. One of the 3 Firefighters injured will required a CT scan for a head injury. The patient in his 30s did not survive, but appears to have died from the electrocution and not the crash.

#### **RELATED:**

A police officer and 2 Paramedic Supervisors were injured in a responding crash yesterday afternoon at a Pittsburgh intersection. The officer was heading to the scene of a fatal shooting in Pittsburgh's Hill District when the collision happened. The Officer and 2 EMS supervisors were taken to a local hospital and have been listed in stable condition.

#### **PA FIREFIGHTER INJURED-CHEMICAL BURNS**

Several Firefighters received chemical burns in Harborcreek Township near Erie, PA yesterday. The American Biodiesel Energy and North American Powder Coatings facility was unoccupied when the fire started last night. However 3 firefighters did suffer minor injuries, said Asst Chief Ronald Hawryliw of the Fairfield Hose Co. At least 2 Firefighters received chemical burns and were transported to the hospital, but their injuries weren't believed to be serious.

#### **INMATE FIREFIGHTERS IN CALIFORNIA**

Following the budget driven reduction of 700 seasonal Firefighter positions in California, Cal Fire said they'll rely more than ever on the state prison inmates to help fight and prevent fires statewide. The firefighting force was reduced as part of state budget cuts made earlier in the year. The inmate Firefighters, who are mostly serving time for lower level offenses and live in minimum security camps near fire-prone areas, work at almost no cost. **The inmates earn \$1.00 a day during their service**

with Cal Fire, and \$1.00 an hour while actively fighting a fire or implementing fire-preventing measures. "It's an honor for them, but they're also paying back their debt to society," said a Cal Fire spokesman. "It's like we have something to prove as inmates," said Don Pride, an inmate working his 3rd fire season. "Here's our chance to show you we're not bums and we can get it done if you give us a chance," Pride said.

The occupants of the building had not used the first floor since the February earthquake, because of damages.

Tragically, this morning, Baldwin (Long Island, New York) A Baldwin Firefighter died of a heart attack after responding to a working fire this morning. Michael Esposito, 43, a 21-year member and Ex-Captain of the department, complained of chest pains in a department truck en route to the fire on the 2800 block of Grand Avenue at 3:30 hours. He was at the scene about 10 minutes when EMS evaluated him and took him to South Nassau Communities Hospital in Oceanside, where he died in the Line of Duty. According to the Baldwin Fire Chief, Esposito had a checkup "within the past few weeks," adding: "He had a clean bill of health." **PA. FIRE REPORT OUTLINES WHAT WENT WRONG/WHAT SHOULD CHANGE  
Firefighters Were Trapped & Burned Last September At a Multi-Family Dwelling Fire.  
These Recommendations Can Be Used By Any FD/Any Of Us, As A Template To Learn From.  
(VIDEO BELOW)**

In a no nonsense report regarding the fireground leadership of the Coatesville (PA) FD, independent investigators outlined a slew of recommendations to assist the department. Mismanagement, dangerously poor communication and broken leadership were significant factors in the emergency response for an apartment building fire that left seven firefighters injured.

**NOTE:** In April, the area local paper, the Daily Local News, made a formal request for a copy of the report; however, the city requested an additional 30 days to determine if such a report was indeed a public document and therefore should be released. Meanwhile, the Daily Local News obtained the report through another source and this information is based upon the findings of reporter Jennifer Carboni. Specifically, the 26-page report says Coatesville Fire Chief Kevin Johnson and other incident leaders failed at their duties during the Sept. 10, 2010, fire at the Millview Apartments. More than 100 firefighters responded to the blaze that caused roughly \$1.5 million in damage to the 28-unit building. According to the report, a major failure in communication allowed firefighters to "stay in an area of danger for far too long." Also, at least two "mayday" calls from firefighters went unanswered during the incident. The report is the result of an independent investigation sought by Chief Johnson. The city paid two retired Philadelphia deputy fire chiefs \$16,000 for the examination and subsequent report, which investigators released to Johnson on March 29. The city has not formally released the report nor discussed its contents publicly.

**RECOMMENDATIONS:**

The investigators, Jim Smith and Bill Shouldis, retired Philadelphia Chiefs, seasoned fire commanders, NFA Instructors and noted tactical firefighting book authors, outlined 24 recommendations on how to improve emergency responses based on how the department handled the Millview incident. Chief Johnson was the incident commander and therefore was responsible for overseeing the entire event, including the fire itself as well as dealing with the media and other agencies. Assistant Fire Chief Dan Paulukinas was operations section chief. An Incident Action Plan is required for all incidents, investigators said, but did not exist for Millview. Moving forward, the department should have a plan in place for all incidents. The plan does not need to be written, but should consider conditions, actions and resource needs and be relayed to responders. "Though the incident commander may have had a mental plan at this incident; it was never made known to anyone including (Paulukinas)," the report states.

Typically, the incident commander (Johnson) would relay the plan to the operations section chief (Paulukinas), who would then "ensure that all tactical units receive the needed information and the resources to carry out their portion of the (plan)," the report states. Without a plan, the firefighters working inside the burning building were not receiving appropriate guidance from leaders on the outside, investigators said. "At this incident no one with command/leadership authority ever asked the basic question: is it still safe to work on the interior? Continuously evaluating safety factors is a basic of a risk management plan," the report states. Later, a ceiling collapsed and injured seven firefighters, including Deputy Chief Robert Pacana, who was working with a team inside the building. (SEE VIDEO BELOW). Pacana, who at the time was a volunteer Firefighter in Coatesville, suffered severe burns and a serious leg injury. Pacana is also a paid firefighter in Washington, D.C., and has not been able to return to work due to minimal mobility with his left foot. In the report, investigators gave numerous examples where communication failed among leadership. For example, both Paulukinas and Johnson were giving tactical directions to crews, which investigators said should never happen. "Two individuals cannot be directing the tactical operations. The incident commander (Johnson) needs to provide guidance, establish the 'framework' of an incident action plan and share strategic views with operations (Paulukinas)".

The incident commander must allow the operations chief to carry out the plan, investigators said. At the same time, the commander and operations chief must stay in constant communication regarding progress with the fire fight. "This frequent exchange of communication is necessary to create a common operating picture. Communication is essential to making operation adjustments based on changes in conditions," the report states. Investigators said training is needed in the department to clarify roles and responsibilities of command personnel. During an interview, Paulukinas reportedly told investigators his strategy was to finish the interior search for residents. However, investigators said, "he failed to follow-up by checking on the progress of search assignments in the fire building and exposures." Additionally, investigators said documentation shows that the interior crew was not only looking for victims, but working to suppress the fire. At the same time, while Paulukinas told the inside crew to perform search and rescue tactics, he did not request feedback. Instead, firefighters were working by self-direction.

"This communication void allowed members to freelance and hampered effective decision making at the strategic level. Without specific instructions and with members determining their own actions, units were allowed to stay in an area of danger for far too long," the report states. Investigators said a scene must be monitored for hazards that could interfere with successfully completing objectives. In the future, leaders should set time frames for search and rescue while fire conditions are monitored. "Firefighters must be withdrawn when primary search is completed or when conditions present too much of a hazard to those attempting to search and rescue," the report states. While the department has an existing policy requiring interior firefighters to provide frequent verbal status reports to operations outside, investigators said such reporting did not occur at Millview. Investigators said Paulukinas should have requested the reports. Investigators said such reports guide the decision to switch from an offensive to a defensive approach, meaning firefighters leave the building and fight the flames from outside. In terms of command, investigators said it is critical for the incident commander or operations chief to establish a visible staging area to assist with direction and organization among firefighters.

Also, investigators said accountability is key among leadership. For example, at times key responders were unable to locate Johnson at the scene. Investigators said it is critical for the incident commander - or a designee - to be stationary and visible. "The command post should be stationary, properly staffed and established in front of the building for recognition by outside cooperating and assisting agencies," the report states. Investigators also documented failures with proper terminology over the

radio, lack of proper direction for responders via radio, and calls that simply went unanswered including a "mayday" call by at least two different firefighters. Investigators said seven firefighters were injured by a collapsed ceiling after being inside the burning building "for a prolonged period of time." Investigators said the establishment of an Incident Safety Officer at the scene would allow one qualified person to "concentrate strictly on the safety of those operating at the incident scene." That person could make suggestions to the incident commander on how to ensure firefighters' safety.

Furthermore, in regard to firefighter safety, investigators said that the firefighters working inside the building were not actually looking for victims, but fighting the fire. "The excessive amount of time that units were operating in an offensive attack should have raised a safety concern. The intense fire caused the roof to burn away and collapse over practically the entire third floor ... Despite these seriously deteriorating conditions, firefighters were allowed to remain inside the structure on an offensive attack," the report states. Firefighters continued working on the offensive from inside the building, despite one of the first responders suggesting crews immediately work on the defensive - outside the building. "Risk versus gain must be assessed at all incidents and it should be discussed between the incident commander, the operations section chief and the incident safety officer," the report states.

**GA FIREFIGHTER DROWNS ATTEMPTING TO SAVE HIS OWN CHILDREN (OFF DUTY)**

A 24-year-old Firefighter trainee drowned in Lake Tobesofkee near Macon, GA while trying to save three children, all who survived. FF Michael Dewayne Jones was pulled from the lake Saturday about an hour after he disappeared. Leon Jones said the man was rescuing three children ages 5, 7 and 8

who were having trouble swimming. Leon Jones said the children, two of which belonged to Michael Jones, were saved but Jones drowned. "He did what firemen are trained to do. But for whatever reason, he slipped. It could've been a catfish hole, it could've been a rock. He went down and he never came back up." #### **MINN. FIREFIGHTER KILLED IN THE LINE OF DUTY-TRAUMATIC INJURY AT TRAINING**

We regret to advise you that a rookie Cambridge (MN) Firefighter was tragically killed in the Line of Duty from a fall while training. Following a training session at the Cambridge Fire Hall on Monday, May 23, at around 2130 hours, Firefighter Chip Imker, 35, fell onto the pavement. FF Imker was flown to Hennepin County Medical Center in Minneapolis, and died as a result of his injuries. Reports are that FF Imker was putting his foot in a looped rope that got twisted, and the rope spread under his weight, came loose, and he fell about 6-8 feet onto concrete. FF Imker was a father, son, brother, partner, soldier, private business owner, Firefighter and coach. He was a certified Firefighter I and II as well as a trained EMS first responder and served his country as a member of the Army National Guard. As always, our most sincere condolences to all affected.

#### **FEDERAL POLITICIANS CONTINUE TOWARD CUTTING FIRE RELATED PROGRAMS**

House politicians moved their first two 2012 appropriations bills through committee today amid fights with other committee members over deep cuts to disaster aid that come as Missouri grapples with a devastating tornado. The Homeland Security appropriations bill, which included cuts to disaster aid and Firefighter funding, was approved on a party-line vote. **The measure would cut \$1.07 billion from fiscal 2011 levels, and about \$3 billion from President Obama's request for next year.**

Rep. David Price offered amendments to the Homeland Security bill to reverse cuts to disaster aid and firefighter assistance grants, but both failed on largely party-line votes. The first amendment would have restored \$460 million for the firefighter grants, bringing funding up to last year's levels and reversing a 65 percent cut. The second amendment would have restored cuts to state and local FEMA programs as well as the Firefighter program. With the cuts, FEMA state and local programs would be reduced by 55 percent compared to levels for fiscal 2011, and by 70 percent compared to fiscal 2010. **MORE HERE:** <http://thehill.com/homenews/house/163091-house-panel-moves-to-cut-fema-firefighter-grants>

#### **LODD UPDATE: TEXAS JUDGE RULES TRANSGENDER WIDOW MARRIAGE IS NOT VALID. SURVIVOR IS NOT QUALIFIED TO RECEIVE FALLEN FIREFIGHTER BENEFITS.**

A Wharton County (Texas) judge declared today that a transgender widow's marriage to Wharton Firefighter Thomas Araguz, who died in the Line of Duty, was not valid, so she is not eligible for his Federal PSOB death benefits. Ever since FF Thomas Araguz died at that fire at an egg farm last year, his family has been fighting his widow, Nikki Araguz, over \$600,000 in death benefits. The Firefighter's family argued that, since Nikki Araguz was born a man, her marriage to Thomas Araguz, under Texas law, wasn't not valid. The family said the death benefits should go to FF Araguz's 2 children, that he had with his first wife. However, Nikki Araguz has maintained that Thomas Araguz knew about her past as a man, and that their marriage was legal. She had sexual reassignment surgery after the marriage but the couple was estranged at the time of FF Araguz's death. Judge Randy Clapp said today that because Nikki Araguz was born a man, FF Thomas Araguz was not married on the day he

died in the Line of Duty, and any marriage, formal or informal, is void. According to attorneys, it's likely that the benefits won't be released until the appeals process is over, and that could take another year. Take Care-BE CAREFUL.

Among the Philadelphia (PA) FD's 116 injuries so far this year are a FF that had hot aluminum drop down his neck, a gas explosion tossing a FF into the air, a FF put his hand thru glass and a medic

was bitten by a dog. Those are included in numbers that are up 26 percent over the 92 injuries reported at the same time last year. **Bill Gault, President of IAFF Local 22 blames "brownouts" and other cost-saving measures, claiming the members are overworked and understaffed.** City officials counter that the spike is a historical anomaly. Injuries did dip to just 45 during the first quarter of 2010. But look at the years before, Deputy Mayor Everett Gillison said, and they average 84 for the same time period, which is in line with the 85 injuries reported in the first quarter of 2011. No surprise, Gillison blasted Gault, saying he's preying on public fears of inadequate emergency protection in a poorly disguised grab for more overtime money. City officials began the brownouts - in which three stations a week close temporarily on a rotational basis - last August in an effort to save \$3.8 million in firefighter overtime. The argument might be decided by an independent research group recently hired, at a \$219,000 price tag, to independently review the PFD. Results are expected in four to six months, according to the Pennsylvania Intergovernmental Cooperation Authority, which commissioned the study at the PFD's request. **HERE is more:** <http://tinyurl.com/3db4fsc>

**N.J. ASSISTANT FIRE-RESCUE CHIEF, 42, DIES IN THE LINE OF DUTY-MEDICAL EMERGENCY**

A Flanders Fire & Rescue Company (Mt Olive Township, Morris County, NJ) Officer died in the Line of Duty today after responding on a run at Mountainview Elementary School. The death of Assistant Fire Chief Thomas Shields, 42, is being called the first line-of-duty death for the Flanders fire company since 1927. The husband and father of two responded to the school because a student reportedly became overheated. The child was fine and Chief Shields returned to the firehouse and then headed home, feeling ill. He told his wife he was having chest pains, EMS responded but tragically Chief Shields died at Saint Clare's Hospital in Denville. **FROM THE IAFC REGARDING ACTION:**

Tomorrow, Wednesday, June 1, the House of Representatives is scheduled to consider H.R. 2017, the Fiscal Year 2012 Department of Homeland Security Appropriations Act. **NOTE: This bill would cut the FIRE grant program from \$405 million to \$200 million and the SAFER grant program from \$405 million to \$150 million. In addition, the bill would end the existing waivers to the SAFER grant program, and limit the number of cities eligible for the Urban Areas Security Initiative (UASI) program to the top 10 cities based on risk.**

Please contact your Representative ASAP and ask them to vote for the following amendments:

Amendment to restore funding to the FIRE and SAFER grant programs. This amendment would restore funding for the FIRE and SAFER grant programs to \$335 million for each program (Sponsored by Steven LaTourette (R-OH) and Bill Pascrell (D-NJ)).

Emphasize that the American public views fire and emergency response as an "inherently governmental function" and that the FIRE and SAFER grant programs are the only federal programs that help fire departments prepare for all hazards, including those of national significance.

Point out that the FIRE and SAFER grant programs use a highly-regarded merit-based, peer-review process to grant awards directly to fire departments. If you have received a FIRE or SAFER grant, explain how they have improved your emergency response capabilities. Also, let your Representative know if you plan on applying for a FIRE or SAFER grant, and how these grant programs can help you protect your jurisdiction.

**Amendment to extend the existing SAFER waivers through FY 2012.**

For the FY 2011 SAFER grants, there is a waiver on the 10/20/50/70 percent local match requirement and a waiver on the requirement that SAFER funds cannot supplant existing state or local funds. For FY 2011, the SAFER funds also can be used to re-hire and retain firefighters. The amendment also would remove the \$100,000 per firefighter cap on SAFER awards and the requirement to retain the SAFER firefighter for a fifth year at the local jurisdiction's expense.

**=Explain why it is important that fire departments be adequately staffed to ensure the health and safety of your fire department and the American public.**

If you have received a SAFER grant, explain how the SAFER-funded firefighters or the SAFER-funded volunteer recruitment/retention programs have improved your fire department's operations.

**=Amendment to remove the limit on the number of cities eligible for the UASI grant program.**

REMINDE THEM that there is still an active terrorist threat and that many of the United States' urban areas are still at risk. If you have received funding as part of a UASI grant, explain how it has been used to improve regional and local cooperation in emergency response operations and enhanced your capability to respond to a terrorist attack or other disasters.

**=Lastly, make it clear that your Representative should oppose any amendment to eliminate the FIRE and SAFER grant programs.**

Explain that the local fire service is the nation's front-line responder to all disasters, natural and man-made, and that these programs play an even more important role now that many local budgets are being cut. **RUNAWAY FD RIG IN NEW YORK :**

An unmanned fire department SUV was slightly damaged this morning after it rolled over a small tree and crashed into a stoop. It happened around 1000 hours when firefighters from the Arbor Hill station were inspecting a building. Rescue 2, a Chevrolet Suburban SUV used to carry paramedics and paramedic equipment, was parked outside on the street when -- for reasons that officials said are not yet clear -- it began to roll slowly down the block. The SUV jumped the curb, crushed a small tree and ran into a concrete stoop at 178 North Lake, shoving the steps about a foot out of alignment-no one was injured. At some point, whether the truck slipped into gear with a failure of some sort, they don't know yet. The Firefighters had been out of the truck for five or six minutes before the accident, the vehicle has been sent for a mechanical inspection.

There is no other call more challenging to fire ground operations than a Mayday call - the moment when a fire fighter's personal safety is in imminent danger. Fire fighter fatality data have shown that fire fighters "becoming trapped and disoriented represent the largest portion of structural fire ground fatalities." The fire burned through all three floors of the house, including tearing through the kitchen floor on one of the levels. The rear fire escape was also rolling shortly after the fire began. The FF suffered neck and facial burns when his mask accidentally pulled off while operating has since been released from the hospital.

**=FEDERAL FUNDING UPDATE FROM THE IAFC:**

Last night, the U.S. House of Representatives passed H.R. 2017, the Fiscal Year 2012 U.S. Department of Homeland Security (DHS) Appropriations bill, which would appropriate \$40.6 billion in discretionary spending for the DHS and its programs. As per an IAFC members alert:

=Restoring \$320 million to the FIRE and SAFER grant programs. This amendment, offered by Representatives Steven LaTourette (R-OH) and Bill Pascrell (D-NJ), restored \$320 million to the FIRE and SAFER grant programs. After passage of the amendment, the FIRE and SAFER grant programs would be funded at \$335 million each.

=Removing the Limit on Cities Eligible for the Urban Areas Security Initiative (UASI) Grants. This amendment, offered by Representatives Hansen Clarke (D-MI), Brian Higgins (D-NY), and Dave Reichert (R-WA), removed the provision in H.R. 2017 that would have limited the number of cities eligible for UASI grants to the ten highest-risk cities. This amendment will ensure that all UASI cities are eligible for the funding.

=Extending the SAFER Waivers Through FY 2012. This amendment, offered by Representative David Price (D-NC), extended the waivers to requirements for the SAFER grant programs through FY 2012. It will allow fire departments to use the SAFER grants to re-hire and retain firefighters. The Senate must now consider its own FY 2012 DHS Appropriations bill later this summer. Then, the House-passed and Senate-passed bills must be reconciled and sent to President Obama for signature by the beginning of the FY 2012 fiscal year on October 1. **2nd SAN FRANCISCO FIREFIGHTER DIES IN THE LINE OF DUTY**

It is with deep regret that we have been advised that San Francisco Firefighter/Paramedic Anthony Valerio, 53, has now also died in the Line of Duty following the loss of Lt. Vincent Perez. He passed at

0740 hours this morning. We will post additional information as it becomes available. As always, our sincere condolences to the SFFD and all those affected by this double LODD.

**DESPERATE SEARCH FOR MISSING SFFD FIREFIGHTERS (Radio Traffic Links Below)**

Fire commanders at the scene of Thursday's house fire in San Francisco desperately sought to find a crew of Firefighters when they became separated from their colleagues, but couldn't locate them before two of them were enveloped in a flashover, radio logs (below) and dispatch recordings show. The fire at 133 Berkeley Way began about 1044 hours, apparently when an electrical outlet sparked and ignited curtains in the ground-level living room of the four-story home, one of the occupants of the home told dispatchers. The woman and three children in the home at the time escaped unharmed.

About 20 minutes after the first firefighters arrived, superheated gases ignited in a room where a two-man crew from the neighborhood station house was fighting the blaze. The leader of the crew, Lt. Vincent Perez, 48, was killed, and his colleague Anthony Valerio, 53, was in critical condition Friday night at San Francisco General Hospital. SFFD is investigating what happened but did not issue any updates on the probe Friday. Dispatch logs and recordings shed light on how what the first responding firefighters called a "low-grade" blaze went tragically wrong.

**ZERO VISIBILITY**

Lt. Perez, a 21-year veteran firefighter, and two colleagues from Engine Company 26 in Diamond Heights were the first to arrive at 10:47 a.m., the dispatch log shows. Dispatch tapes captured him coughing as he reported on the situation. "We have an active fire, zero visibility, third floor," Perez said. The home's third floor is actually the ground level from the street, with two floors below it built into a hillside. A scene commander, identified by firefighters as Battalion Chief Thomas Abbott, ordered a crew from Engine Company 24 to back up Perez's crew inside the building. For several minutes, however, scene commanders repeatedly tried to find the Engine 26 firefighters, without success. Finally, what appeared to be the last communication from the doomed crew came over the radio. "This is 26, this is 26. ... Battalion 6, what's your location?" said a muffled voice. "Twenty-six, this is command, I need to know your ..." came in reply. "This is Engine 26, we're on the third..." At that point, the voice over the radio trailed off.

**VENTING GASES**

Another crew soon asked the command post for permission to cut a hole in the roof to allow superheating gases to escape from the home. It is not clear whether anyone had done that in the dozen or so minutes firefighters had been on the scene, but it would have been a crucial step in preventing what happened to Perez and Valerio. The two firefighters were alone when they were overcome, and exactly when the flashover happened is unclear. One mystery raised by the dispatch tapes concerns a radio message that a dispatcher sent to the Berkeley Way command post at about 11:07 a.m. She said, "Engine 20 activated their emergency alarm and they haven't confirmed their response for five minutes." The emergency alarm is a red panic button that SFFD firefighters carry on their radios. On Thursday, Fire Department spokeswoman Mindy Talmadge said the alarm had come from one of the fallen firefighters. However, Engine 20 was a different company, which was not yet at the fire scene. A fire official close to the investigation, speaking on condition he not be named because the probe is in its early stages, said someone on Engine 20 may have pressed a panic button accidentally while en route to Berkeley Way.

**A HURRIED CHECK**

A commander at the scene, however, said he was heading into the house anyway when he got the dispatcher's radio call. "I copy that, I'm going to look for them right now," said the commander, who is not identified on the tape. A few seconds later, about 11:10 a.m., a firefighter announced that he

needed medics right away. "I've got a man down," the firefighter said, his voice surging with adrenaline. "Come through the front door, go down the stairs to the right, do you copy?" Chief Joanne Hayes-White said the whole episode, including the communications dispatches, will be under review as part of the investigation. "We want to do a complete and thorough investigation," Hayes-White said. "Right now, my complete attention is on Perez and Valerio. We're holding out hope for Tony - he's a fighter." (NOTE: FF/Paramedic Valerio died this morning)

### **Budget Related Items:**

Without pay concessions from city unions, Reno (NV) city officials are planning to eliminate 82 more city employee positions to save \$8 million for the next fiscal year starting July 1, reducing city services to bare-bone levels for police, fire and parks. Saving those positions hinges on the city's 10 labor unions accepting 7.5-percent pay cuts. Eighty employees, including 32 firefighters, were laid off March 1 to balance the current budget and prepare for the upcoming budget. In the possible layoffs, 14 more firefighters would be lost, resulting in closure of the city's fire station at Kings Row or Ralston Street in northwest Reno, Fire Chief Michael Hernandez said. The San Carlos (CA) City Council agreed Monday to pay firefighters hired to work in its new hybrid fire agency with Redwood City less than those currently employed in the soon-to-be dissolved Belmont-San Carlos Fire Department. But council members delayed a decision on whether to apply the 5 percent pay cut to current firefighters who are tapped to work for the new agency. "This would be for new hires," City Manager Jeff Maltbie said. "You could choose to treat existing employees ... not as new hires." Council members also voted to give new firefighters less vacation and sick time than current firefighters, as well as reduced pension benefits. Most firefighters currently receive 3 percent of the average of their three highest annual salaries, multiplied by years worked when they retire at age 55. The San Jose (CA) Fire Department may have to resort to rolling brownouts this summer as the cash strapped city tries to cut costs. That would mean fewer trucks and engines in as many as seven stations. Mayor Chuck Reed's office says only those fire houses with two trucks would be affected, with one of them taken out of service on a designated brownout day. The other stations with only one engine would not participate. Following the reduction of 700 seasonal firefighter positions, Cal Fire said they'll rely more than ever on the state prison inmates to help fight and prevent fires statewide. "We're in tough fiscal times, so this program is a great budget saver," said Cal Fire spokesman Daniel Berlant. He said their force was reduced as part of state budget cuts made earlier in the year. The inmate firefighters, who are mostly serving time for lower level offenses, and live in minimum security camps near fire-prone areas, work at almost no cost. Berlant said they earn \$1 a day during their service with Cal Fire, and \$1 an hour while actively fighting a fire or implementing fire-preventing measures:

What happens when a small town runs out of money? The cost cutting becomes a matter of public safety. Tuesday night the Lincoln (CA) City Council set out to bridge a \$1.7 million deficit. That's the national standard, it's not a gold plated standard, it's a safe standard. Just a couple of weeks ago we had 4 firefighters in the city of Lincoln."

San Jose's (CA) mayor says the city must declare a state of fiscal emergency in the face of skyrocketing pension costs and the planned layoffs of hundreds of municipal workers, including police officers and firefighters, to close a \$115 million budget deficit. Mayor Chuck Reed on Friday also introduced a sweeping pension-reform plan that he hopes to put before voters in November, the San Jose Mercury News reports. The proposal would raise retirement ages and significantly reduce benefits. Reed said the reforms would stabilize the Silicon Valley city's finances as it grapples its 10th straight deficit. Without the changes, San Jose might be forced to cut its 4,200-person workforce to 1,600 within five years, the two-term Democratic mayor warned. The city's annual retirement costs have ballooned from \$63 million in 2000 to \$250 million this year. Retirement costs account for about half of the budget deficit for the coming fiscal year, Reed said. Editorial - A Fire Department for tough times: Los Angeles (CA) Department leaders have come up with a plan that would trim the overall size of the force without significantly increasing response times. The City Council should approve it. The plan is fiercely opposed by the city's firefighter union, which views it as making permanent the cuts that the department has absorbed. Its leaders have drummed up public opposition by highlighting the closure of fire companies, the teams of firefighters and equipment that some neighborhoods will lose if the plan is approved. Some protesters, however, have misinterpreted those missives as suggesting that fire stations will be shuttered. That's false. Not one of the city's 106 stations would be closed. In addition, some have decried the prospect of laying off firefighters. That's false too. The Fire Department's proposed budget contemplates making all the cuts through attrition, leaving positions vacant for the next couple of years as firefighters retire or leave:

The cuts are deep and sweeping. The North Las Vegas (NV) City Council voting Tuesday night to eliminate nearly 260 jobs. No department was spared in the most drastic cuts in city history. "We can sit here and analyze and procrastinate and vacillate all night long. The bottom line is there is going to have to be some folks laid off," said Ward 2 Councilman William Robinson, following nearly two hours of public comment. The Los Angeles (CA) City Council approved the Los Angeles Fire Department's controversial redeployment plan Wednesday, but, in a concession to the firefighters union, it voted against eliminating hundreds of firefighter jobs. The redeployment plan calls for firetrucks or ambulances at about one-fourth of the 106 LAFD stations to be put out of service. It also included the elimination of 318 staff positions, but the city council rejected that part of the plan. Now, city fire jobs will not be eliminated as they come open. Pension benefits for Oregon public employees should undergo deep cuts to shore up the financial health of the Oregon Public Employees Retirement System and reduce PERS' drain on government budgets, a new report from the City Club of Portland says. The City Club report concludes that an average 30-year PERS retiree will receive pension benefits that exceed his final salary, when Social Security payments are added to state benefits. Bringing public pension benefits in line with the typical retirement plan target of 75 percent to 80 percent of salary would reduce costs to cash-strapped state and local governments, said Portland resident Rob Aldisert, chairman of the City Club committee that spent a year researching the issue. "What we're suggesting would be modest reforms that would in the end hopefully result in fewer layoffs and less cuts to services," Aldisert said:

City Manager Carlos Palacios said the city can't save the jobs without pension concessions. Seven police officers, including a lieutenant, three fire captains and one firefighter received layoff notices. Clark County (NV) Fire Department battalion chiefs' salaries would be reduced almost 5 percent under a tentative agreement reached by their union and county officials. The deal, if approved by the County Commission and the nine battalion chiefs affected, would reduce average annual compensation by more than \$40,000, which includes a reduction in base wages of 4.875 percent and "significant" reductions in callback and overtime, according to a county statement. It also would reduce vacation and sick leave accruals, freeze merit increases, reduce longevity pay and reduce bonus leave for new employees:

Without concessions from Palo Alto's (CA) police and fire unions, the city may be forced to shut down a fire station, eliminate an emergency rescue unit, or lay off more than a tenth of its police officers, according to a new report. Though City Manager Jim Keene's 2011-12 fiscal year budget counts on \$4.3 million in concessions from police and fire unions, the city council's Finance Committee asked the departments earlier this month to come up with a list of potential cuts in case negotiations don't pan out. Interim Director of Public Safety Dennis Burns will describe his proposals at a Finance Committee meeting today, including drastic cuts to both departments. "The good news is the unions and the city continue to negotiate," Burns told The Daily News. "And in the meantime, we're also looking for other options. I don't think these are cast in concrete, and I don't think these are the only options." To save \$2.3 million from the fire department, Burns offers two solutions. The city could shut down one engine company, cutting nine firefighter positions, and temporarily close one station at a time in "brownout" fashion. The San Joaquin County civil grand jury Monday released a report saying Stockton (CA) Fire Department crews are too big and recommending cuts that it estimated would save millions of dollars. In its report, the grand jury recommended cutting engine and truck crews by one firefighter each and establishing a relief pool with the remainder to reduce overtime. The grand jury estimated savings from those reductions at \$5 million to \$7 million annually. Working under a worst-case budget deficit projection of \$37 million, the city has proposed closing five engine companies and cutting engine crews to three firefighters and truck crews to four. "Every fire chief in the country would embrace four firefighters on the engines and five on the trucks, but in reality the cost to sustain those firefighters must be addressed at a time when cities are planning deeper cuts to city services to balance the budgets." In a written statement, Capt. Dave Macedo, president of the firefighters union, said the grand jury's analysis was shallow and contained nothing new. Macedo said staffing cuts are almost inevitable. The Fire Department is expected to come up \$19 million short next year. That can't be made up with wage and benefit concessions alone, he said, and the city has proved willing to impose cuts it can't negotiate. - *Someone asked why I run these stories that tend to make the fire service look not-so-professional at times. Well, besides the fact they are public knowledge, I think it is critical for all of us in the fire service – current and future personnel – to learn from not only the good, but the not-so-good of others. Good, bad or indifferent, fire service personnel are in the public eye since we are paid by the taxpayers and they have a right to hold us accountable for our actions since they are paying for us to be here. In today's world, the key to success is building and maintaining positive working relationships with the public, not to mention the elected/appointed officials, since all of them are the ones that ensure we still have jobs and that we get what the community we work for feels is appropriate, reasonable, cost-effective and efficient, in regards to staffing and the number of fire stations and resoures.*

One Clark County (NV) firefighter will be fired for abusing sick leave and 16 others will be disciplined. According to several sources, the disciplinary actions follow an internal

investigation by county and Fire Department administrators. Sources did not know the specifics of the discipline faced by the 16 firefighters who won't be terminated. Allegations that county firefighters have abused the sick-leave system have been floated for more than a year. First reported by the Sun, the allegations surfaced in a March 2010 Clark County compensation study that found the average number of shifts taken off for sick leave by roughly 700 firefighters came to almost twice as many as rank-and-file employees and about four times those of management:

Wheeler also seemed to be avoiding the cameras in the story below about a City Council hearing Wednesday that had the commissioner on the hot seat. Unfortunately, the fire commissioner just continues to make bad stories much worse by constantly giving the impression he is running from the press and has something to hide. The reporters, whether you like them or not, are asking legitimate questions of a public official. That's their job. Your job is to be accountable. If you have a defensible position, defend it and provide the supporting facts. If mistakes were made, get it all out in the open and explain how you are dealing with it and making sure it doesn't happen again. **At some point bad news will happen to almost every fire department and it will likely bring those pesky reporters to the door asking tough questions.** This week it is Osceola County (FL) Fire Rescue's moment in the spotlight after Firefighter Douglas Werk was arrested and charged with breaking into the home of an elderly woman he had taken to the hospital and stealing her guns. This may be a pattern of behavior. WESH-TV reports, "Detectives said Werk may have been scouting out homes to burglarize" and that the firefighter was already on administrative duty after the Osceola County Sheriff's office investigated him for snooping around a different property in February. The response by a fire chief faced with this situation is crucial to how quickly the issue can be put behind them and the department moves on trying to restore its reputation. Too often the chief won't talk to reporters or let anyone in his department come clean about what happened. "It's a personnel matter" or "it's under investigation" are some of the lame excuses used as cover to keep from telling the truth. Usually this makes a bad situation worse, stretching a one day story into multiple days and turning a small brush fire into a conflagration. What can be incinerated in that fire is the department's image and any good will it has built up in the community:

**It has always been hard to sue government employees, but after a recent Tennessee Supreme Court ruling, it could be harder than ever to sue a state, city or county worker who intentionally hurts someone.** A Tennessee Supreme Court ruling recently made a huge distinction: if a government employee hurts you by accident, you can sue the government for

up to \$300,000. If he hurts you on purpose, you now get nothing. "Occasionally, you will have a confrontation, where the employee acts intentionally and illegally, but that doesn't mean that the citizen should have ... the worst the harm is, the less the citizen gets," said David Raybin, a lawyer and noted legal scholar. "That makes no sense at all." All of this came about after Nashville firefighter Dalton Hughes sued the city of Nashville and won \$250,000 when a Public Works employee pulled up behind him and slammed his front loader. Hughes was scared, jumped over a guardrail and injured himself. But the state Supreme Court said the driver of the front loader admitted he "was just joking" and "didn't mean to do that" and was "just trying to scare you all." A federal jury in Alexandria has ruled that the Fairfax County (VA) Fire and Rescue Department knew of and tolerated a male lieutenant's sexual harassment of a female firefighter and has awarded her \$250,000. The county is facing a second federal trial next month involving allegations of years of far more intense and continual harassment of another female firefighter by her male colleagues and superiors. The harassment of firefighter Mary Getts Bland, who retired last year, began when she was being recruited to the Fairfax department in 2001 by Lt. Timothy D. Young, according to a 61-page memorandum opinion written by U.S. District Court Judge James C. Cacheris this month. Summarizing the facts of the case, Cacheris noted that Young reportedly asked Bland questions such as "Do you enjoy having sex with more than one partner?" and "Do you like to be watched while you masturbate?" Also, the first-year wage for rookie firefighters would be lowered by 5 percent. An estimated two-thirds of firefighters who cast ballots voted for the new terms, according to union leaders. These concessions would be on top of the reductions in firefighters' pay and benefits that the county won in arbitration, for a total savings of \$13.3 million yearly, county officials estimate. Last year, county firefighters averaged \$130,000 in wages and \$58,000 in benefits. Battalion chiefs received an average of \$183,000 in wages and \$81,000 in benefits:

**Training & Safety Related Items:**

Independent investigators have faulted Coatesville (PA) fire officials in the response to a blaze last fall that injured seven firefighters, according to The Daily Local News. The 26-page report listed mismanagement, poor communication and broken leadership by Fire Chief Kevin Johnson and other commanders as significant factors during the Sept. 10, 2010 apartment fire. More than 100 firefighters responded to the blaze at the Millview Apartments in the 1800 block of Saginaw Drive that caused approximately \$1.5 million in damage to the 28-unit building. A ceiling collapsed during the blaze, injuring seven firefighters, including Deputy Chief Robert Pacana. Pacana -- who is also a paid firefighter in Washington, D.C. -- suffered severe burns and a serious leg injury and has not been able to return to work. The report states that the breakdown in communication led firefighters to "stay in an area of danger for far too long." It also alleges that at least two Mayday calls went unanswered:

And one of the first things that needs to be done is implementing a culture change to embrace the EMS mission at some departments, according to Mike Metro, Deputy Fire Chief at Los Angeles County Fire Department:

If all goes as expected, Cambria's (CA) former Fire Chief Mark Miller might not be "former" for much longer. Tammy Rudock, then the general manager of the Cambria Community Services District, terminated Miller on April 12, and declined to state any reasons, citing personnel

confidentiality. After substantial community outcry, the district's Board of Directors then terminated Rudock on April 29:

Washington DC Fire & EMS Department Chief Kenneth Ellerbe says he is still working with the union on a compromise solution over his previous order that "DCFD" was out and "FEMS" was in as the department's acronym. In an interview with Lou Chibbaro Jr. at WashingtonBlade.com Chief Ellerbe admits there are concerns about what FEMS means: D.C. Fire Chief Kenneth Ellerbe acknowledged that his decision to postpone an order that firefighters place the initials "FEMS" on the shirts and jackets they wear while on duty was based, in part, on that acronym's perception as a possible derogatory reference to gay men. The chief told Chibbaro that they are working with IAFF Local 36 on a possible compromise logo that will reflect the important role of EMS in the department's mission:

A federal appeals court ruled on Friday that the Chicago (IL) Fire Department must hire 111 African Americans who passed a firefighters entrance exam 16 years ago and pay millions of dollars to thousands more who took and passed the same test. The Seventh U.S. Circuit Court of Appeals ruling was the latest blow to the city, which has been on the losing end of court decisions regarding the 1995 test for years, including a 2005 ruling by a federal judge who said the test discriminated against black applicants and a U.S. Supreme Court ruling last year that the candidates did not wait too long to sue the city. The ruling stems from a test given in 1995 that was intended to measure an aptitude for firefighting. After the test, anyone who scored 64 or below was deemed not qualified, but officials told those who scored above that number that while they passed, they would randomly hire the top 1,800 who scored 89 or better. Because only 11 percent of the African Americans scored 89 or better, the overwhelming number of applicants hired from that test were white. Karsh said the test was discriminatory because there was no evidence that the applicant who scored 89 or better would be any better firefighter than another who scored a 64, and in fact in 2005 a federal judge said the test discriminated against black candidates:

With the Los Angeles (CA) City Council scheduled to vote Wednesday on Los Angeles' \$6.9 billion budget plan, Mayor Antonio Villaraigosa and the Fire Department are pushing hard for passage of a controversial deployment plan that could save an estimated \$54 million. Fire Chief Millage Peaks has been meeting with individual council members to lobby for the staffing plan, which he says would restore some of the cuts made under a previous money-saving deployment schedule. "Right now, we have 22 fire resources out of service under the modified deployment plan," Peaks said in a round-table discussion arranged by Councilman Tony Cardenas. "If this new deployment plan was in effect, we would have 18 resources out of service. "No fire stations will be closed. We will have all 106 fire stations open and staffed." The proposal also would reduce the number of off-duty firefighters from 122 to 106, Peaks said. After determining that medical emergencies comprise 83 percent of the department's calls for service, Peaks proposed sidelining fire engines or replacing them with ambulances at several stations. All 3,300 of L.A.'s firefighters are trained as emergency medical technicians and 700 of them are certified paramedics:

The Belmont-San Carlos (CA) Fire Department's board will not immediately select a new agency head, choosing instead to split the job among three battalion chiefs who will each get a 6 percent raise for the trouble. Chief Doug Fry, who announced his retirement earlier this month and stopped working last week, remains on the department payroll until May 31 because he is taking unused administrative leave time. On May 17, the fire department's board decided that instead of hiring an interim fire chief, the work would be rotated among three battalion chiefs until the agency dissolves in October. A Missouri judge has struck down a state law allowing St. Louis firefighters to live outside the city limits because it infringed on the city's authority to set its own work policies. St. Louis has long had residency requirements for most of its employees. But the Missouri Legislature passed a bill last year giving firefighters the right to live outside the city as long as they were within an hour of their home fire station. Not long after a new Cal Fire unit chief was introduced to the city Monday evening, the organization's contract was brought before the council. Cal Fire first came on the scene to provide fire protection for Atwater (CA) in 2008 on a two-year, nine-month contract, Unit Chief Nancy Koerperich said shortly after being introduced during Monday's meeting. The contract expires June 30. Several Cal Fire personnel sat in the audience during the meeting. Before the meeting, some expressed concerns about the future of the organization in Atwater. Councilman Gary Frago, a former firefighter with the city-run fire department, has been critical of Cal Fire since it came to Atwater. But the criticism is purely based on Cal Fire's cost to the city, Frago said after the meeting. The council was presented options, including continuing services with Cal Fire at current staffing levels, continuing services at lower staffing levels or ending services with Cal Fire, which would start the transition back to a city-run fire department: <http://www.mercedsunstar.com/2011/05/24/1903027/atwater-looking-at-its-cal-fire.html>

Former Coatesville (PA) City Fire Chief Kevin Johnson said Tuesday he did not resign Monday because of a recent report on an incident in September that put him in a poor light. Two retired Philadelphia fire chiefs — James P. Smith and William Shouldis — prepared a 26-page report on a Sept. 20, 2010, fire that caused about \$1.5 million damage to 28 units at the Millview Apartments. The report, obtained by the Daily Local News, said poor communication and a lack of accountability led in part to the injuries of seven firefighters. Nobody — not firefighters, police, passers-by or Berry, 84, — moved into the 55-degree water to try to pull the 280-pound, suicidal man to safety. Firefighters did not go into the water because they are not trained in land-water rescue and don't have a boat that could maneuver into the shallow waters. Friday was the day the Detroit native, who retired in February as an assistant chief with the Los Angeles Fire Department, sat down with TV reporter Charlie LeDuff, the man two previous fire commissioners constantly ran from. And the fact that the former commissioners never understood how to handle LeDuff is one of the reasons Chief Austin has this new job. What Chief Austin needs to remember is the demeanor, candor and poise he showed in the video above. Bottle it. You will need it:

Grand Rapids (MI) City Manager Greg Sundstrom said he's getting tired of having his firefighters put out fires in the neighboring suburb of Grand Rapids Township. The New York (NY) City Council passed a bill extending the age limit for hopeful firefighter candidates who have been stymied by an ongoing legal battle over the entry exams. The extension - from age 29 to 35 - would allow job-seekers who took the 2007 test to remain eligible for the next test. The last firefighter exam was administered in 2007, but the results were invalidated by a federal judge who ruled that it discriminated against African-American and Hispanic candidates. "This rectified a wrong that the court inadvertently created," said Council Speaker Christine Quinn. The FDNY plans to begin accepting applications for a new exam on July 1. The Council also passed a resolution supporting greater oversight of bonus points granted to firefighter candidates living in the city. Currently, city residents get an added five points, but many are suspected of lying about where they actually live:
