CHARLESTON, S.C. — Major factors contributing to a rapid spread of fire at the Sofa Super Store in Charleston, S.C., on June 18, 2007, included large open spaces with furniture providing high fuel loads, the inward rush of air following the breaking of windows and a lack of sprinklers, according to a draft report released for public comment today by the U.S. Commerce Department's National Institute of Standards and Technology (NIST). The fire trapped and killed nine firefighters, the highest number of firefighter fatalities in a single event since 9/11.

Based on its findings, the NIST technical study team made 11 recommendations for enhancing building, occupant and firefighter safety nationwide. In particular, the team urged state and local communities to adopt and strictly adhere to current national model building and fire safety codes.<sup>1</sup> If today's model codes had been in place and rigorously followed in Charleston in 2007, the study authors said, the conditions that led to the rapid fire spread in the Sofa Super Store probably would have been prevented.

"Furniture stores typically have large amounts of combustible material and represent a significant fire hazard," said NIST study leader Nelson Bryner. "Model building codes should require both new and existing furniture stores to have automatic sprinklers, especially if those stores include large, open display areas."

Specifically, the NIST report calls for national model building and fire codes to require sprinklers for all new commercial retail furniture stores regardless of size, and for existing retail furniture stores with any single display area of greater than 190 square meters (2,000 square feet). Other recommendations include adopting model codes that cover high fuel load situations (such as a furniture store), ensuring proper fire inspections and building plan examinations, and encouraging research for a better understanding of fire situations such as venting of smoke from burning buildings and the spread of fire on furniture.

Using a state-of-the-art computer model to simulate the fire, the study team found that the addition of automatic sprinklers inside the loading dock could have significantly slowed the

fire (which began just outside the dock area), prevented it from spreading beyond the dock, and eventually, extinguished it completely. The model also showed that sprinklers on the loading dock likely would have maintained what firefighters call tenability conditions, the ability for individuals in a fire event to escape unassisted.

Factors identified as contributing to the fire's progress include:

1. the high fuel loads—especially furniture—present throughout the building;
2. the lack of sprinklers throughout the Sofa Super Store;
3. the open floor plan of the facility;
4. the hidden build-up of combustible smoke and gases in the area between the drop ceiling and the roof of the main showroom;
5. the non-fire-activated roll-up door that was open between the loading dock and the holding area;
6. the four fire-activated roll-up doors (out of seven) that activated but did not close during the fire;
7. the metal walls in the warehouse and west showroom that allowed heat from the fire to ignite items next to the walls; and
8. the breaking of windows at the front of the store that supplied air to the fire.

NIST's team of experts traveled to Charleston to gather data within 36 hours of the Sofa Super Store fire. Using these data and other information collected in the following months (such as building design documents, records, plans, video and photographic data, radio transmissions, interviews with emergency responders, and informal discussions with store employees), the NIST study team developed its computer model to simulate and analyze the characteristics of the fire, including fire spread, smoke movement, tenability, and the operation of active and passive fire protection systems.

Based on their model and the data collected, the NIST researchers determined the following sequence of events on June 18, 2007, at the Sofa Super Store:

- The fire began in trash outside the loading dock and spread into the enclosed loading dock. The fire spread from the exterior to the interior of the loading dock, which was used for staging furniture for delivery and repair. The fire spread quickly within the loading dock and moved into both the retail showroom and warehouse spaces.
- During the early stages of this fire, the fire was unable to access enough air, a state that slowed its growth. However, the lack of sufficient air for complete combustion did result in large volumes of smoke and combustible gases flowing into the space below the roof and above the drop ceiling of the main retail showroom.
- The fire spread to the rear of the main showroom through the holding area and ignited additional fuel in the rear of the main showroom, at which time it became more visible to firefighters in the main showroom.
- The growth of the fire at the back of the main showroom was still slowed by the lack of air. As the fire burned in the rear of the main showroom, the fire pumped more hot unburned fuel into the smoke layer below the drop ceiling. The lack of air prevented the unburned fuel in the smoke layer from igniting.
- When the front windows were broken (approximately 24 minutes after firefighters arrived at the store), additional air flowed in the front windows, along the floor and to the rear of the showroom, and became available to the fire. The additional air allowed

the burning rate of the fire to increase rapidly and ignite the layer of unburned fuel below the drop ceiling.

- The fire swept from the rear to the front of the main showroom extremely quickly, then into the west and east showrooms, trapping six firefighters in the main showroom and three firefighters in the west showroom.
- Furniture and merchandise in the showrooms and warehouse continued to burn for an additional 140 minutes before the fire was extinguished.

Once the final report is published, NIST will work with the appropriate committees of the International Code Council (ICC) on using the study's recommendations to improve provisions in model building and fire codes. NIST also will work with the major organizations representing state and local governments—including building and fire officials—and firefighters to encourage them to seriously consider its recommendations.

By understanding the technical causes for such incidents and making the information available to the public, NIST scientists and engineers strive to improve the safety of buildings, their occupants and emergency responders. <sup>1</sup>The International Code Council (ICC) I-Codes are used as models for building and fire regulations promulgated and enforced by U.S. state and local jurisdictions. Those jurisdictions have the option of incorporating some or all of the code's provisions but generally adopt most provisions.

## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas. - NOTE: Do not wait until the last minute to attempt to complete the CPAT as it is common for people to fail their first attempt and have to go back on another day for a retest. More and more departments are asking for a CPAT card within six months or one year of the date of their testing process and I've seen many candidates fail the CPAT (and even retests) and not be able to continue through a department's testing process because of their failure to plan ahead. Don't let this be you!

### **ANOTHER DEATH DUE TO THE FAILURE OF CLOSEST UNIT RESPONSE**

In case you were unaware, we feel very strongly that FD's need to generally send the closest, most applicable units, irregardless of borderlines, dispatch centers or jurisdictions. We (all of us) often use the term "we had a fire" which actually is wrong. "We" didn't have anything. The folks who called 9-1-1 are having "their" emergency and are inviting us to please solve the problem. Quickly. 5 Minutes ago. A good template we like to use is to ask the question "What would be best for your family, your kids or your spouse if THEY had a fire or medical emergency?" Exactly. When the house catches fire, when grandma is bleeding or when someone is choking, they need qualified help now. They don't care about some of our egos and/or politically driven debates on what FD or EMS unit should respond.

Palm Beach County (FL) has spent several years developing a centralized dispatch network designed to be efficient and save lives, but the system doesn't always send the closest firefighters to an emergency. And that's a problem to those who are having "their" emergency. That was the case last fall, when fire-medics from a Palm Beach County firehouse more than 5 miles away were sent to help Mr. Bill Dunn, who ultimately choked to death on a piece of meat. The City of Boynton Beach Fire Station 4 was 1.4 miles away, but Boynton Beach, like the Cities of Boca Raton and Delray Beach, are not part of the county dispatch system. Mr. Dunn died in an unincorporated area in the county's jurisdiction, help arrived in 12 minutes and 10 seconds after friends dialed 911 on Nov. 6. Qualified fire-rescue help was much closer, but they just weren't called.

Boynton Beach paramedics had no way to know that Mr Dunn was choking to death nearby, without Palm Beach County calling for them to help. But they did not call them. A top Palm Beach County Fire-Rescue official says everything was done by their book, and that today, a similar case would be handled the same way. WTF!? When Dunn's 911 call came in, it automatically was routed to a county dispatcher, who notified County Station 41. **It was the closest option because Boynton Beach fire stations aren't "in" the county FD network.** The county does have a mutual-aid agreement with the City of Boynton Beach FD and used it 35 times last year, but not in Mr. Dunn's case. "We would not have requested Boynton Beach assistance," a county Deputy Chief said. "Our unit was available and we were responding. "Certainly, the outcome of this individual is unfortunate," he said.

### **A THOUGHT-Where there is a will, there is a way.**

We understand that annexations, pocket jurisdictional boundaries and other political bs interferes with the best service to the public. But that's how it is. Sort of like non-sprinklered buildings interfering with the best firefighting outcome to the public, so we work around it to get water on the fire to the folks who are having "their" emergency. We work around it. If the

dispatch centers are different, a quick ego-less phone call from one to the other could have gotten the closest "first responder" on the scene. It may not be "convenient" that some FD's have different dispatch centers (right or wrong), but for example, in the Washington DC area (amongst so many around North America), dispatchers from DCFD and all the surrounding County FD's pick up phones or call each other on a mutual aid radio channel dozens of times everyday to see if "closest units are available" and they send them everyday---because that's what's best for those who are having "their" emergency. There is a lot to this Palm Beach issue, with significant "turf" battles and "control" battles between some of the cities and the county, with once again, the citizens ending up paying the bills and being the losers. And it will continue as long as the attitude is that "we would do the same thing again". There really oughta be a law. **HERE IS MORE:** <http://tinyurl.com/35aw9km>

Bradley County Fire Rescue (TN) responded mutual aid to Bowater Newsprint Company located in Southern McMinn County, the call was for an explosion and fire with multiple patients, and when they arrived, they found the Bowater fire brigade working to stabilize one of their own: a Bradley County FD member. Station Fire Commander Phillip Shelton, a 30 year member of Bradley County and of the Bowater Fire Emergency Team, was burned

severely when the coal bunker exploded that was involved in fire. Captain Shelton has 35% burns 2nd & 3rd degree to his hands, face, arms chest, back and head. Shelton as well as other Mill Firefighters from the facility were fighting fire when the explosion occurred, others were hurt but were minor in nature. Captain Shelton was transported Friday evening by Air Evac to Erlanger Trauma Center stabilized then sent to the Joseph M Still Burn Unit at Augusta, Ga. Currently the Captain is stable and scheduled for surgery to begin some skin graft work. He is still and has been unconscious since the RSI procedure prior to his initial transport. Reports indicated an explosion in a coal bunker which is a storage unit for coal which fuels the paper manufacturer's boiler system. Coal dust was believed to be the cause for the explosion. Our prayers for a rapid recovery-we will keep you updated via TSL or our home page.

### **UPDATE BOSTON FIREFIGHTER SHOCK**

Our sincere thanks to the BFD Safety Division Chief and the members of BFD Ladder 26 for this UPDATE. Details are that Ladder Co. 26 placed it's aerial to the roof of a three decker. The aerial was placed across and in contact with a primary electrical line. The voltage of this line was 2,800 volts. The chauffeur and officer climbed this aerial to the roof and ventilated without noticing the aerial in contact with the high voltage wire. This hazard was eventually noticed and the IC was just about to call the roof sector and notify them not to use Ladder co. 26's aerial. Before this radio message could be transmitted the following occurred: The chauffeur was descending the aerial and was just above the wire when it started to arc. In the meantime the officer was on the roof and had placed his hand on the aerial and was just about to climb onto the aerial to descend when the arcing began. The member on the aerial did not receive a shock. The officer on the roof felt a small charge pass through his arm. He was able to descend on a different aerial and was convinced to be checked at a local hospital. He was treated and released and is doing fine. He spent Sunday at his daughter's soccer game! The aluminum aerial melted in two spots, where it came into contact with the primary wire and where it came in contact with the roof flashing. Ladder 26 is now out of service.

As an additional learning point for the TSL members, I'll will relate what occurred after the CLOSE CALL. The arcing wire broke in half and fell to the street with one wire landing 20' from the command post and the other landing 20' feet from rear entrance of the building. When the wire fell to the street it narrowly missed hitting approximately half a dozen BFD members. Fortunately the wire arced three times before it broke. This gave members below the wire some warning and time to run out of the way. The area of the live wires were barricaded and an announcement was made over the radio to all members concerning the electrical hazard. The electrical utility responded approximately 30 minutes later to kill the power. The utility worker was on scene for approximately 20 minutes when he notified command that the wire close to the command post was dead and that he was about to kill the power to the line at the rear of the building.

**IMPORTANT NOTE:** The utility worker was questioned twice by members of command concerning confirmation that the wire was in fact dead. He responded to both inquiries that in fact the power was off to that wire. It was pointed out to the electrical worker that the wire he was talking about was sitting in a large puddle and that the water around the wire was smoking, and the wire was smoking. He then changed his opinion about the status of the dead line and informed command that the line at the rear of the building was the dead one

and that the line at the front of the building was in fact still charged! This incident reinforces the basic that all lines should be treated as alive until they are cut free -and we can completely confirm that they are cut free from the overhead. It also reminds us that sometimes the utility company can make big mistakes on the fireground and that someone from the FD should be responsible for checking the accuracy of their statements and verify information to be fact.

**UPDATE: MAINE FIRE OFFICER CHARGED IN CRASH-BUT CREDITED WITH SAVING LIVES**

A Captain with the Shapleigh FD (Maine) has been charged with driving to endanger for an August 8 crash that destroyed the apparatus. Captain Natasha Kinney, 30, of Lebanon was issued a citation Wednesday by the Maine State Police. Captain Kinney, who had been with the SFD for five years prior to the crash, was driving a 2005 tanker-pumper carrying about 1,800 gallons. She had left the scene of a dryer fire and was returning to quarters. Kinney was rounding a bend when she lost control of the vehicle. The truck rolled and came to rest upside down. Captain Kinney suffered minor injuries because she was belted in. The truck narrowly missed four motorcyclists who were riding in formation. One of the riders ditched his motorcycle in the soft shoulder in order to avoid the apparatus. The riders credited their own safety training, and Captain Kinney's attempts to maintain control of the apparatus, with saving their lives.

Firefighter Cummins was driving a piece of apparatus on a structural fire call when he suddenly collapsed and apparently died of a cardiac event. The apparatus was in a ditch when they found him in it. FF Cummins had just filled the rig up, after loading a tankful of water. There were no other injuries. **FAMILY OF LODD FIRE OFFICER FILES WRONGFUL DEATH LAWSUIT**

The family of a Boston Fire Lieutenant who was killed when his ladder truck rolled down a steep hill and crashed into a building has filed a wrongful death lawsuit against 6 businesses who worked on or inspected brakes on the truck. Lt. Kevin Kelley was killed in the Line of Duty on Jan. 9, 2009, when the brakes failed on the truck. 52-year-old Lt. Kelley was the Officer in the truck when it went down a hill, struck two parked cars, crashed through a brick wall and slammed into the side of a brick building before stopping. The lawsuit filed today alleges that because of negligence and faulty work by private vendors who serviced the ladder truck, the rear brakes had severely reduced braking power. The lawsuit seeks unspecified damages

## **INDIANA FIREFIGHTER DIES IN THE LINE OF DUTY-HEART ATTACK**

It is with deep regret that we advise you that Fire Lieutenant Richard Drake, 39, of the German Township (IN) FD, Taylorsville (IN) in Bartholomew County, died in the Line of Duty yesterday following a run. Reports to us are that Lieutenant Drake and other members of the GTVFD responded on an EMS run to someone having difficulty breathing. They assisted with treating and loading the patient for transport and returned in service at 1224 hours. Lieutenant Drake returned to the firehouse and began conducting equipment checks. Around 1445 hours Lieutenant Drake's wife called 911 to report he was having severe chest pain, she was visiting him at the firehouse. Shortly afterward, Lieutenant Drake advised his medical condition via radio. While being transported via ambulance, Lieutenant Drake went into cardiac arrest. He was pronounced dead at Columbus Regional Hospital. He had 3+ years of service and leaves his wife Christy and four children: Andy-18, Elizabeth-17, Eric-10, and Abby-8 behind. Hey,

A 67-year-old Long Beach (Nassau Co, Long Island, NY) man was killed late yesterday when he walked into a moving fire apparatus as the rig responded to a fire call at a nursing home. City of Long Beach FD members were responding at about 2245 Hours when a career firefighter, driving the apparatus, noticed a man standing on a median. As the truck passed the pedestrian, the man apparently ran into the side of the truck with his head lowered. The victim worked as a custodian for the city of Long Beach and was taken to a nearby hospital where he died of multiple head injuries and internal injuries. Strangely, the victim was at a different hospital about an hour before the accident where was treated for cuts to his head and face.

When the Deepwater Horizon drilling rig exploded on April 20, it killed 11 platform workers, injured 17 others, and sent oil slicks toward the Gulf Coast shores and wetlands. ### **TENN. FIREFIGHTER STABBED ON A RUN**

A bad guy is in custody after he stabbed a Firefighter this afternoon. The stabbing happened when a fire crew arrived at a fire that was reported in East Knox County. The fire in a garage building on Midway Road was reported by a passerby. The Firefighter who was stabbed was transported to UT Medical Center with injuries that are not considered life threatening. After the stabbing, the suspect ran off and Firefighters backed off the scene. The bad guy was taken into custody around 1400 hours this afternoon by Knox County cops.

### **17 Year Old NEW YORK FIREFIGHTER SERIOUS AFTER RESPONDING CRASH**

A Spring Valley (Rockland Co, NY) Volunteer Firefighter responding to a fire call was seriously injured last night when he lost control of his car and collided with another vehicle. Brandon Daniello-Jacobs, 17, was headed north on Route 45 toward the Rockland Hook and Ladder Company firehouse around 2300 hours when his Honda crossed the double yellow line, and hit an oncoming minivan broadside. Both vehicles were badly damaged. The driver of the minivan was able to crawl out of the car and was treated and released. FF Jacobs was pinned inside his car and the South Spring Valley FF FF's extricated him. It was raining at the time of the crash.

### **JUST Say NO To "Mutual" Aid? - "MUTUAL" would be the key word.**

In what we are seeing more and more of, communities who drastically cut their levels of fire service should not expect neighboring FD's to "simply" or automatically bail them out. In many areas, the "neighboring" FD's are asking why they should bail out a community that won't fairly support their own fire department or one that accepts lower levels of service? **It certainly is more complicated than that, and while many of the issues are unique and diverse**, generally, when a community cuts their fire service, they should not assume that another FD from another community is just going to automatically help fill that gap without lots of questions being asked. In an area I recently visited, the neighboring/surrounding suburban volunteer FD's advised the city career FD (whose budget & staffing was being seriously cut) that they will respond only if the IC at a scene calls for them (specifically to help and support the career FF's), but they (the volunteers) would not automatically supplement the cuts in service that city made. The volunteer FD's did so because their automatic response would provide an inappropriate and false sense of the cuts being "no big deal". When a community cuts their FD to a level where service (staffing, response etc) is measurably reduced, it's a big deal - and the city hall dwellers who make the cuts have an obligation to factually let the public know what will, and what will not respond when they have a fire. **Mutual aid needs to be mutual, and fair.**

**INDIANA FIRE CAPTAIN LODD-PINNED IN FIREHOUSE BY APPARATUS**

It is with deep regret that we advise you of the Line of Duty Death of Jackson Township Fire Captain Leonard Murray. Jackson Township is near Nashville, in Brown County, Indiana. Tragically, Captain Murray suffered fatal head injuries after the fire department vehicle he was doing work maintenance on rolled and pinned him against a wall at the firehouse. According to local reports Capt. Murray and one other person were standing in front of the fire truck as work was being done on its steering mechanism. At one point in order to turn the steering wheel so that work could continue on the mechanism, a person inside the vehicle turned the key in the ignition, expecting it to go from the locked position to the first position and release the steering. Instead, the key and ignition were already in the first position and turning it caused the engine to turn and the truck to lunge forward, trapping Capt. Murray and the other person between it and the wall. The driver backed away and jumped out of the truck to go assist the two men, but when he did, the truck lunged forward again, trapping only Capt. Murray and killing him instantly. The incident occurred around 1830 last night, Friday evening. Captain Murray was 53 years old and survived by his wife, two sons and other family. As always our most sincere condolences to all affected.

Hey,

We wanted to pass these video clips on to you as it is very impressive as it shows the force of the fire and eventual explosion caused by that head on crash involving two freight trains carrying oil and gasoline. Reports are that 17 out of 32 tanks traveling in convoy through the Polish city of Bialystock caught fire last week but, amazingly, only two people were hurt. The below footage shows the burning crash wreckage suddenly erupt, sending massive fire and smoke into the air. More than 30 fire companies were sent to the scene and extra firefighters came in from other jurisdictions. Firefighter Jan Gradkowski said: "When we arrived at the site we found a lot of burning tanks. "The last tank derailed and collided with a locomotive moving in the opposite direction. Two train drivers were hurt in the blast, however neither suffered life-threatening injuries. This is a pretty "classic" example of what can happen after the arrival of Firefighters, on any kind of incident.

### **PA FIREFIGHTER DIES IN THE LINE OF DUTY-WHILE TURNING OUT FOR A HOUSE FIRE**

It is with deep regret that we advise you that around 0200 hours this morning, a Firefighter from North Irwin (Westmoreland County, PA) has died in the Line of Duty. Reports are that the 63 year old Firefighter turned out for the run but was found "down" by other Firefighters in the station. He was treated, transported to Westmoreland Hospital where he succumbed. We will post more on our home page later. As always, our most sincere condolences. Additionally, related to the same fire, another Firefighter broke his ankle while getting out of the apparatus at the scene.

### **INDY FIRE OFFICER SUFFERS SERIOUS INJURY WHILE TRAINING**

An Indianapolis Fire Officer was seriously injured yesterday when a hose line exploded while he was setting up a training detail. IFD Captain Willie Thompson, 46, is in stable condition at St. Vincent Hospital after the 1335 Hours accident at the IFD training facility. Captain Thompson was preparing for a training detail by filling a hoseline with air instead of water when the system exploded in his right hand. The training evolution he was preparing for is a survival skills maneuver taught to IFD Firefighters. The preparation for this requires that the 1 3/4" hoseline be charged with air instead of water, through the use of a high pressure (4500 lbs) SCBA air tank. Captain Thompson, with 11 years on the job, has reportedly conducted the specific maneuver hundreds of times, but the connection at either the metal hose coupling or the gated "wye" ("Y" connection) exploded, causing serious injury to his hand. IFD is conducting an internal investigation. We'll advise more as it becomes available from IFD.

He said the majority of layoffs could come from police and fire. It's still not clear if cuts can actually be made at the fire department because of the federal SAFER grant received earlier this year. Walling believes the city can get around that with a waiver. Officials said they sent out a memo last week about the excessive use of sick leave that has created overtime and what needs to be done to prevent this from getting out of control. "I can't explain why there has been a surge or an increase of sick leave on the weekends," AFD Chief James Breen said. In an internal memo sent out late last week, Breen broke down the numbers. Since August, more than 20 percent of the staff is using excessive amounts of sick leave, mostly on the weekends causing the department to over spend its overtime budget. "The worst case scenario would of course be brown outs. Brown outs are where selected units are placed out of service in order to balance the budget," Breen said:

Tennessee and Georgia Fire Departments question 24 hour shifts: A Walker County, Ga., ambulance driver who was charged with reckless driving after he crashed into an oncoming car was in the 11th hour of a 24-hour shift, records show. Georgia State Patrol officials said Gerald Zigner was charged because he fell asleep at the wheel.



While most counties in Tennessee and Georgia operate on 24-hour shifts for firefighters and paramedics with 48 hours off in between, some area officials are beginning to question the safety of those shifts. "As call volume increases ... you'll see more and more departments looking to make adjustments," said Dwayne Jamison, president of the Northwest Georgia Fire Chiefs Association. Fatigued fire and emergency management drivers on roads is a growing concern among state fire chiefs and was brought up at this year's Georgia Fire Chief Association meeting, Jamison said. The 24-hour shift is a contributing factor in the number of wrecks that occur, Jamison said. In Rockingham County, N.C., EMS stations are making the switch from 24- to 12-hour shifts, County Manager Tom Robinson said. But the process takes time because shorter shifts are costlier, he said:

**A must read for ALL fire service personnel of all ranks:** "It's not your grandfather's fire." That phrase was used by Bob Backstrom of Underwriters Laboratories (UL) to describe the kind of fire produced by modern contents, construction techniques and materials. I rarely run across such a succinct way of describing an issue. The key is understanding how it will impact our operations in the future. By now, many in the fire service have heard of the dangers to firefighters from engineered wood products used in modern construction. Lightweight, less expensive and structurally sound construction materials that are "engineered" (meaning designed structural elements, not dimensional lumber) are receiving strong support and use in the construction industry. And for good reason: They're less expensive and work well—in normal conditions. But recent field experiences and some studies have also pointed out that such materials fail more quickly in a fire than the old-style wood-frame construction. That creates a hazard for firefighters, who risk falling through a roof or even a floor made with lightweight construction more quickly than they anticipate:

Jim McCluskey loved to ride his bike to St. Joseph's Hill with his fellow Los Gatos firefighters and paramedics. Tragically, McCluskey's dedication to biking cost him his life in August 2008--he was biking around his hometown of Patterson when he was hit by two motorcyclists who were racing. About 60 of McCluskey's friends and family

gathered on Oct. 17 at the top of St. Joseph's Hill to dedicate a bench in his memory, a rarity since the Mid-Peninsula Regional Open Space District doesn't often allow structures on its property. A plaque on the bench reads in part, "With dedication to Santa Clara County (CA) firefighters and the memory of firefighter/paramedic James McCluskey. May they continue to enjoy this open space and ride together in spirit."

Responding to anxious homeowners, the East Contra Costa (CA) Fire District board on Monday night reversed its decision to close its contract fire station in the Marsh Creek-Morgan Territory area. Directors voted 8-1 to renew the agency's \$366,000 contract with CalFire, which had been providing fire protection during the offseason from a station that the state agency owns in that region. How the district will come up with the money will be determined. Director Bob Brockman voted no, saying the action was inconsistent with the decision to close two of its own stations in mid-July to balance its budget. With a 24-hours-on-and-48-hours-off schedule, he usually finishes a Gwinnett shift and goes straight to a Roswell firehouse. Most metro departments don't use part-timers at all,

but Roswell hires them by the truckload. One hundred twenty-two of Roswell's 140 fire employees are part-timers -- by far the most in the area:

Jimmy Ghi left a stable job in Virginia and uprooted his family two years ago to help the Charleston (SC) Fire Department fix a host of training problems that came to light in the aftermath of a deadly blaze. A 30-year fire service veteran with a fistful of credentials, Ghi thought he had a lot to offer a fire department reeling from the loss of nine men. He said he didn't suspect that he too might become a casualty of the department's "deep-seated culture" and "destructive pride." On Wednesday, the 50-year-old battalion chief submitted his resignation as training director, citing a pattern of harassment and ill-treatment from the fire chief on down. Ghi hand-delivered a 10-page letter to Fire Chief Thomas Carr's office, outlining a host of grievances. Friday will be his last day with the department. Ghi said he is departing under duress and without a backup plan. He said he is unable to cope any longer with being undercut by superiors, bad-mouthed by the rank-and-file and thwarted in his mission to train firefighters in modern tactics and standards:
