**M**y suggestion to everyone is to register as soon as you are eligible to. Classes fill up very quickly, and I with more people wanting to become firefighters, I don't see our numbers of students decreasing, only increasing. I would have liked to offer more classes in the summer time and in the fall; however the state budget crisis does not appear to be going away anytime soon. I think we are very fortunate if we get to keep the above courses that I have scheduled. Also, if you are registered in the Chabot College system, you are eligible to take classes at Las Positas College in Livermore as well. Just because one class is full (or does not fit your schedule) at Chabot doesn't mean it isn't being offered at Las Positas. When you register for classes on the Chabot College website, you can see both schedules – Chabot and Las Positas.

## **ARE YOU A FIREFIGHTER WHO HAS BEEN LAID OFF?**

**I**f so, I want to extend to you a free, 2 hour oral interview private coaching session to help you get back on your feet. Included in this session will be free resume evaluation and critiquing for improvement.

**W**hile lay offs used to be unheard of in the fire service, we are starting to see more and more communities being forced to lay off firefighters due to the tough economic times. While some laid off firefighters are fortunate to get picked up rather quickly by other fire departments (our department picked up three laid off firefighters from a neighboring department), many find themselves in a very tough situation, due to a variety of reasons such as the lack of local openings and the fact that they may not be on top of their game when it comes to competing with the thousands of other firefighter candidates.

**J**ust because you are laid off, it doesn't mean you automatically go to the top of the hiring list without having to participate in a testing process. Every fire department and governing body has different rules as to how to hire firefighters, so it is not guaranteed that a laid off firefighter gets a 100% score and ranks #1 on the hiring list, without having participated in a written exam, an oral interview, and the other typical components of a fire department testing process.

One of the challenges of being laid off is that you may have been on the job for a few years and the last thing you have been doing is staying on top of your oral interview skills, not to mention keeping your resume up-to-date.

## **FIRE SERVICE EMPLOYMENT INFORMATION:**

### **Las Vegas Fire & Rescue 2010 Firefighter Recruitment Information**

Welcome and thank you for taking the time to consider Las Vegas Fire & Rescue as a career opportunity. We share your enthusiasm for the fire service. Built on tradition and dedicated to public service, our department contributes significantly to the quality of life and safety of our citizens. Given the amount of trust the public places on our profession, we always strive to hire the most suitable individuals as firefighters. We are committed to selecting the most prepared and competent individuals who will bring *pride* to our profession, *strength* to our department, and *quality* service to our community.

In seeking top candidates, Las Vegas Fire & Rescue has developed a specialized and highly competitive recruitment process. We have addressed some of the most frequently asked questions about our recruitment process below.

### **When will you be accepting firefighter applications?**

The Las Vegas Fire & Rescue offers a testing opportunity every two years, from which a list of prospective candidates is created and utilized for a two-year period. We will be accepting applications for firefighter trainee beginning **8:00 a.m. on September 28, 2009**. The filing deadline for Firefighter Trainee applications is **4:30 p.m. on October 16, 2009**.

### **Where can I pick up an application?**

You can pick up an application in person, or you can download an application off of their website - [www.lasvegasnevada.gov](http://www.lasvegasnevada.gov). Human Resources is located on the 2<sup>nd</sup> floor of City Hall, 400 Stewart Avenue, Las Vegas, Nevada on the corner of Stewart Avenue and Las Vegas Boulevard. **Please note that we only accept applications for Firefighter Trainee during the open recruitment period (see FAQ above).**

### **How will I send in my application?**

If you live in the local area you MUST deliver your application to Human Resources in person. Applicants who live outside of the local area may mail their application to City of Las Vegas, Human Resources, 400 Stewart Avenue, Las Vegas, NV 89101. Due to the large number of application received, we do not accept faxed applications for Firefighter Trainee. **Your application must be received and time stamped by Human Resources within the application period. We do not use post marked dates in determining whether an application is timely.**

### **What are the minimum qualifications on the date of application?**

- High School Diploma or GED
- Current Valid Driver's License
- Must be 18 years old.

### **Are there any other requirements?**

Yes. On the date of conditional job offer a candidate must have an EMT-Basic certification and must meet current physical condition requirements. You do not have to meet these requirements on the date of application.

### **Does that have to be a Nevada EMT-Basic certification?**

No. Your EMT-Basic certification can be from any state. National Registry certification is also acceptable. Please note that any certification must be current and valid at the time of conditional job offer.

### **What is your testing process?**

Those candidates that meet the minimum requirements are scheduled for a Written Examination. Those applicants who score 90% or better on the written examination are scheduled for the Candidate Physical Ability Test – CPAT. This is a pass/fail test. The links below provide more information about this test.

### **When will you give the written exam for this recruitment?**

The written exam will be held on **January 12, 2010** at the Texas Station Convention Center located at:

### **Can the written examination be taken at another time?**

No. All applicants must take the written examination as scheduled or wait until the next recruitment period.

### **How do I study for the written exam?**

You can download the Fire & Police Selection, Inc. (FPSI) study guide on their website - [www.lasvegasnevada.gov](http://www.lasvegasnevada.gov). This is the only study guide we recommend.

### **What other information should I know about the written exam?**

- There is a fifteen-dollar (\$15) administrative fee required at the time of the written exam (exact amount in CASH only).
- The written exam process is estimated to last approximately three (3) hours.
- You will receive your appointment time for the written exam by mail.
- No adjustments will be made to accommodate candidates exam dates and times.

**When will you give the Candidate Physical Ability Test (CPAT)?** Spring 2010.

### **I recently passed the CPAT with another agency. May I use my passing score on the CPAT to avoid taking the CPAT with the City of Las Vegas?**

In lieu of taking the Candidate Physical Ability Test with the city of Las Vegas, the city of Las Vegas will accept a "Card of Completion" from the (CFFJAC) CPAT Center dated no earlier than **September 28, 2009**. We do not recognize any other CPAT completion cards or letters.

### **Is there more testing involved after the written exam and the CPAT?**

Yes. Candidates who pass the physical ability examination will move to the second phase of testing which is completed over a 4 – 5 month period. Candidates should note that these events are not pre-scheduled and candidates typically receive approximately 2 weeks, or less, notice of each event. The candidate's personal schedule must be flexible during this phase.

The department will select from the most qualified candidates during this period and make conditional job offers. Those candidates not selected initially, will remain on the list and may be considered for any future openings during the two year period. The testing for this second phase may consist of:

- Oral Interview
- Criminal & Personal Background Check
- Suitability Assessment
- Medical Exam (upon conditional job offer)

### **I do not live in Las Vegas. May I still apply?**

Yes. Please note, however, that the selection process involves many steps. Out-of-state applicants should plan on at least 3 trips to Las Vegas to complete the entire process. All travel is at the applicant's own expense.

### **I am already a firefighter. Do I have to take the written exam?**

Yes. We do not have any lateral positions for firefighter. You will have to complete the entire testing process and complete the academy if selected.

**Is there a maximum age limit for applicants?**

No, but you do have to be 18 years of age to apply.

**Do I have to be a US citizen to apply?**

No. However, you must have the legal right to work in the United States.

**How many firefighters will you hire in the next recruitment period?**

The exact count is unknown. The number of people hired varies from year to year, depending on the number of employees retiring, employee turnover, and the number of new stations opened.

**What is the salary for firefighter trainee?**

The monthly salary for firefighter trainee while in the academy is approximately \$3,593. The monthly salary for firefighter is approximately \$4,178.

**How long is the firefighter trainee academy?**

The academy is approximately 16 weeks in length.

**EMT-Basic Training**

The city of Las Vegas does not provide Emergency Medical Technician – Basic training, nor do we endorse any training by any specific organization. As a courtesy, we are aware of three community organizations that provide this training and have provided their contact information below. - How to read, interpret and apply fire protection research, human behavior studies, fire dynamics research, fire protection law and emerging issues.

**Student Selection Criteria:** Priority selection will be given to those applicants who express interest in and meet minimum qualifications to become course instructors. **Prerequisites:** ICS 100 level and ICS 200 level training. Preferred courses are Q462 and Q463 available through NFA Online at [www.nfaonline.dhs.gov](http://www.nfaonline.dhs.gov). Chief's signature attests that the applicant has completed this required training.

### Local Firefighters to Help Consumers Prepare for DTV Transition

## ***USFA Supports the IAFC Collaborative Effort to Assist the FCC in Converter Box Installations***

Washington, D.C. – As part of the Federal Communications Commission's (FCC) comprehensive nationwide DTV transition assistance effort, the FCC and the International Association of Fire Chiefs (IAFC), through its Digital TV Transition Assistance Project, have entered into an agreement that will enable firefighters to visit homes where individuals need help to connect their digital converter boxes and adjust their set-top antennas.

“The USFA would like to applaud the efforts of the IAFC and our nation's firefighters for joining in this effort to ensure a successful national conversion from analog to digital technology. Firefighters know first hand the importance of citizens being able to access critical preparedness information before, during, and after community emergencies. It is critical to fire service and emergency management officials that residents of this nation are prepared, and able to access on their televisions, important life safety messages from all fire, EMS, emergency management, and health care agencies.”

**The DTV transition is of special importance to the fire and emergency service community because the switch to digital television service will free up airwaves that can be used to expand the national public safety communication network.** Consumers should call the FCC's national toll-free help line, 1-888-CALL-FCC, if they need help preparing for the DTV transition.

Assistance will focus on groups the FCC has determined are most affected by the transition, including low-income individuals, minority communities, non-English speaking consumers, senior citizens, consumers with disabilities and individuals living in rural areas or on tribal lands.

The IAFC is one of several organizations that have been enlisted to help prepare the public for the transition and it is still recruiting fire departments to sign up to help in this effort. On June 12, all full-power television stations in the United States will stop analog broadcast service and transmit only digital signals. Consumers who do not subscribe to pay television services and have older, analog televisions will need to attach digital-to-analog converter boxes to their televisions in order to continue receiving over-the-air television programming. They may also need to adjust or upgrade their television antennas.

The switch to digital will reward most viewers with better sound, a better picture, more channels, and more programs. The transition will also help save lives by clearing airwaves for better first-responder radio service and making room for the future by clearing airwaves for advanced mobile Internet services.

## **PARAMEDIC PROGRAM INFORMATION:**

**A**pplications for the fall 2009 Emergency Training Services Paramedic program in Santa Cruz, CA are now available on their website – [www.emergencytraining.com](http://www.emergencytraining.com)! See below for more information about their program, including the requirements to apply.

A paramedic is a health care provider trained in the emergency care of patients who suffer from sudden illness or injury. Paramedics are trained in the highest level of Emergency Medical Services and function in the prehospital environment under the direction of a physician. The ETS/ROP Paramedic Program can usually be completed over the course of 9 months to 1 year. It is comprised of 1,234 hours of training divided into three categories: didactic (classroom), clinical internship and field internship.

Didactic sessions meet on Mondays, Tuesdays, and Wednesdays in the Fall and Wednesdays, Thursdays and Fridays in the Spring, for approximately 25 weeks. These are 8-hour daytime sessions. Areas of study will include advanced instruction in topics such as: anatomy, physiology, pathophysiology, pharmacology, drug administration, EKG interpretation, airway management, toxicology, pediatrics, chemical dependency, obstetrics and ALS strategies for all major medical and trauma emergencies.

After the 15th week of instruction, students begin clinical internships that last a minimum of 160 hours. Each student will be assigned a nurse preceptor, who will guide them through the practice of skills and techniques in a hospital setting. A typical clinical internship schedule will include 3, 8-hour shifts per week for 2 months. Some of the hospitals we maintain contracts with include: Stanford Medical Center, Kaiser Santa Clara and Dominican Hospital Santa Cruz.

The field internship phase consists of a minimum of 480 hours of active paramedic application. Each student is assigned to a paramedic unit to act as an integral member of the mobile intensive care team. The student, while under the supervision of a paramedic

preceptor, will apply principles of paramedic care to patients in the field setting. We maintain contracts with AMR - the largest emergency care provider in the US, many fire departments in California, and a few out of state. A typical field internship schedule will include 2-3, 24-hour or 8-hour shifts per week for 3-6 months.

The ETS Paramedic Program is accredited by CAAHEP and ABHES.

### **Prerequisites**

- All applicants must be at least 18 years of age and possess a high school diploma or equivalent.
- Candidates must be currently certified as an EMT at the time of application.
- Candidates must be free from any felony convictions.
- Classes recommended for course preparation include: anatomy, physiology, medical terminology, and chemistry.

### **How to apply**

There will be two Paramedic Programs scheduled per academic year. Applications will be available in the spring and fall. Applicants that meet all requirements will be accepted for a screening process. This process may include aptitude testing and an interview. The screening and interview process commences in the summer for entry into the fall program. Screening begins in the winter for entry into the spring program. Complete details will be included in the application packet. If you would like an application packet, please call the office and we will put you on the mailing list. The tuition is \$12,000. Tuition includes all books, uniforms and internship fees.

### **Career Opportunities**

The ETS/ROP graduate has several career paths available. Paramedics are employed in private ambulance companies and fire departments. Salaries start at about \$35,000 per year. Salaries and benefit packages vary with each employer. To become employed at an ambulance company or fire department, an ambulance driver's certificate or appropriate class driver's license, as well as a high level of physical agility is required. Such employers usually require criminal background checks prior to hiring.

With assistance from the U.S. Department of Homeland Security, the Institution of Fire Engineers US Branch has established a steering committee comprised of noted fire service and related agency leaders to guide a national strategic planning process for the fire loss prevention that results in a national plan that will coordinate activities and fire prevention efforts. This steering committee is called Vision 20/20. The website is [www.strategicfire.org](http://www.strategicfire.org).

1. This project involves a large number of participants representing all areas of fire prevention as well as other advocates and stakeholders to the plan and its recommended outcomes.
2. This project is committed to action, with a few strategic recommendations being converted to a national plan that stakeholders will be asked to support with documentation of specific actions and benchmarks instead of a long list of recommended practices that everyone agrees are important (but then never get completed).
3. This project will not create recommendations in a vacuum. Other existing efforts that have identified significant progress toward achieving prevention goals will be taken into account to avoid competing efforts.
4. A long term monitoring mechanism will provide regular reports on the progress of the strategic initiatives that arise out of Vision 20/20.

Previous national plans for fire protection have had a great deal in common. President Truman's 1947 Report on Fire Prevention, to the landmark report America Burning, first completed in 1973, and subsequent national reports from Wingspread, Solutions 2000 and others, a common theme for increasing efforts in fire prevention are always emphasized as a key component to the fire safety problem in the United States.

A subgroup (Task Force)--of the Vision 20/20 committee mentioned above--has been established and one of its goals is to raise or embed the importance of fire prevention/risk management within the fire service. As a beginning stepping stone, you are being asked to be part of this important process. Included herein is a link to a survey which will help define where we currently stand with regard to national fire prevention efforts, and specifically within firefighter recruit training programs. Thus, this survey, which should consume a minimal amount of time to complete, is vital to beginning a new phase of learning for the US fire service. It is imperative that we get as much input from all corners of the Nation as possible, so please participate or pass the survey on to an authority responsible for recruit training. The deadline to complete the survey is July 10, 2009.

## **A Message from the United States Fire Administrator about Residential Fire Sprinklers**

The U.S. Fire Administration has promoted research, development, testing, and demonstrations of residential fire sprinkler systems for more than 30 years. The research regarding residential fire sprinkler systems has indisputably demonstrated the following:

- Residential fire sprinklers can save the lives of building occupants.
- Residential fire sprinklers can save the lives of firefighters called to respond to a home fire.
- Residential fire sprinklers can significantly offset the risk of premature building collapse posed to firefighters by lightweight construction components when they are involved in a fire.
- Residential fire sprinklers can substantially reduce property loss caused by a fire.

The time has come to use this affordable, simple and effective technology to save lives and property where it matters most – in our homes.

In the past year, the National debate about the benefits of residential fire sprinklers passed a major milestone with the adoption of a change to the International Residential Code that will require fire sprinklers in all new construction. This code change survived rigorous scrutiny, during which all interested parties had ample opportunity to comment on the technical merits of the issue. Since then, parties who oppose this life-saving technology have started a vigorous campaign to enact laws at the state level that will prohibit adoption of sprinkler requirements for new homes.

I encourage every member of the fire service to stay abreast of this rapidly changing situation, and to be ready to voice any concerns that you have about proposed legislation to your respective state legislature. The Fire Sprinkler Initiative website has been established to provide a central clearing house for up-to-date information. Log on to the site at <http://firesprinklerinitiative.org> – stay vigilant and keep the fire service community informed of developments in your area. Only by working together can we save lives.

**It is the position of the U.S. Fire Administration that all Americans should be protected from death, injury, and property loss resulting from fire in their residence. All homes should be equipped with both smoke alarms and residential fire sprinklers, and all families should have and practice an emergency escape plan. The U.S. Fire Administration supports all efforts to reduce the tragic toll of fire losses in this nation, including the recently adopted changes to the International Residential Code that require residential fire sprinklers in all new residential construction.**

## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

**T**he Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

**S**uccessfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas.

## **FIRE SERVICE BUDGET ASSISTANCE INFO FROM THE U.S. FIRE ADMINISTRATION:**

### **Fire Station Construction Grants Coming Soon**

The Department of Homeland Security's Assistance to Firefighters Fire Station Construction Grants (FSC) will provide financial assistance directly to fire departments on a competitive basis to build new or modify existing fire stations in order for departments to enhance their response capability and protect the community they serve from fire and fire-related hazards. The authority for FSC is derived from the American Recovery and Reinvestment Act (ARRA) of 2009 (Public Law 111-5). Congress appropriated a total of \$210 million for this Fiscal Year (FY) 2009 program.

DHS consulted with the nine major fire service organizations to obtain insight and expertise providing funding priority recommendations. Our primary goal is to help fire departments meet their firefighting and emergency response needs. FSC seeks to support organizations lacking the tools and resources necessary to effectively protect the health and safety of the public and their emergency response personnel with respect to fire and all other hazards.

The program will be administered by the Department of Homeland Security (DHS) Federal Emergency Management Agency's (FEMA) Grant Programs Directorate in coordination with the U.S. Fire Administration by the Assistance to Firefighters Grant (AFG) Program Office.

The AFG Program Office will be utilizing the established grant process employed for all other grant opportunities with AFG. Applications will be submitted via the automated e-grant application and the program office expects the e-application will be available the week of June 8<sup>th</sup>. The submitted applications will be screened using the answers to the questions in the application to determine which applications will go to panel. Finally, a panel of peers will review each application sent to panel and provide recommendations regarding which applications will be funded.

Well....duh.  
Did folks in ANY community think there would not be a "cost" if FF's are cut?  
If firehouse are shut?  
If response times increase?

While most of us who read this understand the REAL issue is the loss of life to the public when they HAVE a fire, and to the FF's who have ridiculously increased risks because of what we are often expected to do-with less....perhaps this WILL get the attention of those who want to cut fire services.

Or those in any community who just may not know the realities of cuts. **Or may not be told. 'Magine that.**

Looks like Atlanta property owners might end up paying as much as **10 percent more** for their fire insurance unless the city hires more firefighters and shows its training is up to snuff, Georgia's Insurance and Fire Safety Commissioner John Oxendine warned today. He said that the preliminary findings of a report by the Insurance Services Office (link below) found Atlanta's public protection classification rating dropped from 2 to 4 on a scale of 10 with 1 being the best rating. Atlanta has nine months to make changes that will allow the city to keep its current rating or drop to a 3...and that could cost taxpayers money-or more.

Most insurance companies use the ISO rating to help determine how much building owners should pay for insurance. The ISO inspects quite a bit from the number of firefighters a government has to the location of its fire hydrants....and the new proposed FSRS will be looking at even more. **More than ever.**

"The rating drop can be stopped by the City Council by saying life safety is a priority," said Commish Oxendine, **who is, by the way, running for governor.** But on the other hand: "While we are disappointed in the slight drop in rating, we are proud to be one of the highest ranked cities in Georgia," Fire Rescue Chief Kelvin Cochran said. Oxendine said Atlanta maintaining its 2 rating will be a challenge. "They are quite deficient"

So while they battle it out in Atlanta ...and in hundreds of communities around the USA who are experiencing cuts, station shut downs and layoffs...we do know this:

**==It has been proven that fires grow uncontrolled and rapidly without an effective and timely FD response unless the building is sprinklered.**

**==It has been proven that the less staffing, the more the fire can gain on us-and those who are in or own the building.**

**==It has been proven that when staffed companies take longer to arrive because of firehouse shut downs, the more the fire gains, the more civilians and FF's are in predictable, increased danger.**

**==And very soon, thanks to the IAFF, NIST and WPI, there will be even more measurable proof that crew size and staffing really does make a difference when it comes to saving lives and property.**

"Butch" Cobb recently joined ISO as Director of Community Hazard Mitigation after retiring from his responsibilities as Jersey City's Deputy Chief/Fire Department Operations and Deputy Coordinator, Office of Emergency Management/Homeland Security. Butch is also a veteran member of his local Volunteer FD where he is also an Former Chief. At ISO, Butch directs their public fire protection information gathering and analysis process that includes the Fire Suppression Rating Schedule, the manual containing the criteria ISO uses in reviewing the firefighting capabilities of individual communities. He will also act as ISO's key spokesperson to the nation's fire service.

In one corner, Hickory Creek Fire Chief Marc Trollinger said his department, who arrived first, were threatened with arrest unless they stopped their efforts. They said that led to a delay in recovering the body. They got to the lake a little after 1800 hours after receiving a report of a possible drowning in Hickory Creek Park. Witnesses reported seeing a man in distress less than 100 yards off the shore. Chief Trollinger said they got a sonar reading, sent divers into the water, but were later told to leave the scene by the Sheriffs Office who declared it a crime scene.

**MORE FIREFIGHTER LAYOFFS? 238 FIREFIGHTERS?**

In more insanity across the Country, the Columbus (OH) Division of Fire (one of the absolute best operating FD's in the USA, I.O.O.) announced today that a "no" vote of the city's proposed income tax would force the layoffs of 238 Firefighters and close up to seven fire stations. The possible layoffs would affect firefighters hired as far back as 1999 and the layoffs would include 122 paramedics, according to Chief Ned Pettus. "That is absolutely a devastating number for our operations," **Chief Pettus rightfully stated: "There is no way we could continue our operation procedures and achieve the response times we currently achieve."**

**So let us get this straight, everything else in Columbus government has been cut to the absolute bare bones...absolutely everything, and this is the final straw?** Cutting 7 firehouses and the related staffing? In a City that has some of the heaviest fire load and most runs nationwide? And the answer is the threaten the public that if they don't vote for the tax

A Southern California man has been sentenced to death for setting a 2006 wildfire that killed 5 Federal Firefighters in the Line of Duty. Raymond Lee Oyler was convicted of five counts of first-degree murder in March for setting the Oct. 26, 2006, blaze in Riverside County, about 90 miles east of Los Angeles. Oyler was convicted of first-degree murder in the **Line of Duty deaths of Fire Capt. Mark Allen Loutzenhiser, 43, and Firefighters Pablo Cerda, 24, Jason Robert McKay, 27, Jess Edward McLean, 27, and Daniel Hoover-Najera, 20.** The Firefighters were killed operating at the 41,000-acre Esperanza wildfire on Oct. 26, 2006. Riverside County Judge W. Charles Morgan imposed the penalty this morning after relatives of the victims made emotional statements to the court.

**NORTH CAROLINA FIREFIGHTER KILLED IN THE LINE OF DUTY-RESPONDING ON A FIRE CALL**

A Volunteer Firefighter was killed in early this morning in the Line of Duty when his car wrecked as he was on the way to a vehicle fire...he was not wearing his seat belt. 18-year-old Matthew Douglas Tramel of the Pembroke (N.C.) Fire Department was killed about 0053 hours this morning when the vehicle he was driving struck a tree. FF Tramel was driving his private vehicle, and was alone in the car, was driving about 65 mph in a 55-mph zone when the vehicle exited the road to the left and struck the tree.

FF Tramel, who, as stated, was not wearing a seat belt and was killed immediately. He joined the Pembroke FD in April of this year. Our sincere condolences to all affected-especially the members of the PFD and his friends and family.

Two very serious crashes last night and it appears neither were due to any wrong doing by FD personnel.

The first was around 1800 hours last night (Saturday night), when an adult and an infant were killed in a crash involving a **Detroit (MI) FD Ambulance** that was transporting a cardiac patient with no vital signs.

2 DFD EMT's and the patient they were transporting at the time of the crash were taken to a hospital and as of now, it was unclear how badly the civilian occupant of the ambulance was hurt. The 2 who died were in the vehicle involved in crash with the ambulance. The "other" vehicle was a van carrying two adults and two children. Witnesses stated that the ambulance had its lights and sirens on. "The EMS hit it, but the EMS had the right of way," a witness said. "EMS had the light. Everybody had stopped except the van." The two children, ages 1 and 12, were thrown from the van...the 1-year-old girl was pronounced dead...the 12-year-old girl is listed in critical condition. The van's driver and another adult are listed in stable condition with non-life-threatening injuries. **The DFD EMS crews were injured but immediately started treating those involved.**

### **FIRE APPARATUS CRASH KILLS 3 CIVILIANS IN MISSOURI**

About 17:30 CST time last night (Saturday evening) Engine 11 of the Moreau Fire Protection District in Missouri was **returning to quarters** from a structure fire when it was involved in a very tragic crash. Engine 11 is a 13 year old custom engine and only had the driver on board. A civilians vehicle **crossed the center line** on a curve on US 87 north of Eldon, Missouri and hit the fire apparatus head on. The Firefighter who was operating the rig is ok and was wearing his seat belt which kept him from being ejected through the windshield. Tragically there were 3 fatalities in the civilian vehicle which had 7 total passengers. We will post more on our home page later.

**KUDOS to the Fire Chiefs & Firefighters across Texas** who are urging Gov. Rick Perry to veto a bill that would ban cities from requiring fire sprinkler systems in new or existing homes. But their advocacy has put them at odds with, guess who?....the Texas Association of Builders, which says the systems are overkill and can add thousands of dollars to a home's price. **Here we go again.**

Senate Bill 1410, which passed the Texas Legislature in the waning days of the recently ended session, targets the growing ranks of cities nationwide that have mandated sprinklers to save the lives and property of their occupants-and the lives of firefighters who respond.

Many communities in North Texas, including Allen, Celina, Farmers Branch and Plano, have

sprinkler requirements for all or some homes....and in those towns, amazingly, the world has NOT come to an end and homes are still being sold.

**The Senate bill, which awaits the Governor's signature, would PROHIBIT** municipalities from adopting any new sprinkler requirements for new or existing homes. SO much for "home rule"....the bill is retroactive to Jan. 1.

Naturally, the Texas Association of Builders, which lobbied for the ban, whined that home buyers should be able to choose whether they want to install sprinklers. "Sprinklers work to put out the fires, but smoke alarms save lives," said Scott Norman, the clearly uninformed executive director of the Texas Association of Builders, which represents about 11,000 members statewide. "We have nothing against sprinkler systems. But it should be the consumer's choice."

A spokeswoman for Perry said the governor has yet to act on the bill. He can choose to sign it, veto it or allow it to become law without his signature. The deadline for action is June 21....see below.

To underscore his opposition to the sprinkler bill, Plano Fire Chief Hugo Esparza made reference to the arson fire at the Texas Governor's Mansion in Austin last June that nearly destroyed the 150-year-old structure. The mansion, which was undergoing a renovation at the time of the blaze, was slated to have a sprinkler system installed. Working sprinklers could have saved the structure, Esparza said. "For us, it's a matter of public safety"

**THE TEXAS POLITICAL SIDE STEP DANCE VIDEO:**

The original intent of the bill, sponsored by state Texas Sen. Mike Jackson was to **overhaul plumbing licenses**. The sprinkler prohibition was later added at the homebuilders' push. For his part, Politician Jackson said he agreed with the builders but empathizes (sidestepping the issue) with both sides. "The argument on one side is that it saves lives...and the argument of others is that it increases the price of a home," he said. "The Legislature will be back in session in less than two years from now....maybe we should just revisit the issue then".....Wow....nice fence.

## **VERMONT EMS MEMBER KILLED IN THE LINE OF DUTY - AMBULANCE CRASH OHIO FIREFIGHTER SUCCUMBS-LINE OF DUTY DEATH**

A **Bennington (Vermont) Rescue Squad** ambulance tragically left the highway around 1530 hours this afternoon and crashed into a tree Monday afternoon, killing the member operating the rig in the Line of Duty. Initial reports are that the EMS driver was pronounced dead at the scene, but transported to the Southwestern Vermont Medical Center. At least two other passengers in the ambulance, including a patient who was being transported when the crash occurred, were taken to the hospital. Their conditions were unavailable. Weather conditions at the time of the crash were steady rain with thunder and lightning. Our sincere condolences to the members of the Bennington Rescue Squad.

Nine firefighters were killed on that day, eight more injured; eight women widowed, twenty-five children lost their fathers; a shocked city mourned before the sympathetic eyes of the entire nation. We regret to advise you that a Firefighter had a heart attack and died in his vehicle Tuesday evening while sizing up an area for downed trees and power lines in Chester (SC), following major storms. FF Jimmy Cameron, 47, pulled over, turned off his car and died in the southern part of the county after a storm hit around 1830 Hours. FF Cameron was with the South Chester Fire Department for at least 20 years, said fire chief Blair White. White said FF Cameron was a dedicated member of the department who was almost always available. White said he wasn't sure if the high-stress situation of a powerful storm triggered the heart attack, but added that Chester hasn't seen a storm of that caliber for 10 years. "You can't believe the damage we have down here," White said. "We didn't know how many people might be injured or trapped. At the time, he didn't know that." Funeral plans for Cameron are not yet available. As always, our sincere condolences to all affected.

**SHOTS FIRED AT FIREFIGHTERS IN THE U.K.**

A firefighter had to dive out of the way after a gang shot at him with an air rifle while he was tackling a blaze at a scrap yard in Greater Manchester, U.K. The crew had been operating at the suspected arson attack, which resulted in 60 cars going up in flames in Chadderton, Oldham. The FF saw a boy pointing the gun at him and threw himself out of the way....the pellet flew past him and embedded in a nearby car. Here are some updates related to the Federal FIRE funding process for SAFER and Fire Act Grants:

**SAFER GRANTS:**

Congress has voted to allow the use of federal funding to rehire laid off fire fighters and prevent fire department staffing reductions. The new rules for Staffing for Adequate Fire and Emergency Response (SAFER) grants make funding available to help keep Firefighters safe and on the job and bring back those who have been laid off as a result of the current financial crisis. The bill, which has been lead by the **IAFF** from the start, is now on its way to the White House where it will be signed.

**Firefighters now must work with their local officials so they apply for the needed funding.**

**FIRE ACT GRANTS:**

On Tuesday night, the House Rules Committee passed a "closed rule" for the Fiscal Year 2010 DHS Appropriations bill (H.R. 2892) that would **NOT** allow Representatives Bill Pascrell (D-NJ), Steve Austria (R-OH), Peter King (R-NY) and Ann Kirkpatrick (D-AZ) to offer their amendment on the House floor. The "Pascrell" amendment would have increased funding for the FIRE grant program by \$40 million to reach \$420 million. (the House Rules Committee writes the rules for the consideration of each bill before it goes to the House Floor...and that's where it stopped).

However, Representative David Price (D-NC), the chairman of the House Homeland Security Appropriations subcommittee, **DID** include an extra \$10 million (just 25% of the Pascrall proposal) for the FIRE grant program in his manager's amendment, which passed last night.

**The budget woes continue, in various forms and fashions:**

In a major breakthrough for the city's grueling budget process, Sacramento (CA) firefighters have tentatively agreed to freeze their salaries in order to save the jobs of dozens of their comrades. By forgoing a 5 percent raise due to them next month, the firefighters would avoid a \$5 million cut to their department's budget that includes eliminating 50 positions. Some of those positions are already vacant, but city officials said the proposed cutbacks would result in at least 38 firefighters getting laid off:

San Bernardino (CA) City Council members agreed Monday to a pay-and-benefit cut for firefighters aimed at saving the city \$1.4 million over the next thirteen months. Council members approved the agreement unanimously. San Bernardino City Firefighter union members already had approved it, union President Scott Moss said. The agreement, which expires at the end of the 2009-2010 fiscal year, marks the final wage concession by San Bernardino employee groups to plug a \$9 million deficit in the city's \$150 million general fund budget. The contract calls for an across-the-board 8.7 percent pay cut and does away with an earlier negotiating point that would have cut the city's contribution for health coverage by \$664 per employee per month:

Three public safety associations want more funding to staff their fire and police stations, to better serve the City of Reno (NV). But, the city says it's impossible right now in this economy. City officials say the funding being looked for by these associations would be used to pay for other services. Both sides are trying to find a compromise. "This city council does not want to lay off anybody -that is not our goal," Reno Mayor Bob Cashell says. The Reno City Council on Monday authorized City Manager Donna Dreska to make those cuts, equal to 3 percent of the city's \$186.7 million general fund budget, after again appealing to unions to give up two 2.1 percent contracted pay raises over the next year to avoid any layoffs:
