### **U.S. Fire Administration Announces 2008 Outstanding Research Award Winners**

EMMITSBURG, MD. – The United States Fire Administration announced today the four fire service executives who will receive the National Fire Academy's (NFA) 2008 **Outstanding Research Awards**. This annual award recognizes [Executive Fire Officer Program](#) students for their research projects. The 2008 award winning projects will be presented at the [21<sup>st</sup> Executive Fire Officer Symposium](#) on April 17-19, 2009, at the National Emergency Training Center in Emmitsburg, Maryland.

"Now more than ever our communities need tangible, real outcomes to provide direction in the delivery of emergency services to the jurisdictions that our Executive Fire Officer Program participants represent," said Acting U.S. Fire Administrator Dr. Denis Onieal. "The Applied Research Projects selected this year provide examples of research that is founded upon the belief that scientific approaches to real problems can produce data which will assist not only these communities represented by their EFOP officers, but respond to the complex problems that confront all fire and emergency services organizations across the United States."

The Executive Fire Officer Program is designed to provide senior fire officers with a broad perspective on various and challenging facets of fire administration. Over a four-year period, the officers continue their professional development in four courses at the Academy, which are recommended for either graduate-level or upper division baccalaureate credit equivalency by the American Council on Education. Participants in the program are required to complete an applied research project in their organization six months after the completion of each of the four course areas.

## **Fire/EMS Safety Week**

### **First of Four Key Areas: Safety - Emergency Driving**

Fairfax, Va., Apr. 6, 2009... The [IAFC](#) and the [IAFF](#) are asking you to **Protect Yourself: Your Safety, Health and Survival Are Your Responsibility**. We're calling on all fire/EMS departments and all IAFF affiliates to participate in the 2009 [Fire/EMS Safety, Health and Survival Week](#) scheduled for June 14-20.

The recommended focus of this year's Safety Week will incorporate four key areas where standard operating procedures, policies and initiatives—along with the training and enforcement that support them—can limit fire and EMS personnel's risk of injury or death:

- Safety: Emergency Driving (Enough Is Enough—End Senseless Deaths)
- Health: Fire Fighter Heart Disease and Cancer Education and Prevention
- Survival: Structural Size-Up and Situational Awareness
- Chiefs: Be the Leader in Safety

To support your planning, we'll provide you with information about each of the 2009 key areas. Below is the first area for your consideration. Look for the second key area to be included in the May 1 **On Scene**.

**First of Four Key Areas:**

**Safety: Emergency Driving  
(Enough Is Enough—End Senseless Death)**

During Safety Week, we encourage all fire/EMS personnel to demonstrate they are truly dedicated to protecting themselves and the lives and safety of others by adopting an individual safe-driving code.

Start by never driving above posted speeds any time you're responding to or returning from an alarm or incident. Drive the fire apparatus or your personal vehicle with great respect for your coworkers and the community you serve, allowing for your safe arrival on the scene to provide assistance to others. Response times are important, but not at the expense of losing a life in the process.

It's been proven time and time again that wearing a seatbelt save lives. Start by saving your own by wearing a seatbelt every time you ride in any type of vehicle! No exceptions!

Driving through an intersection in front of oncoming traffic is one of the most dangerous things we do, putting all of the crew at high risk. You should always stop and ensure every other vehicle at the intersection sees your vehicle and allows you to drive through. Never assume they'll stop for you. Look the other driver in the eye and make sure they are stopped to allow you to proceed.

**USFA Announces Arson Awareness Week Theme for 2009**

EMMITSBURG, MD – The United States Fire Administration (USFA) announces the theme for the 2009 Arson Awareness Week: **Arson for Profit**. USFA and its partners will use the week of May 3rd to the 9th to focus public attention on the alarming statistics about Arson for Profit and hopes to expand the resources and support necessary to reduce this crime.

Arson for Profit, or economic arson, is when businesses or individuals set fires to reduce financial loss, recoup initial investments, or dispose of depreciated assets usually for a payout from insurance companies. The USFA is partnering with the Coalition Against Insurance Fraud, the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) and the International Association of Arson Investigators (IAAI).

"Each year firefighters and innocent civilians are needlessly put in danger, injured and killed as a result of arson fires," said Glenn A. Gaines, Acting United States Fire Administrator. "We

are pleased to partner with the law enforcement community on efforts to reduce the crime of arson."

According to the National Fire Protection Association (NFPA), in 2005 an estimated 323,900 intentional fires reported to U.S. fire departments resulted in 490 civilian fire deaths, 3 firefighter on-duty deaths, 1,500 civilian fire injuries, 7,600 firefighter on-duty injuries and \$1.102 billion in direct property damage.

"Arson is a costly crime that's being fanned by the flames of recession. Firefighters and innocent families are endangered when desperate people illegally torch their homes, businesses and cars for insurance bailouts," according to Dennis Jay, Executive Director, Coalition Against Insurance Fraud. "Arson also is raising insurance premiums at a time of great stress on honest people's pocketbooks. All Americans are victims of arson, and we all must work to ensure fewer arson matches are ever lit."

The Federal Bureau of Investigation's 2007 Uniform Crime Reporting statistics showed the average dollar loss for all types of arson was \$17,289. For structures, arson damages were \$32,364 on average and \$7,890 for motor vehicles. Arsons of industrial and manufacturing structures resulted in the highest average dollar losses—an average of \$114,699 per arson.

"Arson is one of the most heinous crimes imaginable. When the arsonist unleashes fire, he does so with a callous disregard for what the outcome will be. He cares not a whit about the firefighters that will risk their lives responding to the fire, the innocent victims that may be disfigured or killed, the neighboring residents or businesses that may suffer damage or destruction, the blight his deeds will leave on a community or the financial costs that burned property imposes on society," said Ken Finley, IAAI-CFI, President, International Association of Arson Investigators. "Please join us in our never ending fight against those who use fire as a vicious tool for their own gain."

The USFA's National Fire Incident Reporting System (NFIRS) states the two leading causes of civilian deaths are arson, at 28 percent, and smoking, at 18 percent. Arson is, by far, the leading cause of property loss, at 26 percent. Arson is an enormous problem in the United States, especially to outside and nonresidential structure properties.

David M. Wulf, Chief of the ATF's National Center for Explosives Training and Research adds, "In view of the economy and uncertainty within the housing market, arson for profit presents an increased concern to both fire service and law-enforcement agencies."

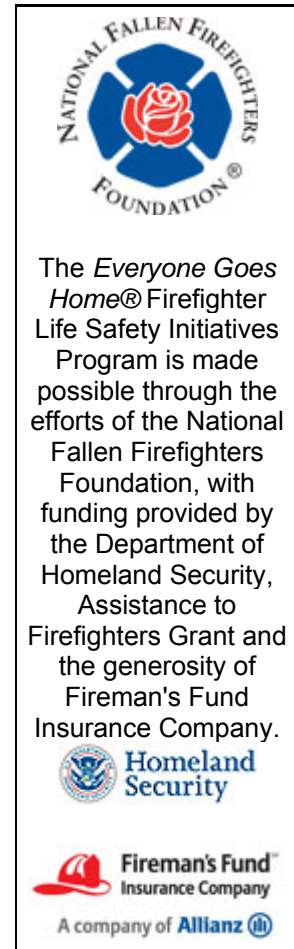

## **USFA Releases Outdoor Fires Topical Report**

WASHINGTON D.C. - The United States Fire Administration (USFA) has issued a special report examining the causes and characteristics of outdoor fires. The report, **Outdoor Fires**, was developed by the National Fire Data Center, part of the USFA. This report is based on 2004 to 2006 data from the National Fire Incident Reporting System (NFIRS) and the National Fire Protection Association (NFPA). The report, part of the USFA's Topical Fire Report Series, shows an estimated 655,200 outdoor fires occur annually in the U.S. resulting in 50 civilian deaths, 875 civilian injuries, and \$154 million in property loss.

According to the report, outdoor fires peak in March, April, and July and account for 41 percent of all fires in the U.S. Together, trash or rubbish fires (47 percent) and natural vegetation fires (44 percent) account for 91 percent of outdoor fires. In 73 percent of outdoor fires, organic materials such as crops, grass, and trees are the items first ignited. Fires that are started unintentionally are the leading cause of outdoor fires.

The short topical reports are designed to explore facets of the U.S. fire problem as depicted through data collected in NFIRS. Each topical report briefly addresses the nature of the specific fire or fire-related topic, highlights important findings from the data, and may suggest other resources to consider for further information. Also included are recent examples of fire incidents that demonstrate some of the issues addressed in the report or that put the report topic in context.

### **Former Fairfax County Fire Chief Named as Deputy Assistant Administrator for the United States Fire Administration**

Washington, D.C. - Acting Federal Emergency Management Agency Administrator Nancy Ward has announced the appointment of former Fairfax County Fire Chief Glenn Gaines as the new Deputy Assistant Administrator for the United States Fire Administration (USFA). A well respected member of the International Association of Fire Chiefs and its Metropolitan Fire Chiefs Section, Chief Gaines has spent the past eight years as a principal architect and manager of both the Assistance to Firefighters and SAFER grant programs. In this new role, Chief Gaines brings to the position of Deputy United States Fire Administrator a keen understanding of the needs of career, combination, and volunteer fire departments and the issues affecting them during these unique times in our Nation's history.

## **CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

The Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter.

Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas.

**FIREFIGHTERS AND OUR ARTERIES:**

Firefighters appear to be more likely than people in other professions to have prematurely narrowed arteries, increasing their risk for strokes and heart attacks, according to a new study. **Experts cite the smoke we work in, our eating habits and sleep patterns as potential causes.**

22 percent of a group of 77 firefighters studied by researchers at the University of Kansas averaged **39 years old but had the blood vessels of 52-year-olds** because of significant plaque buildup in their carotid arteries. The findings were presented yesterday at the American Heart Association's conference on cardiovascular disease in Palm Harbor, Fla. Here is more information worth checking out:

**FIREFIGHTER HEALTH AND UNIFORM PANTS:**

As you may have read or heard, concerns have been raised by some Firefighters in South Florida related to the possibility of illness due to the uniform pants they were issued and wearing. NIOSH was contacted to evaluate the concerns and did so. Below are some questions and answers from the NIOSH health hazard evaluation related to antimony exposure among firefighters in Florida, February 2009.

**---What is antimony?**

Antimony is a silver-white metal that is found at very low levels throughout the environment, including air, soil, and food. It is used in the production of ceramics, glass, paints, fireworks, and batteries. Antimony compounds, particularly antimony oxides, are used as flame retardants in textiles, plastics, rubber, adhesives, and paper.

**---What health effects can antimony cause?**

Overexposure to antimony trioxide can cause irritation to the skin, eyes, nose, and respiratory tract. When ingested, it may also result in nausea, vomiting, abdominal pain, and diarrhea. Toxicity from acute or chronic exposure to antimony trioxide in industry is rare. According to the International Agency for Research on Cancer, the evidence that antimony trioxide can cause cancer in humans is inadequate, but there is some evidence that it can cause cancer in laboratory animals.

**---Why did NIOSH test the firefighters for antimony exposure?**

NIOSH was asked by the Boca Raton Fire Rescue Services Chief to determine whether firefighters had absorbed antimony through their skin from wearing uniform pants made from FireWear® fabric, whose FFR® (Fibrous Flame Retardant) fibers contain antimony trioxide for its flame retarding properties.

**---Why were firefighters concerned about antimony exposure?**

Prior to NIOSH's involvement, and prompted by unexplained health symptoms in one firefighter, a group of firefighters in Florida had been tested for antimony exposure using hair analysis. The hair tests suggested high antimony levels.

**---Which firefighters did NIOSH evaluate?**

NIOSH investigators evaluated 20 Boca Raton Fire Rescue Services firefighters who had not worn pants containing antimony for the prior four months. NIOSH investigators also evaluated 42 Tamarac Fire Rescue firefighters, who had worn pants containing antimony in the previous two weeks.

**---How did NIOSH test the firefighters?**

NIOSH investigators visited the two fire departments in Florida on February 3-6, 2009. They surveyed participants about personal characteristics, work history, and possible sources of exposure to antimony. They also collected urine samples to measure antimony levels. The urine samples were analyzed at the Centers for Disease Control and Prevention's (CDC) National Center for Environmental Health Laboratory.

**---What did NIOSH find?**

The urine levels of antimony for all the firefighters tested were not elevated regardless of whether or not they had been wearing uniform pants made from FireWear® fabric. The levels were similar to the urine levels of antimony found in the U.S. population. NIOSH investigators concluded that wearing the pants containing antimony trioxide does not cause elevated levels of antimony in the bodies of firefighters.

**---Why did NIOSH perform urine testing instead of hair testing?**

Urine testing is the most accurate, reliable, and valid test method for measuring antimony levels in the body. Hair testing is not a validated method for heavy metals testing (which includes antimony), and is not recommended by the American Medical Association (AMA) or CDC's sister agency, the Agency for Toxic Substances and Diseases Registry.

**---What are the normal levels for urine antimony?**

CDC has established ranges for urine levels of antimony in the U.S. population: 0.120–0.364 micrograms/ gram creatinine. This information helps scientists assess whether antimony

levels in specific groups are unusual. Similar information is not available for levels of antimony in hair..

**---Why is hair testing not an accepted method?**

NIOSH investigators believe results from hair analysis are unreliable. Accepted standards on methods for collection, storage, and analysis of hair are lacking. Problems also exist with the regulation and certification of laboratories conducting hair analysis. It has been shown that different laboratories can report different results for hair samples collected from the same person. In addition, hair analysis cannot distinguish between internal exposure (substances inside the body) and external exposure (substances that might stick to the hair, like those in hair care products).

**---Will NIOSH test the pants?**

NIOSH investigators do not think that testing the pants is necessary. First, if antimony was being released from the pants and absorbed through the skin, the urine tests would have indicated that firefighters wearing the pants had levels higher than 1) the U.S. population and 2) the firefighters not wearing the pants. Our results showed no differences between these groups. Second, a private technical consulting and engineering firm has tested the fiber in the past. They concluded that antimony trioxide exposures associated with use of clothing made from these fibers comply with the requirements of California's Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65).

**---Are the pants containing antimony safe?**

NIOSH investigators consider the pants containing antimony to be safe to wear. They recommend that fire departments issue and firefighters wear station uniforms that comply with the National Fire Protection Association (NFPA) 1975 Standard. The pants made from FireWear® fabric are one type of pants that meet this standard. NIOSH investigators also recommend that firefighters follow garment label instructions when laundering station uniforms.

**---The garment labels suggest low temperature washing and laundering without chlorine bleach....is this to prevent release of antimony?**

No. The garment care instructions are consistent with instructions for fabrics containing cotton and FFR® fibers and ensure that the garment remains durable and does not lose color.

**---Is NIOSH planning to conduct further evaluation?**

NIOSH investigators do not think further evaluation of this issue is needed. The final reports of the NIOSH evaluation is currently being prepared and will be available next week at: <http://www.cdc.gov/niosh/hhe/>.

**REMEMBER PITTSBURGH:**

We remember **Pittsburgh Battalion Chief Charles G. Brace and FF Richard A. Stefanakis** who were tragically killed in the Line of Duty on Saturday March 13, 2004 when the bell tower of the Ebenezer Baptist Church collapsed following a multiple alarm fire. **RIP.**

**3 FRENCH FIREFIGHTERS KILLED IN THE LINE OF DUTY-DURING TRAINING**

Yesterday, **3 Firefighters were killed in the Line of Duty in France.** 2 of the Firefighters were participating in a training session related to outdoor rescue operations in Ain County in the town of Cerdon and when, for a yet undisclosed reason, the detail went wrong, and the 2 Firefighters were drowned. The 3rd Firefighter was killed in the Line of Duty after he fell 100' while attempting the rescue of the other 2 Firefighters. The Firefighters killed were respectively 30, 40 and 46 years old and leave 7 orphan kids. Additional details will follow.

**UPDATE: BANGLADESH FIRE: NOW REPORTED 4 FIREFIGHTERS KILLED IN THE LINE OF DUTY**

**"I managed to escape but some of my colleagues were burnt to death. I heard one firefighter screaming but I could do nothing,"** an injured Firefighter said today outside the Bangladesh's biggest shopping mall where a big fire broke out on Friday. The fire, which began on the 17th floor of the 19-story shopping complex Bashundhara City in capital Dhaka Friday afternoon, lasted for eight hours before it was put out last night. **Seven people including four fire fighters were killed** in the fire and at least 18 others injured while two of them are still in critical condition. Reports are that the fire security system inside the building was not functioning well which caused more death. **There are some 2,500 shops, a cinema and cafes in the shopping mall.** Though the fire fighters were praised widely for their excellent performance, the lack of required equipment was blamed for their delay to extinguish fire. Details to follow.

**LONG ISLAND APPARATUS CRASH:**

A Bethpage (NY) FD vehicle responding to an emergency call collided with a car on Long Island, leaving the car's driver with serious internal injuries wounds. Reports are that 2 Firefighters were treated for minor injuries after the crash around 0800 Saturday. Nassau County police are investigating but say there was no criminal conduct. The Firefighters were responding in a Bethpage FD sport-utility vehicle on when they collided with the car at an intersection. It's not known how fast either vehicle was going or who was at fault.

**SERIOUS RESPONDING FIRE APP. ROLLOVER CRASH IN IOWA-RESPONDING TO GRASS FIRE:**

2 Firefighters and a civilian were injured yesterday in a crash involving a pickup truck and a City of Pulaski fire truck north of Pulaski, Iowa. FF Todd Lyn Garmon, 38 was air lifted from

the scene to University of Iowa Hospitals and Clinics in Iowa City. FF Michael Elliott Ashlock, 24, was taken to the Davis County Hospital by ambulance. The civilian, Rex B. Blackwell, 73 was transported by POV. The pickup, driven by Blackwell, was northbound and attempting to turn west on a street. The fire apparatus was also northbound responding emergency to a grass fire. The fire apparatus, driven by FF Garmon, attempted to pass Blackwell and struck his pickup on the driver's side....**the apparatus rotated clockwise and then entered a ditch, rolling several times before coming to rest on its top in the bottom of the ditch.** Reports are that at least 1 of the Firefighters was seriously hurt-updates will follow.

### **APPARATUS CRASHES WHILE RESPONDING TO A WORKING HOUSE FIRE IN ALABAMA**

A Spring Garden Fire Truck overturned trapping 3 Ff's inside for a short period of time while en-route to a structure fire at around 0530 hours this morning. The driver of the apparatus apparently lost control and overturned in a curve near the intersection. All injuries are reported to be minor.

### **"THE FIRE SPREAD FROM HOUSE TO HOUSE" RESIDENTIAL CONSTRUCTION, FIRES AND YOU:**

In our continued effort to do whatever we can to help clarify the BS that some homebuilders associations are attempting to pass on (as reality) concerning residential construction and fire sprinklers, here is a story and clip worth of any FD's viewing. **LODD: FRENCH FIREFIGHTER SHOT / KILLED DURING A "CHECK ON THE WELFARE" RUN**

An 85-year-old man who is hard of hearing mistook a 32 year old Firefighter for a burglar and shot him to death in the southern French city of Belley yesterday. Neighbors had called the fire department because they were worried about the health of the old man. When he did not respond to shouts at the door, the Firefighters forced entry into the apartment. **The man mistook the noise for a break-in, locked himself in a room and fired a shot that struck and killed one of the firefighters in the Line of Duty.** The occupant, who collapsed upon being informed of his error, was taken into police custody. Our sincere condolences to all affected.

- **2 NEW NIOSH LINE OF DUTY DEATH REPORTS HAVE BEEN ISSUED:**

**TEXAS: WALL COLLAPSE KILLS FIRE CHIEF IN THE LINE OF DUTY:**

On July 05, 2008, a 42-year old male Fire Chief was killed in the Line of Duty when he was struck by a collapsing brick parapet wall during a commercial structure fire...an automotive repair and upholstery business. The Chief grabbed an SCBA from the engine and pulled a preconnected 1 ¾-inch handline to the front door, assisted by a Firefighter who had just arrived in her personal automobile. The Chief worked the nozzle through the doorway (using tank water) while the other Firefighters established water supply. Less than 5 minutes after the engine arrived on scene and shortly after water supply was established, the brick parapet wall at the front of the structure collapsed, striking the Chief and burying him under the brick debris.

**PA. FIRE CAPTAIN ELECTROCUTED/LODD DUE TO AERIAL LADDER CONTACT WITH POWER LINES:**

On January 6, 2008, a 40-year-old male Fire Captain was electrocuted after coming into contact with a 12,400-volt overhead powerline. The victim and a Firefighter had been assigned to vent the roof of a structure and were using a tower ladder to get to the roof. The victim was in the process of maneuvering the platform beneath a three-phase overhead powerline when he contacted one of the powerlines with his neck and back. Two occupants of the apartment building died as a result of the fire.

**UPDATE: MASSACHUSETTS APPARATUS CRASH:**



State officials are monitoring whether Provincetown (Cape Cod) Firefighter Elias Martinez III will retain his EMT certs after his role in a fire apparatus crash in November. Cops have accused Martinez of wrecking the PFD's only ladder Nov. 9 while driving under the influence of alcohol. The 21-year-old FF/EMT also faces a criminal charge of driving to endanger the public, and cops have cited him for speeding and failing to slow at an intersection. FF Martinez is certified as an emergency medical technician through April 1, state records indicate. If convicted of the criminal charges, Martinez could lose his driver's license. That loss would prevent him from qualifying for an EMT job. Martinez is currently on unpaid administrative leave with the PFD and a town meeting, voters will be asked April 6 to approve spending \$300,000 to replace the ladder truck. The total cost of a replacement is estimated at \$650,000. The town's insurance provider is expected to cover \$350,000 of the purchase. Martinez faces a pretrial hearing in Orleans District Court March 26.

### **It's Salad Time for FIREFIGHTER/EMS RECRUITS...**

A new study finds that many new Firefighters, paramedics and cops are overweight and obese. The study, was conducted by researchers from the Harvard School of Public Health. Researchers examined the health records of more than 370 firefighter and ambulance recruits and found that up to 75% of new recruits for emergency services in Massachusetts were either overweight or obese, a bad sign because of the job they are in. **OKLAHOMA FIREFIGHTER KILLED, OTHERS INJURED IN THE LINE OF DUTY: HYDRO GRAIN ELEVATOR FIRE**

It is with deep regret that we advise you that a Firefighter has died in the Line of Duty and 5 others were hurt today at a fire at a grain elevator in Caddo County, Oklahoma. Initial reports are that the Firefighters ran out of air but that is preliminary. At least one additional Firefighter injuries are serious, but the others' injuries are not considered life-threatening. About 1030 hours this morning, a soy bean storage bin caught fire at the grain elevator in downtown Hydro. Hydro and Weatherford Firefighters responded, and one of the Hydro firefighters died in the Line of Duty, at the scene. One of the four Firefighters with minor injuries is from Weatherford and the rest are from Hydro. Hydro's firefighters are volunteers.....and the fire continues to burn as of 1500 hours, Hydro and Weatherford are in far southwestern Oklahoma. Additional details will follow.

**FIREFIGHTER CLOSE CALL-MANURE PIT**

A Firefighter battling a grass fire in northern New York fell into a manure pit and was rescued from possible drowning. Depauville FD recruit Kevin Zoll saved the 6-year veteran Ernest Ross on Friday at a farm in Clayton. Ross was cutting across a field toward a building where flames were spreading when he fell into an unmarked manure pit....it was covered with straw and looked like the field. FF Zoll crawled to the edge of the pit, reached out with a broom handle and pulled Ross in. Ross says that saved his life, than in a few minutes he would have been submerged. Yesterdays fire in Hydro, Oklahoma **killed their Fire Chief in the Line of Duty** and injured other members. The Volunteer Fire Chief died Monday while operating at a fire inside a

downtown grain bin, while other Firefighters were pulled from the fire and taken to hospitals. **The Hydro FD had just 10 members-3 from the Chiefs family.**

**Hydro Fire Chief Nolan Schmidt**, a father of two and a local mechanic was one of at least 5 Firefighters who climbed into the giant bin (photos on our home page) half full of soybeans. While inside, they became trapped for a yet to be determined reason or event. Firefighters later cut through the side of the metal bin to rescue Chief Schmidt and four other Firefighters, who were overwhelmed by the thick smoke. The injured Firefighters include:

- Hydro's Assistant Fire Chief Warren Schmidt, listed in **serious condition** at OU Medical Center.
  - Hydro Fire Capt. Paul Schmidt, who was listed in good condition at Integris Baptist Medical Center.
  - Hydro FF Allen Entz, who was listed in good condition at Weatherford Regional Hospital.
  - Weatherford FF Kyle Nonast, who was listed in good condition at Weatherford Regional.
- Firefighters in neighboring Weatherford responded to the Hydro fire about 1130 hours. Work was being done at the grain bin when a fire broke out.

**FLORIDA FIRE LT DIES FOLLOWING RUN**

Melbourne Fire Lieutenant Robert Strang died in the Line of Duty unexpectedly last night at Fire State 74 in Melbourne. Strang is a 29 year veteran with the department. Lieutenant Strang returned from a structure fire Thursday night. About 40 minutes later, he was found unresponsive in quarters...his crew initiated resuscitation efforts and he was transported to Holmes Regional Medical Center where resuscitation efforts were unsuccessful. So far, no cause has been determined. The fire was at an office complex in downtown Melbourne. The department says Strang did not have any complaints prior to retiring to his quarters. Lt. Strang began his career with the Melbourne FD in February 1980. During his 29 years he was promoted through the ranks from firefighter to

Lieutenant....he also spent some time working with Orange County Fire Rescue. Strang is survived by an 18-year-old son and the Lt was scheduled to retire soon. As always our sincere condolences.

**FIREFIGHTER MISSING IN BRAZIL**

A Firefighter is reported missing in the City of Barueri, state of Sao Paulo, since Tuesday when he was testing a rescue boat engine in a dam area. Searches are being conducted by ground people, divers and an helicopter.

We have reports that there was at least 1 FF ejected in an apparatus vs apparatus responding crash in Houston just a little while ago. As many as 10 people, including 8 Firefighters have been taken to hospitals after the responding rigs crashed and one of them rolled onto a car. Also among the victims is a woman who was riding her bicycle when the apparatus overturned and pinned her.

The apparatus was responding to a reported fire-which turned out not to be. At least 1 of the Firefighters was thrown from an apparatus and suffered serious injuries and one of the occupants of the car also suffered serious injuries. The pumper was reported to be responding northbound and the ladder was heading east, witnesses reported. The pumper t-boned the ladder from the side and the ladder then rolled onto the front half of a car. We have some pics on our home page-updates to follow.

Hey...

In what is turning out to be such a horrible situation, a **preliminary investigation** indicates the responding HFD ladder truck ran a red light before crashing into the responding pumper at an intersection Monday morning. Both companies were responding to what had been reported as a possible fire when they crashed. The initial fire report was prompted by smoke testing of sewer lines in the area.

Before overturning and coming to rest on top of a car, the ladder truck **struck a bicyclist** and snapped an electric pole and tree. The collision injured 11 people, the bicyclist, Leigh Boone, 29, was critically hurt and remains in critical condition. HPD cops have stated that it appears that FF Warren Ducote, who was driving the rig will face charges of failure to use due

caution. However, the cops have not yet spoken with the drivers of either HFD apparatus. 9 Firefighters were taken to hospitals, but none suffered life-threatening injuries, with 2 remaining in the hospital for various fractures. Capt. Michael Mayfield, who has been on the job for 34 years, was listed in fair condition this morning at Ben Taub General Hospital. FF Brian Edwards, with 19 years on who was driving the pumper, was listed in good condition at Memorial Hermann Hospital. 1 FF was ejected in the crash.

Cops are also looking into the Opticom system to see what role it played in the crash.

We have received many e-mails about this story with numerous comments. Here are our thoughts:

**=Make It CLEAR What Your FD Policy and Local Laws Are...In Writing.**  
**=Train All Drivers To Insure They Are Qualified To Operate Apparatus.**  
**=STOP at Red lights and Stop Signs When Responding.**  
**=SLOW WAY DOWN in intersections no matter what color the signal is ...due to people turning right on red etc....expect someone to cross your path. EXPECT it.**  
**=EXPECT someone to pull into your path of response.**  
**=SLOW down so that if "something or someone" gets in your way-you have a shot at stopping.**

**=WEAR a seat belt. Everyone. Confused on HOW to wear a seat belt?....Here ya go:**

**=DRIVE apparatus and emergency vehicles as if your family is on the road-and in your path.**  
**=MAKE SURE Your Drivers And Fire Officers Understand The Consequences Of An Apparatus Crash And What THEIR Level Of Accountability Will Be.**

While we are seeing improvement, especially with FF's wearing seatbelts, not all do it or get it. Simply put, be it this crash or any others, we know of no Firefighter that would NOT handle it different if they were given a chance to repeat history. **An apparatus crash, especially one like this, is the LAST thing ANY FF from ANY FD wants to happen.** While we are in the business of doing good, we can't do good if we don't arrive. Time IS critical getting to a fire-but we gotta get there. **The LAST thing the HFD FF's wanted was for this to happen.** Lots for all of us to learn from this crash-and more, as more facts come out. We pray for the recovery of the FF's as well as the civilians affected.

=Also receiving an award tonight is the survivor advocacy group founded by the **National Fire Sprinkler Association, Common Voices** consists of six women who have been sharing their stories of personal loss to advocate for fire sprinklers. Since the group was formed in 2007, they have visited Capitol Hill on many occasions to meet with members of Congress to advocate for the Fire Sprinkler Incentive Act.

### **TAKE HOME CARS ?**

What does this have to do with FF safety or close calls? Funding for FF staffing. Saved \$ can mean saved jobs and adequate staffing. Adequate staffing saves lives. **Read on.** Wanna get someone with gold on their sleeves to pay attention?...talk to them about take home cars and headquarters parking spaces. And while take home cars are **certainly necessary** at some FD's (vs Parks and Recreation Dept cars...ridiculous abuses like that)... the word "**necessary**" even at a FD can be real subjective. In our humble opinion, a FD take home car should be "taken home" when the "taker homer" is regularly subject to (and does) respond to a scene where their **very timely** arrival is critical to FF / civilian safety, life saving or "working incident" command/support roles. Generally that should mean that you live in or very close to your response area and you have to arrive within minutes of being alerted.

**Otherwise, what's the rush?** And while take home cars are certainly a benefit (and a taxable one as well), the issue is that when any community is looking at budget cuts including firefighter layoffs', no matter what the cost saving-take home cars "taken home" by folks who are not regularly responding to, or critically needed at emergencies are often, and often justifiably targeted. If cutting back anywhere can help save FF jobs directly related to fireground staffing-, we support it. **Park the non-critical cars - save a Firefighters critical job.**

When he went to check, the homeowner found the propane tank on his grill had exploded. The homeowner says the grill was not in use at the time...the homeowner made it out safely and called firefighters. Firefighters say the fire took off quickly through the dwelling and the 2 Firefighters were injured when there was a smoke explosion as they opened an attic door....the FF's were

**APPLICABLE "SMOKE EXPLOSION" TRAINING VIDEOS:**

The following video is a fire in a Mixed Occupancy Balloon Frame 5 Story Building, just after midnight, in Vermont, almost 30 people in the building in apartments on the upper floors - did not want to evacuate. Initial conditions were nothing visible on the outside and light smoke on Division 2 - things went downhill rapidly a few minutes into the call around 0115 hours when conditions went from minor to major with smoke boiling from the upper floors. The Firefighters evacuated shortly after and the 2nd floor collapsed. In the end, the fire was seven alarms and 3 civilians lost their lives. Hey...

Cindy Schuenke, the Missouri Fire-Medic who was severely burned in a fire three years ago in St. Louis County, has filed suit against three fire agencies and numerous firefighters who responded to the fire with her, according to media. FF Medic Schuenke, 44, suffered severe burns March 29, 2006, while reportedly searching for the mother of a fellow firefighter in a burning dwelling. Her suit, filed last week in St. Louis County Circuit Court, **alleges that firefighters at the scene, and their commander there, made mistake after mistake. The suit also alleged that two fire chiefs had failed to train their fire personnel to properly handle such situations.**

The suit also names Grace Industries Inc., the maker of a personal alert safety system (PASS) device that Schuenke wore into the fire. The suit says the device failed to sound, therefore failing to alert rescuers to her predicament and location. In addition to numerous firefighters who responded to the fire, the suit names as defendants the Mid-County FPD, its chief, Tom Vineyard, and Capt. Ankenneth Corbin, the Incident Commander at the fire; University City and its chief, Steve Olshwanger; and the Northeast Ambulance and FPD and two of its firefighters who were inside the house with Schuenke. **The suit does not name Schuenke's employer, the Community Fire Protection District, as a defendant. She cannot sue that district because she is receiving worker's compensation benefits through it.**

**The suit accuses the Incident Commander of the fire of:**

- Failing to order that water be sprayed through the basement windows onto the source of the fire.
- Failing to order a search-and-rescue team to use a thermal-imaging camera in the search for the victim.
- Wrongly ordering Schuenke and other firefighters to enter the burning building because, among several reasons, it was improbable that Geneva Rooks was still alive.
- Failing to have a properly prepared rescue team ready to respond when Yahnke called for someone to help Schuenke.

The suit also accuses a University City assistant chief and battalion chief of failing to recognize "that Corbin was mismanaging the fire scene, had lost control of the fire scene, and was exposing firefighters ... to a heightened and unreasonable risk of danger." The two should have removed Corbin as incident commander, the suit says. Schuenke has since had several surgeries, amounting to more than \$1.16 million in medical costs. Here is the entire article:

**VIRGINIA FIREFIGHTERS CHARGED WITH "FAILURE TO WEAR SEAT BELT" IN CRASH:**

Two FF's in Spotsylvania County were charged yesterday after an early morning apparatus crash sent them to the hospital with injuries. ...the firefighters were responding to a house fire. The truck crossed the road's double yellow line and crashed into an embankment. The truck's driver, FF Andrew Debord, was charged with failure to maintain control of a vehicle and failure to wear a seatbelt. The front seat passenger and officer in charge, Michael Gray II, also was charged with failure to wear a seatbelt....they were taken to the hospital for examination but were thankfully, released.

**AND IN CONNECTICUT: A FIREFIGHTER IS HAND CUFFED:**

New Haven FD Lt. Filipe Cordero started out to help a woman apparently overdosing on drugs, but instead ended up in handcuffs in the back seat of a police car. Nice. Details of what happened Wednesday might be in dispute, but the end result is not, and Thursday the chiefs from both departments launched a joint Internal Affairs investigation into the matter. Fire Lt. Cordero ultimately was released and finished his shift. He was not charged. As you will remember, on Friday, April 4, 2008, **Captain Robin Broxterman**, 37-years-old, a 17-year veteran career firefighter and paramedic, and **Firefighter Brian Schira**, 29-years-old, a six-month probationary, part-time firefighter and Emergency Medical Technician with Colerain Township (Ohio) Fire & EMS died in the Line of Duty after the floor they were on collapsed into the burning basement at that dwelling fire. Many members of our area community along with the fire service will remember them in a memorial service this morning. **But there is another way that ANY Firefighter and Fire Officer can remember them:**

Following that tragic loss, the Colerain Township Fire/EMS Department issued a preliminary report (**link below**) with initial and valuable details on what happened based upon the information available at the time. Critical details such as the importance of size-up, 360 walk around and other information is of great value to any Firefighter and Officer. A more in-depth final report is being developed and is expected to be released later this year along with the NIOSH report. As stated in the preliminary report "the department will never forget the ultimate sacrifice made by Captain Robin Broxterman and Firefighter Brain Schira in their service to the community. **By sharing the knowledge gained** from this very tragic and painful incident, the Department will ensure their sacrifice was not in vain and hope that other fire departments can avoid a similar tragedy"

**ONE VICTIM-And Her ATTORNEY-SPEAK OUT:**

The media also got ahold of Jotika Ramchandani - and her attorney - and she says she honestly doesn't know how she is alive today. She describes the moments after that fire department ladder truck crushed her car. She can't say exactly what she was thinking at the time. She never lost consciousness despite the force of the impact. She did get out through one of the back doors of that car and then staggered across the street for help. She was treated and released from the hospital the day of the wreck.

**READ: She says she has a lot of lower body pain and that she is taking a lot of pain medication to cope.** She says she has constant nightmares now about being trapped, about free falling. She is considering seeking counseling now to help her deal with that.

How do you think **that** is going to end up?

**AND THEN THERE IS** the bicyclist who was involved in the crash..she remains hospitalized. Leigh Boone is in critical condition.....

And finally, THE FIREFIGHTERS have all been released and thankfully should all recover, at least from their physical injuries. GOOD FIREFIGHTERS WANTING TO DO GOOD-without a doubt...that's why they were RESPONDING. But for reasons that have been described and whatever other reasons, this "simple response" will now last a lifetime for so many involved...and it's just only started.

It is with deep regret to report the **Line of Duty Death of Firefighter John Weber** of Township Fire Department in Eau Claire, WI. On Saturday, April 4, 2009, The Township FD was dispatched to a report of a brush fire. FF France was treated on scene by emergency services personnel and subsequently transported via helicopter to the USA Medical Center in Mobile, AL where he succumbed to his Line of Duty related injuries.

**FIREFIGHTER KILLED IN THE LINE OF DUTY AFTER BEING STRUCK BY BRANCH**

We regret to advise you that Firefighter was killed this morning when a burning tree branch collapsed and struck him on the head in New Zealand. The volunteer fire service from Willowby, south of Ashburton, had been called to a tree fire in around 0430 Hours this morning. When they arrived a single tree was burning...the FF's had just got out of the fire apparatus and apparently the firefighter who was killed walked around the front of the truck and at that stage a branch has fallen down and struck him on the head. The Firefighter had initially been treated at the scene, but had died within half an hour of the accident.

**UPDATE: FLORIDA FF LODD.....also STRUCK BY A FALLING TREE----REPORT REVEALS FACTS & THE FAMILY OF THAT FALLEN FIREFIGHTER PREPARES TO SUE:**

An investigation report blames the Volusia County (FL) Fire Service for the Line of Duty death of a Firefighter 17 months ago ....and, expectedly, Fallen Firefighter's family states that they are ready to sue.

FF John Curry was killed in November 2007 while learning to cut down trees in the event of a wildfire. An internal investigation says FF Curry and other trainees were sorely unprepared and didn't have the basic skills or supervision they needed to train safely. The report further says the county failed to provide a safe workplace, so now all Firefighters will be required to be retrained. It also states that the county had violated safety issues, writing that "inexperienced and untrained trainees were placed in positions they were not prepared to perform." FF Curry had never been trained for the drill, but was assigned as a spotter for a man to cut down a tree. The tree wasn't cut correctly and, instead of falling at an expected angle, it twisted 135 degrees off its stump. At that point, the instructor realized the tree was falling on the escape path, so he ran into the woods. But apparently FF Curry didn't know that and, when he ran to the escape route for safety, he was hit and killed by the tree.

**THE ATTORNEY SPEAKS OUT & THE FD RESPONDS.**

Attorney Geoff Bichler believes Volusia County knowingly placed their Firefighters in a dangerous situation with inadequate training. "This is a case of such gross negligence it should be a crime. The blood of John Curry is on the hands of this agency based on these failures," Bichler said. "We wouldn't agree with that assessment at all. We have excellent training," said Dave Byron, Volusia County spokesman. The county said it will comply with all the recommendations in the report.

Retired Chicago Fire Captain Richard Scheidt, a subject of one of the grimmest and most iconic newspaper photographs in Chicago history, has died. He was 81. On Dec. 1, 1958, FF Scheidt, his face drawn in sorrow, carried the wet, lifeless body of 10-year-old John Jajkowski Jr. from Our Lady of the Angels grade school on the West Side. The fire, one of the worst tragedies ever, killed 92 children and three nuns. Scheidt, a member of Rescue Squad 1, carried the bodies of 20 children from the school. Jajkowski was the first. A Prince George's County Firefighter was critically injured this morning while operating at a house fire. At 0201 hours this morning, companies were alerted for a fire in a carport attached to the house. Firefighters from the Largo Co. #846, with a crew of 6 Firefighters, were first due and arrived to find a vehicle and carport burning with extension into the 2-story single family dwelling. Firefighters entered the dwelling and were operating when a MAYDAY was transmitted. Firefighters from Kentland Co. #833 quickly located the Firefighter in a 1st floor living room, sounded the MAYDAY and removed the injured Firefighter by way of a window. The Firefighter had sustained severe burns to his face and head and transported to the Washington Hospital Center Burn Unit. **He is listed in critical/stable condition.** 2 other Firefighters sustained minor burn injuries and it is anticipated that they will be treated and released from the same Burn Unit. The critically injured Firefighter is a 21 year-old-male (will be 22 in May) and is a 4-year career member of the Prince George's County Fire/EMS Department. Updates to follow.

Hey...

That Prince George's County Firefighter hurt this morning remains in **critical/stable** condition at the Washington Hospital Center Burn Unit. **Fire Fighter/Medic Daniel McGown**, 21, (22 in May 2009) and a 4-year career member, sustained severe burn injuries to his face with respiratory involvement while operating at that house fire this morning. Fire-Medic McGown is intubated and sedated....the Doc's advise that the next 72 hours will be critical. FF/Medic McGown was part of a crew of six from Engine 846 (Largo). According to PG officials, something went wrong in the kitchen area and FF McGown, attempting to get out, ended up unconscious in the living room. A crew from Station 833 (Kentland VFD) **heard a PASS device** and discovered the downed firefighter. A "mayday" was called and then Firefighter McGown was carried through a window of the home to the outside. Due to McGown's condition paramedics decided not to wait for a medevac helicopter and drove the firefighter to the burn facility.

FF/Medic Daniel McGown is the son of retired Prince George's Deputy Fire Chief William "Bill" McGown. Bill served with the Fire/EMS Department for nearly 25 years before retiring in April 2006. He is currently serving as the Deputy Director of Public Safety Communications. Bills daughter, Kimberly McGown Blackistone, is a 7-year career FF/Medic with the Department. We have posted a PDF copy of the report issued by the State of Florida Fire Marshal related to the Line of Duty Death (at training) of the Volusia County FF. The report is on our home

The report states that FF John Curry, killed in the Line of Duty during that training-when a tree fell on him, was a result of improperly trained firefighters and an unsafe workplace. The Volusia County officials dispute that...and naturally, the attorneys are all on board.

**THE CRITICAL ROLE OF DISPATCHERS---And PASSING ON Information:**

We'll have more on this soon, but here is a link related to the murders of those 3 Pittsburgh Police Officers on Saturday-and how the **dispatch center call taker failed to pass on information** known. Information known to dispatchers and call takers is useless...unless responders also know...and know timely. The part-time dispatcher was hired in November...she went through 320 hours of training, which took about 13 weeks to complete...since she worked 24 hours a week. That means she started taking calls in late February or early March....

For those of you on "Facebook"...a group has been created: "**BE STRONG FIREFIGHTER DANIEL McGOWN**" ...As you know, at 0200 this morning, FF/Medic McGown responded on Engine 846 from the Kentland's Largo Station, on the way to the house fire (details below) fire. They had a fire, which appears to be arson, spreading from a carport and into the home Herrington Drive. FF/Medic McGown was on a hose line in the kitchen when the ceiling caved in, knocking him down and stripping the protective mask from his face. FF/Medic McGown suffered 2nd and 3rd degree burns to his face and respiratory track and remains in critical but stable condition at Washington Hospital Center's burn unit.

**ALSO IN WASHINGTON HOSPITAL CENTER: WEST VIRGINIA FIREFIGHTER CRITICAL:**

A Baker Heights Firefighter injured while operating at that barn fire last night is also being treated for life-threatening injuries at Washington (D.C.) Hospital Center. FF Kenneth Ayers, 45, was taken to City Hospital in Martinsburg for treatment and then taken to Fairfax Inova Hospital in Falls Church, Va., He later was transferred to Washington for treatment of facial and head trauma...and is listed in critical condition. FF Ayers and another firefighter from Bedington VFD were hurt when a gust of wind got underneath tin on the barn roof and pushed a timber in one of the sidewalls out and down on them as they were attacking the fire. The firefighter from Bedington was treated and released.

**FIRE SPOTTER AIRCRAFT CRASHES IN WISCONSIN-POSSIBLE LINE OF DUTY DEATH:**

A Wisconsin State Department of Natural Resources plane being used to help spot grass fires crashed this afternoon, killing at least one person. The crash occurred about 1430 Hours in a field about six miles southwest of Marshfield. The plane was being used to help observe a wildfire as firefighters worked on the ground. Our condolences to all affected....details to follow.

**FIREFIGHTER KILLED IN THE LINE OF DUTY- APPARATUS CRASH (Paderborn, Germany)**

**Other Firefighters Critical & Civilians Injured and Killed (Photos on our home page)**

Earlier today (Friday) in Paderborn (Germany) a taxi cab with 5 passengers crashed into a responding ladder truck from the Paderborn Fire Brigade. The ladder company was on a run to a fire with 3 FF's on board when 2 other cars, a Toyota and a Ford, with 4 occupants between them, were also involved in the crash. The ladder was responding with blue lights and siren and then...a taxi occupied with 5 persons came along. The vehicles crashed in an intersection. The impact threw the ladder against a traffic light pole/mast, ripped it from the anchor and pulled it down. The apparatus slammed over the crossing into the opposite lane, collided with the Toyota and the Ford, and landed on its side...when then a fire broke out in the rear part of the apparatus.

Because of the impact, the taxi was thrown into the roadway. Due to his severe injuries, a 46 year old man who was sitting in the back seat of the taxi was DOA on the scene. His 40 year

old wife, who was sitting in the back seat too, died later in hospital. **A 48 year old Fire Fighter who was sitting on the right side of the apparatus was transported to Paderborn Hospital in critical condition - he died there. The other 2 Firefighters (31 and 21 years old) were seriously injured and are in Paderborn hospital with critical injuries but it appears right now, that they have a good chance of survival.**

The taxi driver (43 years old) suffered life threatening injuries, two other occupants of the taxi, of which one man (47 years old) was sitting in the front passenger seat and a 56 year old man, which sat on the backseat, were seriously injured too. As far as the Toyota, with which was also hit by the TTL, two young men, 18 and 17 years old, are seriously injured. The 38 years old driver of the Ford and his 36 year old wife had NLT injuries. We will have more details on this crash later. We have posted photos on our home page. **As always, our sincere condolences to the families and friends of the Firefighters involved.**

#### **OKLAHOMA WILDLAND FIRES: 1 Firefighter Burned.**

One firefighter suffered severe burns fighting the fires in Oklahoma. The Firefighter, who was burned in Lincoln County was treated and transported and is reportedly in serious condition. Details will follow.

More positive news from the Washington Hospital Center Burn Unit today. Fire Fighter/Medic Daniel McGown remains listed in a stable critical condition; however, he continues to show positive signs of improvement. He walked around the Burn Unit ICU again last night, this time with less assistance. He had a bronchoscopy (scope) performed this morning. This is a procedure that allows the doctor to look at his airway through a thin viewing instrument called a bronchoscope. The results were encouraging in that the damaged area appears to be superficial in the lungs. There is some edema present. Edema means there is swelling caused by fluid in his body's tissues. Dan has a slight fever which is not unexpected with his injuries and is being treated appropriately. He will undergo another scope tomorrow and if his injuries continue to improve then the intubation tube may be removed. The remainder of the day involved rest and more walks around the Burn Unit.
