Just a reminder...

The first of two offerings of the Fire Technology 89 course is scheduled for Wednesday, October 8 (5-9pm), Friday, October 10 (5-9pm) and Sunday, October 12 (8:30 am to 5:30 pm) - all three days.

The second offering is Tuesday, October 21 (5-9pm), Thursday, October 23 (5-9pm) and Saturday, October 25 (8:30 am to 5:30 pm).

If you are offering courses that conflict with the dates and times of FT 89, students who wish to take 89 will approach you for a Class Overlap Form. Please fill out the form and sign it. You would then give it to the student to get the Division Dean, Tom Clark, to sign the card. Once both signatures are on the card, the student needs to take the card to registration to add the course in person.

Please check with your students to find out if any of them are planning to take one of these two courses in preparation for the Spring 2009.

Also, let all students know: if they plan to take the Spring 2009 Academy, but have not taken the FT 89 course yet, they must complete one of the two upcoming offerings of FT 89. There are no plans to offer another FT 89 course after October 25th prior to the Spring Academy.

## **FIRE SERVICE INFORMATION COURTESY OF THE U.S. FIRE ADMINISTRATION:**

### **Lowering the U.S. Flag**

Did you know that the law requires the U.S. flag be lowered in tribute on only a few days each year? Quite appropriately, one of these days is the observance of the National Fallen Firefighters Memorial Service.

On October 16, 2001, President George W. Bush approved legislation requiring the U.S. flag to be lowered to half-staff on all Federal buildings to memorialize fallen firefighters. Public Law 107-51 requires this action to occur annually in conjunction with observance of the National Fallen Firefighters Memorial Service.

Let your local media know that U.S. flags across the country will be lowered on Sunday, October 5, 2008. This includes the U.S. Capitol and the White House, as well as buildings in your local community.

Remember to lower the U.S. flags at your home, fire department, and business. Encourage your local community to follow the Federal Government's example. When you lower your flag this year, you will recognize the brave men and women who died protecting their communities from natural and manmade emergencies and disasters and those who carry on the proud tradition.

You may also want to ask your state and local officials to include lowering the flag in a proclamation recognizing the brave men and women who made the ultimate sacrifice.

## **FIRE SERVICE PUBLIC EDUCATION INFORMATION FROM THE U.S. FIRE ADMINISTRATION:**

### **U.S. Fire Administration Commemorates National Fire Prevention Week**

Emmitsburg, MD - **National Fire Prevention Week** ([www.firepreventionweek.org](http://www.firepreventionweek.org)) will be commemorated this year from October 5-11. The theme for 2008 is "Prevent Home Fires."

"As winter months and holidays get closer, the rates of fire and fire deaths increase. Take a little time to ensure that you and your family do not have to suffer the effects of a fire in your home," said U.S. Fire Administrator Greg Cade. "Each of us would benefit from checking our own homes for fire hazards and making sure that everyone in the residence knows what to do in case of fire.

Each year, fire departments respond to over 400,000 residential fires. Annually more than 3,500 people die from fire in their own homes. In many cases, some simple steps may have prevented the fire from starting. The most common causes of home fires result from cooking, heating, electrical malfunction, smoking materials, and candles. Each of these activities carries with it a risk of fire, but that risk can be greatly lessened if you follow some common sense safety tips.

- Stay in the kitchen when you are cooking. Many fires start from "unattended" cooking.
- Maintain heating equipment and chimneys by having them inspected and cleaned annually by a qualified professional.
- If you smoke, put it out, all the way, every time.
- Keep things that can burn away from light bulbs, light fixtures, and lamps. For any suspected electrical problems, call a qualified electrician.
- Use flashlights during emergencies, not candles. If using candles, blow them out when leaving the room, and keep them away from things that can burn.

*Note: The NFA policy of only 1 stipend-supported trip per fiscal year remains. However, a qualified individual may seek to participate without stipend assistance. PLEASE INDICATE with your application that you are aware of this restriction when you apply for the course.*

#### **FAQ – NFA Vacancy Lists**

**Q: Why are there vacancies at the National Fire Academy? Are enrollments down?**

A: Enrollments in the National Fire Academy (NFA) are actually up. Last year, in cooperation with our State training partners, our on-line training at NFAOnline, and in our resident and off-campus delivery program, the NFA reached 108,000 fire service professionals. In 1995 we trained just 15,000. Like every college, we plan our academic year based on last year's enrollments, the number of new courses on the schedule, waiting lists for current courses and the calendar and our best estimate of the demand for courses the following year. It's not an exact science.

Vacancies occur for any number of reasons – some classes have low demand because the number of fire department members doing that job is low (e.g. public educators, data analysts, training, plans review, budget), but these courses are in many ways critical to the success of fire and life safety and the administration of the fire department. Other times we may overestimate the demand. When that happens, we cancel a low-demand course, move the enrolled students into another delivery of that course and use the funds to run an additional high-demand course.

**Q: It seems that I'm hearing more about vacancies than I ever have in the past. Why is that?**

A: Well, you are. Before widespread communication using web sites and email, the NFA relied on last minute telephone calls to fill seats. We couldn't announce the vacancies in sufficient time to get the students here to campus. Now, with improved communications, the increased membership and support of the Alumni Association and the participation of many

of the fire service organizations, we distribute vacancy announcements in a matter of minutes. It is working very well.

What you are seeing, though, is only the vacancies. We never send out the list of classes that are already filled and have a waiting list. The lists show only the few vacancies we have.

**Q: I don't apply during the application period, I like to wait to see what classes have vacancies before I apply, is that a good idea?**

A: NO! The first requirement for a student's eligibility to attend the NFA is their current job responsibility (Box #16). If you wait, it is likely that the courses you qualify for will be filled by others in the normal application process. When that happens, you lose the best chance you had to attend the NFA. Worse, if applications are low, the class you seek may be cancelled. The most useful and valuable course for you may never show up on a vacancy list. The better strategy is to apply during the normal application periods (May 1- June 30 and Nov 1 to Dec 30). Remember, if you qualify, you may apply for two different courses in the same semester (using a separate application for each); however, you will only receive a stipend for one trip per fiscal year (Oct 1 through Sept 30)

**Q: Why are there waiting lists and vacancy lists at the same time?**

A: Our courses are academically rigorous, and every class is considered mid- to upper-level college course work. It is important to ensure that each student is capable of success in the course before being admitted.

Students are accepted to the NFA based on the 'target audience' criteria listed in the catalog. We want to make sure that the course is a benefit to both the fire department and the students when they return; and is of sufficient complexity to advance the student's knowledge to improve local service delivery. Students who do not meet the 'target' criteria would slow the class down, and expose the student to possible failure.

It is more important to fill a seat with a qualified student than it is to simply fill a vacancy. This ensures success for the department, the student and the rest of the class.

**Q: What is the most frequent cause of application rejection?**

1. Used the wrong application. For resident courses, applicants should submit the long form (75-5) application which requires the chief's signature
2. Didn't fill out the application completely
3. Didn't sign the application, or have the Fire Chief sign the application
4. Failure to describe your activities/responsibilities as they relate to the course for which you are applying and identify how you will use the information obtained from the course. (Box 16).

**Q: Any suggestions to increase my chances of success?**

A: On our website, there is a document that provides eight "tips" for completing a successful application. It only takes a minute – but will dramatically improve your chances for success:

**CANDIDATE PHYSICAL ABILITY TEST (CPAT) INFORMATION:**

**Just in – There is a new Sacramento California Fire Fighters Joint Apprenticeship Committee CPAT Testing Center in Sacramento, CA!**

**T**he Candidate Physical Ability Test (CPAT) is a must have for any person planning on becoming a firefighter. More and more departments are requiring a candidate to possess a CPAT completion card (no older than one year) just to apply for their department. If you do not possess a current CPAT, you do not pass go, you do not collect two hundred dollars, and you miss out on the opportunity to compete for a firefighter position at many departments. The CPAT does not guarantee that you will be a successful firefighter. Successfully passing the CPAT means that you should be able to enter a firefighter academy at a reasonable level of fitness appropriate to the job. I encourage you to learn more about the CPAT, and also look into having this certificate on your resume. Trust me, this may be an eye-opener for some – many of you will not pass it the first time. Make sure you take advantage of the orientation and practice sessions and learn where your weak spots are so you can focus on those areas.

## ***Basic Information For The CPAT Test***

### **QUALIFICATIONS:**

Applicants must be 18 years of age and must show government issued photo identification (i.e. drivers license, school or military ID; or a passport or visa). Candidates without a photo ID will not be allowed to take the CPAT.

### **APPLY EARLY**

Applications are accepted in the order they are received. Applications are not accepted until the fee has been paid.

### **PAYMENT:**

The fee to take your first test at their site is \$150.00. Your fee must be paid for your application to be accepted. This fee is non-refundable. Payment can be made with check, money order, Visa, or MasterCard. If you are paying by check, the check must clear your bank before you can take the CPAT. Make payments to “CFFJAC.” Your fee includes participation in an orientation session, related printed materials and test.

### **ORIENTATION SESSION:**

Working with experienced CPAT proctors, you will be given the opportunity to try each of the 8 events and determine where you may need to strengthen yourself. You will be given a set of exercises to physically prepare yourself for the CPAT. If you elect not to participate in the orientation, you will be required to sign a waiver acknowledging that the orientation was offered. There are no discounts if you elect not to participate in an orientation. The CPAT dress code is enforced for all candidates who attend an orientation.

### **TEST:**

The registration form has a place for you to choose a preferred and second orientation day as well as a preferred and second test day. You will be notified by mail of the confirmation of your orientation and test dates. A group of candidates are scheduled every half hour to report to the CPAT center. Please be on time, but not excessively early. Space for waiting is limited. If for some reason you cannot attend your scheduled test day, please notify us as soon as possible. Every effort will be made to reschedule you to a test day that will fit your schedule.

### **RETESTS:**

**Chabot College Fire & EMS News**

If you have taken the CPAT at a CFFJAC monitored venue in the past and would like to retest, the fee is \$100.00.

**PRACTICE SESSIONS:**

For \$25.00, you can schedule a supervised practice on the CPAT course with a proctor. Your session is designed to meet your individual needs. A session may include: Training on the CPAT equipment, watching the instructional video, going through the course in its entirety. ### **National Fire Academy - Water-Based Fire Protection System Plan Review (P136) - Pilot Courses Scheduled**

The United States Fire Administration (USFA), Department of Homeland Security, is recruiting students and instructor candidates to attend pilot classes for its new six-day off-campus or State enfranchised course *Water-Based Fire Protection System Plan Review*. The first pilot will be offered December 7 to 12 in Champaign, Illinois. The pilot delivery is a

partnership with the Illinois Fire Service Institute. Students will arrive Saturday December 6 and depart Saturday, December 13.

The course will enable students to perform a plan review to evaluate the suitability of the fire sprinkler, pump and standpipe plans and calculations in accordance with nationally recognized standards for design and installation. Course content covers fire protection standards, plan reading, water supplies, building envelope features, fire protection hydraulics mathematics, fire pumps, sprinkler systems, and standpipe systems.

A second pilot will be delivered at the National Emergency Training Center (NETC) in Emmitsburg, Maryland March 29 to April 3, 2009. Students will arrive Saturday March 28 and depart Saturday, April 4. (The application period for the on-campus pilot will open beginning November 1, 2008 and must be postmarked not later than December 31, 2008.) Other than this second pilot, there are no plans to offer this on campus at the National Fire Academy.

Pilots are highly participatory among the instructors, course developers and students. Attendees are expected to contribute their ideas and expertise to improve course content and delivery.

**Target Audience:** The target audience for this course is the student who is responsible for the review and approval of plans for water-based fire protection systems in his/her jurisdiction.

**Student Selection Criteria:** Individuals who have code enforcement responsibilities for the review and approval of plans for water-based fire protection systems in his/her jurisdiction.

Priority selection will be given to those applicants who express interest in and meet minimum qualifications to become course instructors. ### **New Reports on Fire Protection and Municipal Water Supply Systems**

Emmitsburg, MD. – The United States Fire Administration (USFA) has completed a project with the Society of Fire Protection Engineers (SFPE) Educational and Scientific Foundation to study and evaluate the latest trends and technologies related to municipal water supply systems to enhance effective fire protection. This study was conducted with support of the Department of Homeland Security's Science and Technology Directorate.

"This initiative will be of value to local-level fire protection, supporting USFA's goal to reduce the loss of life and property from fire," said U.S. Fire Administrator Greg Cade. "This cooperative effort allows communities to have comprehensive information on the latest technologies in municipal water supply systems in support of fire suppression activities and concerns."

The team examined issues of interoperability and critical infrastructure protection, as well as backup and redundant water supply systems for fire protection, and from their analysis created the two reports: Volume I – Water Supply Systems Concepts and Volume II - Water Supply System Evaluation Methods. "This study reflects SFPE's commitment to advancing the science and technology that protects people from fire," said Chris Jelenewicz, SFPE Engineering Program Manager. "SFPE was pleased to work with USFA in advancing the understanding of critical water supply systems and their importance in fire protection."

Both reports are available for download (**only**), free of charge, from the USFA Web site.

**KS LODD: Drowning, CA FF LODD: Head Injury (The Secret List)**

It is with deep regret that we advise you that rapid flood waters claimed the life of an Argonia (Kansas) Firefighter, Saturday night, after he attempted to save eight people, three of them emergency workers. FF Dennis Rhodes, 47, of Argonia was killed when he attempted to enter the Chikaskia River to the trapped victims. There is some controversy related to this tragic loss as it is reported that the rescue unit leader directed FF Rhodes to remain out of the water and to not attempt an individual rescue according to quotes from a local EMA Director. Reports are that after entering the river, FF Rhodes lost his balance and was swept under the current until he was retrieved by emergency workers. Members of the rescue crew brought Rhodes back to shore — performing CPR and transporting him to an area hospital where he was pronounced.

**15th FIREFIGHTING LOSS IN CALIFORNIA:**

A 77-year-old contract Firefighter has died from injuries he suffered while operating at a fire in a Northern California forest last month. Curtis Hillman, of Happy Camp, died on Sept. 11 at Mercy Medical Center in Redding. FF Hillman sustained head injuries on Aug. 25 when he jumped or fell off a road grader in the Six Rivers National Forest near the Oregon border. Hillman, a member of the Karuk Indian tribe, is the 15th firefighter to die from job-related causes in California this summer. Eleven were killed in a helicopter crash last month and three died in July—one of a heart attack, one after being struck by a falling tree and another of burns.

**SIZE UP REMINDER:**

Just a quick reminder to **all of us**: SO MANY of the very recent LODD's (and their investigative reports) point out the critical importance of (and failure to do) a SIZE UP. Be it single family dwellings requiring a size up with walk around to allow us to DETERMINE CONDITIONS and.... WHAT THE FIRE PROBLEM IS ...to a water rescue or whatever else we are responding to...we gotta SIZE IT UP (initially, continuous and throughout).

When doing a size-up, a complete 360-degree view "walk-around" of the building be taken whenever possible. Identification of conditions such as smoke, fire, construction type, occupancy, life hazard, FF hazards, walk-out basements or changes in building size are all quickly identified. These features will help us determine the attack and may drastically change our initial thoughts on our tactical approach to the incident. Additionally, every door or window you see gives you escape options as well as helping with building landmark identification.

**While we naturally wanna grab tools and a line and go in and "get it"...a thorough SIZE UP can be a big help from "it getting" us.**

Seeing 5 civilians and 3 rescuers trapped on the low head dam Mr. Rhodes tragically decided to attempt a rescue against the recommendation of the local FD. Mr Rhodes was swept over the dam into the boil, had a life line attached, but by the time they pulled him out it was too late. A swift water team from my Wichita FD was dispatched. WFD Rescue arrived and were able to remove all eight from the dam. Unfortunately Mr. Rhodes lost his life before we could arrive with swift water capabilities. Our condolences to his family and friends.

When Joe Shields was contacted by emergency responders and crash investigators and told about his wife's accident early Thursday morning, he had just completed his final shift at the local department before transferring to the Bargersville department, where he would have joined his wife in employment early next week. **MARYLAND STATE POLICE MEDEVAC CRASH-MULTI POLICE/FIRE LODD:**

Just after midnight, Maryland State Police EMS Helicopter "Trooper 2" crashed in Prince Georges County while transporting victims from a run in Southern Maryland. Dispatchers were unable to reach the unit for a significant amount of time but approx 90 minutes later, did find the wreckage. The number of crew/patients on board is reported as 4 DOA's (MSP pilot, MSP medic, a victim/patient and a Southern Maryland area Firefighter being on board to assist from the initial run) as well as 1 trauma victim/patient (18 y/o female) who is currently being treated. The crash occurred in the Capital Heights/Ritchie area within a regional park. Weather conditions were bad at the time of the crash. One report also states that the helicopter was transporting, the weather was too bad-so they planned to meet up with ground EMS to continue the transport. As an update, Maryland State Police helicopter Trooper 2 crashed early this morning in a park in central Prince George's County. The helicopter was discovered by a Prince George's County police officer. Police and fire crews had been searching for the chopper after contact was lost during a medevac transport. (Details on the search below)

According to Prince George's County Fire/EMS Department Chief Spokesman Mark Brady, four people were found dead at the crash site. Eighteen-year-old Jordan Wells, who was being flown from an accident scene in Waldorf, MD, was pulled alive from the wreckage. Wells is in critical condition.

**The names of the four people killed in the crash are:**

**1. MSP Pilot Stephen H. Bunker**, the 59-year-old pilot from Waldorf, MD. Bunker had retired as a corporal in 1998 after 26-years with MSP. He returned as a civilian pilot. Bunker had been flying for MSP for 24-years and was a certified flight instructor and a certified instrument flight instructor. Stephen Bunker was married with three grown children.

**2. MSP TFC Mickey C. Lippy**, the 34-year-old flight paramedic from Westminster, MD. Trooper Lippy joined MSP four-year-ago. Prior to that Lippy had been a firefighter and medic with the Anne Arundel County Fire Department. He had been assigned to Station 18 (Marley) for much of his career. Trooper Lippy had recently returned from family leave following the birth of his daughter, now four-months-old. Lippy was also a member of the Owings Mills Volunteer Fire Company in Baltimore County and also worked part-time as a firefighter with Gamber & Community Fire Company in Carroll County, MD. We have been advised that Trooper Lippy's wife works full-time for Gamber & Community Fire Company.

**3. EMT Tanya Mallard**, the 39-year-old EMT-B with Waldorf Volunteer Fire Department, Station 12. Mallard is survived by her husband and two children.

4. Civilian Ashley J. Younger of Waldorf, MD. Tragically, she was the 17-year-old victim of the automobile accident.

**INCIDENT DETAILS:**

Trooper 2 was dispatched to the Waldorf crash around 2300 hours. According to Brady, the helicopter crew was on the way from the accident scene in Waldorf to Prince George's Hospital Center when the pilot told SYSCOM (which is the Maryland Statewide Communications System that provides communications among ambulances, medevac helicopters, dispatch centers, hospital emergency departments, trauma centers, specialty referral centers, and law enforcement) that they would be landing at their Andrews Air Force Base hanger because of bad weather. Prince George's County Fire was contacted at 2353 hours to have two BLS units meet the helicopter to continue the transport to the hospital.

Trooper 2 never arrived and local, state and federal authorities immediately launched a massive search for the helicopter, but after an hour the wreckage was still not found. **Using technology to track signals from the cell phones of the crew**, authorities eventually narrowed their search to an area near Walker Mill Road and Berry Lane in Capitol Heights. At 0200, an officer spotted the crash site. The helicopter had come to rest deep inside the 470-acre Walker Mill Regional Park, near a paved bike path behind a series of softball fields. The crash scene is in Walker Mill Regional Park, about three-miles north of Andrews Air Force Base.

**INCIDENT RELATED INFORMATION OF INTEREST:**

The Maryland State Police operate a fleet of 12 EuroCopter Dauphin helicopters capable of medical evacuations. The unit conducts almost all aerial medical evacuations in Maryland, and are the only such publicly run, statewide service in the country. **Trooper 2 that crashed, has routinely ranked as one of the busiest in the country in recent years.**

**EXCELLENT SUPPORT FROM POLITICIANS:** The state legislature last year endorsed **replacing** the department's 18-year-old fleet at a cost of \$110 million. Some lawmakers said maintaining the state-run fleet was critical to equally serving residents in rural and urban areas, and some have expressed concerns about its safety. The state police keep the helicopters in eight locations across Maryland so they can reach any corner of the state within 18 minutes. Last year, a DC area newspaper reporter rode along on Trooper 2 as it took off and landed more than 20 times in six hours, carrying patients to and from Prince George's County hospitals.

Shortly after noon yesterday, an Atlanta Fire Rescue ARFF truck was responding on a simulated emergency call (a "response drill") at the Atlanta Airport when it flipped while negotiating a curve. All 3 Firefighters (a Captain, an Apparatus Operator, and a Firefighter) **were fully belted**, secured with harnesses and no one was hurt....all were checked out (precautionary) and released back to duty. The apparatus suffered severe damage (see our news/updates on the home page) but each firefighter was fine.

And....in BRAZIL, we regret to advise you that a 34-year-old 15-year veteran Fire Sergeant of Brasilia Fire Department (in Brazil), Sgt. Washington Nunes, **died in the Line of Duty yesterday** during a specialization course for rescue divers. A investigation is on going to determine the cause of death and if there was any excess expectations during the training. The specific course related to rescue diving for the Firefighters of Brasilia is considered extremely difficult and controversial as to the challenges that are expected. Our condolences to all affected.

We regret to inform you of the **Line of Duty Death of a Firefighter in Gretna, Louisiana**. Initial reports are that an aerial device boom crushed a Firefighter between the boom and the apparatus, resulting in a Line of Duty death. The name of the department that protects Gretna is **David Crockett Steam Fire Co. No. 1**. According to Fire Chief Bobby Black, the Firefighter was operating equipment that allowed an insurance adjuster to evaluate damage caused by Hurricane Gustav ....the boom was apparently being lowered to the ground when the Firefighter became pinned between the equipment being lowered and the apparatus. We will provide additional updates as soon as they become available.

Hey...

**A Firefighter with the Rockville VFD/Montgomery County (MD) Fire Rescue was burned this morning in a floor collapse. He is stable in the Washington DC MedStar Burn Unit.** According to the RVFD, companies responded at about 0130 hours to a basement fire in a house. F/R III Joel Rogozinski was performing search operations on the first floor when the floor gave way and he began to fall through the floor into the basement. He was able to catch himself before falling fully....but the FF could not pull himself up and dropped down into the basement. Previously, when he had arrived on the scene, he had done a circle check and noticed a basement window on side "D". After he dropped into the basement, he located the window and was able to rescue himself with assistance from Firefighters outside. In the meantime, a mayday had been called by other firefighters on the first floor. **During the event, Joel suffered 30% 1st, 2nd, and 3rd degree burns to his arms and legs. He was transported by ground to MedSTAR and has no other injuries.**

Further info from the RVFD indicate that the FF is in good shape; he has no respiratory involvement but has a lot of pain from the burns. Joel has been admitted to the burn ICU as a precaution and will be there for at least one day. He will likely be in the hospital for several days and in recovery for a few weeks.

Further from the RVFD is that despite the floor collapse, other actions by crews on the scene knocked the basement fire prior to the floor collapse, which allowed the FF the opportunity to escape. The area he fell in and the window he climbed out of was heavily involved in fire just a few moments prior to the floor collapse.

It is with deep regret that we advise you of the passing of CO II Douglas Falconer on Wednesday, October 1, 2008. Officer Falconer, a part of Globe's inmate Wildland Fire Crew, had been dispatched with a crew to the Sacramento Fire in the vicinity of Lake Havasu City near the California border. The crew had just set up its gear and was working the fire line when he expired due to a medical emergency. Officers and inmates alike responded immediately and emergency medical assistance made every effort to revive our esteemed coworker. CO II Falconer is survived by his wife, Cherry. Our condolences to all affected.

**FIREFIGHTER SERIOUSLY BURNED:**

A Firefighter from Reagan County (Texas) was airlifted to Shannon Medical Center yesterday afternoon after being injured while operating at an oil-rig fire north of Ozona. VFF Dustin Rojas suffered second and third degree burns to his legs and knees. Reports are that the firefighter "stepped back into a puddle of water that was really hot and he was burned." We wish him a rapid recovery.

**MONTGOMERY COUNTY (MD) FF BURNED / MAYDAY UPDATE:**

Yesterday morning, Montgomery County (MD) experienced a Mayday as a result of a Firefighter falling through the first floor into the basement area of origin of a single family home. According to MCFRS, the Firefighter, a member of the Rockville VFD, was driving Rescue Squad 703 on a first due dwelling fire and in performing his responsibility of controlling exterior utilities did a circle check of the structure during which he noted fire

coming from a Side Delta, Quadrant Delta basement window. Here are some initial details from Chief Tom Carr, MCFRS.

Once the FF completed his exterior duties, he entered the structure with PPE fully and properly donned. During entry he fell through the fire weakened dining room floor to his arm pits into the basement room of origin. At some point he dropped the rest of the way through to the basement. T703 announced a Mayday. Now in the super-heated, just extinguished (reportedly by E723, entering through the exterior basement entrance) room the RVFD FF had the presence of mind to remember that small (14x30) window he saw in his walkaround. The FF looked up 5 1/2 feet and saw his opportunity for escape. Apparently, he climbed a set of shelves in front of the window and removed bars on the window and then recognized he could not fit through the opening w/his SCBA on his back. He removed his bottle BUT kept his face piece in place. As he started out, pushing his bottle in front of him, he was assisted out by rescuers.

As commented by Chief Carr, the FF had a tremendous presence of mind! He reacted immediately and instinctively. If he hadn't reacted as he did the outcome very well may have been different. The FF was treated and transported to MEDSTAR Burn Center. He had no respiratory burns, Indicative of how much of a close call and a near miss th is was, he did have other serious burns. Last night the RVFD member is recovering after skin graft surgery. He has 35% 2nd and 3rd degree burns on his arms, upper torso, and lower leg; he also suffered a de-gloving of his left pinky finger. He should have a full recovery although it will be a painful, lengthy endeavor. He is scheduled for more surgery on Monday. Thanks to Chief Carr for the above update.
